Inglewood Mayor Adjourns Council Meeting After Only 15 Minutes

In a very short but eventful city council meeting, Inglewood Mayor James T. Butts adjourned the proceedings early when a resident speaking during the public comment period didn't walk away from the microphone fast enough. Shortly after the beginning of the weekly meeting, Michael Wilson with the Youth Justice Coalition approached the podium and directed a question to City Treasurer Wanda M. Brown. Upon answering the question, Wilson's timer reached zero at which point Mayor Butts told Wilson to step away from the microphone.

"In my eyes I wasn't hostile or rude--I was speaking to an elder [Brown], so I show respect to her," Wilson said. "I was very interested in her investments and when she spoke about how her investments did well and had a turnover, I wanted to give her accolades. Instead I was vilified instantly."

When Wilson asked if he could have an extra 20 seconds, which ticked away when Brown was answering his question, Mayor Butts repeated that Wilson's time was over only to shortly thereafter adjourn the meeting. Immediately after, a group of six police officers walked into the room and stood between the Council dais, which at that point was empty, and Wilson--and what was left of an audience. At that point one person in attendance held up pictures of Kisha Michael and Marquintan Sandlin, who were shot and killed by Inglewood Police officers in February 2016. Another gentleman recorded the incident as several other attendees stood in solidarity with the woman holding the pictures of the slain couple.

"I was here in solidarity with people who want questions to be answered regarding these questionable deaths of two young people sleeping

in their car," Wilson added. "Is Inglewood turning into a cover-up from the top city?"

The meeting, which was adjourned at 2:15 p.m., ended with the mayor and councilmembers leaving the chambers, not to return, in response to a resident's ongoing request for more time to speak. After a 20-minute wait, the lights were turned off and doors to the council room locked as the group of six asking questions about the police-involved shootings took the elevators downstairs.

In the past Wilson has used public comment to demand answers regarding the death of Michael and Sandlin and was present at this week's meeting in solidarity with Black Lives

Matters supporters, who ask the community to do the same during every council meeting. "Inglewood shouldn't be scared of a community wanting more communication," said Wilson. "We have an absolute right to give open comments in an open forum."

Michael (31), a mother of three boys, died at the scene while her partner Sandlin (32), a father of four girls, died later in a hospital. They were killed on February 21, 2016, but few to no answers have been provided regarding the police officers' actions that night on Manchester Boulevard and Inglewood Avenue.

Wiseburn School Board Hears Dana ELA Presentation, Fetes Retirees

Schoolchildren of a certain age once had their lesson plans guided by the tenets of what were termed the “three R’s” (reading, riting, and rithmetic)—a phrase coined more than 200 years ago. With the onslaught of technology now confronting both teachers and 21st Century learners, the main presentation at the May 4 Wiseburn Unified School District School Board meeting could be considered a bit retro. It focused on the seemingly quaint idea of actually reading books and fostering student writing skills.

In her 25-minute presentation to the Board, Dana Middle School English teacher Lisa Wilberg highlighted the strides being made at the school in the English Language Arts department. Her presentation was entitled “A Path to Writer’s Workshop.”

Writer’s Workshop is an interdisciplinary writing technique that is gaining traction in many elementary schools. It is a program that seeks to build students’ fluency in writing, featuring continuous, repeated exposure to literacy through the process of writing.

Wilberg, discussed what she termed “big ideas “in increasing the student’s breadth of understanding and achievement in the basic disciplines. “We want to create and maintain a culture of joyful literacy at our school,” she said. “We believe that all students are capable of reading, writing, and achieving at high levels.” She noted that while 2017 career fields such as math, science and engineering are “booming,” her belief is that literacy is at the core of the success that will be achieved in any of the STEM fields.

Wilberg highlighted the advancements being made at Dana from the 2011-12 school year forward as the ELA department started researching and implementing the mandated Common Core requirements, shifting the way English was taught in schools away from certain areas that may have had little real world relevance and applications. It means much more of an emphasis on critical thinking and much less focus on terminology. “I tell students all the time that you can’t get better at reading without reading,” Wilberg said, adding that the 2014-15 school year was the first time the new way of teaching English was implemented in Dana classrooms.

The 2016-17 school year has also seen the continued refining and mapping of ELA units. Wilberg said a Writer’s Workshop program, initially developed at Columbia University, drew her interest. In the spring of 2016, Wilberg and other teachers and administrators were able to travel to Pacific Elementary School in Manhattan Beach and see how a neighboring school was implementing the workshop program. She came away very impressed with how engaged the Pacific students were in their writing, and is hoping to implement the workshop program at Dana.

Wilberg concluded her program with data on the strides made by Dana students, with 75 percent meeting or exceeding mandated standards. The California state average is 49 percent. She also detailed events like “Literacy Week” that took place just prior to the spring break. Wilberg is also continuing to visit other schools that are successfully implementing the Writer’s Workshop curriculum. She cited the program benefits, which include giving the students a large amount of writing choices, being highly adaptable, and focusing on clear, specific writing skills. “This is where we’d like to go,” Wilberg concluded. She added that she hopes to return to a future School Board meeting with a proposed budget in

hand to implement the Writer’s Workshop program in the District.

After the presentation, School Board Vice President JoAnne Kaneda added her input: “I have four sons who are all engineers, and each one has told me that what differentiates them from other engineers, who might be just as good at engineering, is their ability to read and write.”

A second presentation highlighted the tech opportunities available in the District. Nancy Wloch and Margaret Thelen, two members of the American Association of University Women, were on hand to brief the Board. Their organization raises funds to send seventh grade middle school girls to week-long summer science camps as part of a program that is called Tech Trek. They announced that Dana students Carolina Echavarría, Nayeli Ortiz and Sierra Clark were scholarship recipients. Echavarría will be attending the program at UC Santa Barbara; Ortiz at UC San Diego, and Clark at Whittier College. Said Superintendent Tom Johnstone, “It’s a great program. The girls that go have a wonderful experience.”

Dana students Aidan Cessor, Logan Evans, Garrett Hoff and Diego Diaz were recognized for their top finishes in the school’s recent Geography Bee, with Cessor also competing at the state-level bee held in Fresno. District Spelling Bee 1-3 finishers were also recognized. They included Zachary Roach (Dana); Aldo Ayala (Burnett Elementary); and Eva Reyna (Dana), with Roach advancing to compete in the LACOE “grade bee” in Alhambra on March 29 for students in grades four two six.

After the special presentations concluded, Board members thanked the presenters. In his comments, President Israel Mora mentioned a recent joint meeting between the DaVinci School Board and the Wiseburn Board: “What is special in our District is how well we work together,” said Mora.

Four retiring District teachers were recognized during the action item portion of the 90-minute meeting. The retirees are Jeanette Payne Sutton, currently teaching fourth grade at Anza Elementary and completing her 34th year of service to the District; Sheila LaCour from Dana, who is retiring after serving the District for 28 years; Susan Coulbourne, who also teaches at Dana and is wrapping up 20 years of service; and Dana teacher Erma Bisignano, who is finishing her 14th year. Johnstone noted that having four teachers retire at the same time is a unique event for a district the size of Wiseburn.

The Board then took action approving a traffic signal analysis study that would address student safety and traffic congestion issues as construction continues on the Douglas Street property leading up to the August 22 opening at the new Wiseburn High School.

Consent agenda items were quickly addressed, including the approval for students and staff to participate in the Robert H. Herndon Memorial Science Competition that takes place at the Aerospace Corporation on May 25.

In his remarks, Johnstone painted a positive picture of the current events in Wiseburn. “We have the right people in the right places at the right time,” he said. Great things are happening.”

The next regularly scheduled Wiseburn School Board meeting is on the calendar for Thursday evening, May 25, and will be held on the Cabrillo Elementary School campus. •

Free Rides on Metrolink During Bike to Work Week

Metrolink will offer free rides during Bike to Work Week, May 15-19, 2017, to anyone who brings a bike onboard Metrolink. This offer will be effective on all Metrolink trains in operation Monday, May 15, 2017 until Friday, May 19, 2017. Riders must accompany their bike for the entire trip. Free ride offer is limited to one person per bike.

Metrolink Bike/Board Cars are in high demand across the Metrolink system as more cyclists continue to take the train. Due to the high demands across Metrolink’s system, there will be limited bike capacity during Bike to Work Week. If the train cannot accommodate

any additional bikes, you will be asked to take the next train or find alternative means of transportation.

To ensure the safety of all passengers, Metrolink conductors have the right to ask bicyclists to relocate to another passenger car or in the situation where there is no more bike storage available, ask you to wait for the next train. The free rides on Metrolink are not eligible for free transfers to any other bus or rail operator. This offer does not apply to any Amtrak trains including shared service trains. .

El Camino Receives \$40,000 Grant from Pritzker Foster Care Initiative

The El Camino College Foundation recently received a \$40,000 grant from the Pritzker Foster Care Initiative to continue programs that support foster care youth as they pursue higher education. The Pritzker Foster Care Initiative grant will help fund El Camino College’s Guardian Scholars program to assist with retention and academic persistence among students from foster care.

The ECC Guardian Scholars program currently supports 68 students. Foster care youth receive funds for tuition, books, supplies and campus resources such as the “LINK UP” program. This program provides foster youth students with informational sessions each month, covering topics such as job search strategies, money management, college transfer, and skills to achieve classroom success. LINK UP provides a community environment where students can come together, receive support from professionals, access additional information, and share a meal with others in the program.

Research indicates that there are over 400,000 children in the U.S. foster care

system with over 100,000 waiting to be adopted. Every year, 23,000 of these youth will age out of the system, never having found a permanent home. Young people who age out of foster care face a tough road: they are more likely to experience significant challenges with completing their education, obtaining a job, homelessness, and maintaining financial security.

The Pritzker Foster Care Initiative, part of the Anthony & Jeanne Pritzker Family Foundation, made a previous \$40,000 grant in December 2015 to initiate the Guardian Scholars program at El Camino College to provide support services for foster care youth. In addition to their foundation, Jeanne Pritzker also launched the non-profit Foster Care Counts in 2012 to provide support to programs that help foster youth as they leave the system and work toward becoming successful young adults.

LAX Relocations Mean Major Changes for Passengers

The biggest airline relocation in Los Angeles International Airport (LAX) history is about to take place as Delta Air Lines relocates from Terminals 5 and 6 to Terminals 2 and 3. Airport officials say the end result will be more efficient airline operations between partner carriers, and planned facility improvements for Terminals 2 and 3.

The activity taking place on the nights of May 12, 14 and 16, into the early morning hours the following day, has been planned for nearly a year. It is part of a larger effort that began when American Airlines and Delta Air Lines swapped four gates in Terminals 5 and 6 at the end of January. Each night when the airlines that are moving have completed their operations, they will begin the process of moving equipment to their new home, where they will begin operations the next morning. In many cases this means aircraft will be towed from one terminal to another, ground service equipment and entire offices will change places in the early hours of the morning. Delta will move portions of its operations on each of the three nights—May 12, 14, 16. Delta will operate from as many

as four terminals between May 13 and 16. The remaining airlines will move on one day and start in their new location the next morning. Extra staff and volunteers will be on hand to help guests find their way around.

There will be a moratorium on construction in the Central Terminal Area (CTA) during the week of the moves. While that week will be most busy, passengers using LAX should always plan ahead to navigate sidewalk and vehicle lane closures and in-terminal work. Construction alerts showing Central Terminal Area (CTA) roadway lane restrictions and sidewalk closures, as well as a pedestrian walking map and helpful airline terminal finder, can be found at www.laxishappening.com. LAX provides real-time traffic status in and around the CTA, and space availability in the terminal area parking garages and Lot C on Waze, the community-based traffic reporting app.

Hawthorne Keeps Sliding, Loses Two vs. Eagles

The Hawthorne Cougars late-season slide has continued and now it's beginning to become a bit difficult for the team and its fans to remember what it was like to win. Hawthorne has failed to come up with a victory in any game since the end of March when head coach JC Randolph's team defeated Animo Leadership for the second time this season. With an eight-game losing streak, it has become safe to wonder if the Cougars will pick up another win before the end of this regular season to somehow sneak their way out of last place in the Ocean League standings.

Last week's matchup for Hawthorne may have been a little bit more exciting if it weren't going up against an El Segundo Eagles team that is currently in first place in its division, has only lost six games all season long, and has now finished in second place or better in all three seasons that the team has been in the Ocean League. The Cougars received the full brunt of the Eagles' power on both the offensive and defensive ends of the diamond. In a two-game set, Hawthorne was outscored by a total of 18-0 as the team took consecutive losses by scores of 4-0 and 14-0.

In Game 1, it could be said that both teams got out to a slow start on Hawthorne's home field. Hawthorne, however, never got going, while El Segundo eventually began putting runs up on the scoreboard. A double by senior Kobe Estrada knocked home Sean Emery for El Segundo's first run of the game in the third inning. Despite the other three runs that the Eagles would eventually score, one run is all that the team would need. Junior Jamie Galicia pitched seven strong innings for El Segundo, allowing seven hits but no runs while striking out seven. Two of those hits came at the hands of senior Charles Phelps, who went two for four on the day. Senior Victor Valdez and junior Danny Villarreal each had a double, but were later left on base to round out the offensive output for the Cougars on the day.

Coach Randolph went with Kealoha Noguchi on the mound and the pitcher, all things considered, had a nice outing. Noguchi has only tossed 16 innings this season—but in just over five last Tuesday afternoon, the senior only allowed one earned run and five hits. Senior Bernardo Robles came on in relief and allowed one hit and one run in just over one inning on the mound. "Pitching has been our Achilles heel all season long," Randolph explained. "I'm just proud of the guys and how they always battle."

Game 2 went much differently for Hawthorne, Randolph and his pitching staff. Robles took the mound again for the Cougars and gave up eight runs (only one earned) in the first inning. By the end of the third, Hawthorne was down 12-0 and was clearly out of the game entirely. Opposing pitcher Spencer Long held the

Cougars to just one hit over five-plus innings of work. In all, Hawthorne made 12 errors over the two-game series, which led to 13 runs of production for El Segundo.

Hawthorne will cling on desperately to their final two games of the regular season against Lawndale to try to get a win. Though the Cardinals swept the Cougars (4-13, 0-8) last year, Randolph and his team know that this series is their best opportunity in league play to come away with a win. El Segundo will look to keep its first place standing alive as it takes on Santa Monica for two before the playoffs.

LAWNDALE HIGH

The Lawndale Cardinals have experienced some success of late and will look to close out the regular season by climbing the Ocean League standings. Last Thursday afternoon, Lawndale hosted divisional rival the Beverly Hills Normans and walked off of the diamond with a 2-1 victory. For Lawndale, the win was the fourth in the team's last six games and had head coach Robert Dempsey feeling optimistic about the direction of the ballclub.

The Cardinals got their offense going quickly against Beverly Hills, putting up one run in the bottom of the first inning and one in the bottom of the second. Senior Salvador Mercado had a base hit to knock home Michael Zambrano for the team's first run of the day. In the second, senior Hermilio Diaz knocked home Roberto Novelo for the second and final run of the contest. The rest was up to pitcher Jesus Sanchez. Sanchez pitched 5.2 innings, allowing only four hits and one run while striking out four. Senior Leo Cervantes came on in relief and closed the game out by retiring every batter he faced. The Cardinals (6-11, 2-5) will play three games in their final week of the regular season as the club takes on the Culver City Centaurs and the Hawthorne Cardinals (two-game series) while looking to stay hot to finish things off.

INGLEWOOD HIGH

The Inglewood High School baseball team closed its regular season out with back-to-back losses to the Peninsula Panthers. While the second game of the two-game set was forfeited by the Sentinels, Game 1 ended early because of a blowout. Though Inglewood was able to grab a run in the fourth and final inning of the game played last Tuesday afternoon in Inglewood, the Peninsula offense was simply too much. With three runs in the first inning, 12 in the second and nine in the third, the Panthers were well on their way to what wound up a 28-1 victory. Despite beginning the season with a 4-1 record, Inglewood (4-9, 0-8) and head coach Kewatta Wade finish things off with an eight-game losing streak as Bay League play simply proved to be too much for the Sentinels. •

If the Chargers stay healthy—which has been a big if lately—they may have a chance to challenge the rest of the AFC West for a division title. The Rams, on the other hand, will be lucky to get any positive production out of Goff, their second-year QB. Even if they do, it certainly won't be enough to challenge the likes of the Seattle Seahawks and the Cardinals in the NFC West.

The Rams moved to L.A. first—and for that reason, they currently have more fans in the area. With a little time and a lot of winning, though, the Chargers will be poised to take over as the team of Los Angeles well before the new stadium in Inglewood is prepared to open. A successful team is one that has the ability to gain attention across the league and the ability to gain fans from within the city. The current construction of the Chargers, which is in very stark contrast to that of the Rams, will have L.A.'s newest team taking over the city sooner than anyone would have otherwise thought possible. • —Asixlion@earthlink.net

The case remains under investigation and was forwarded to the Los Angeles County District Attorney's Office in November. The facts that have been confirmed are that Michael received 13 gunshot wounds while Sandlin was shot seven times. The couple was initially described as being unresponsive in their Chevy Malibu at 3 a.m. However, there was never a weapon recovered at the scene nor has there been an official statement that the victims attacked police officers.

An Internal Affairs investigation was supposed to result in a report earlier this year, but that has not been released to date. The Inglewood Police Department (IPD) was investigated by the Department of Justice's Civil Rights Division in 2009 due to a series of officer-involved shootings in 2008. While no investigation has been launched against IPD as a result of the Michael/Sandlin shooting, residents like Wilson believe that the City of Inglewood should be transparent and provide answers to residents' questions regarding the case. "It's scary that the police have been under investigation before," added Wilson. "I am literally speechless that they demonized me for being a participating citizen and for doing my civic duty. I am completely baffled at the demeanor and hostility that the mayor has for the community." •
