Public Hearing Leads to Ordinance Modifying Permit Parking

After a public hearing with little public comment, the Mayor and City Council this week approved the introduction of an ordinance to amend the Inglewood Municipal Code to modify Parking Permit District No. 4 by adding a new street. "The establishment of a permit parking district is to ensure the availability of on-street parking to the adjacent property owners within the defined area where patrons and employees of a nearby business or industrial facility are otherwise using most of, if not all, available on-street parking," said Director of Public Works Louis A. Atwell.

With the ordinance, the parking permit district will include 83rd Street between Victoria Street to the west and Crenshaw Drive to the east. At the time of the public hearing, the City of Inglewood had 14 parking permit districts--13 in residential zones and one in a commercial zone. Parking Permit District No. 4 was established due to the lack of parking for residents due to neighboring businesses. Prior to the amendment the parking district's boundaries were 81st Street and West Boulevard to the northern point on 84th Place, all the way to 85th Street's southern point, where the street bends southwest back toward West Boulevard and north to Manchester Boulevard.

"We had permit parking and everything was fine, but for some reason the block voted it away and now we want it to come back," 39-year Inglewood resident and Parking Permit District No. 4 resident Larry Stem said. "In order for you to park in front of your house on any day, you have to leave your car there because the apartment buildings around the

corner and up the street--even on Crenshaw Boulevard--will come all the way down, leave their cars since they have too many cars and can't park where they're at. I am hoping that you make this right and I can come home and park in front of my house and not have to park up the street or around the corner."

Once approved, the required purchase and installation of signage will cost the City an estimated \$2,500, which can be paid through Inglewood's Gas Tax Fund, Public Works, Gas Tax Maintenance/Street Gas Tax-Street Related Cost account.

"The lack of adequate parking in this instance is attributable to the Forum activity and patrons looking for parking in residential neighborhoods," states the staff report signed by Atwell.

Each household may obtain up to four parking permits per calendar year, at \$5 each. For non-residential property owners there will be parking permits available for purchase, but at \$25 per parking decal.

Resident Diane Sambrano questioned the

Wiseburn School Administration Selects New Principal for Cabrillo Elementary

Last Thursday evening’s Wiseburn School Board meeting featured a lengthy update on the state of the progress made by construction crews and affiliated workers at the new Wiseburn High School site at 201 N. Douglas Street. Balfour Beatty, the company that is managing the four-story, \$140 million construction project that started taking shape in August of 2015, had representatives Wayne Roehmild and Don Rondeau on-hand to provide information on the project’s progress as workers strive to make deadlines that will allow the on-campus ribbon-cutting ceremony to take place on August 12, with the first day of classes at the new facility slated for August 22.

Vince Madsen, Director of Facilities Planning, introduced the Balfour Beatty representatives, who said that while there were issues with some of the logistics of the project, workers had been toiling overtime to make sure that the facility would be ready to welcome students and staff when the doors officially open in less than two months.

When asked by a Board member if there were any “surprises” being encountered on Douglas Street, Roehmild said that “while not everything has been perfect,” there were “no more surprises--just a lot of work.” IT issues, fire alarm integration, and getting the building elevators to mesh with the building’s infrastructure were mentioned as typical areas to still be addressed as a project of this magnitude moves into the final stages.

Also present during the meeting to answer questions were Alvin Flores and Scott Griffith, representatives from the K-12 architectural design firm Ruhnau, Ruhnau and Clarke. The Board was set to approve the sum of \$180,000, contracting with the firm to develop an architectural master plan and provide design services for the soon-to-be-vacated land at the west portion of Dana Middle School, bordering Aviation, once the District offices are moved to the new High School facility. The Board will officially vote on the item during a brief meeting scheduled the morning of June 28. The new facility will be known as the Dana West Sports Complex. Wiseburn Superintendent Tom Johnstone has mentioned the possibility of installing a full running track on the property.

Not mentioned at the meeting, because it is pending Board approval, was the selection of the new principal for Juan Cabrillo Elementary. Prior to the meeting, Johnstone said that Lisa Baggio, an assistant principal at Marco Forster Middle School in San Juan Capistrano, will be taking over for the retiring Margaret Lynch. The Board was expected to approve the appointment of Baggio at a very brief meeting that was set to take place yesterday morning.

Emailed Baggio about her new position: “I am thrilled to have been selected as principal at Juan Cabrillo Elementary. It is an honor to become a part of such a prestigious district and school. I am truly looking forward to working with the dynamic team at Cabrillo. I am excited about getting to know all stakeholders and continuing the progressive work that Juan Cabrillo and Wiseburn Unified

are known for.”

Baggio will be joining the recently selected Kim Jones (Peter Burnett Elementary) as new school principals in the District for the 2017-18 school year. Jones’ selection was approved by the Board at the June 8 meeting.

Baggio obtained a BA from Chapman University, a Masters from UC Irvine, and another Masters in Educational Leadership from UCLA, and has also worked in education in New York City. One of 17 initial applicants for the position, Baggio was one of three candidates called back for a second interview.

Both Lynch and Laura Sullivan, principal at Burnett, who is also retiring, attended the Thursday evening meeting, and were praised by Board members for their years of service to the District.

The only special presentation that took place during the 100-minute meeting was made by Sarah Nitsos, the District’s Intervention coordinator. Nitsos shared with the Board what she termed her “deep dive” into reading intervention, with a specific focus on K-2 students.

Nitsos, who had served the District in a prior capacity as the principal at Anza, talked about the successes of Wiseburn’s 2016-17 reading intervention program. Initially focusing on K-2 readers in need of extra help to increase their reading comprehension, the program provides a goldmine of specific data that enabled Nitsos to not only help classroom teachers identify young learners who may be falling behind, but also grace teachers with specific information and data that they could use to help young learners improve their reading and comprehension skills.

Said Nitsos: “My job was exploratory in nature, much like Christopher Columbus.” While each school site, she said, had previously had interventions, they were not necessarily synched-up throughout the District. She sought to develop a program that would be implemented throughout Wiseburn, provide teacher feedback--and not only be child-focused, but also allow teachers and administrators to mine available data.

Post the special presentation, Board member comments ensued, with several asking about the program as it moved forward into the 2017-18 school year. Nitsos said she would like to see the program expand, but that would entail “personnel.” One of the limitations of intervention, she said, was the timeframe that current intervention personnel could devote to the program.

Said Superintendent Johnstone: “It is a huge blessing to us to have a principal quality person that really has an unbelievable knowledge of students from the classroom level up to the principal level to be focused 100 percent of the time on this topic.”

Lynch lauded the work done by Nitsos. She noted how it was very important for the District to create and fund the intervention coordinator position, and how Nitros has “brought it to life” and “brought the conversation from teachers talking about ‘my kids’ to teachers talking about ‘our kids.’”

The next regularly scheduled Wiseburn Board meeting is on the docket for Thursday, July 20. •

SBWIB Receives \$500,000 from EDD to Assist Veterans with Training and Jobs

The South Bay Workforce Investment Board (SBWIB) has been awarded \$500,000 to assist unemployed and underemployed veterans with barriers to employment find rewarding civilian jobs. The funding was made available through a Veterans’ Employment-Related Assistance Program (VEAP) offered by the State of California Employment Development Department (EDD) under the Workforce Innovation Opportunity Act (WIOA).

The SBWIB/VEAP program will focus on training and placing veterans into the construction industry, a sector projecting thousands of new job openings in the next few years, in particular surrounding the construction of the new Inglewood football stadium. For veteran job seekers that may not fit within the construction sector, the SBWIB will assist them to find jobs in other industries.

Training will be provided by local training agencies, community colleges and employers and will include pre-employment and job-readiness workshops, on-the-job training, paid work experience, and certified vocational training

leading to credentials and job placement. The program will service transitioning and recently separated veterans, veterans with service connected disabilities, eligible spouses, women and minority veterans, homeless veterans, veterans recently released from incarceration, veterans lacking a high school diploma or equivalent certificate and other veterans with barriers to finding employment.

Outreach and recruitment will be supported by existing partnerships with local area employers, the Los Angeles Air Force Base, the EDD (JVSG) (DVOP) (LVER) and other community partners such as U.S. Vets.

The SBWIB previously established the Military Veterans to Civilian Career Pathways program to assist with resources needed to secure gainful employment for vets and over seventy percent of veterans enrolled in the program find employment. The new SBWIB/VEAP program will open many more doors for veterans helping them to secure meaningful employment and successful careers. - Content: SBWIB

LA Metro Construction Lane Restrictions Through July 7

LA Metro will be performing ductbank work for the LAX/Crenshaw Line along Arbor Vitae Street in both eastbound and westbound lanes between Aviation Boulevard and Bellanca Avenue from Monday, June 26, to Friday, July 7, which will require alternating eastbound and westbound lane closures.

Work on the segment is scheduled from 9 a.m. to 3 p.m. each weekday. During the construction periods, lane closures will alternate

between eastbound and westbound Arbor Vitae Street, though at least one eastbound lane and one westbound lane will always be maintained at all times. There will be no lane restrictions over the weekend of July 1-2, or during the Tuesday, July 4, Independence Day holiday.

Motorists will also have the option to use Manchester Avenue as a detour during the construction period. - Content: Los Angeles World Airports

Bill to Streamline Construction of Assisted Living Facility Passes Senate Committee

Assemblymember Al Muratsuchi’s (D-Torrance) Assembly Bill (AB) 994 unanimously passed the Senate Governance and Finance Committee last week. The bill will allow a much-needed upgrade of the Beach Cities Health District’s (BCHD) campus to be built using a streamlined design-build construction method that will cut costs of construction by as much as 20 percent. The upgrades include much-needed maintenance on the original hospital facility, and construction of an assisted living center for the expanding senior population in the South Bay.

The construction of the facility will also bring many well-paying, middle-class jobs to the South Bay. “The Beach Cities Health District campus is in urgent need of upgrades. This bill will enable campus construction of a much-needed assisted living facility for seniors to be completed utilizing a cost-effective construction method called design-build, that will save taxpayers up to \$20 million on planned projects,” said Muratsuchi. “This construction project will also create good, middle-class jobs for the South Bay.”

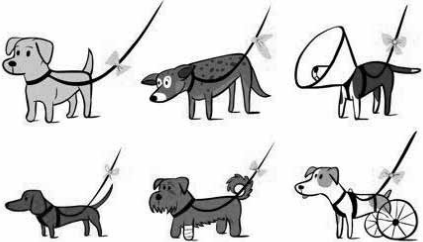
Congrats to mother and daughter, Bette and Joan finding their way to a new home together!

Lakers Hand Franchise Keys to Lonzo Ball

The Los Angeles Lakers have finally received what the team and its fans have been waiting ever so impatiently for. With the second overall pick in last Thursday's 2017 NBA Draft, Magic Johnson, new general manager Rob Pelinka and the rest of the Lakers organization selected Lonzo Ball in the first round to join the Purple and Gold. Any time the Lakers get a new piece to add to their otherwise depleted puzzle, the sports world goes crazy--and like a busy day on Wall Street, craziness ensues as opinions and conjecture begin to frantically fly around the room as if people's lives depended on it. The acquisition of Ball will certainly fuel that very same fire and as Lonzo takes the keys of what has been an old, rundown Ford Explorer, he'll immediately be expected to turn it into a Lamborghini Veneno. That being said, it has become increasingly evident that the pressure mounted on the 19-year-old's shoulders to deliver what the Lakers have been lacking is enormous, to say the least.

The NBA Draft is a tricky place to try to build a team's future. Throughout the years, there have been many players who were set to come into the league with all of the hype in the world surrounding them, only to quickly fizzle out and leave the team that drafted them curious, angry and still sitting at the bottom of the standings once again at the end of the year. Anthony Bennett in 2013 may be the best example of a number one overall pick not panning out. There was also Michael Beasley at number two in 2008, Adam Morrison at

three overall in 2006, Evan Turner at number two in 2010...and who could possibly forget Greg Oden with the first overall pick in the 2007 draft? Needless to say, now Lonzo must do everything he can to not be mentioned in the same paragraph as those, and other, first round draft day busts.

Lonzo may be the most NBA-ready player to enter the league from this year's draft. Not only did he improve his Chino Hills High School team drastically on the way to an undefeated record and a national championship in his senior season, but he also carried UCLA during his freshman year in college. Lonzo has the unique ability to share the ball, get his teammates involved, and assist his roster in playing better overall team basketball. He led the nation in assists his freshman year and broke the UCLA record for most assists in a season in the only year he was there.

Ball has shown throughout high school and college that he is a leader whose only concern is winning. His goal as a player is to make the players around him better--not to fill up the stat line with 60-point nights like a previous Lakers legend did so effortlessly on occasion. Ball should be able to improve his team in every way possible, but must first get past the enormous amount of pressure that has already been placed upon his shoulders.

Magic didn't hesitate to put that pressure squarely on Lonzo's shoulders immediately after he was drafted. "You look to your right, there's some jerseys hanging on the wall," Johnson said to Ball. "We expect a Ball jersey

hanging up there one day, all right? Good."

Who could be mad at Magic, though, when he flashes those big pearly whites and the entire room smiles with him? "So, Lonzo," he continued. "Just leave me one or two records alright? Don't break all my records." Even Pelinka got involved in the immediate praise heaped upon Ball before the latter had played even one minute of NBA basketball. "Those leadership qualities are what's going to take the Lakers to our ultimate destination, which is winning an NBA championship," Pelinka said. One second overall draft pick and the Lakers, their front office and fans everywhere are already thinking about championship.

It wasn't long ago that D'Angelo Russell was supposed to be the savior for the Lakers. Russell, the number two overall pick in the 2015 Draft, just got shipped out of town with Timofey Mozgov for Brook Lopez and this year's 27th pick. Now that he's gone, it's easy to point out all of the point guard's flaws, but he was at one time considered to be the player who was going to turn the Lakers franchise around and had everyone acting like they were on Wall Street again. Russell may still reach his full potential in New Jersey with the Nets, but he alone showed that becoming the league's next big star is clearly not as easy as simply stepping foot on the basketball court--especially in Los Angeles.

To call someone a franchise player before they have even logged one minute of game-time action is a bit hasty, to say the least. Sure, it's fun to imagine what a roster full

of potential with players like Ball, Brandon Ingram and Julius Randle might look like, but potential is the key word in that sentence. Ball is facing sky-high expectations. With as much pressure that is on the 19-year-old, though, Magic and Pelinka should be feeling even more. Ball is just one piece in turning the Lakers around into a championship team. With the enormous target that has now been placed on his back, he's going to need a lot of help around him to secure any sort of team transformation. It's up to Magic and company to find that help in free agency before talk of a championship should even be uttered down the Staples Center hallways.

"The tide has turned. People want to play here again," Magic related to a crowd of reporters. "It's exciting times for the L.A. Lakers." The Lakers will have an extreme amount of roster and salary cap flexibility come the 2018 offseason. That's when Magic plans to do most of his damage in free agency and most of his recruiting to get big-name players like Paul George, for instance, into the Purple and Gold. For now, Laker fans can throw conjecture across the walls and run around yelling at a frantic pace, hoping that their team is championship material. No one's beating the Golden State Warriors anytime soon, so let Lonzo play his first minute of NBA basketball and maybe then, the Lakers can begin what will still need to be an absolutely enormous transformation into becoming a playoff-ready basketball team. •

City’s methods and reasons for creating permit parking districts and asked that in reality the residents are surveyed and spoken to before imposing such parking restrictions. Atwell shared that 75 percent of the 83rd Street residents voted in favor of permit parking, helping staff’s decision to recommend the amendment to the Council. “We have been asking for the last year and a half,” said Stern.


Mayor to Sign Deed Restrictions for Darby Park Art Action Anti-Graffiti Project

Mayor James T. Butts was given authorization by his Council colleagues to sign deed restrictions on behalf of the City with regards to the anti-graffiti program. Back in November 2012, the City applied for the Proposition A-funded Artistic Anti-graffiti Grant Program. Tailored to prevent vandalism, the grant funds are used to work within the community. The city’s intention was to combat the Darby Park handball court’s graffiti problem through the creation

of the Darby Art Action—a youth-led mural team. Grant money (\$25,000), combined with \$15,000 from the Parks, Recreation and Library Services Department and \$3,000 from Public Art Fund, allowed the City to complete the mural by June 20, 2014.

“The City’s Artistic Anti-Graffiti Program files were recently audited by the Los Angeles County Regional Park and Open Space staff,” states the staff report signed by Parks, Recreation and Library Services Director Sabrina Barnes. “In order to close out the Darby Art Action Project, a Deed Restriction is required by the Los Angeles County Regional Park and Open Space (RPOSD) to record a restriction on the Darby Park title.”

The restriction will ensure that the property is used for its intended purpose along the grant’s requirements. It will also allow the City to obtain maintenance and servicing funds for the mural in the future, while making sure that the open space remains a park. •



ARESOLUTION OF THE CITY COUNCIL OF THE CITY OF INGLEWOOD DECLARING ITS INTENTION TO LEVY AND COLLECT ASSESSMENTS WITHIN THE STREET LIGHTING ASSESSMENT DISTRICT NO. 1980-1 FOR FISCAL YEAR 2017/2018 AND APPOINTING A TIME AND PLACE FOR A PUBLIC HEARING
