## Council Appoints, Ratifies Members to South Bay Workforce Investment Board

The recommendation to adopt a resolution that would ratify the appointments and reappointments of members to the South Bay Workforce Investment Board [SBWIB] was approved by Inglewood Mayor James Butts and members of the city council.

Since Dec. 4, 2012 the mayor and council have authorized the city to function as the administrative body for the SBWIB. The state nonprofit operates as a public benefit corporation responsible for “contracts to provide job training and employment services to the Administrative Entity of the South Bay Workforce Investment Board Area [SBWIA],” indicates the staff report.

The people appointed and reappointed to the SBWIB include: Jesus Fernandez, organized labor; John Hefferman, Inglewood business private sector; Linda Bradley, Inglewood business private sector; Lilian Haney, Hawthorne business private sector; Marty Jones, Hawthorne business private sector; Tod Sword, Hawthorne business private sector; Raj Dhillion, Hawthorne business private sector; Glenn Mitchell, Gardena business private sector; Michael Jackson, Redondo Beach business private sector; David Noflin, Carson business private sector; Tamal Lewis, Carson business private sector; Janine Hamner, Carson business private sector; Fran Fulton, Torrance Economic Development; Christopher Braun, Torrance business private sector; Ellenmary Michel, Torrance business private sector; and Hattie Harrison, Torrance business private sector.

“From time to time, the SBWIB has a need to appoint members to its board, which is done pursuant to the legislative mandates outlined in the Workforce Investment Act

[WIA] of 1998,” states the staff report. “Members of the Board of Directors are appointed by the participating cities and ratified by the Inglewood City Council, which serves as the administrative entity.”

The SBWIA consists of 11 cities and include Inglewood, Hawthorne, Lawndale, El Segundo, Manhattan Beach, Redondo Beach, Hermosa Beach, Gardena, Lomita, Torrance and Carson. Members of the board are responsible for meeting workforce development challenges within their service area. Challenges include the development

of comprehensive strategies that will fulfill the needs of businesses such as finding a skilled workforce.

In addition, the SBWIB works to create career opportunities for workers by assisting in their preparation to enter the workforce through well-paid careers. In order to achieve its goal, the SBWIB works closely with a variety of stakeholders such as business, labor, education, social services, nonprofits and community-based agencies in order to better identify the local needs of both employers and potential employees.

The Board, made up of 60 members representing all of the involved stakeholders, provides oversight for the SBWIB’s programs while developing policies that will guarantee compliance as well as efficient operations.

**Council Amends City Contract With CalPERS, Reflects Agreement Between IPOA, IPMA**

A recommendation by the city’s human resource department to adopt a resolution amending the city’s contract with CalPERS to show the agreement between the

Inglewood Police Officers Association [IPOA] and Inglewood Police Management Association [IPMA] was approved by the mayor and city council.

The agreement is for IPOA and IPMA to pay an additional 4 percent of their CalPERS employee rate for classic members, while the city covers 1 percent of the 9 percent employee rate.

“The current Memorandum of Understanding [MOU] with the IPOA and IPMA members requires a salary increase on or about August 27, 2015, and the classic

members [those members hired before January 1, 2013 when the new PERS law went into effect] will simultaneously begin paying an

additional 4 percent,” states the staff report.

In June of 2014 the city council and mayor approved new MOUs for the IPOA and IPMA members, which required the members of each bargaining group to “incrementally pay their entire” CalPERS rate.

As of August of last year, members of both bargaining groups were required to pay an additional 4 percent of their employee CalPERS rate. By August 2015 there would be an additional 4 percent contribution required of members, which bumped the total amount being paid by members of both bargaining groups to 8 percent.

“The Employer Paid Member Contribution or EPMC will be reduce to one percent,” states the staff report. “This requirement will go into effect upon adoption of the Salary Ordinance and the attached Resolution. However, in order for CalPERS to recognize these changes, a resolution amending the city’s PERS EPMC contract must be adopted to incorporate these changes.” \*

## NASA’s New Horizons ‘Phones Home’ Safe after Pluto Flyby

**Based on joint press release from NASA, Johns Hopkins University Applied Physics Laboratory, and Southwest Research Institute, provided by Bob Eklund. The call everyone was waiting for is in. NASA’s New Horizons spacecraft phoned home just before 9 p.m. EDT Tuesday, July 14, to tell the mission team and the world it had accomplished the historic first-ever flyby of Pluto.**

“I know today we’ve inspired a whole new generation of explorers with this great success, and we look forward to the discoveries yet to come,” NASA Administrator Charles Bolden said. “This is a historic win for science and for exploration. We’ve truly, once again raised the bar of human potential.”

The preprogrammed “phone call”—a 15-minute series of status messages beamed back to mission operations at the Johns Hopkins University Applied Physics Laboratory in Maryland through NASA’s Deep Space Network—ended a very suspenseful 21-hour waiting period. New Horizons had been instructed to spend the day gathering the maximum amount of data, and not communicating with Earth until it was beyond the Pluto system.

Pluto is the first Kuiper Belt object visited by a mission from Earth. New Horizons will continue on its adventure deeper into the Kuiper Belt, where thousands of objects hold frozen clues as to how the solar system formed. New Horizons is collecting so much data it will take 16 months to send it all back to Earth.

### PLUTO’S ICY MOUNTAINS

Close-up images of a region near Pluto’s equator reveal a giant surprise: a range of youthful mountains rising as high as 11,000 feet above the surface of the icy body.

The mountains likely formed no more than 100 million years ago—mere youngsters relative to the 4.56-billion-year age of the solar system—and may still be in the process of

building, says Jeff Moore of New Horizons’ Geology, Geophysics and Imaging Team (GGI). That suggests the close-up region, which covers less than one percent of Pluto’s surface, may still be geologically active today.

Moore and his colleagues base the youthful age estimate on the lack of craters in this scene. Like the rest of Pluto, this region would presumably have been pummeled by space debris for billions of years and would have once been heavily cratered—unless recent activity had given the region a facelift, erasing those pockmarks.

“This is one of the youngest surfaces we’ve ever seen in the solar system,” says Moore.

Unlike the icy moons of giant planets, Pluto cannot be heated by gravitational interactions with a much larger planetary body. Some other process must be generating the mountainous landscape. The mountains are probably composed of Pluto’s water-ice “bedrock.”

Although methane and nitrogen ice covers much of the surface of Pluto, these materials are not strong enough to build the mountains. Instead, a stiffer material, most likely water-ice, created the peaks. “At Pluto’s temperatures, water-ice behaves more like rock,” said deputy GGI lead Bill McKinnon of Washington University, St. Louis.

The close-up image was taken about 1.5 hours before New Horizons closest approach to Pluto, when the craft was 478,000 miles from the surface of the planet. The image easily resolves structures smaller than a mile across.

## Hands-On Learning Better Prepares Students For Cyber Security Careers



(BPT) - Cyberattacks like the hacks on Sony Pictures Entertainment and Target have put serious cybercrime on the radar of the American public and government alike, so it’s no surprise that the Bureau of Labor Statistics (BLS) projects that the cyber security industry will grow 37 percent by 2022.

The hack on Anthem Inc., a leading U.S. health insurer, in early 2015 involved a massive breach of data containing nearly 80 million personal records, prompting investigations by state and federal authorities. During his January State of the Union Address, President Obama warned that cyberattacks are among the most serious economic and national security challenges facing our nation, and urged Congress to pass legislation in response to their evolving threat.

Cyber security experts, also known as information security analysts, plan and activate security measures to protect a company’s computer networks and systems. These professionals are in high demand to protect the nation. Employment in the field will reach 102,500 jobs by 2022, the BLS predicts.

In the past, cyber security jobs were restricted to technology companies and financial institutions. Today, they are available in all fields because businesses in all industries rely on computers and the Internet to function, from providing customers a product, online services, or entertainment, to managing a viral marketing campaign.

This rising demand is outpacing the number of cyber security experts qualified for the role. The U.S. must develop a pipeline of future employees who are technologically-skilled and cyber-savvy to maintain a technical advantage over cyber attackers.

A variety of academic options are available for those looking to jump-start a career in cyber

security. Most companies require cyber security professionals to have at least a bachelor’s degree in computer science, programming or a related field. DeVry University offers a bachelor’s degree in Computer Information Systems with hands-on learning opportunities built into the curriculum. According to job search engine Monster, hands-on experience like this is a necessary first step in making you qualified for cyber security positions.

Accessibility to these industry leaders can offer access to career development, lectures and events, and competitions to test and enhance your skills, preparing you to stand out in the job market once you graduate. “The NetRiders competition provides students with hands-on experience that is vital to a well-rounded education and preparation for IT roles,” says Renee Patton, U.S. public sector director of education, Cisco. “Conducted in a practical, competitive environment, the NetRiders competition gives students a chance to test their skills, showcase their knowledge, identify areas for improvement, and develop interactive networking skills.”

Security experts warn that 2015 will be the “Year of the Healthcare Hack.” Now, more than ever, analysts must provide innovative solutions to prevent hackers from stealing critical information and weakening computer networks.

With open positions in the field ranging from intelligence and threat analysis to operations management and development or customer service and technical support, the possibilities for job seekers are endless. Accessible, state-of-the-art computer science programs and experiential learning opportunities strengthen students’ skill sets in advanced technologies and prepare them for the exciting challenges of a career in cyber security. •

For more than 30 years, the South Bay Workforce Investment Board (SBWIB) has administered employment and training programs for LA County's South Bay Area.

A layoff aversion plan was formulated that resulted in the SBWIB approaching a local adult school partner to assess the employees'

English skill levels and set up on-site training. Since September, the affected employees have been attending Business English classes three days a week with several of those individuals now being considered for promotions.

Recruitment assistance, pre-screening of applicants, On-The-Job training and Transitional Subsidized Employment (TSE) are other programs available to local companies and small businesses.

The SBWIB also prepares youth for entry into the workforce by emphasizing education and services that promote relevant workplace skills and experiences leading to industry-recognized credentials and career pathway employment, including apprenticeships. Special emphasis is aimed at the reengagement of disconnected youth through intervention and prevention services.

The SBWIB is one of the highest performing Workforce Investment Boards (WIB) in the state and is often recognized by the California Workforce Investment Board (CWIB) for its achievements.

Continuous collaborations with business, economic development, education, government, labor and community organizations, helps the SBWIB provide a dynamic, efficient and effective workforce development system, ensuring a skilled workforce and vibrant economy in the South Bay Area.

## Lennox Captures Section and Southern California 50/70 Crown

The Lennox Little League Baseball had three District 37 all-star champions who advanced to the California Section 4 Tournament with the 50/70 team consisting of players from ages of 11-13 years old coming out champions and moving on to the California Division 3 (Southern California) Tournament recently at Stearns Field in Long Beach. Lennox won the title by eliminating District 25 champion and host North Venice 9-4 on July 1.

Lennox began the classic by topping District 36 champion Manhattan Beach 10-3 on June 27 before losing to North Venice 8-5 a day later. Lennox, though, bounced back to rout North Venice 11-1 on June 30 and pulled out the title a day later. Lennox rallied out of the loser's bracket to sweep Upland 9-3 and 15-2 on July 12.

Lennox began by downing Fillmore 8-3 on July 7. On July 9, Upland edged Lennox 6-5, but Lennox came back with two easy wins on July 12 and advanced to the Western Regionals last week in Yucaipa. Results were unavailable.

Even though there was no District 37 Tournament in the Junior division, Lennox did field a team and automatically won the title and advanced to the sectionals.

Lennox advanced with a win over District

27 champion North Torrance on July 13 before falling to District 36 champion El Segundo last Thursday. Lennox was eliminated by North Torrance last Friday. Scores were unavailable.

Lennox managed to win just one of three in the Junior (age 13 and 14) Division last week at the Henderson Youth Sports Complex in San Pedro. After opening with an 9-5 win over South Torrance Riviera, the District 27 champion, on July 11, Lennox fell to powerful District 36 champion Manhattan Beach, which advanced to the World Series last year, 10-4 on July 12 before being edged by District 25 champion North Venice 8-7 on July 14. Manhattan Beach won the crown over North Venice last Thursday and moved on to the Division III tournament.

The District 36 already won five of six section titles with Manhattan winning the Majors (ages 11-12 but consisting a few younger players), Juniors and Seniors (ages 15-16). Minor (ages 9-10) champion El Segundo and age 10-11-year-old champion Redondo Beach also won their section championships and move on to Southern California.

The Hawthorne-based South Bay Swim Team was already involved in some summer meets as more is on its way. Beginning

next Wednesday through Aug. 2 will be the Summer Junior Olympics Championships at the Riverside Aquatics Complex on the Riverside City College campus.

Also on August 2 will be the annual International Surf Festival Two-Mile Hermosa Beach to Manhattan Beach Pier Swim, usually among the most popular races among the youth and adult squads. The Surf Festival, held in the South Bay Beach Cities, has been held annually since 1962 and will be on from next Wednesday through August 2. It begins with the Charlie Saikley Memorial Six-Man, Six-Woman and Co-ed Six-Person Beach Volleyball Tournament next Wednesday on the south side of Manhattan Beach Pier. It also includes lifeguard events that will be on July 31 and August 1 at Manhattan Pier Beach with lifeguards from all over the United States and Australia.

The Hawthorne Pool will host an all-age group championship clinic on August 6 and, two days later, will be the Southern California Athletic Association Championship Meet at the Downey Aquatic Center. Registration deadline is on Friday.

That period will be busy, as August 9 will be highlighted by the Naples Islands Swims in Long Beach. A day later, the team will host its age-group medal and awards meeting

from 5-6:30 p.m.

### HAWTHORNE HOSTS SPECIAL OLYMPIC ATHLETES

The City of Hawthorne is currently hosting Special Olympic athletes from Nigeria and Estonia. The athletes arrived on Tuesday and the city will have events for them through Friday before beginning the opening ceremonies that will be on Saturday at the Los Angeles Memorial Coliseum. The Special Olympics will be from Saturday through August 2 at venues throughout the Los Angeles area.

The athletes are expected to be training at various local facilities. Special Olympics features 25 sports and approximately 6,500 athletes from 165 countries. The Special Olympics consist of athletes with intellectual disabilities. Started by Eunice Kennedy Shriver in 1968, the first Special Summer Olympics took place at Soldier's Field in Chicago with athletes from the United States and Canada.

After the opening ceremonies at the Coliseum, which will cost spectators from \$47-\$120, events will be held at the Balboa Sports Complex, UCLA, University of Southern California, L.A. 



Film Review

Jake Gyllenhaal’s resurgence as a bankable, “serious” Hollywood actor only speaks to the long list of films he has starred in to date. His current string of stunning performances dating back to 2011’s *Source Code* and leading up to last year’s snubbed *Nightcrawler* has been dazzling. The kid from *Donnie Darko* has actually grown into a pretty daring actor. He’s always been one though. In 2001, he flipped from the demented *Bubble Boy* to the seedy surrealism of *Donnie Darko*; 2005 saw him play his, at that point, brawniest role as a Gulf War soldier in the underrated *Jarhead* and then gather an Oscar nomination for his most tender and vulnerable role as a gay cowboy in *Brokeback Mountain*. Gyllenhaal has been a chameleon his entire career. With *Southpaw*, he is proving it louder than ever.

*Southpaw* follows the trials and tribulations of Billy “The Great” Hope (Gyllenhaal), the

light heavyweight boxing champion of the world. Coming up through the system, Hope has risen to superstardom and great wealth alongside his wife Maureen (an impressive performance by Rachel McAdams) and his daughter Leila (Oona Laurence). After his wife is tragically shot at a charity event, Hope falls into a pit of despair and poverty. When Leila is taken into child services, Hope turns his life around to get back into the ring and fight - literally and metaphorically - for his family and the good of himself.

The film is an impressive turn from director Antoine Fuqua, himself in a commercial

renaissance following the back-to-back action success of *Olympus Has Fallen* and *The Equalizer*. *Southpaw* is a strong return to his dramatic peak over a decade ago with *Training Day*. The direction here is confident, though also vulnerable, something that Fuqua seemed to lack during the energetic masculinity and action ferocity of his preceding filmography. Not to undermine the aggressiveness in *Southpaw*, however, as it’s possibly the most brutal boxing film in more than a decade.

The boxing sequences themselves are, appropriately, the most visceral moments of the film. Gyllenhaal is a brute force in the

ring eating up the scenes and spitting them out, bloodied. His punch-drunk performance is a spectacle, though unfortunately despite Gyllenhaal “The Great” Hope’s best efforts, he cannot lift the dramatic moments out of all too familiar territory. *Southpaw* is no *Million Dollar Baby* or *The Fighter*. Fuqua’s directorial hand falls far too hard, especially in the film’s former half. TV veteran Kurt Sutter’s screenplay is manipulative and inconsistent, to boot. A great performance by Forest Whitaker as Hope’s trainer in the latter acts adds a much-needed humanity that hoists the film up into the later rounds.

If anything, the film is a triumph for its performances and a victory for Fuqua proving he can capably direct more than popcorn action. Through all of the film’s dramatic tribulations, *Southpaw* is impossible not to root for. *Southpaw* opens nationwide, including at ArcLight Beach Cities, this Friday. •

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HAWTHORNE, CALIFORNIA, AMENDING SECTION 2.06.010 (LEGISLATIVE BODY) OF CHAPTER 2.06 (CITY COUNCIL) OF TITLE 2 (ADMINISTRATION, CIVIL SERVICE AND PERSONNEL) OF THE HAWTHORNE MUNICIPAL CODE TO CODIFY THE TERM OF OFFICE FOR MEMBERS OF THE CITY COUNCIL.  
**WHEREAS**, the City of Hawthorne was incorporated as a general law city on July 25, 1922, with the legislative body consisting of five members;  
**WHEREAS**, pursuant to Government Code section 36801, general law cities select one of its number to serve as mayor and another to serve as mayor pro tem;  
**WHEREAS**, Government Code section 34900 also provides: "At any general municipal election, or at a special election held for that purpose, the city council may submit to the electors the questions of whether electors shall thereafter elect a mayor and four city council members, and whether the mayor shall serve a two-year or four-year term."  
**WHEREAS**, pursuant to Government Code section 34090, the City Council of the City of Hawthorne adopted Resolution No. 4986 which submitted to the voters a certain measure relating to election of a directly elected mayor and term of office for mayor, for consideration by the voters at the April 8, 1980 general municipal election;  
**WHEREAS**, on Tuesday, April 8, 1980, the voters of the City of Hawthorne did indeed approve that certain measure, entitled "Proposition A," which established the office of a directly elected

mayor with a term of office of two (2) years;  
**WHEREAS**, by adoption of Resolution No. 5003 on April 15, 1980, the City Council of the City of Hawthorne certified the results of said general municipal election;  
**WHEREAS**, since April 15, 1980, the term of office for the directly elected mayor has been two (2) years while the term of office for the four (4) councilmembers on the legislative body has been four (4) years;  
**WHEREAS**, Government Code section 34900 further provides: "...In cities presently having elected mayors, the city council may also submit to the electors the question of whether the mayor shall thereafter serve a two-year or a four-year term...";

**WHEREAS**, pursuant to Government Code section 34090, the City Council of the City of Hawthorne adopted Resolution No. 7545 which submitted to the voters a certain measure to change the term of office of the directly elected mayor from two (2) years to four (4) years, for consideration by the voters at the November 5, 2013 general municipal election;  
**WHEREAS**, the voters of the City of Hawthorne approved that certain measure entitled "Measure A" which established a four-year term of office for the mayor;  
**WHEREAS**, by adoption of Resolution No. 7587 on December 10, 2013, the City Council of the City of Hawthorne certified the results of said general municipal election;  
**WHEREAS**, the Hawthorne Municipal Code requires an amendment in order to provide and clarify the term of office for the City Council of the City of Hawthorne, with said amendment codifying that the term of office for each member

of the City Council, including the mayor, is four (4) years, consistent with Measure A;  
**WHEREAS**, the City Council of the City of Hawthorne wishes to amend Section 2.06.010 of the Hawthorne Municipal Code in order to codify the term of office for the legislative body.

"The legislative body of the city shall consist of **four council members** and **the mayor, who are all** elected at large. **Said** body shall be known as the city council. **All members of the city council shall hold office for a term of four years from and after the Tuesday next succeeding the date of such election and until their successors are elected and qualified."**  
**SECTION 2.** The City Clerk shall certify to the passage and adoption of this Ordinance and shall cause the same to be published once in an adjudicated newspaper in the City of Hawthorne.  
**SECTION 3.** If any provision, clause, sentence or paragraph of this Ordinance or the application thereof to any person or circumstance shall be held invalid, such invalidity shall not affect the other provisions of this Ordinance which can be given effect without the invalid provisions or application, and to this end the provision of this Ordinance are declared to be severable.

**SECTION 4.** The City Clerk shall certify to the passage and adoption of this Ordinance and shall cause a summary to be published once in a newspaper of general circulation, published and circulated in the City of Hawthorne, or if there is none, he shall cause it to be posted in at least three public places in the City of Hawthorne, California. The City Clerk is also directed to forward a copy of Ordinance No. 2061 to Quality Code Publishing, 2100 Westlake Ave. N. Suite 106, Seattle, WA 98109.
