Council Adopts Revised Salary Ordinances in Compliance With 2015-2016 Fiscal Year

Inglewood Mayor James T. Butts and members of the Inglewood City Council introduced a salary ordinance in order to grant authority to continue paying salaries during the remainder of the 2015-2016 fiscal year.

Every year the city is required to adopt a salary ordinance in order to grant authority to continue paying current salaries, as well as to implement agreed-to salary modifications based on collective bargaining, to implement adjustments to existing classifications such as title changes and to add new classifications.

“The Human Resources staff is charged with ensuring compliance with minimum wage requirements, examining employees’ existing duties versus proposed duties (if applicable), reviewing recruitment history for position(s), and comparing internal classification relationships, salary alignments, and proper titles to the relevant labor market in making recommendations to enhance employee recruitment and retention,” states the staff report signed and presented by Human Resources Director Jose O. Cortes. “At any time during a fiscal year, should it become necessary to make changes to the Salary Ordinance to ensure compliance with state legislation or collective bargaining agreements, an amended Salary Ordinance must be introduced for the approval by the Mayor and City Council Members.”

In 2013 the California State Legislature approved legislation that Governor Brown signed, approving raise to the minimum wage in two parts: \$9 per hour as of July 2014 and \$10 per hour as of Jan. 1, 2016. Expecting the upcoming increase in the minimum prompted city staff to examine each job classification in

order to ensure compliance with state laws.

“At this time, there are eight (8) job classifications with beginning salaries below the 2016 minimum wage requirement,” indicates the staff report. “These positions are within the Recreation/Human Services programs and are designated as non-classified hourly positions. These hourly positions are primarily filled with temporary, seasonal and/or part-time workers who work in seasonal programs (summer/ afterschool), have restricted work schedules and receive limited to no fringe benefits.”

In addition to wage adjustments, the ordinance reclassified titles and range modifications to vacant positions. Positions that were adjusted to meet the state minimum wage requirement of \$10 per hour include: Library Support Aide, Parking Structure Attendant, Food Services Aide, Recreation Aide, Transportation Assistant, Senior Center Assistant, Vocational Trainee and Recreational Leader I. The Recreation Leader II and Recreation Specialist/Preschool Teacher positions were modified in order to increase the salary range in order to avoid compaction issues as a result of minimum wage compliance. In addition, the Program Specialist-Finance position was added via the ordinance as a new employment opportunity.

“As most of the positions are in the same

job class series, changing the salary to the entry-level classification impacts the salary compaction to the other classifications within the job series,” states the staff report. “This makes it necessary to modify the salaries with the family group.”

While changes are made to avoid compaction, the changes in salary ranges are not to impact every employee working under their particular job classification. Only employees whose salary range falls under the state’s minimum wage requirement, based on their job classification.

“All others serving in the job classification will remain at the current but will have room to grow,” states the staff report.

City Offices, Buildings Closed For Christmas

In observance of the Christmas Holiday, several city buildings and facilities will be closed, including the Inglewood Public Library and Inglewood City Hall.

Inglewood City Hall, which has been closed since Friday, Dec. 19, will reopen on Monday, Jan. 4, 2016. The Inglewood Public Library will have a shorter break, and will only be closed from Thursday, Dec. 24 to Sunday, Dec. 27 as part of the Christmas Break. The library will reopen on Monday, Dec. 28 under modified hours, from 11 a.m. to 6 p.m., and will remain open until Wednesday, Dec. 30. STEM Club for Kids will take place as scheduled on Monday, Dec. 28 at 4:30 p.m., Storytime at the Library on Tuesday, Dec. 29 at 5 p.m. and Legos and Board games on Wednesday, Dec. 30 at 4 p.m.

The IPL will go on a New Year’s break on Thursday, Dec. 31 and reopen on Monday, Jan. 4, 2016 under its regular operating hours. •

Chevron's Fuel Your School Program Benefits 40,089 Students in Select Cities in and around the South Bay Area of Los Angeles County

Chevron U.S.A. Inc. announced today that its 2015 Fuel Your School program generated \$500,000 to help fund 538 classroom projects, including 223 focused on science, technology, engineering and math (STEM), to help connect real world experiences to classroom learning for 40,089 students at 151 public schools in select cities in and around the South Bay Area of Los Angeles County.

Students at the Da Vinci Innovation Academy received a Physics Fun Park Electronics Discovery Kit. The kit will be used to help students gain a better understanding of the laws of physics and how these concepts are used to create and run an amusement park.

Film Review

The Poignant Stop-Motion Anomalisa is One of the Year's Best

He is the mind behind some of cinema's most creative and original films, such as 1999's *Being John Malkovich*, 2002's *Adaptation*, and 2004's *Eternal Sunshine of the Spotless Mind* – now, screenwriter-turned-director Charlie Kaufman is back with his second feature film, *Anomalisa*. In similar Kaufman fashion, the protagonist is a middle-aged cynic crippled by the mundanity of modern life, only to come to life when a

together, Michael and Lisa embark on a personal journey of love and heartbreak that makes for one unforgettable experience.

Despite the inherently childlike quality of a stop-motion animated film, *Anomalisa* is definitely not for children. The animated format includes adult subject matter, including scenes of sexual content, which only serve to highlight the film's mature themes.

The stop-motion production is a marvel, taking a full day's work for animators to create just two seconds worth of screen time. Because of the tedious nature of the job and close attention to detail, no second in *Anomalisa* is wasted. The quirky mannerisms exhibited by everyday people that otherwise go unnoticed in daily life are so carefully captured here, playing as some of the film's most inspired laughs. Composer Carter Burwell creates a minimal but beautiful soundtrack to emphasize Michael's desires, resonating with and affecting all.

Kaufman originally penned this longing-for-love story for the stage (released under the pseudonym Francis Fregoli) and cast David Thewlis, Jennifer Jason Leigh, and Tom Noonan to be his principal, and only, actors. With growing interest of turning this "sound play" into a film, Kaufman hesitated, afraid that the movie adaptation would lose authenticity. Those who backed the film's production on Kickstarter had other thoughts, however, as the film raised over \$400,000 of its \$200,000 goal and proved that the interest was there and ready. With support from Starburns Industries and co-director Duke Johnson, Kaufman recruited his original cast of three to create the film.

Anomalisa is a transfixing, thoughtful, and touching film that goes deep into the viewer's psyche and stirs up emotions of introspective thought. Critics are highly praising the film's ability to transcend reality. *Anomalisa* has been nominated for an Oscar for Best Animated Feature Film, and there is no doubt that Kaufman's latest masterpiece stands out as one of the year's best.

Anomalisa opens with a limited release at The Landmark on December 30. Rated R for strong sexual content, graphic nudity and language. •

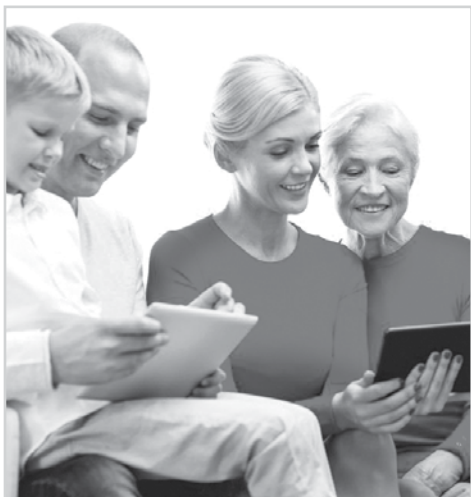

Best Holiday Gift For Seniors?

Teach Them How To Use Tech To Stay Connected



(BPT) - If you're thinking of buying Grandma her first ever smartphone or tablet for the holidays, but aren't sure she'll be able to handle the technology ... make that purchase! Studies show technology can lead to the deeper levels of social engagement associated with improved mental and physical wellbeing in older adults. But there's a catch - you need to help Grandma learn how to use that mobile device in order for her to reap the full benefits of social technology.

"Simply having technology isn't what leads to greater life satisfaction for older people," notes Dr. Kevin O'Neil, chief medical officer of Brookdale Senior Living, and a clinical professor of aging studies at the University of South Florida. "Using technology for meaningful social engagement is what counts, and the rewards can be life-altering for many seniors."

Ample research shows social interactions are good for older people, yet more than a third of Americans older than 80 don't use technology for social networking, a study by Brookdale and the Stanford Center on Longevity found. Sixty-three percent of seniors do use technology to stay connected to loved ones. Seventy percent who use technology, such as cell phones and computers to stay connected, say it improves their communications with loved ones. And those who do use technology say they feel happier, more satisfied and their health is better, the study found; 85 percent said they were satisfied with life, and 72 percent said they were in good or excellent health.

"Feeling overwhelmed by the complexities of new technology was the top reason older people said they didn't try new technologies," O'Neil says. "Fortunately, that's a fairly easy fix. All that's really required is some assistance from more tech-savvy younger loved ones to help seniors learn how to use new technologies to enrich their social and intellectual lives."

Brookdale, America's largest provider of senior living communities, has developed

programs to help residents learn to use new technology so they can stay socially connected to their loved ones as part of the company's efforts to use technology to enrich the lives of seniors known as "Rewiring Aging." O'Neil and the aging experts at Brookdale offer some tips to help seniors overcome barriers to technology use:

- If you're buying technology for an older loved one, remember simple is better and less is more. Forty-one percent of older people polled in the Brookdale study said new technology is too complicated. If you want Grandma to be able to make calls, text and access her Facebook account, she probably doesn't need a smartphone with all the other bells and whistles. Look for a device that does only what she needs and not much more.

- Look for devices that are larger, with screens that will be easier to see, such as a tablet versus a smartphone, or a laptop with a larger screen.

- Assist with setup of the device. Increase the on-screen font size and use bold to help older eyes more easily see text on small device screens.

- Screen colors can affect readability, so pay attention to the color of the font and background. Avoid pastels and light colors that are difficult to see. Adjust the device's background theme to be minimally distracting.

- Help your older loved one create user names and passwords, and write them all down to be stored in a secure location. Be sure to address security settings on social media accounts. Limit who can contact your loved one through social media, and make sure your older loved ones understand why they must never accept online invitations or interactions from people they don't know in person.

- Show your loved one how to use email and text messaging, attach or open photos. Again, stress the importance of never opening an attachment in an email from someone they don't know.

- For seniors with dexterity challenges, a separate, larger keyboard can make device use much easier. Or, consider showing your loved one how to use voice-to-text applications so typing is unnecessary.

- Load some fun brain games onto the device to help stimulate your older loved one's mind.

"Technology can be a wonderful way to enrich older people's lives, allowing them to stay connected with loved ones regardless of distance and mobility," O'Neil says. "Helping your older loved one learn how to connect with their loved ones via technology can be a wonderful holiday gift that will benefit them all year long!" •

WINTER WATERING TIPS FOR OUTDOOR LANDSCAPING

- Winter should bring rain and cooler temperatures, presenting an opportunity to scale back irrigation.

- Install water-efficient sprinkler heads, and check to make sure your sprinklers are positioned to irrigate the lawn and not your sidewalk, driveway or gutters.

- Survey your lawn irrigation system and fix any sprinklers, valves and lines that may be damaged or leaking water.
- While hand watering your lawn, focus on dry spots and pay close attention to avoid runoff.
- Avoid watering your lawn on windy days to limit overspray and evaporation.

Leuzinger, which improved to 5-5, looked impressive as it scored 25 first quarter points to 14 for Hawthorne, which fell to 5-6 after losses to Vista del Lago in non-league and Granite Bay in the Sacramento Tournament.

The Olympians continued to dominate the smaller Cougars. In the fourth period, though, Leuzinger's defense let up and Hawthorne made a last ditch effort with 29 points to 15 for the Olympians, due to its effective full-court press defense. A basket by Christian Brown cut Leuzinger's lead to 72-62 with 52 seconds left in the game. The Olympian lead seemed to be still comfortable but Jones knew he had to make the team be able to play a full four quarters. "We're not playing 32 minutes of basketball," Jones said. "We're just learning. We are a young team. It's been that way, so far this season. We don't play well in the fourth quarter."

One thing that pleased Jones was Leuzinger's depth as five players scored in double figures. Washington led with 15 points. Kavian Fair added 14 points. Terrell Williams chipped in 13 points, followed by Davion Crowder with 11 and Tyler Ridley with 10.

Hawthorne, on the other side, had the game's two highest scorers. Christian Brown led with 27 points, followed by Deris Gibbons

Sacramento Tournament but was routed in the first round by Granite Bay 67-32 on Saturday. Hawthorne started out well leading 12-9 after the first quarter and was down 26-22 at halftime. Granite Bay, located east of Sacramento, outscored the Cougars 41-10 in the second half.

Leuzinger played in the Oaks Christian Tournament in Westlake Village from last Saturday through Wednesday but results were unavailable. The Olympians will not play, again, until January 2 when they face Brentwood, which they lost in the 13th

place final of the Beverly Hills Tournament 59-55 in overtime on December 5, in the Jordan Brand Showcase. Hawthorne's next game will not be until January 13 when it begins the Ocean League at home against Santa Monica.

Morningside Wins Consolation: After losing its opening game of the Titan Pride Classic to eventual champion Dana Hills on December 14 at Pioneer High in Whittier, Morningside High's boys' basketball team came back with three consecutive wins to capture the consolation title. The Monarchs won the consolation final over Montebello 62-57 last Saturday. Brandon Anyanusi, who was all-tournament, led with 16 points and 10 rebounds. In the consolation semifinal last Thursday, Morningside rolled over Lakewood Artesia 72-53. The Monarchs started off well with a 19-4 first quarter and were in command all of the way. In the consolation quarterfinal on December 15, Morningside stifled Bell 55-34. Anyanusi led the Monarchs with 14 points and 10 rebounds. Camairi Smith also chipped in 14 points. Charles Akano contributed 10 points and a team high 18 rebounds. Despite 17 points, 12 rebounds and three blocked shots from Anyanusi, Morningside lost to Dana Hills 68-60. Khabar finished with 11 points and Charles Akano had 13 rebounds and seven points. The Monarchs begin the San Pedro Pirate Classic against South Torrance Saturday at 4:45 p.m.

Lee High from Huntsville, Alabama 66-63, but came back with wins over South Anchorage from Alaska 60-28 last Friday and Lahainalula of Lahaina, Maui, Hawaii 55-35 on Saturday. In non-league action at Inglewood on Dec. 11, the Sentinels recorded a 59-46 win over small schools power Price Christian from South Los Angeles and, shortly before leaving to Hawaii, defeating Taft High from Woodland Hills 64-50 on December 15. •

Looking Up

NASA's Fermi Satellite Kicks off a Blazar-Detecting Bonanza

A long time ago in a galaxy half the universe away, a flood of high-energy gamma rays began its journey to Earth. When they arrived in April, NASA's Fermi Gamma-ray Space Telescope caught the outburst, which helped two ground-based gamma-ray observatories detect some of the highest-energy light ever seen from a galaxy so distant. The observations provide a surprising look into the environment near a super-massive black hole at the galaxy's center, and offer a glimpse into the state of the cosmos 7 billion years ago.

"When we looked at all the data from this event, from gamma rays to radio, we realized the measurements told us something we didn't expect about how the black hole produced this energy," said Jonathan Biteau at the Nuclear Physics Institute of Orsay, France. He led the study of results from the Very Energetic Radiation Imaging Telescope Array System (VERITAS), a gamma-ray telescope in Arizona.

Astronomers had assumed that light at different energies came from regions at different distances from the black hole. Gamma rays, the highest-energy form of light, were thought to be produced closest to the black hole.

"Instead, the multi-wavelength picture suggests that light at all wavelengths came from a single region located far away from the power source," Biteau explained. The observations place the area roughly five light-years from the

black hole, which is greater than the distance between our Sun and the nearest star.

The gamma rays came from a galaxy known as PKS 1441+25, a type of active galaxy called a blazar. Located toward the constellation Boötes, the galaxy is so far away its light takes 7.6 billion years to reach us. At its heart lies a monster black hole with a mass estimated at 70 million times the Sun's.

As material in the disk falls toward the black hole, some of it forms dual particle jets that blast out of the disk in opposite directions at nearly the speed of light. Blazars are so bright in gamma rays because one jet points almost directly toward us, giving astronomers a view straight into the black hole's dynamic and poorly understood realm.

In April, PKS 1441+25 underwent a major eruption. Luigi Pacciani at the Italian National Institute for Astrophysics in Rome was leading a project to catch blazar flares in their earliest stages in collaboration with the Major Atmospheric Gamma-ray Imaging Cerenkov experiment (MAGIC), located on La Palma in the Canary Islands. Using public Fermi data, Pacciani discovered the outburst and immediately alerted the astronomical community. Fermi's Large Area Telescope revealed gamma rays up to 33 billion electron volts (GeV), reaching into the highest-energy part of the instrument's detection range. For comparison, visible light has energies between about 2 and 3 electron volts.

Following up on the Fermi alert, the MAGIC team turned to the blazar and detected gamma rays with energies ranging from 40 to 250 GeV. "Because this galaxy is so far away, we didn't have a strong expectation of detecting gamma rays with energies this high," said Josefa Becerra Gonzalez, a researcher at NASA's Goddard Space Flight Center in Greenbelt, Maryland. "There are fewer and fewer gamma rays at progressively higher energies, and fewer still from very distant sources."

The reason distance matters for gamma rays is that they convert into particles when they collide with lower-energy light. When a gamma ray encounters starlight, it transforms into an electron and a positron and is lost to astronomers. The farther away the blazar is, the less likely its highest-energy gamma rays will survive to be detected.

The EMV chip technology is intended to help reduce debit and credit card fraud, and thanks to a collaboration between America's payment networks and card-issuers, you'll see many more merchants using EMV-equipped card readers over the coming months.

Chip-enabled cards store the same basic information that's already in the magnetic strip on the back of your card, such as the card number and expiration date. They add a layer of fraud protection by producing a single-use code to validate every transaction. While EMV technology is intended to reduce card fraud, it's still important to be aware of how fraud happens, what you can do to prevent it and what your card-issuer does to help protect you.

"Fraud prevention is a partnership between cardholders and the bank," said Pam Codispoli, president of Chase Consumer Branded Cards. "By working together, we can help customers keep their accounts safer and more secure."

Chase offers some tips to help you stay alert to fraud while you holiday shop and in the New Year:

- Keep your contact information, including phone number and email address, up to date so the card issuer can contact you quickly if they detect signs of fraud on your account.
- Review your card agreement to be sure you understand what anti-fraud measures the issuer takes. For example, Chase uses specialized monitoring tools to keep an eye on your account 24/7.
- If your card company or bank offers it, sign up for account alerts to monitor your finances and keep your accounts safe. Most issuers will allow you to choose to be alerted to any unusual account activity via text, email or phone call.
- Review your statements every month to ensure all charges are accurate and authorized by you. If you spot a charge you don't recognize, contact the card issuer or bank immediately. With the shift to greater use



of EMV technology, if fraud occurs on your account and you have a chip-enabled card, the merchant will be responsible for the costs in most situations. Also, banks like Chase offer zero liability protection - you won't be held responsible for unauthorized charges made with your card or account information.

• Monitor your credit reports. Although you're entitled to a free report from all three major credit bureaus once a year, checking your report more often can help catch signs of fraud earlier.

• Opt for secure paperless billing. Theft of paper documents, such as from your mailbox or trash, is still a top way fraudsters obtain information. By going paperless, you eliminate an opportunity for someone to steal your statement and get your account information.

• Switch to secure online or mobile payments to help protect your account information. Online payments add layers of security to your transaction and can help ensure you never miss a payment.

• When using your card in a store, never allow the card out of your sight. If you have to enter a PIN number to use the card, be aware of who's standing around you and shield the keypad from view when you type in your PIN.

Oven Roasted Lake-Raised Tilapia with Winter Vegetables and Citrus Vinaigrette



Ingredients

- 4 lake-raised tilapia fillets
- 12 fingerling potatoes
- 2 turnips
- 8 small carrots
- 1 sweet onion
- 3 parsnips
- 2 cups washed baby spinach
- 1 lemon
- 1 lime
- 1 orange
- 4 tablespoons extra virgin olive oil
- 1 teaspoon honey
- sea salt
- fresh pepper

Preparation

THE VEGETABLES

Preheat oven to 375 degrees Fahrenheit. Peel turnips, carrots, onion and parsnips; cut roughly the same size as a halved fingerling potato. Halve potatoes. Place vegetables on oiled sheet pan. Season with salt, pepper and extra virgin olive oil (EVOO). Roast 25 minutes or until fork tender.

THE DRESSING

Juice lemon and lime. Peel orange and segment; add juice from the pulp to the lemon and lime juice. In a metal mixing bowl, use a metal wire whisk to whisk honey, salt, pepper and 1 tablespoon citrus juice. Slowly drizzle 4 tablespoons of EVOO. Fully emulsify the dressing.

THE FISH

Brush lake-raised tilapia fillets with EVOO, season each side with salt and pepper. Place on oiled sheet pan. Roast at 375 degrees Fahrenheit for 20 minutes.

TO PLATE

Place one quarter of the roasted vegetables in the center of each of four plates. Top with the roasted tilapia. Toss spinach and orange in the dressing using tongs. Place small amount of salad alongside fish and vegetables, and serve.

Keep in mind that the vegetables will take longer to cook than the fish. For the best flavor, time the fish to come out of the oven last, and enjoy! •
