## Council Considers Cars2Go Program, Crime Down by 8.1 Percent

After more than a six-week hiatus from meetings due to the recent holidays, the Lawndale City Council met for the first time in 2013 on Tuesday due to the federal Martin Luther King, Jr. holiday observance on the regular third Monday of the month. Mayor Pro Tem Larry Rudolph was absent from the dais.

The Council held a lengthy discussion about the Cars2Go program, questioning where the vehicles for the program will be allowed to park when awaiting rental by a consumer and expressing concern for the use of parking spaces in the residential areas or where a two-hour parking limit is imposed—and not being in favor of any penalty or ticketing exemption for Cars2Go vehicles. The Council agreed by consensus to allow City staff to gather additional information and to schedule a public hearing on the issue of car-sharing. Specifically, the provisions of an ordinance to be added to the municipal code and the wording of a permit to be issued for Cars2Go to operate the program within the boundaries of Lawndale will be prepared for consideration. The ordinance and permit will limit parking in residential areas and contain wording that permits parking of the car-sharing vehicles in the center median along Hawthorne Boulevard only.

In his Public Safety Report, Sheriff Matthew Dendo reported that statistics for 2012 indicate a 8.1 percent decline in crimes in Lawndale--down since 2011. Overall since 2007, crime has declined by 22.1 percent. Dendo then announced that he has been reassigned, along with Sergeant Enfield, to the Detective Branch of the Los Angeles County Sheriff's Department, and that after five years of serving the City and citizens of Lawndale, he will be departing from his duties here. He introduced his replacement, Sheriff Eli Vera, a 24-year member of the Sheriff's Department and former SWAT Commander. A reception will be hosted during the February 4 Council meeting to thank Sheriffs Dendo and Enfield for their service to Lawndale.

The adoption of a new ordinance amendment, after the second reading, confirms the way that any vacancies of City elective offices will be handled in the future with the appointment of a replacement to be fulfilled within 60 days from

the vacancy or a call for a special election. In the case of an appointment, an appointee shall remain in the position until the next scheduled general election.

The consent calendar included the approval of the transfer of the administrative duties for the South Bay Workforce Investment Board to the City of Inglewood. The replacement of playground equipment at Jane Addams and Rogers-Anderson Parks received approval with a call for bids to be issued. The improvement project at the 145th Alley and Manhattan Beach Boulevard has been completed. The removal of the damaged trailer at the Blue Bonnet Trailer Park has taken place without notice for bids and the emergency action was terminated.

Appointment by Mayor Harold Hofmann of Margery Heinemann to serve on the Senior Citizens Advisory Committee was affirmed by Council consensus.

A public hearing was held for the projects that will be funded under the Community Development Block Grant (CDBG) program for the 2012-13 year and projected for the 2013-14 fiscal year. The allocated funds amount to approximately \$311,577, including senior activities funded in the amount of \$46,736 and street improvements for \$264,841. Unallocated funds of approximately \$610,000 for fiscal year 2012-13 will be reallocated for the Burin Avenue Street Improvement and the replacement of playground equipment at various Lawndale parks. After the public hearing, the resolution for the fiscal year 2013-14 CDBG program participation and projects was adopted by unanimous vote, with Rudolph absent.

An amendment to the CDBG program administration assistance was approved with allocation of necessary funds not to exceed \$80,250 from the general fund in order to improve the administration of the program and move the administration over to the Los Angeles County system.

Metro Express Lanes program reported on the HOV and SOV lanes allowed only with a registered transponder on a vehicle on the 110 North Freeway. The program for the 110 North only began on November 10, 2012, extending from Gardena to the Adams Boulevard off-ramp in Los Angeles. A decrease in traffic, an

average speed of 66 mph in the carpool/HOV/ SOV lanes, and a reduction in congestion at the Adams Boulevard end of the carpool lanes have been recorded as a result of the transponder-only program. Transponders can be acquired at AAA locations and Costco at a discount and for \$40 before discounts directly from Metro Express by calling 511 or going to the agency's website ([www.metroexpresslanes.net](http://www.metroexpresslanes.net)) to arrange for the device to be issued. Vehicles using the carpool lanes without a transponder are subject to a \$25 ticket from the California Highway Patrol (CHP).

Lawndale Founders Day is scheduled at the Lawndale Community Center on Saturday, February 23 from 2 p.m. to 5 p.m. A call has been issued for the oldest living resident of Lawndale to contact City Hall with their name, length of time as a resident--but especially if they were born in the city limits--and their contact information for the Lawndale Historical Society.

A contest to win a handmade quilt from the Friends of the Library must be entered by January 31, 2013 at the Lawndale Library by donating \$10 to the Friends or becoming a member of the Friends of the Library. The winner of the quilt will be announced on February 1.

The Christmas Baskets program for 2012 gave gifts and turkeys to 101 families, including 350 children and 505 people in total, plus 12 senior citizens. CVS Pharmacy donated 75 turkeys to the cause. Charmaine Doty, coordinator of the annual project, thanked all the volunteers and all those who donated to the cause to make the holidays a little easier for families in need.

A zoning text amendment for signage to conceal security bars and gates was presented during a public hearing. The first reading of an ordinance amendment to add an exemption from permit requirements for signs that conceal security bars and/or gates from the storefronts of businesses was approved by a unanimous vote of 4-0, with Rudolph absent. The signage will be permitted, although monitored, so that storefronts do not add to any blight in the business district.

The next meeting of the Lawndale City Council will be held on Monday, February 4 at 6:30 p.m. •

# Jefferson Elementary Makes Steady Gains

During its meeting last week, the Hawthorne School Board heard a positive report from Jefferson Elementary School Principal Wendy Ostensen on her campus’ rising academic performance. She cited the school’s steadily increasing Academic Performance Index (API) score and also discussed her plans to shore up some deficiencies in areas such as math. Since 2010, Jefferson’s API scores have hovered in the 790s, with its most recent score being 794. However, Ostensen’s goal has been (and still is) to achieve an 800 or higher score, which would place Jefferson in the ranks of the district’s higher performing elementary schools such as Ramona and Zela-Davis--both of which are just under an 820 API score. While progress to an 800 or higher score has been slow, Ostensen believes her plan will get the school to it. “We would like to see higher test score growth, but we have a long-term plan in place,” said Ostensen. One area Ostensen is taking a close look at improving is math. School-wide, the number of students scoring proficient or advanced on the California Standardized Test (CST) has fallen from 56.6 percent to 54.5 percent, with the majority of those losses happening in third and fifth grade. Ostensen believes that improving math will greatly impact Jefferson’s academic record. “School-wide math needs to improve,” said Ostensen. “It does have an impact on our test scores.” In order to improve students’ math skills, Ostensen has implemented many changes. She has had a math coach working with teachers to model lessons and work with special projects, and intervention teachers to identify and address areas in math that might need more attention. The area with the most room for improvement is number sense. Ostensen said that students are struggling in that area, but her staff is already working to provide additional instruction in the form of “fast facts” that should allow students more time to practice their number knowledge before the test. Teachers have already noticed that student benchmark scores have improved since introducing fast facts. “Number sense is very heavily weighted,” said Ostensen. “Teachers know if students can master their fast facts, they will succeed in number sense.” Another avenue Ostensen is attempting to use to teach math more effectively is providing materials and workshops for parents so they can better help their students. However, Ostensen said the number of parents taking advantage of these resources is less than

she’d prefer. “That is an area of need--we need more support from our parents,” said Ostensen. “We do as much outreach as possible, but I’m sure there is always more we could be doing.” There are some very encouraging signs from Jefferson that things are improving academically. Ostensen said that the second grade has experienced “dramatic growth.” In the 2010-2011 school year, 57 percent and 66 percent of second graders scored proficient or advanced on the language arts and math portions of the CST respectively. This year those numbers are up to 75 percent in language arts and 74 percent in math, which means Jefferson leads the district in those two categories for second grade. Ostensen feels this a major achievement for her and her staff. “We are very excited and proud of our grade level growth,” said Ostensen. Another achievement at Jefferson has been a sharp decline in disciplinary actions compared with last year. Between September 1, 2011 and January 10, 2012, there were 14 suspensions at the school. However, during that same period this year there has been only one. Fewer suspensions should translate into better test scores, as more students are in the classroom and not being distracted by bad behavior. “We all know discipline is a factor in how well students do in the classroom--and if they aren’t in the classroom, they aren’t learning,” said Ostensen. “We are seeing a dramatic decrease in discipline problems, which means more students in the classroom.” Jefferson’s staff members aren’t the only ones anxious to see the school earn an API score of over 800. The students have made a deal with Ostensen that if they can get a high enough score, they can shower her in slime. “When we get to 800, these students have said they want to pour green slime all over me and I said, ‘Okay, once we get to 800,’” said Ostensen. “I think we’ll get there this year.” Overall, the Board seemed happy with Jefferson’s progress. Board member Alexandre Monteiro complemented Ostensen for her work in addressing both the school’s academic issues, with increased coaching and intervention, and the discipline concerns with bullying workshops and new classroom management strategies. “I’m glad to see those benchmarks showing you are on the right track--data doesn’t lie,” said Monitero. “I also like to see those discipline results. It shows the bullying workshops are working.”•

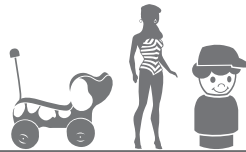

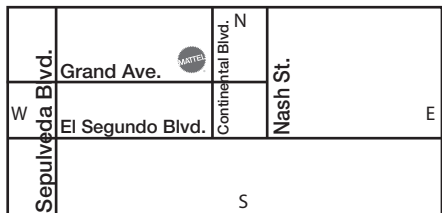

On January 16 at Hawthorne High, Morningside High’s boys’ basketball team from Inglewood downed the Cougars 63-52 in a contest that ended in a bizarre brawl between players and fans. The event caused seven Cougar players to be suspended for last Friday’s game at Culver City and as a result,

Hawthorne Principal Mark Newell asked that his school, which had just three players left and did not want to move up junior varsity players to the varsity squad, forfeit and have the game canceled against the Centaurs.

Hawthorne, which had a fine showing in preseason play at 10-4, is 0-4 in the Ocean League, also losing the previous league games to host Beverly Hills (64-56 on January 9) and a 72-71 nail-biter to Inglewood on January 11.

The brawl stemmed from a hard foul by the Cougars’ Akeem Allen. At the end of the contest as both teams started shaking their hands, Monarch players and fans were dashing and beginning to attack Allen, according to sources. ## Police Department Hosts Blood Drive, Battle of the Badges

The Hawthorne Police Department, in collaboration with the Red Cross, hosted the Battle of the Badges in the most recent blood drive to be hosted in the city. Battle of the Badges, which took place January 15, is a friendly competition that gives all badge-carrying personnel an opportunity to donate blood on behalf of their department to see which entity can donate the most. The blood drive also welcomes community members and anyone willing to donate.

“We have done this for four years at the Hawthorne Police Department and last year we had a 90 percent increase in our donations, so we were very happy with that,” Community Affairs Sgt. Chris Cognac said. “This year we have a very good turnout even though we had a little bit of a glitch because the blood mobile broke down on the way here, so we only have half the time to collect the blood donations--but we have a full room of people willing to donate. A lot of people came in from the community.”

Battle of the Badges, which was constantly announced on the Police Department’s Facebook and Twitter accounts, is in its seventh year of existence and has been experiencing a growth in participants since the beginning of the campaign. Last year, there were a registered 5,178 donors for the drive by the United States Probation Office and other participating agencies. This year, the Red Cross set its goal of units collected at 5,500.

“We greatly appreciate the Hawthorne Police Department and their support, especially at this time because we are coming out of the New Year and our supplies are a little lower because we are still recovering from the holidays,” Red Cross Account Manager Alice Lan said. “People do not think of donating blood during the holidays. People are out of town, with family or on vacation, so it’s harder. Each day, we require 1,500 units of blood to ensure that we meet hospital patients’ needs. This can be people who are suffering from blood disorders, people who require surgery, people who have been in some sort of trauma, burn victims or premature babies.”

The blood drive attracted donors from within the department, the City staff and employees from local entities. “I heard about it [blood drive] at work,” Medical Records Director with the Hawthorne Healthcare and Wellness Center Valerie Cardona said. “They brought it up in our meeting and they said it would be great if we went as a team and showed our support. I just went for it.”

For Leah Seharf, also from the Hawthorne Healthcare and Wellness Center, donating blood is something she plans to continue doing. “We are here supporting the City of Hawthorne,” Seharf said. “This is our first time and the first time that I know that they have had something like this since I have been working in the City of Hawthorne. I am actually pretty excited and if I ever need blood one day, I will probably need somebody else’s blood, so it is good to give some of my own.”

Aside from the friendly competition behind Battle of the Badges, Sgt. Cognac believes that hosting such events not only contributes to the Red Cross’ goal of maintaining a blood supply, but also provides an opportunity for the department and residents to interact and build a stronger relationship. “Blood is truly the gift of life and blood is in constant need--we are always in a shortage of blood,” Sgt. Cognac said. “Our blood supply is not forever. Blood expires and so there is a constant need for it and you really can save a life, or two, or three with your donation. That is why we always need to do things like this. This brings the community together and it lets everyone become a part of something. It is nice because we get to come here and talk to people as well. I am waiting to donate my blood and I am sitting next to a regular citizen that saw us on Facebook and decided to donate blood. It is good, it helps us build a nice little bond and we get a sense of community.”

Lan added, “I hope that they walk away knowing that they saved three lives with their donation and that they really made an impact in somebody’s life. They have helped a brother, sister or a mom and we are really grateful that they are able to donate their time and their blood.” •

- 1 teaspoon course black pepper
- ¼ cup light sodium soy sauce

Mix together all ingredients then rub onto whatever you are going to grill. Let sit for 10 minutes, then grill and eat. •
