# **Drug Maker Doesn't Have to Explain Price Hikes to Shareholders**

Call this a case of the right hand not knowing what the left hand is doing. A federal government lawyer told one of the country's largest pharmaceutical companies last month it can remain silent about why it raised prices on life-saving therapies. The irony here is that the people asking for that information are concerned shareholders of the biotech company Amgen whose CEO was called recently to the White House for a meeting with the President.

Amgen is based in Thousand Oaks, yet it is a darling with fund managers and South Bay investors because of the company's sustained growth and annual profits that will return \$11 or \$12 per share to investors this year. The company earned \$6 billion in profit last year, and made \$16.6 billion in sales on its 10 topselling therapies. A faith-based shareholder group that includes the Catholic healthcare system Dignity Health filed a proposal last fall asking Amgen's management to explain to the stockholders why it raised prices on some drugs dating back to 2010. Specifically, the Mercy Investment Services group asked for details about the company's rates of price increases and the reasoning behind them. The request included any assessment of risks to Amgen from price hikes on its 10 best-selling drugs. An attorney for the group argued to the SEC that the healthcare debate in Washington and public opinion over patient-drug costs put Amgen and its investors on shakier ground in 2017. Stockholders could be affected if the federal government caps reimbursement for prescription drugs covered through Medicare and Medicaid, attorney and former law school professor Paul Neuhauser wrote to the SEC in January. That letter was a follow-up to another one sent last fall to Amgen CEO Robert Bradway and his management team. The Mercy Investment members were worried about public outrage over pharmaceutical prices and by comments made by President Trump during his campaign.

Trump said that drug makers were "getting away with murder" and vowed the federal government would negotiate lower prices on his watch.

The group is largely comprised of religious groups, including the Dignity Health system that operates clinics in Inglewood and Torrance. Their attorney reminded the SEC staff that in the past they had sided with shareholders wanting drug makers to explain to them how prices were set on FDA-approved medicines. Amgen, in its own letter to the SEC, said that it already provides drug information on its website. However, the faith-based group says the drug maker is being secretive and that the information it wants is more detailed than what the company has divulged publicly.

Drug pricing represents a moral issue for the religious community, Neuhauser said, noting that CEOs of major drug companies have appeared before Congress and been roundly criticized over increases to drug costs, including a 400 percent hike for EpiPen, used by children with severe food allergies. Turing Pharmaceuticals caught flak from Congress and the public after it hiked the price by 5,000 percent on an anti-parasite therapy called pyrimethamine. President Trump in January met at the White House with pharmaceutical executives, including Amgen CEO Robert Bradway. One topic of discussion reportedly was the need to make drugs cheaper for U.S. patients. The President promised U.S. corporate tax cuts from his administration and gave the CEOs a tour of the White House, but he didn't ask for any specific commitments from the pharmaceutical executives on capping their pricing. The interfaith shareholder group is keenly aware that the President, Congress, insurers and patients are closely watching how Amgen and the industry, known as Big Pharma, respond to the palpable dissatisfaction with high drug costs. Amgen's business plan "can be upset if there's enough public pressure," Neuhauser said. The company's revenues grew by eight percent annually over a five-year period, according to Amgen figures.

Amgen attorney Andrea Robinson successfully argued that drug pricing falls into ordinary business operations, which needn't be discussed with shareholders under SEC rules. In a letter dated January 10 to the SEC's Division of Corporation Finance, Robinson reminded the commission staff that the exemption exists so that stockholders of a publicly owned company don't micromanage how it conducts business. That includes how it sets prices and prepares for any backlash, she wrote.

"The supporting statement further requests that the Company provide 'detailed justification for price increases." These mandates demonstrate that the Proposal is seeking to probe deeply into matters of a complex nature upon which stockholders, as a group, are not in a position to make an informed judgment," Robinson wrote.

SEC staff issued its legal opinion in the Amgen matter on February 10 in favor of the drug maker. Though the opinion is non-binding, the Mercy Investments group will not pursue the issue with Amgen at this year's shareholder meeting, the group's attorney said. Identically worded proposals were submitted to at least eight U.S. drug makers, and SEC staff gave a thumbs down to each shareholder plan for more transparency about drug pricing. Mercy Investment members were involved in some, but not all, of the calls for more transparency from the pharmaceutical industry, Nehauser confirmed. It's possible his client will pursue this issue next year with Amgen management, he said. Other drug makers being pushed by stockholders for more transparency about their pricing decisions include some of the largest pharmaceutical companies in the country. SEC staff in February blocked proposals filed with Biogen, Bristol-Myers, Eli Lilly, Gilead Sciences, Merck & Co., Pfizer and Vertex Pharmaceuticals, according to SEC records. The campaign by

## **Check Your Bank Statements!**

Herald Publications had two bank transactions within two months that contained surprising errors. In January, a \$300 check was paid out as \$900.00. Last month, a \$480.00 check was paid out as \$408.00. These errors were not caught by our bank, but by our bookkeeping service. According to our bank, the errors were due to the fact that electronic transfer images, which are sent to the Federal Reserve Bank were misread. Our checks were printed checks and easily read. I've been advised that written checks would have more of a problem. Mistakes can happen. Businesses should be advised that according to our bank, and confirmed by another bank, any transactions under \$5000.00 are not looked at manually.

**Suggestions:** Make sure the font on your checks is large and clear. Review your bank statements to ensure all transactions match up. •

## Street Closure on Centinela Avenue Between Beach and Florence for Crenshaw/LAX Transit Project

Centinela Avenue will be closed to traffic until 4 p.m. on Friday, March 17 between Beach and Florence Avenues in Inglewood to build a rail crossing at Centinela and Florence Avenues as part of the Crenshaw/ LAX Transit Project construction. The work consists of demolition, excavation, installation of duct banks, back filling with ballast, installation of rail and components, and minor street improvements.

Right and left turns will be restricted onto Centinela Avenue from Florence Avenue. Local access to La Colina Drive will be maintained. Drivers will be guided by flaggers at the corners of La Colina Drive and Beach Avenue. One southbound lane on Centinela Avenue will be closed between Beach Avenue and Hyde Park Boulevard. There will be eastbound lane reduction on Centinela Avenue when approaching La Brea Avenue.

Detours will be available. If traveling west bound on Florence Avenue, take La Brea Avenue north to Centinela Avenue. If traveling eastbound on Florence turn left to La Brea then turn left on Centinela Avenue.



## **Rotary Awards Four Teachers** Mini Grants at School Board Meeting

At last Wednesday's Hawthorne School Board meeting, members of the Hawthorne/ LAX/Lennox Rotary Club presented four Bud Carson Middle School teachers with minigrants created to help teachers fund special educational projects in their classrooms. "This particular one [mini-grants] we have been doing for about 13 years, and are always looking for things that are in the community and are helping people out," Rotary Club Co-President Doug Krauss said. "Rotary as an organization has certain topics that they focus on--education is one of them--so when we are helping teachers, that falls in line with our mission. We certainly look for things that are local and that help, and teachers can certainly use the help...so that works great with us."

Each mini-grant is worth \$200, with the awards going to eighth grade teacher Anakonia Matsumoto for her "Take Charge in Your Learning" initiative; and to sixth grade teacher Erika Chavez, seventh grade teacher Nancy Arambula and eighth grade teacher Janet Andrade for their STEAM Girl t-shirts.

"The program is to encourage females to pursue careers in the field of engineering," Arambula said. "They [team] were in need of t-shirts and we heard about the Rotary Club--so we figured we should apply and we were able to obtain the grant."

Through the mini-grant program, the Hawthorne/LAX/Lennox Rotary Club is able to encourage teachers to apply for these funds. The grant requires applicants that demonstrate innovative and collaborative projects among teachers that work to improve student achievement. Each project is required to be accomplished within a specific period of time.

Councilwoman Olivia Valentine presented winner Anakonia Matsumoto for "demonstrating initiative, innovation and inspiration in shaping the future of our nation through the education of our children." On behalf of Matsumoto, who was unable to be present, Bud Carson Principal Mark Silva received her grant. Bud Carson Middle School has been seeing positive results from implementation of Project Lead the Way (PLTW). Brought to the school via a partnership with El Camino College, PLTW is the basis of the STEAM (Sciences, Technology, Engineering, Arts, Mathematics) team being led by Andrade, Chavez and Arambula.


"We are just starting this--it's 20 of them and they already entered a competition and it seems like their confidence has definitely increased," Arambula said. "We are building and going with it and now we can say things are going smoothly."

Bud Carson's teams recently excelled at a MESA competition hosted at USC where each team finished in first or second place and earned the opportunity to compete at regionals. "This is an afterschool class and one of the things that we noticed during that time was that when we we're teaching an engineering concept, a lot of the girls would shut down and then the boys would take over," Arambula said. "So it is great to see the really quiet girls in an environment where they are free to express themselves."

For the grants, each district reviewed its own applications and was asked to select no more than 10 applications, which would then be sent to the Mini-Grant Selection Committee. The STEAM Team at Bud Carson was started by Andrade after the lead teachers attended several conferences where they were encouraged to promote the engineering aspect of the program. The introduction to math and engineering careers is intense, but Chavez shared that the students have risen to the challenge and continue to thrive.

"They engage in design and modeling and computer applications in one class, and in another class they'll engage in medical detective work where they have to carry out a murder investigation and present DNA," Chavez said. "It is intense, but the kids are exposed to all these fields. They are now doing energy and environment to learn about solar panels and global warming. Toward the end of the year, they will be involved with green architecture and will be building houses. It will be pretty neat."

Krauss added, "It is always good to give out and help. Money doesn't always come, but we are always helping whether we have it or not. This year, we were lucky enough to have enough funding to fund all of our applicants through all of the Hawthorne and Lennox school districts." •

## Hawthorne First Time **Home Buyer Program**

The City of Hawthorne is now accepting applications for persons and households interested in participating in its First Time Home Buyer Program, which makes available a limited number of deferred payment (no monthly payment of principal or interest, and with no interest) second mortgage loans. Program assistance can provide the lower of up to 30 percent of the purchase price, or the amount required to maintain a 33 percent front-end ratio, or the program maximum of \$125,000. The loan can potentially provide funding for a portion of reasonable closing costs for applicant without sufficient resources. Actual amounts funded depend on individual applicant conditions. With head coach JC Randolph at the helm, Hawthorne will be returning a team that only managed to lose four seniors from one season ago. Two losses in a row to Santa Monica were shortly followed by a two-game sweep at the hands of El Segundo and two more consecutive sweeps at the hands of both Culver City and Lawndale. The Cougars, who began the season on fire, suddenly had gone 1-9 inside of league play and eventually saw themselves in the last place position in the final Ocean League standings.

The 2017 Hawthorne team is trying to forget all about last year. The loss of Monarrez is certainly not a good thing for the team's offense, but there are enough talented young players on the roster to replace his production. Noguchi has already picked up from where he left off last season. A senior this year, Noguchi recorded three RBIs and two runs scored in the opening game of the season, which was an 11-8 win for the Cougars over the St. Bernard Vikings. Hawthorne has also gotten great production out of junior Johnny Pacheco and senior Andres Cordova in the early going. The Cougars will be looking to those two and Noguchi to lead their team through a traditionally tough Ocean League schedule.

That problem was going up against the likes of Culver City, El Segundo, Beverly Hills and Santa Monica throughout an entire Ocean League schedule. Elite teams like the ones that face Lawndale in league play don't tend to let up very often. That fact resulted in the Cardinals going 2-8 in league play, with the team's only two inter-division victories coming in the final two games of the season against Hawthorne.

Lawndale is back this season and looking to get better under new head coach Jeff Prihode. So far, the team is off to a shaky start, to say the least. An Opening Day 27-1 victory over Hawthorne Math and Science Academy gave the Cardinals a certain sense of optimism. Freshman Wayne Sales had three hits, scored three runs and recorded six RBIs while hitting a double and a home run in the game. Senior Jesus Sanchez also had a home run that led to a five-RBI day and five runs scored. However, the Cardinals followed their massive victory with five straight losses. ## **Los Angeles Rams Begin Building for Future**

After a crazy day in NFL free agency last Thursday afternoon that saw many big names from around the league on the move, the Los Angeles Rams failed to make a huge splash, though they were busy. Last Thursday was the first day of the new NFL year and also marked the first day that free agents could sign contracts with other teams. It's no question that the Rams certainly have a lot of needs to address if they will look to improve on their 4-12 record from one season ago. The moves that the team has made thus far should improve the roster a bit, but Los Angeles has a long way to go if it wishes to compete in a perennially tough NFC West.

Perhaps the most important thing that the Rams could have done this offseason is beef up their offensive line. Doing so would not only help the prospects of last season's rookie quarterback Jared Goff, but it should also open up a few more holes for running back Todd Gurley. Neither Goff nor Gurley looked particularly effective last year. New veteran left tackle Andrew Whitworth will hope to change that. Whitworth, now age 35, has spent his entire 11-year career in Cincinnati clearing lanes for the likes of Jeremy Hill, Giovanni Bernard and others. The first-team All-Pro in 2015 finished second among tackles in the league last season according to Pro Football Focus. Whitworth will now be tasked with protecting Goff's blindside while also leading the way for Gurley, who will be looking to rediscover the dominance that he displayed in his rookie season once again.

While the Rams lost their leading receiver from one season ago, Kenny Britt, they will be giving a familiar face the chance to say hello to the Coliseum again. Britt went to the Browns, but former Serra High School star and USC Trojans standout Robert Woods has left the Buffalo Bills to play on the grass of the Coliseum once again. Woods is still young, at age 24, and should serve as a nice complement to Tavon Austin--but in all honesty, he's not the kind of player that is going to turn next season around for the Rams. As a second-round pick by the Bills in 2013, Woods has compiled career stats of 203 catches, 2,451 yards and 12 touchdowns. There is hope that Woods may be hitting his prime and could be poised for a breakout year, but the Rams receiving core certainly doesn't strike fear into any defense in the league just yet.

The most important thing that Los Angeles did this offseason was free up some muchneeded cap space. The Rams traded starting defensive end William Hayes to the Miami

Dolphins and released veteran center Tim Barnes, tight end Lance Kendricks, and defensive lineman Eugene Sims. None of those were necessarily impact players for the Rams last season and creating more cap room will go a long way toward giving Los Angeles flexibility in the future. The departures of the players freed up nearly \$16 million in cap space, which will likely go toward the acquisition of other key free agents this offseason before the 2017-'18 campaign gets it start.

The Rams can still use some help on the offensive line, particularly at the center position. As of last Thursday, the only center on the roster was a seventh-round pick from 2014, Demetrius Rhaney. Pahroh Cooper and Tyler Higbee round out the semi-recognizable names on the wide receiver and tight end depth chart, so L.A. could certainly use some more talent there as well. Help on defense at the linebacker spot and defensive line wouldn't hurt a group that is now led by defensive guru Wade Phillips. Robert Quinn has continued to be the most impressive player on that side of the ball. Phillips will certainly be looking to add more impact players, especially with the possible departure of cornerback Trumaine Johnson looming. Johnson signed the franchise tag this offseason, meaning that the Rams will owe the five-year veteran \$17 million next season. That number may just be too rich for a team that has a plan in place to work toward the future. As of last Thursday, Los Angeles had already been rumored to be shopping Johnson on the trade market.

The Rams were certainly active at the beginning of this year's free agency period with more moves likely to come in the near future. What fans need to keep in mind is the plan that owner Stan Kroenke originally had in place when he decided to move the team to Los Angeles. The new stadium in Inglewood is planned to open for the 2019 season. That's when Kroenke and the rest of the Rams front office hope to field a legitimate team and compete for the NFC West title and perhaps even the Super Bowl. That means, in the meantime, Los Angeles is destined to rebuild. Creating cap space and making the necessary room for young players like Goff, for instance, to get some real NFL experience is currently the priority in Los Angeles. So far, this offseason has accomplished the immediate needs of the Rams. Don't expect to see next year's team win a Super Bowl, but hopefully they can finish with more than just the four wins that they ended with one season ago. – Asixlion@earthlink.net

about the pricing of its leading drug therapies went unreturned as of late last week. The company's website did not mention the SEC lawyer's favorable ruling.

Amgen had product sales of \$21.9 billion last year, and total revenues increased six percent, according to 2016 financials. Drug sales grew six percent in 2016 over the previous year, led by a 49 percent increase in sales of Blincyto for leukemia patients. The company's other big gainers for the year included Kyprolis for treatment of myeloma-up 35 percent-and bone-density-building Prolia, which was up 25 percent in annual sales. The top-10 sellers for Amgen, which the shareholder group targeted in its proposal, generated \$16.6 billion for the biotech firm last year. Only a dozen or so drug companies outsell this Southern California success story. The company can choose to address at its annual shareholder meeting the drug-pricing issue and the risks from the current political debate over healthcare costs in the nation's and state capitals, but for now the federal government watchdog over publicly traded companies won't force pharmaceutical makers to say anything. This ruling is corporate America's version of the Miranda rule. The SEC decided a drug maker has the right to remain silent, even when it's the investor-owners of the company asking the questions.

that I'm aware of was successful in the 1990s," Neuhauser said. "There have been successful ones since. I think the problem this year was more the way it worded than the basic notion."

Shareholders in three 2015 cases overcame a drug maker's resistance to producing its pricing data, according to Neuhauser. In each case, the companies argued like Amgen that investors were trying to micromanage the business operations, yet SEC staff rejected the argument Neuhauser presented in January in writing. The former law school professor pointed to other SEC's staff opinions regarding drug companies and price-setting.

"This is not too intricate a matter for shareholders to understand. Note that it is the rate of increase that is being requested, not the actual prices charged. Indeed, the proposal 'micromanages' significantly less than the proposals that were deemed not to micromanage in Celgene Corp. (March 9, 2015), Vertex Pharmaceuticals Inc. (February 25, 2015) and Gilead Sciences, Inc. (February 23, 2015)," he wrote.
