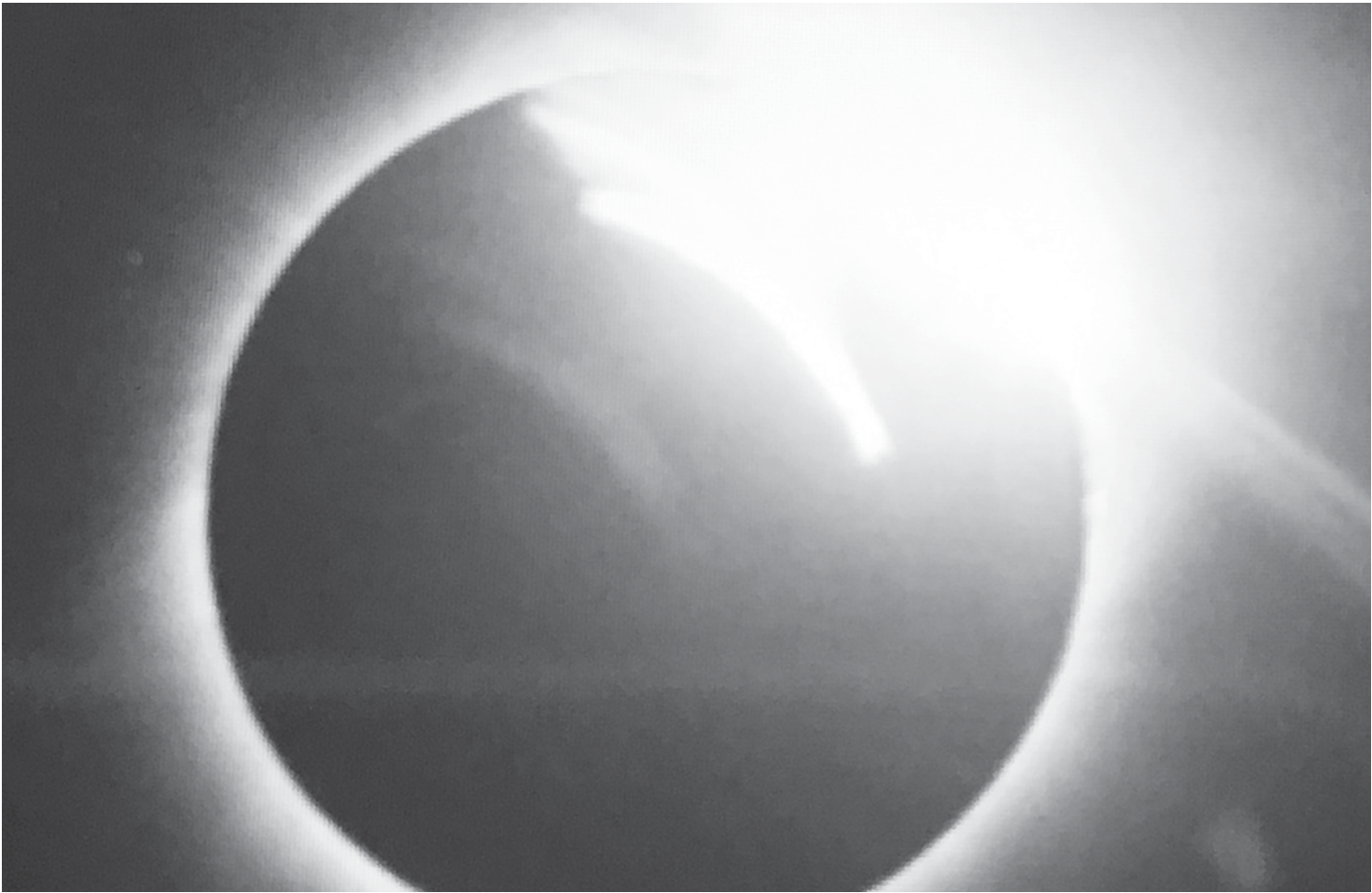

# Council Keeps City Codes Static on Parking and Smoking

Parking pads and hookah bars were on the agenda at Monday's Lawndale City Council meeting, but support for either of the items was minimal at best.

Parking, a perennial issue in Lawndale, was on the docket--this time for consideration of parking pads and attendant landscaping on residential properties. The Council and residents had plenty to say.

Mayor Pro Tem Daniel Reid noted there are cases when a parking pad makes sense, notably where handicapped citizens reside. In those cases, said Reid, "I would support a drop to 40 percent landscaping, but no further."

Resident Pam London expressed disdain for parking pads, saying they are unsightly. "The Council should never consider reducing the 50 percent landscaping requirement--we have enough [pads]," she said, noting the concrete slabbing is grandfathered in for residents prior to 2009.

One resident displayed a sense of neighborly payback. "They didn't want my artificial turf; I don't want their concrete," she said.

Resident Stephen Koontz agreed the pads need to be restricted. He also questioned landscaping codes. "What's allowed in that 50 percent?" he asked.

Johnny London provided an insight. To discover code violations since 2009, he said, "Use Google Earth." The online mapping app will reveal residences where concrete slabs have been installed since the practice was banned.

The Council agreed the accommodation for handicaps was warranted. Mayor Robert

Pullen-Miles said, "If the handicap triggers a variance, then yes. But otherwise, let's keep it status quo."

Sean Moore, Director of Community Development, reported on agenda item 11—hookah bars and smoking lounges. He noted city codes prohibiting such businesses have not been revisited in several years. He pointed to the example of Lomita, and potential revenue from the social gathering places.

Councilmember Jim Osborne noted the City's commitment to "smoke-free" environments. Both Councilmember Pat Kearney and Reid echoed that concern.

Residents spoke in favor of the lounges, with one man noting that nightlife in Lawndale is minimal. "Libraries and parks are closed, and the lounges provide a social element," he said, asking the Council to "take a look at it again."

Johnny London, who is also a homeowner, noted other forms of pollution in the city. "Why should we condemn them?" he asked. Also, regarding the dearth of nightlife in Lawndale, London added, "Let them have something."

Pullen-Miles weighed in, cautioning against the dangers of second-hand smoke. "I'm not inclined to encourage smoking," he said. The Council took no action on the issue, simply filing the staff report.

The Council approved a change to the term of office for advisory boards, aligning those with the newly-established elections schedule. The Council will continue to make appointments shortly after the elections in November, with two-year terms to start February 28 of the following year.

In the public safety report, Captain April Tardy gave an overview of school safety tips and introduced two new officers recently added to the local Sheriffs detail. Tardy reported Deputies Paz and Shintaku have worked in the South Bay, most recently as partners covering El Camino Village.

In public comments, several residents thanked the City for swift action in removing a sidewalk obstruction at 169 Street, reported at last meeting. Pam London noted RVs are taking up already limited parking throughout town. "They have to do like other cities and park on their property or in storage facilities," she said.

Barbara Lettre reported flowering trees on Manhattan Beach Boulevard, and showed the Council a green 12-inch frond resembling a short spear. She said people have been hit by foliage falling from the trees. Lettre described these sprouts as "miserable," saying they also create a mess. Kearney suggested the hazard be referred to Frank [Senteno, Director, Public Works]. "He's our tree expert," said Kearney.

Library Manager Jose Parra reported several new programs for the fall, including STEM programming every Saturday, beginning next month. STEM initiatives expose school-aged kids to career paths in science, technology, engineering and math. The library will host a meeting of the teen group on September 2 from noon to 1, and a homework open house on September 12 at 4 pm.

Kearney reported on a new Jamba Juice and ice cream shop opening. Council members

## LESD Modernizes Campuses for New School Year

Over the summer, Lawndale Elementary School District (LESD) undertook several projects to improve facilities and provide students with high-quality learning environments.

Two of the major projects were funded by Measure L, a general obligation bond approved by Lawndale voters in November 2016. Measure L will provide the District with \$27 million to improve outdated and worn facilities. Thanks to the community’s support, LESD’s facilities have undergone a major makeover, which includes:

– New Paint: The Addams, Rogers, Anderson, and Green campuses received fresh coats of paint. This project has had a significant visual impact on the schools and improved the look of the surrounding community.

– New Roofing: The Green, FDR and Anderson campuses received new roofs. While the visual improvement is not as drastic as the paint job, there will not be as many leaks as the past few years!

In addition to the aforementioned Measure L projects, the District also completed the following projects:

– Installing a sound fence along Marine

Avenue for FDR Elementary.

– Projector Installation: Interactive projectors have been installed in all LESD classrooms.

– New Water Fountains: One new water fountain per campus will be installed at Mitchell, Twain, and FDR Elementary Schools. They will include a chiller, water bottle filling station, and upgraded filter. Students and staff will be well-hydrated.

– Fencing/Gates: New fences and gates have gone up at Mitchell and Green Elementary schools to improve the appearance of the campuses and support student needs.

– Grounds work: LESD maintenance team worked throughout the summer to keep campuses looking clean and inviting.

“All of this work would not have been possible without our Business Services Department’s concerted effort to support our students—a huge thank you to our Accounting, Purchasing, Maintenance, Food Services, and Technology teams! None of this work could have been completed without their perseverance. ## Safety Improvements Completed at LAX Runways

Los Angeles International Airport (LAX) has completed mandatory safety improvements to all four of its runways, and those are once again operating at their full length. The U.S. Congress required all the nation’s airports to undertake Runway Safety Area (RSA) improvements that provide an extra margin of safety for landing and departing aircraft. RSAs provide a buffer zone should an aircraft overshoot, overrun or veer off a runway while landing or taking off. RSAs are typically 1,000 feet by 500 feet at each runway end and 250 feet from the runway centerline. The RSAs are not runway extensions.

The RSA improvements at LAX began in March 2015, and were phased in to limit impact to operations. The RSA work also provided an opportunity for LAX to perform other airfield improvements and runway maintenance.

Airport officials consulted with airline partners, the Federal Aviation Administration (FAA), and

neighboring communities on flight management plans to minimize impacts to surrounding communities and air travelers during construction.

The final RSA improvements on Runway 7L-25R were completed last weekend, and the runway reopened at its full 12,091-foot length on Monday. Work on Runway 7L-25R began in October 2016, following completion of the RSA construction on Runway 6R-24L.

Runway 7L-25R remained operational starting in October 2016 in a shortened configuration while its east end and adjoining taxiways were reconstructed. It then closed in late April to allow for maintenance and rehabilitation work, electrical revisions and the start of RSA improvements on the west end of the runway. The runway reopened in a shortened configuration in late May while west end RSA work continued, before completion this weekend and reopening today full length. – Source: Los Angeles World Airports

## Pancreatic Cancer: Know your Family, Know your Risk

(BPT) - Pancreatic cancer is one of the most deadly cancers, with a mere 29 percent one-year survival rate. In 2016, pancreatic cancer became the third leading cause of cancer death in the United States, surpassing breast cancer.

The time frame between diagnosis and death is often short. Only 7 percent of people diagnosed with pancreatic cancer survive five years. This is incredibly small compared to prostate cancer or breast cancer, where more than 90 percent of patients survive for five years after diagnosis.

“Most people are unaware of how deadly pancreatic cancer is,” says Jim Rolfe, president of Rolfe Pancreatic Cancer Foundation. “These chilling statistics can serve as an eye-opener that motivates people to learn more about their risks and contact their health care professional.”

### Early Detection Is Important

Although pancreatic cancer is one of the most deadly cancers, early detection can significantly impact survival rates. The five-year survival rate for pancreatic cancer approaches 25 percent if cancers are surgically removed while they are still small and have not spread to the lymph nodes.

### Know your Family, Know your Risk

Family history is a risk factor for pancreatic cancer. When you know more about your genetics and which members of your family have been affected by pancreatic cancer, you can better manage your own health.

To make the process easier, the Rolfe Pancreatic Cancer Foundation has introduced a new series of online tools. Visit [www.KnowMyRisk.org](http://www.KnowMyRisk.org) to download a worksheet and access other helpful tools that let you explore your family history and become your own health advocate.

Print out the worksheet and call or visit your grandparents, parents and other extended family members. You may not be aware that someone a few generations removed from you was affected by cancer. Having this conversation can be empowering, because once you know your risks you can take charge of your future.

### Consider Genetic Counseling

When considering how personal a cancer or disease diagnosis can be, it is no surprise that medicine is looking at our DNA to uncover information. This makes genetic counselors an important part of the health care team, helping you ask the right questions and uncover familial genetic risk factors.

If you learn you have a history of pancreatic cancer in multiple family members, you should consider meeting with a genetic counselor to assess your level of risk. From there, the counselor and your doctor can decide on a course of action.

Dodgers Adding More Key Pieces for October Playoff Run

What’s most amazing about the Los Angeles Dodgers may not even be their record, which is by far the best in baseball and could wind up being the tops in Major League Baseball history. The team that is dominating the National League West and all of baseball is doing so without its best pitcher and without a few key pieces of their lineup. With just over one month of the regular season left to play, the deepest lineup to maybe ever play the game of baseball is poised to get even deeper and more explosive, if that can even be fathomed.

What was supposed to be the most glaring hole in the Dodgers’ lineup is revving up to get back into action. Barring an unforeseen setback, Clayton Kershaw should be back in the starting rotation sooner, rather than later, for the first time since a lower back strain sidelined the ace on July 24. Kershaw threw a 35-pitch simulated game last week and will presumably throw against live hitters sometime this week. “Once he passes that marker right there, then we’ll see where he goes,” Dodgers manager Dace Roberts explained. “It’s probably going to be a start either in Tulsa or OKC.”

Don’t tell the Dodgers or their fans, but it’s looking like the team doesn’t even need Kershaw. Since his departure to injury, the Dodgers had only lost four games in his absence dating back to last Sunday, while putting together a 21-4 record in that same time frame, if you count the game from which Kershaw was removed.

What has become the scariest part about Kershaw’s impending return is imagining the Dodgers rotation once the starters are all fully healthy. Beginning with Kershaw, the rotation would also boast a variety of starters including the recently acquired Yu Darvish and a mix of Alex Wood, Rich Hill, Kenta Maeda and Hyun-Jin Ryu. That combination is as good as, if not better than any in the entire league. The numbers prove that fact to be true as well. With a team ERA hovering right around 3.10 as of last weekend, the Dodgers’ overall ERA amongst starting pitchers was the best in

all of baseball.

Pitching isn’t the only thing that the Dodgers have been bulking up on lately. Adrian Gonzalez returned to the batting order for the first time in 57 games last Friday, adding even more depth to an already elite lineup. “I feel great,” Gonzalez said after being activated from the 60-day disabled list. “Last year was when the whole issue started with the back. Right now, I feel like I’m before that, before it all started. So hopefully this is the end of the back issue.” If his play has anything to say about it, it certainly looks like it is the end. Gonzalez doubled in his first at-bat since June 11 and went on to knock in the first run of the game last Saturday afternoon in what wound up being a 3-0 Dodger win.

The run that Gonzalez knocked in just so happened to be his new Dodger teammate, Curtis Granderson. The Dodgers traded for Granderson last Friday night and in doing so immediately upgraded offensively over Joc Pederson, who was sent to AAA to work on his swing before his inevitable recall in September. Granderson, previously of the New York Mets, learned of the trade just after midnight Saturday morning on the East Coast. He was in Detroit to start in right field for the Dodgers when they took on the Tigers later that day. Granderson got to work right away, scoring the first run of the game for his new team on Saturday in a 3-0 win. The very next day, he broke up Justin Verlander’s no-hit bid with a home run in the sixth inning for the first run of the game (and the Dodgers’ only run that day).

Granderson’s arrival, combined with the reemergence of Gonzalez and the looming reinstatement of Andre Ethier, will give Roberts a very good problem to have. Those players, together with the likes of Cody Bellinger and Chris Taylor (who can play just about anywhere) will not only give the Dodgers an extremely deep bench, but also allow the team the versatility to move players around on the

field. Heading into the playoffs, Los Angeles will continue to have the strongest pitching staff in the entire league, combined with one of the most powerful batting orders and deepest lineups that baseball has seen in quite some time.

The Dodgers may not break the record for most wins in an entire season. They may even break their trend and go on a mini-slump heading into the playoffs. What’s important, though, isn’t how the team finishes the regular season. The Dodgers and their front office have done

everything that they can to set their team up for postseason success. A roster that is only getting healthier by the day should be primed to perform both down the stretch in September and well into the playoff months of October and November. Now, the machine that is the Dodgers simply needs to keep on grinding. It’s not the postseason yet, but this Los Angeles squad is showing the most promise of any other Dodgers team in recent history of bringing home a World Series title. – *Asixlion@earthlink.net* •
