## New Taxes Will Benefit Lawndale

The Lawndale City Council received a report at Monday's meeting from Senator Steven Bradford, including an update on the legislative year which ended on September 15. Bradford explained that of 21 bills he introduced, 14 made it to the Governor's office and 11 passed. He detailed three of the most significant impacts, including the gas tax which took effect last week, a housing bond and a fund for improving state parks.

People are already feeling it at the pumps, said Bradford. The tax, which effectively raised gas 12 cents per gallon throughout the state, will raise \$5 billion a year. Additional fees for vehicle registration and electric cars will be implemented over the next several years to address a \$130 billion backlog in transportation maintenance. "We have over 400 roads and bridges in dire need of repair," he said.

Bradford said passing this much-needed funding bill was not a cakewalk and ultimately won favor with the inclusion of a "diversity clause." It ensures that women and minority-owned businesses will have a piece of the pie," said Bradford, referring to contracts for road construction and repair. The housing bond addresses the state-wide housing shortage, compelling developers to set aside a percentage of residential units for affordable housing. State parks will also get a boost, with cities being eligible for \$200,000 to upgrade park infrastructures.

A public hearing was opened on item H on the agenda: Marijuana Use Regulations. The action sought would amend City of Lawndale municipal codes to be consistent with state regulations on marijuana sales, cultivation and usage. Resident Pamela London expressed the Lawndale Planning Commission's concern that the City could miss out on tax revenue. "This is also an issue of voters' rights," she said, referring to the overwhelming support for Prop 66, making marijuana legal in California.

Resident Randall Abrams represented the Planning Commission. "All the Planning Commission is saying is you should explore this in more detail," he said. "The increased tax revenue could be used for additional staffing

of law enforcement."

Council members Bernadette Suarez and Pat Kearney both urged the Council to retain the group's original position, which is a ban on commercial use dispensaries in the city. Israel cautioned the Council that state laws legalizing the substance go into effect on January 1.

Mayor Robert Pullen Miles reminded his colleagues that the proposition did pass "by a pretty significant margin." He said three cities are negotiating with the marijuana industry to develop a reasonable-use initiative that would allow municipalities to shape their individual responses versus the industry setting the protocols. Pullen-Miles asked that staff bring the item back. "With a complete ban, we lose the public safety abatement funding" included in the legislation, said the Mayor. "This is an opportunity to regulate an industry that is not going away. We run the risk, if we simply say no, of losing control of regulating it [in Lawndale]."

Also on Monday, the Council recognized the Lawndale Rotary Club for participation in World Polio Day. Republic Services Representative Sam Pena introduced Resident Elizabeth Leighton as the winner of the Lawndale Fall Clean-Up event. Republic Services is the City's partner in recycling and waste disposal, sponsoring a twice-yearly pick-up and drop-off event. In March, over 67 tons of refuse were brought in and another 25 tons were collected at curbside, said Pena. Residents may call the City's 800 number to schedule curbside pick-up, year-round, and up to four times in a year.

The Council also honored two residents for outstanding volunteerism in support of the SBCOG Environmental Services Center. The Bronze Sustainability Leadership Award was presented to Maelyn Evans and Miguel Vasquez for 262 and 250 volunteer hours respectively in the areas of energy efficiency and conservation.

Sergeant Nitz gave the safety report, describing an arrest on October 30. A hotel manager discovered a large cache of weapons and drugs at a local hotel, he said. Several suspects were arrested and the contraband confiscated. Sgt. Nitz also cautioned residents to practice

holiday safety, noting that sleep deprivation happens during the holidays and can lead to risky behavior.

In public comments, Johnny Castro asked the Council to remember a homeless resident who for 30 years was a presence in the city. "Mike" was most often seen at 166th and Hawthorne, where a large memorial of flowers, candles and other mementos were left in his honor. Mike died on October 23, according to Castro.

A large group of supporters of Brooklyn Bar, a local watering hole on Hawthorne at 166th Street, turned out at the Council meeting in support of the establishment, which has received a 30-day suspension from the City. Jim, a manager at the bar, implored the Council to keep the venue open. With a loyal following and the holidays coming, Jim said, "It's gonna hurt." An eight-year resident who has worked at the bar for two years, Jim emphasized that the place does not attract biker-gang customers.

City Attorney Tiffany Israel said the bar's management has the right to an appeal process, but needs to direct it to the City Manager and not the Council. Councilmember Jim Osborne sought clarification. "Didn't we get email notification that residents made complaints?" he asked. "Several," responded City Manager Steve Mandoki. He noted that jurisdiction for these kinds of complaints belongs to the Community Development department. Code enforcement contacts the owner, who is given 15 days to appeal the suspension. The group of more than 20, most wearing Brooklyn Bar T-shirts, walked out of the meeting at that point. It was not clear if an appeal to the suspension had been filed.

Osborne noted the Veterans Day Field of Honor will be installed on the City Hall lawn on November 10 and will remain on display through November 12. Commemorative flags are still available. The Lawndale City Council meets the first and third Monday of every month, unless otherwise noted. The November 20 meeting was cancelled due to proximity with the Thanksgiving holiday. The next regular Council meeting will take place December 4, at 6:30 p.m., in the Lawndale City Hall Council Chamber. •






### Brazile's DNC Allegations Indicate More Than Unethical Agreements

Covering the Marvel Cinematic Universe from a critical perspective is always interesting: the behemoth franchise never missteps or whiffs, but often fails to leave us with an individual film to be remembered. The most inarguably flat film of the entire franchise may be *Thor: The Dark World*. While we all have our favorites (or least favorites), this cold, heartless sequel is never brought up in conversation since its release. With the first outing of *Thor*, a compelling character arc was put in place: our hero went from being a brash, arrogant and clueless character to a more grounded hero by the end of the film. It's a great journey, but it only lasts for one film--so by the second *Thor* movie, there was no place for him to go forward and the writers didn't even bother to attempt it. This, more than any other reason, is what made the second film so stale.

So where to go from there? If there is ever proof that anything can be great under the guidance of the right person, it is *Thor: Ragnarok*. Entrusted in the hands of indie favorite Taika Waititi--whose last two films, *Hunt for the Wilderpeople* and *What We Do in the Shadows*, are some of the best

comedies of the decade--it was anyone's guess what a massive scale blockbuster would look like under his influence. To our delight, the film more closely resembles the work of Waititi than a conventional Marvel film, and we are all able to benefit from it.

From the very get-go when we see Thor in action on some brooding, otherworldly setting, there is a juxtaposition from the grandiose visuals of the *Thor* universe met with the oddball

Waititi humor that never fails to deliver. For the first time in a while, it feels like a director has taken command of the reins of a Marvel movie. Mind you, unlike most sequels to bad movies where they attempt to revise history or scrap previous entries, this film embraces all the story points from the last film but chooses to have a lot of fun with them.

The plot on its own could be a more straightforward tale: An evil villain (Cate Blanchett)

who has a history at Asgard, enters into the fray with the intention of ruling over the entire galaxy. Thor (Chris Hemsworth), meanwhile, is thrown off guard again and lands on a junk-pile planet where, in order to escape, he must serve as a gladiator. Borrowing cues from throughout the decade, I'm struck with how well employed this '80s homage is--by setting it on a specific planet, it gives the entire universe a more layered feeling where certain places have different atmospheres than others. The balance between the two planets, the regal Asgard and the synthesized '80s-inspired second planet, is a great contrast and the variety makes the whole adventure a delightful romp.

Of the Marvel movies, the only one I can actively recall re-watching is the original *Avengers*. After viewing this film, I can safely say I'd be thrilled to relish in *Thor: Ragnarok* again. With its humor, vision and sincerity, the bar has been raised for what Marvel can accomplish, and I hope its look continues to invite more brilliant directors to jump into the fray.

## World Series Loss Means More Heartache for Dodgers and Fans

The World Series championship that has eluded the Los Angeles Dodgers for so long will have to wait at least another year to find itself a home in Southern California. A series filled with amazing victories, heartbreaking losses, incredible performances and gigantic meltdowns most likely could have gone back and forth for another seven games. Eventually, however, it ended in favor of the Houston Astros, as the American League team showed up on the road in the game that mattered most. The Dodgers will have a very long offseason to look back at what went wrong in the World Series. They'll also have an even longer 162-game regular season schedule to play in order to make another run at the team's first championship victory in what will now be 30 years of heartache.

Heartache probably can't begin to describe the feeling of Dodger fans everywhere as they watched their team quickly take a 5-0 deficit in the only Game 7 of the World Series that Los Angeles has ever been a part of in the team's local history. In the biggest moment of his career, on one of the grandest stages in the entire sports world, Dodgers pitcher Yu Darvish failed. The conclusion to a series that may have been among the most dramatic ever played ended in the most anticlimactic fashion possible as Los Angeles was out of the game and championship contention from what seemed to be the opening pitch.

Word came out days later that Darvish was tipping his pitches, meaning that batters like George Springer, Jose Altuve and Carlos Correa knew what was coming before the ball even reached home plate. It certainly looked that way. Much of the blame there can easily be placed on Darvish--a pitcher the Dodgers acquired for exactly this situation. How, though, as coaches, do you leave a pitcher who clearly doesn't have it out on the mound in the most important game of the year to give up five runs==especially after his last outing against the same Astros team in Game 3 in which he looked just as bad?

As far as blame goes, it can certainly be placed on Dave Roberts and the rest of the coaching staff for trusting too much in analytics and not in their own eyes. Many different questionable moves throughout the entirety of the World Series simply culminated in leaving Darvish out on the mound for far too long. That, combined with the way that the Dodgers' best players sulked and felt sorry for themselves from the second inning on, gave the team zero chance at pulling off a come-from-behind victory in a winner-take-all game in front of their home crowd.

Ten players left on base only began to tell the story of a team that clearly did not want it as much as the Houston Astros. Cody Bellinger--who looked as if he had been out partying too late for Halloween the night before--committed a brutal error

to start the game when he inexplicably threw a fielded ground ball behind Darvish, who was covering first base, in a play that led to two runs and a massive momentum switch for Houston. Not only was the Los Angeles home crowd taken out of the game from that point forward, but Bellinger also proceeded to hurt the team at the plate. He struck out three times on the night and went 0-4, acting as the main, major hole in the lineup that led to almost zero offensive production for a team that still managed to obtain more hits than its counterparts in the final box score.

The Dodgers were 98-0 this season when having the lead after eight innings of play. Yet, in Game 2, Roberts left Jansen in for his second career six-out save attempt and the Dodgers wound up losing the game. The Dodgers were 100-1 in starts by Clayton Kershaw when he was given at least a four-run cushion. Kershaw gave up both a four-run lead and a three-run lead in Game 5 before being pulled in a loss that eventually saw the Dodgers go down 3-2 in the best of seven series. Theoretically, the Dodgers should have won five of the first six games played against the Astros, were it not for bad coaching decisions and All-Star players buckling under playoff pressure.

Putting the blame game aside, the Astros were simply the better team. They made more plays when it counted and fewer mistakes at key moments in the series.

For the Dodgers, they are now forced to once again focus on next year. How will the team get better so that it can finally take the next step forward and become champions instead of simply making it to the playoffs or the Fall Classic? Darvish, Logan Forsythe, Brandon Morrow and Chase Utley are all free agents, among others. Clayton Kershaw will be another year older, coming off of another year in which he was injured. Corey Seager may need surgery to repair his ailing elbow. Drama involving Adrian Gonzalez hovers around the team. All of those questionable situations, and more, surround a 104-win team that finished with the best record in baseball yet will be looking to improve upon a year that once again somehow ended in letdown.

The Dodger season went on for as long as it possibly could have this year, providing the team's fans with a maximum amount of entertainment value. The year may have ended with a loss and in disappointment, but the memories of joy, elation, excitement and accomplishment will remain. The only thing to do now is to focus attention toward next season. The Dodgers have been through three decades of baseball that have all ultimately ended in disappointment. Los Angeles and the team's fans will once again look forward to next year in order to finally rid the franchise of all of its surrounding regret. •

# Looking Up

## Martian Ridge Brings Out Rover’s Color-Distinguishing Capabilities

Based on a Press Release from JPL, Provided by Bob Eklund

Color-discerning capabilities that NASA’s Curiosity rover has been using on Mars since 2012 are proving particularly helpful on a mountainside ridge the rover is now climbing.

These capabilities go beyond the thousands of full-color images Curiosity takes every year: The rover can look at Mars with special filters helpful for identifying some minerals, and also with a spectrometer that sorts light into thousands of wavelengths, extending beyond visible-light colors into infrared and ultraviolet. These observations aid decisions about where to drive and investigations of chosen targets.

One of these methods for discerning targets’ colors uses the Mast Camera (Mastcam); the other uses the Chemistry and Camera instrument (ChemCam).

Each of the Mastcam’s two eyes—one telephoto and one wider angle—has several science filters that can be changed from one image to the next to assess how brightly a rock reflects light of specific colors. By design, some of the filters are for diagnostic wavelengths that certain minerals absorb, rather than reflect. Hematite, one iron-oxide mineral detectable with Mastcam’s science filters, is a mineral of prime interest as the rover examines Vera Rubin Ridge.

“We’re in an area where this capability of Curiosity has a chance to shine,” said Abigail Fraeman of NASA’s Jet Propulsion Laboratory, Pasadena, California, who leads planning for the mission’s investigation of Vera Rubin Ridge.

This ridge on lower Mount Sharp became

a planned destination for Curiosity before the rover landed five years ago. Spectrometer observations from orbit revealed hematite here. Most hematite forms in the presence of water, and the mission focuses on clues about wet environments in Mars’ ancient past. It found

evidence during the first year after landing that some ancient Martian environments offered conditions favorable for life. As the mission continues, it is studying how those conditions varied and changed.

Curiosity’s ChemCam is best known for

zapping rocks with a laser to identify chemical elements in them, but it also can examine targets near and far without use of the laser. It does this by measuring sunlight reflected by the targets in thousands of wavelengths. Some patterns in this spectral data can identify hematite or other minerals.

“The colors of the rocks on the ridge are more interesting and more variable than what we saw earlier in Curiosity’s traverse,” said science team member Jeffrey Johnson of the Johns Hopkins University Applied Physics Laboratory, Laurel, Maryland. He uses both Mastcam and ChemCam data for analyzing rocks.

Hematite occurs at sufficiently small grain sizes in rocks found at this part of Mars to preferentially absorb some wavelengths of green light. This gives it a purplish tint in standard color images from Curiosity, due to more reflection of redder and bluer light than reflection of the green wavelengths. The additional color-discerning capabilities of Mastcam and ChemCam show hematite even more clearly.

“As we approached the ridge and now as we’re climbing it, we’ve been trying to tie what was detected from orbit to what we can learn on the ground,” said Curiosity science team member Danika Wellington of Arizona State University, Tempe. “It’s still very much a work in progress. The extent to which iron-bearing minerals here are oxidized relates to the history of interactions between water and rock.”

Vera Rubin Ridge is named for astronomer Vera Rubin (1926-2016), who confirmed the existence of dark matter. •


