# Undetectable New Cars Told to Make Some Noise

We can't hear you!

That's the message the federal government has sent to car companies that make electric and hybrid vehicles. Alternative fuel vehicles are so quiet when the motor's running that 2,400 pedestrians a year are struck in crosswalks, streets and parking lots, according to estimates.

The National Highway Traffic Safety Administration just added a sound requirement for new hybrid and electric light-duty vehicles. The safety standard, put in place to protect pedestrians who are blind or have low vision, will help prevent as many as 2,400 pedestrian injuries per year once all hybrids on U.S. roads are properly equipped.

Protecting pedestrians is near the top of the agency's to-do list now that vehicular deaths are on the rise, ending a 50-year decline in the nation. Drivers are more distracted than ever, and cell phones and mobile devices are getting most of the blame. Pedestrians play a role in traffic safety, and it just makes sense they should be looking out for danger instead of at their phones. "This is a common-sense tool to help pedestrians — especially folks who are blind or have low vision — make their way safely," said NHTSA Administrator Dr. Mark Rosekind. "With pedestrian fatalities on the rise, it is vitally important we take every action to protect the most vulnerable road users." Under the new rule, all hybrid and electric passenger vehicles will be required to make audible noise when they're moving at speeds below 20 mph, either forward or in reverse. The government says tire and wind noise would drown out the engine's sound at higher speeds. Carmakers may choose to install external speakers in the front grill. When an electric or hybrid is in motion, a recording of a car engine would begin to play. The lack of sound made by electric cars especially has been discussed since the early 2000s, which Edmunds.com noted in a January 2015 article titled "The Danger of Too-Quiet Car."

The website, used by car buyers looking for pricing and reviews about car models, admonished the automakers and the driving public that "you can have too much of a good thing. Take silence."

Three studies were done and each one confirmed the dangers to pedestrians of silent cars driving at low speeds. A 2009 study found that at low speeds, hybrids and electrics were twice as likely as non-hybrids to be involved in a pedestrian crash. A 2011 federal study reported that pedestrian crashes were 35 percent higher with hybrids and electrics versus combustion-engine cars.

A third study by the Highway Loss Data Institute concluded hybrids are up to 20 percent more likely to be involved in injuring pedestrians than other cars. Not all automakers waited for the government to come to the foregone conclusion that an approaching vehicle should make a familiar sound. Nissan installed a vehicle sound warning for pedestrians on its electric Leaf, starting last year. The plug-in hybrid Chevrolet Volt also has an alert noise, which the driver can activate, Edmunds.com reported. The government wants the sounds coming from electrics and hybrids to be recognizable--not a jumble of noises like phone ringtones. Carmakers have until September 1, 2019 to equip all new hybrid and electric vehicles with sounds that meet the new federal safety standard. Half of new hybrid and electric vehicles must be in compliance one year before the final deadline. Advocates for the blind say the noise requirement on cars is needed because Americans who can't see are living active lifestyles nonetheless. More than 20 million Americans, close to 10 percent, say they have trouble seeing or are blind.

"This regulation will ensure that blind Americans can continue to travel safely and independently as we work, learn, shop and engage in all facets of community life," said Mark A. Riccobono, president of the National Federation of the Blind.

What about current owners of these tooquiet cars who want to give bicyclists and pedestrians warning that a car is approaching? The National Highway Traffic Safety agency isn't recommending that electrics and hybrids on the road now install any noise devices.

The experts at Edmunds.com said not to expect to find aftermarket sound-making devices anytime soon. Alternative fuel cars represent a small fraction of U.S. vehicles in use today, though that number was expected to reach four percent this year. California is leading the charge, so to speak.

Governor Jerry Brown's administration has set a goal of 1.5 million electric cars in the state by 2025 as part of a pledge to reduce emissions and slow the effects of global climate change. Assemblywoman Autumn Burke, D-Inglewood, is pushing the auto industry to make that happen. There are more than 200,000 electric vehicles being driven in California, according to a group calling itself the Union of Concerned Scientists. "Unless we take action, the state won't come close to meeting this goal," Burke said. "That's why we need to reform the rules to require that 15 percent of all cars sold in California have zero emissions by 2025." Burke introduced last summer what she calls the "15 by 25" plan. It would direct the California Air Resources Board to require at least 15 percent of all new passenger cars sold in California be zero emissions by 2025. Burke's bill is currently inactive, having been heard in the Assembly Natural Resources Committee and in the Senate Rules Committee. No action has been taken on the South Bay lawmaker's bill since August 17. •

# **Community Briefs** Airport Commissioners Approve New LAX Concourse

With current and future passenger growth at record levels and an objective to provide a "top tier" passenger experience, the Los Angeles Board of Airport Commissioners recently agreed to fund a Midfield Satellite Concourse (MSC) and related Baggage Optimization Project (BOP). The concourse, an addition to the Tom Bradley International Terminal (TBIT), will include 12 gates in phase one of construction. The MSC will provide needed flexibility and gate space, while reducing reliance on LAX remote gates where passengers are currently bused to board aircraft. Construction of the MSC North and the BOP will improve capacity to handle baggage at both the MSC and TBIT.

The North Gates phase of the MSC will include two gates for Group VI aircraft (Airbus 380 super-jumbo, Boeing 747-8 Intercontinental) while the remaining 10 gates will handle Group V aircraft (Boeing 777 and 787, Airbus 330). The concourse will also include food and retail options, plus space for airline clubs.

The concourse will connect to TBIT via a 1,000-foot-long passenger tunnel that will start in a gateway facility built adjacent to the terminal. The tunnel will feature 42-inchthick walls and a roof designed to withstand 660 tons-plus.

The concourse design specifies LEED Silver certification and CAL Green Tier 1 status, with substantial completion slated for late 2019.

A second phase will add gates on the terminal south end. Site preparation has begun with demolition of the former TWA hangar, with demolition of the former U.S. Coast Guard hangar to follow.

Maximize your social security benefits. It might be tempting to start claiming your benefits as soon as you're eligible, but if you can, wait. The longer you wait, the more you and your spouse will be paid. Especially if you're currently healthy, try to defer your benefits until you're 70. If you do, your payments will increase by as much as 75 percent. This will put you in a good position to meet any unexpected costs in the future.

Sell your life insurance. Just like stocks and bonds, a life insurance policy is an investment. Periodically, you should review your policy to see whether or not it's still deal with health care bills.

Consider a reverse mortgage. This is a loan available to homeowners that allows them to convert part of the equity in their homes into cash. The loan is called a "reverse mortgage" because instead of making monthly payments to a lender, as with a traditional mortgage, the lender makes payments to the borrower. The borrower is not required to pay back the loan until the home is sold or otherwise vacated.

# Pension Plan Funding Shortfalls Threaten Retirees in All 50 States

(BPT) - Everyone knows it is important to save for retirement in order to build a nest egg and enjoy the "golden years." So why is it that state and local governments many times act irresponsibly when it comes to saving for the future of public employees?

Government pensions are the way in which state and local public employees like teachers, police officers and firefighters receive retirement benefits. Typically both the employee and the government set aside money each year to be invested. The investments will hopefully grow over time, and both the annual contributions and the investment growth is understood to form the pool of money public employees will be able to use once they reach retirement. That's the theory.

Unfortunately, according to Unaccountable and Unaffordable 2016, a new, state-by state analysis from the American Legislative Exchange Council (ALEC), government pensions are being massively underfunded across the states, and now hardworking taxpayers are on the hook. What is the price tag? Across the 50 states, unfunded pension obligations now total \$5.6 trillion. Now, that number sounds large at a national scale, but what does it mean for the average American? To be exact, this state pension debt equates to an average price tag of \$17,427 for every man, woman and child in the United States.

There are numerous reasons why pension liabilities are so large. For one, the stock market is not growing as quickly as many assumed it would, exiting the recent economic downturn. Therefore, investments for many pension funds are not meeting expectations. The average pension fund assumes they will earn a whopping 7.37 percent on their investments over the long term. These overly-optimistic assumptions fly in the face of what many financial experts are calling a "new normal" of lower than expected investment earnings in the future.

Another inconvenient truth is that many state governments have failed to deposit the annually required contributions into pension funds every year. The urge to spend more money on other government projects, however well intentioned, has diverted much-needed contributions away from pensions and has contributed significantly to unfunded liabilities.

When pensions are unstable, millions of Americans are faced with an uncertain retirement. However, this is not only a problem for government workers - it affects all Americans. Without a sustainable solution to underfunded pensions, higher taxes will be the reality for all hardworking taxpayers.

What's more, an increasing percentage of state budgets are being drained to pay pension benefits, with less money available for important functions like funding public schools and fixing roads. One especially sobering story comes from Illinois, where since 2009, this trend is so extreme that 89 cents out of every new dollar of education spending has gone to teacher pensions, leaving just 11 cents for salaries, textbooks, building costs and the various in-classroom costs of education. And by 2025, Illinois will spend more on teacher-retirement costs than it will spend on the classroom.

Pension funding is not a Republican vs. Democrat issue. It's a retirement issue that affects all Americans. Unfunded pension liabilities will be harmful to the future of workers, retirees and taxpayers alike, if forward-thinking policymakers do not tackle pension reform in a timely fashion.

# Hawthorne Revving up for Ocean League Basketball

The Hawthorne Cougars head basketball coach may be nicknamed "Jello," but he's looking for his team to be anything but floppy this season. In what has traditionally been an extremely competitive Ocean League, David "Jello" Gray is looking to guide his team where it hasn't been since he took over the club in 2013--to the top of the Ocean League standings. With a great core group of returning seniors, aided by a few young stars on the team, Gray and the Cougars will look to improve on a season from a year ago that failed to yield even one victory in Ocean League play.

It has been a rough go for Gray since he assumed head coaching duties for the team. When he began his tenure, it was the 2013-'14 season and he took over a team that wasn't necessarily supposed to compete against the superior lineups of the Ocean League like Beverly Hills, Santa Monica and Lawndale. His premier season yielded an overall record of 7-17 with only one win in league play (1-9). Things didn't get much better for Gray in the 2014-'15 season. The Cougars went from 7-17 to 5-21 and still only mustered one victory in league play. That brings us all the way up to last year. Gray's team produced seven wins again--but instead of attaining one victory in league play, the team fell to 0-10. Needless to say, Jello is looking to get things shaking in his fourth year with the team.

A trade that was denied by the NBA that could have sent Paul to the Lakers wound up with the All-Star point guard setting up home on the other side of the Staples Center. Paul certainly set a tone of winning in the locker room. The Clippers have made the playoffs every year since his arrival. Despite the team's relative success, they have always fallen a bit short of expectations and have still failed to make it past the second round of the playoffs.

When teams continuously fall short, things never end well. Either a marquee player gets shipped out or the coach has to go because his message simply isn't being received any longer. Rivers hasn't exactly lost the locker room yet, but the guys on the team haven't necessarily gotten along with each other in the recent past either. With free agency coming up this offseason, the Clippers could face the loss of many of their key pieces to the club. When the season began, it looked as if the shot the Clippers had to win that championship had a great chance to come to fruition. # Hot Spring in Chile May Show

Two geo-scientists at Arizona State University have made a discovery among hot springs in Chile that may spur scientists to revisit a location on Mars explored several years ago by NASA's Spirit rover. The discovery involves fingerlike structures that form in the hot spring deposits by processes that combine biological and non-biological activity. The Chilean hot springs are at a place called El Tatio and lie at the edge of the extremely dry Atacama Desert, one of the best "Mars analog" sites on Earth.

Co-authors Steve Ruff and Jack Farmer, of ASU's School of Earth and Space Exploration, report that El Tatio produces silica deposits with structures influenced by living organisms that appear nearly identical to those found eight years ago by Spirit in Gusev Crater on Mars. Their report was recently published by Nature Communications. The question naturally arises whether what Spirit found on Mars might also have been influenced by life. "Mars exploration has reached a stage where we can start looking for biosignatures," says lead author Ruff. On Earth, fossils are an everyday example of a biosignature of past life. But biosignatures can take more subtle forms such as organic molecules trapped in rocks. Biosignatures can also include physical structures such as compacted mats of microorganisms called stromatolites, found in various environments on Earth.

No lander or rover on Mars has yet detected any fossils. So scientists assume that any Martian biosignature would be small-think microscopic-and difficult to identify, let alone even find, on a planet with as much surface area as all of Earth's land areas.

In 2007, NASA's rover Spirit was exploring next to an eroded deposit of volcanic ash dubbed Home Plate in the Columbia Hills of Gusev Crater on Mars. The rover's right front wheel motor had failed, and as the rover dragged the stuck wheel like a plow across the ground, it uncovered a rich deposit of pure silica surrounded by outcrops also rich in silica. This is a mineral commonly found in hot springs and geysers like those in Yellowstone National Park.

Several years later, Ruff learned about the El Tatio hot springs from a scientific journal. The hot springs are among the highest known active thermal springs on Earth (over 14,000 feet). At night, even in summer, temperatures at El Tatio often drop below freezing, and by day lots of ultraviolet light from the Sun comes through the thin, dry air.

"We went to El Tatio looking for comparisons with the features found by Spirit at Home Plate," says Ruff. "Our results show that the conditions at El Tatio produce silica deposits with characteristics that are among the most Mars-like of any silica deposits on Earth."

These characteristics compare favorably with the Martian Home Plate silica outcrops, Ruff explains. "The fact that microbes play a role in producing the distinctive silica structures at El Tatio raises the possibility that the Martian silica structures formed in a comparable manner-in other words, with the help of organisms that were alive at the time." •




