The name Charles Hopper may not be all that well known. This is a bit surprising here In the South Bay because he was of such great importance to the area.

Specifically, Mr. Hopper was a very successful real estate developer.

He founded the City of Lawndale in 1905 (named after a Chicago suburb with which he was familiar). After a lack of initial sales, he planned another "opening day" in February 1906, which brought the first settlers. Then, in May 2006, an additional subdivision opened just east of the first, named "Lawndale Acres." There is, however, even more to Mr. Hopper's accomplishments. He was one of the five individuals who pooled resources to form the Inglewood Park Cemetery Association. We know this site today as the languid and beautiful Inglewood Cemetery with its many angel statues. Years later, he became President of the Association and helped to make it much more successful. He also was instrumental in organizing no less than the Automobile Club of Southern California. As to the City of Lawndale, which he founded, its motto is the Heart of the South Bay. Mr. Hopper, thank you. Let me bring you up to date: There are 31,000-plus residents, and a lot of history, in Lawndale's two square miles. This unique town is nestled near (among other great locales) Hawthorne, Manhattan Beach, El Segundo, and LAX. It is close to the beach, as well as diverse restaurants and shops.

Recreation Center was named after the historic activist and home to the annual Lawndale Blues Festival. Alondra Community Regional Park, among other amenities, has a lake frequented by ducks and swans. Rudolph Park, which has picnic areas, a playground, and sand play, is named after Larry Rudolph, who served on the Lawndale City Council for 30 years.

Now, I am not a realtor, so you should check for yourself, but my impression is that Lawndale homes are more affordable (or less unaffordable) than several other South Bay locations. Some might well say that Lawndale is a diamond in the rough. (adjacent to the park bearing her name), not to mention three high schools: Lawndale, Leuzinger, and Environmental Charter. That is an impressive list right there! Of note is that Lawndale High School was closed in 1981. In fact, a local headline at the time read, "School's out forever in Lawndale ." Not quite.

Lawndale High School re-opened in 1998, has enjoyed some remodeling since, and was awarded the California Distinguished School Award in 2009. It also houses the Centinela Valley Center for the Arts, which is a great venue and provides academic resources as well. One of Lawndale's other points of pride





Film Review

The Good Nurse: A Dark Doctor Thriller and Unnerving True Story

A killer nurse's trajectory from doctor's scrubs to handcuffs is depicted in the eerie crime drama *The Good Nurse* (now streaming on Netflix). Based on the true story of Charlie Cullen's 16-year crime spree – which included the murder of at least 29 hospital patients and up to 400 additional victims – the film details the horrific events that led

While initially optimistic about Charlie's addition to the hospital staff, his presence is overshadowed by the mysterious death of two patients. These unnatural circumstances lead the hospital's senior staff to involve state police and an external investigation into their causes of death is quickly launched. The two detectives assigned to the case, Danny Baldwin (Nnamdi Asomugha) and Tim Braun (Noah

to his eventual arrest. Directed by Tobias Lindholm, whose previous credits include screenwriter on 2021's Oscar-winning film *Another Round* and writing the teleplay for one of Netflix's most binge-able crime series, *Mindhunter*.

Academy Award-winning actor Eddie Redmayne transforms himself into the 40-year-old sociopath Charlie Cullen. Having bounced around from hospital to hospital throughout his questionable tenure as an ICU nurse, he lands on the floor of a hospital in Central New Jersey in 2003. Here, he meets fellow ICU nurse Amy Loughren (Academy Award-winner Jessica Chastain), a compassionate woman and single mother of two whose own struggle with her health is becoming life-threatening. Amy immediately takes to Charlie's sweet disposition and kind nature, and his goodwill extends beyond that of just a colleague. Their relationship quickly goes from co-workers to friends, staying purely platonic but genuinely invested. However, Amy soon discovers that Charlie's projection of being a good guy isn't necessarily true for everyone he meets.





Seniors New Options for Affordable Insulin

(BPT) - In the United States, there are 37.3 million people with diabetes. And for many, diabetes is an expensive and complex medical condition, often requiring multiple medications - including insulin - and regular doctor visits. In fact, diabetes is the most expensive chronic condition in the nation, according to the Centers for Disease Control and Prevention (CDC). The annual cost of diagnosed diabetes is an estimated \$327 billion - and climbing.

Medicare Part D has helped seniors and other Medicare beneficiaries save billions of dollars on their prescription costs over the last two decades. But still, Kaiser Family \$1 billion in 2020.

In March 2020, Centers for Medicare & Medicaid Services (CMS) announced a new Part D Senior Savings Model for Medicare beneficiaries who use insulin. Plans voluntarily participated in this model to provide seniors a low, stable, predictable insulin copay. This helped members who did not already receive Extra Help and were enrolled in participating Medicare insurance plans with prescription drug coverage. Their monthly out-of-pocket costs for insulin reduced to \$35 or less per covered prescription during three phases of coverage: the deductible phase, the initial

2023 changes from the Inflation **Reduction Act**

In 2023, broader changes to help make insulin more affordable will take place, implemented by the Inflation Reduction Act. All Medicare beneficiaries with prescription drug coverage, regardless of income, will pay a maximum of \$35 for a one-month supply of covered insulin products through all four phases of drug coverage.

While a \$35 cap has been in place for most UnitedHealthcare plans with prescription drug coverage, in 2023 it will be extended to all members across all Medicare Advantage plans with prescription drug benefits and stand-alone Part D plans.

EMPLOYEES AND POSITIONS IN THE SERVICE OF THE CITY FOR FIS-CAL YEAR 2022-2023; INCLUDING THE INGLEWOOD TRANSIT CONNECTOR (ITC) GRANT FUNDED TRANSITIONAL **APPOINTMENTS AND REPEALING ALL** PREVIOUS ORDINANCES OF THE CITY IN CONFLICT OR AT VARIANCE HERE-WITH: THE CITY COUNCIL OF THE CITY OF INGLEWOOD, CALIFORNIA, DOES ORDAIN AS FOLLOWS:

SECTION 1.
