A Food Delivery Robot is at LAX



NomNom is a cargo robot that is able to carry up to 40 pounds of food at a time as it follows behind delivery staff from AtYourGate, which delivers food ordered via LAX Order Now. The robot can move at speeds up to 6 mph and uses a series of cameras and sensors to recognize and follow its handler throughout the airport. Chasing Napoléon Bonaparte

In 1940, when Adolf Hitler arrived to play tourist in the newly conquered city of Paris, his favorite photo op took him to the Left Bank and the massive dome of Les Invalides, gazing down at the tomb of the nineteenth-century French Emperor, Napoléon Bonaparte. It was the greatest moment of Hitler's life—he would later say—when he finally came face-to-tomb with his spiritual idol.

Today, most would agree that Hitler's legacy has vanished into nothing more than a dirty stain on the pages of history. There are no monuments to his military victories, because they all eventually ended in failure. His legal code dissolved into a nightmare of thuggery and opportunism, and his squeaky-clean social revolution lost all credibility in the snows of Stalingrad and the ovens of Auschwitz. You can travel virtually anywhere Hitler conquered—or came to play tourist—and you'd be hard-pressed to find a trace of the man.

In the nineteenth century, on the other hand, it can be argued that Europe made the modern world; that the French, more than anyone, made Europe; and that Napoléon made the French.

Most famously, there were the military victories and Napoléon's complete re-write of the laws of military strategy. There was his destruction of the guilds and feudal systems that had stifled invention and commercial competition since the Middle Ages. There was the common-sense Napoleonic legal code that, even today, governs a huge chunk of the planet. There was the fervor of nationalism that, for better or worse, has become the key to world governance. But mostly, there was the sense that individual merit—and not birth or class—should be the

sole determinant of a human being's worth and social mobility.

Not that everyone remembers the Emperor so fondly. From the minute the Mob stormed the Paris Bastille on July 14, 1789, they set off a wave of war, revolution, and terror that would engulf all five continents well into the twentieth century. The British, Austrian, and Russian aristocracies threw everything they had into holding back the modern era, and if it wasn't for Napoléon, they might have succeeded. This is the reason the Emperor's sarcophagus at Les Invalides—fashioned from huge blocks of Russian quartzite and French granite and marble—feels a bit gaudy and overdone to celebrate a mere human being—yet woefully inadequate to memorialize the impact of Napoléon Bonaparte.

So... What about the human being at the eye of this hurricane of energy? Who, what, and where was he? How can we as travelers

get a feeling for the ages that made him and the forces he encountered, latched onto, commanded, and unleashed? After growing up in the shadows of Waterloo, we've spent a lifetime chasing Napoléon's story through the ancient Europe he disrupted and the modern world he did so much to create. A handful of the many stops along the way:

Ajaccio, Corsica.

The neighborhood where Napoléon was born into a large and happy bourgeois family was anything but uncomfortable. But it was much too small, dull, and conventional for a man of his talents. Once Napoléon became Emperor, he sent plenty of money and public works home, but never gave a thought to returning himself.

Toulon, France.

The first test of Napoléon's organizational genius, which he passed with spectacular

Belle Mixes Beauty and The Beast with the Metaverse

When Mark Zuckerberg recently announced Facebook's plans of creating a virtual reality – "The Metaverse" – to the world, I immediately thought of the online virtual parties that I "attended" during last year's Sundance Film Festival. My user-created avatar mingled with other online avatars "at the bar" and "on the dance floor," but in reality, I was simply navigating my character from the comfort of my couch. I thought to myself, "This future is kind of a bummer." But as the new movie *Belle* shows, maybe I just wasn't in the "right" virtual reality.

In this new mesmerizing animated film, Academy Award-nominated director Mamoru

safety online. Determined to restore peace within "U," Belle takes it upon herself to uncover the identity behind the Beast, hoping that by knowing that while second chances are hard to come by in reality, everyone can start over in "U."

Hosoda shows us that not all virtual societies are awkward fantasy lands. Distributed by legendary Anime production company GKids, *Belle* is a cautionary tale about the joys and dangers that can be experienced as we all continue to grow up using immersive social media.

Painfully shy schoolgirl Suzu is the embodiment of adolescent insecurity. Having lost her mother as a child, she has always struggled to live a fully secure life. That changes when she downloads the app "U," a fully immersive virtual society that boasts over 5 billion users. Through "U's" advanced technology, Suzu's hidden strengths in the real world are used to create her online avatar. And so, she gets the confidence that she so desperately lacks in the real world to excel in an alternate, online one.

She creates the avatar "Belle": a beautiful, fairy-esque woman with cotton candy hair and the voice of an angel. As Belle, Suzu dazzles everyone with her charm and talent. She makes the other avatars feel good about themselves, and in turn, she begins appreciating and embracing her individuality within the metaverse.

Her connection gets disrupted when a cyberbully known as "The Beast" begins trolling the other avatars and threatening her

themes of bullying, friendship, and forgiveness and presents them through the lens of future-facing technology which feels like an optimistic, albeit slightly naive, view of the upcoming digital trends.

Having sat through the film completely enthralled with the complexity and beauty of this make believe virtual reality, I'm more open to giving avatar parties another chance. And with the news that this year's Sundance Film Festival is going completely virtual this year, I may just have my chance.

Belle is in theaters this Friday, January 14.

Need A Career Boost? Try An Accelerated Degree

(BPT) - Amidst dramatic shifts in the national workforce and ever-changing job market, those in or entering their careers without formal education face an uphill challenge.



Sweet Potato Bake

- 16 ounces fresh sea scallop, cut in quarters
- 8 ounces frozen cooked peeled large shrimp, thawed
- 1 can (10 1/2 ounces) Campbell's® Condensed Cream of Shrimp Soup
- 2 tablespoons chopped fresh parsley

Directions

- **Step 1:** Cook and drain the spaghetti according to the package directions. While the spaghetti is cooking, heat the oil in a 12-inch skillet over medium heat. Add the broccoli, celery, onion, mushrooms and garlic and cook for 3 minutes, stirring occasionally.
- **Step 2:** Season the scallops and shrimp with salt and pepper. Add the scallops and shrimp to the skillet and cook for 3 minutes.
- **Step 3:** Stir in the soup and parsley and heat to a boil. Reduce the heat to low. Cook for 5 minutes or until the shrimp and scallops are done. Season to taste. Serve over the spaghetti.

Tip

- **Do I have sea scallops or bay scallops?** - The easiest way to tell the difference is by size- sea scallops are about 1 1/2 to 2 inches across, and bay scallops are about 1/3 that size. We call for sea scallops cut in quarters in this recipe, but you can also use bay scallops and put them in whole!

how they may affect your career outcomes.

Generally, it takes a minimum of four years to attain a bachelor's degree and an additional two years to graduate with a master's. An accelerated program allows learners to shorten the time it takes to attain either of these degrees. Summary of Adoption of Ordinance 2228 Setting the Compensation of the Mayor and City Councilmembers Commencing January 1, 2023
Pursuant to Government Code section 36933(c), the following constitutes a summary of Ordinance No. 2228 which will be considered for adoption by the City Council at its regular meeting on January 11, 2022 at 6:00 p.m. Pursuant to California Government Code section 36933(c)(1), the City Council has previously directed the preparation and publication of a summary of Ordinance Nos. 2228 which will set the compensation of the mayor and city councilmembers commencing January 1, 2023.
Ordinance No. 2228 sets a new compensation for mayor and city councilmembers as follows: **Pursuant to California Government Code section 36516, the councilmembers' salaries were established in 2001 at \$600 per month. Government Code section 36516(a)(4) authorizes an increase in said salaries up to 5% for each year. The mayor and councilmembers may increase their salaries 100% since they did not vote for an increase in 20 years. Ordinance No. 2228 would bring the new monthly salary for each councilmember to \$1,200 per month. Under Government Code section 36516.5, the said salary increase will become effective on January 1, 2023, after the November 3, 2022 general election.**
This proposed ordinance is not a "project" under the California Environmental Quality Act. portable signs, signs placed on public utility poles, flags, banners, video screens, cold air balloons, electric message boards, projections of commercial messages, inflatables, light emitting diode signs of a commercial nature and building wraps) visible from any public street are prohibited, except for signs that have a valid permit issued pursuant to the Inglewood Municipal Code. Except as otherwise provided in this paragraph, mobile advertising (including, but not limited to, signs on or attached to a "mobile unit," portable device or person) is prohibited. Notwithstanding the foregoing, buses, taxicabs, and other delivery vehicles that display advertising as a secondary use of the vehicle in the ordinary course of business, may travel within the Event Zone to pick up and drop off passengers and goods.
b. The sale or distribution of merchandise that violates state or federal laws, including without limitation counterfeit merchandise may result in the suspension or revocation of a permit issued by the City and prosecution under any applicable state or federal law.
SECTION 4. Violations and Penalties.
A violation of this Ordinance shall be subject to an administrative citation with a fine in the amount of \$100 for a first violation, \$250 for a second violation, and \$500 for a third or subsequent violation. Each day that a violation is permitted to exist shall constitute a separate offense. Penalties or fines assessed hereunder shall be in addition to any other penalty or remedy provided by law, including without limitation, the abatement of the violating condition, injunctive relief, or suspension or revocation of any permit or license.

Notwithstanding the foregoing, and at the discretion of the City Attorney, any violation of this Ordinance, which does not involve sidewalk vending of legal merchandise, may be prosecuted as an infraction or misdemeanor.
SECTION 5. SEVERABILITY.
If any section, subsection, subdivision, paragraph, sentence, clause, phrase or word of this ordinance, or its application to any person or circumstance, is for any reason held to be invalid or unenforceable, such invalidity or unenforceability shall not affect the validity or enforceability of the remaining sections, subsections, subdivisions, paragraphs, sentences, clauses, phrases or words hereof declared invalid or unenforceable.
SECTION 6. The City Clerk shall certify to the approval, passage, and adoption of this Ordinance by the City Council and shall cause the same to be published in accordance with the City Charter; and thirty days from the final passage and adoption, this Ordinance shall be in full force and effect.

ORDINANCE NO. 22-04
AN ORDINANCE OF THE CITY OF INGLEWOOD, CALIFORNIA DESIGNATING CERTAIN PORTIONS OF THE CITY AS AN "EVENT ZONE" IN ORDER TO REGULATE CERTAIN ACTIVITIES IN CONNECTION WITH SUPER BOWL LVI AND RELATED EVENTS
WHEREAS, Super Bowl LVI will be held at SoFi Stadium in the City of Inglewood on February 13, 2022; and
WHEREAS, the National Football League (the "League") owns, produces, and controls the Super Bowl; and
WHEREAS, NFL Properties LLC ("NFLP") or, together with the League, the "NFL," along with other NFL Affiliates, owns, produces, controls, and licenses certain events associated with the Super Bowl; and
WHEREAS, the Los Angeles Super Bowl Host Committee ("Host Committee"), a California nonprofit, will serve as the liaison between the NFL and the Los Angeles region to harness Super Bowl LVI-related opportunities to elevate the community; and
WHEREAS, the Host Committee has established the Super Bowl LVI Business Connect program to connect experienced, event-ready Los Angeles County businesses with opportunities to compete for contracts for Super Bowl LVI related events ("Official Events"); and
WHEREAS, the Business Connect program is committed to supporting minority, women, LGBTQ+ and veteran owned businesses through professional development, networking, and contract opportunities for Official Events; and
WHEREAS, in addition to SoFi Stadium, the

City also has within its jurisdiction various other facilities and their premises, and public rights-of-way which may be used for the purposes of organizing, promoting, accommodating, staging and conducting Official Events; and
WHEREAS, the Official Events will attract many visitors to the City, and the number of people attending the Official Events will greatly exceed the typical number of people attending events in the City; and
WHEREAS, the Official Events will enhance community involvement by getting local businesses and volunteers involved; and
WHEREAS, given the large scale of the Official Events and the large number of people attending or participating in the Official Events, the City will need to adopt certain regulations concerning temporary structures, the outdoor sale or distribution of goods or materials on streets, sidewalks, and other public rights-of-ways, and temporary outdoor advertising displays visible from public streets in the vicinity of the Official Events in order to prevent congestion, litter and other obstructions to vehicular traffic, pedestrians, and emergency services vehicles and personnel; prevent line of sight obstructions; easily identify and investigate unclaimed/suspicious packages and vehicles impacting public safety operations; protect the security of the Official Events; and protect the health and safety of the public; and
WHEREAS, with respect to the COVID-19 health and other potential public health issues, the City may separately address and implement necessary regulations and recommended precautions as established by the Centers for Disease Control or applicable

Public Health Agency, to protect the public health and safety of persons attending the Official Events; and
WHEREAS, to that end, it is necessary to identify "Event Zones" also known as "Clean Zones" and establish a temporary Event Zone ordinance in the areas of the City which are in proximity to or impacted by the Official Events scheduled to occur during the time periods and within the specified boundaries designated in this Ordinance; and
WHEREAS, based on the foregoing, the City has a substantial interest in adopting the temporary regulations in this Ordinance, which shall be effective only during the specified dates and within the specified boundaries set forth herein; and
NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF INGLEWOOD, CALIFORNIA, DOES ORDAIN AS FOLLOWS:
SECTION 1. The Recitals set forth above are hereby adopted and incorporated into the body of this Ordinance as if fully set forth herein.
SECTION 2. Event Zone Boundaries.
In order to prepare for, host, and demobilize the Official Events, all property located on or within the boundaries as depicted in the map attached hereto and incorporated herein as **Exhibit A**, including public rights-of-way are hereby designated as an Event Zone.
SECTION 3. Event Zone Regulations. The regulations set forth in this Ordinance shall be in effect in the Event Zone beginning at 6 a.m. on February 10, 2022, and ending at 6 p.m. on February 15, 2022.

results. The port had gone over to the Royalists and the British, and the French Revolutionaries were little more than an ineffective, if energetic, rabble. From the heights above the city, you can easily picture how Napoléon's leadership and re-invention of the role of artillery sent the traitors and foreigners packing and made him a French national hero.

Colle del Gran San Bernardo, Switzerland.

At 8,100 feet above sea level, the Great St. Bernard Pass through the alps of southern



Ambition in Paris—third-floor walk-up and a junior officer's commission.

Switzerland has become the standard for vicious weather, stranded travelers, and large, fluffy rescue dogs with casks of brandy tied around their necks. With superb organization and immense personal courage, Napoléon

personally shoved 40,000 troops through a gauntlet we'd never dream of driving off-season. The Austrians were just as shocked when he pounced on their armies on the Italian plain of Marengo, just north of Genoa.

Palais des Tuileries, Paris, France.

From the beginning, Napoléon scorned Versailles and everything it stood for at the heart of the despised and fossilized Ancien Régime. Every one of his major political acts was approved by a plebiscite, however sketchy. So when he took power, his favorite palace sat right in the center of the noisy Paris Mob, between the Louvre and the Tuileries Gardens. In the Commune of 1870—the revolution that started Karl Marx on his lifelong quest for disruption—Napoléon's old palace was deliberately burned to the foundations.

Austerlitz, Czech Republic.

If you hope for grand, lasting monuments to your military triumphs, don't pile up your victories in enemy territory. Napoléon's two greatest battles, here and at Jena-Auerstedt in Germany, are barely marked on the ground, yet figure in any textbook on military strategy. Before Napoléon, armies would meet, too many soldiers would die, and the loser would vacate the field of battle with his forces more or less intact. Napoléon changed all that when he made it his objective to pursue enemy armies to utter destruction.

Notre Dame de Paris, France.

When Napoléon took the imperial crown out of Pope Pius VII's hands and placed it on his own head and then on Josephine's, he ended the relationship between the Roman Catholic Church and imperial power that had existed since the Middle Ages. The church went from infallibly pronouncing God's

judgment on our mortal affairs to serving as just another propaganda tool for propping up the French imperial regime.

Rueil-Malmaison, France.

The Château de Malmaison is one of the most beautiful palaces in France, a delicate symphony in blond sandstone amid forests, meadows, orangeries, and exquisitely scented rose gardens. Joséphine de Beauharnais bought the property and nearly bankrupted her husband while turning it into a luxurious haven away from the noise of Parisian politics. Napoléon gave Joséphine the estate in their divorce, then retreated here himself after the final defeat to nurse his regrets and await the judgment of his enemies.

Waterloo, Belgium.

Napoléon nearly always faced armies far larger than his. His other contribution to the art of war was to split those enemies and out-maneuver and attack each component before they could combine. The strategy worked brilliantly, until the Duke of Wellington adapted Napoléon's own artillery tactics at Waterloo to hold out and await the arrival of his Prussian allies. The greatest cavalry commander of the age, Maréchal Michel Ney, led one lunatic charge after another at the British guns, but failed to die the heroic death he so desperately desired. By the end of the day, the famous French martial élan—the spirit that had burst out of France in revolution and then sustained an Empire for the ages—was utterly crushed.

And on the Silver Screen...

Eleven years of nonstop warfare sent the exhausted Emperor into permanent exile on the British island of Saint Helena in the South Atlantic. As much as the world had respected and, in many cases, loved the man, the sighs

of relief could be heard from one capital to another, including in Paris. This is the point in time where the four-part 2002 mini-series "Napoléon" takes up the story, with the deposed Emperor casting his thoughts back through the public and private extremes of his life. No one movie can entirely explain the Napoleonic phenomenon, but if you're looking for a pre-travel introduction to the man and the country and continent he so dominated, you could do much worse.


