

After 29 Years, El Segundo's **Still Feeling Lucky**

Since the early 1990s, Lucky's has been a staple of El Segundo, supplying the community with fresh baked pastries, donuts, coffee and lottery tickets non-stop.

The shop's owner, Seng Fou, opened the donut shop with her husband, Than Chau, with one goal in mind—to run a successful family business with the skills passed down to her from years of experience.

"When we were looking for a donut shop to open, we just drove around and stumbled on El Segundo. We saw the area, we loved it, and so we bought it." says Fou.

From behind the counter, her daughter, Brenda Chau, chimes in and adds some context to her mom's statement.

"We actually live in Long Beach, and at the time, my parents lived in Orange County when they opened the business."

Brenda, who is currently a student at Cal State Long Beach, studying Criminal Justice, shares that "it was already a donut shop when [they] took over."

"There used to be a gas station here a long time ago, but they tore it out and built a shopping center instead. The area has changed a lot, especially the people, but everyone is so nice—the changes keep us busy," Fou explains.

Staying busy is understatement. According to Brenda, her mom works seven days a week, baking twice a day with her father and brother, Kevin Chau, working the night shift.


"So my dad bakes at night time, and my mom hired a person to bake here in the early mornings before she comes in," says Brenda. "Our donuts are always fresh we bake them at around 8 AM. It's the best time to come—when the donuts are still warm."

But even after the morning crowd gets their fix, Lucky's gets a second wind from local officers and travelers leaving and entering the city.

"At night, all the customers are from the

I hear, the El Segundo police always stop by. For some reason, they don't come by in the morning, but at night they always stop in. It must be because our coffee is pretty good, too."

Along with delicious coffee from Farmers Brothers mixed with a few different blends, their top donut sellers are Glaze and Maple Longs. Fou even claims that she prepares and goes through more than "a hundred ham & cheese croissants a day."




Check It Out

Film Review

Sundance 2020: The Assistant is a Gripping Thriller for the Harvey Weinstein Era

A day in the life of an overworked and under-appreciated production assistant plays like a silent horror film as she becomes increasingly aware of her boss's inappropriate transgressions - and the company's feigned ignorance - in Kitty Green's third Sundanceselected feature, The Assistant.

The film's protagonist, Jane (Julia Garner), is a reserved yet whip-smart young woman florescent lights all add to the hyper-realistic nature of the story, really placing the audience in the office with Jane. Bare and constrained, the film's soundtrack is also delicate, much like our protagonist. Composer Tamar-kali uses sparse piano sequences and strings to convey a sense of fragility. Director Kitty Green's dedication to the ASMR aspect and absence of a large orchestral score is subtle and the perfect choice for this type of film.

who endures verbal and emotional abuse within the culture of an unnamed NYC production company. As the film opens, it's immediately clear that she is the backbone of the company, keeping the office running in a timely and orderly fashion. Despite her dedication to her position, the office environment is very much a "Boy's Club." She deals with the disparity by keeping to herself and excelling where she can, usually in solo office projects and menial tasks. But when water cooler gossip circulates that the boss is engaging in inappropriate acts with the company's newest intern (Kristine Froseth), Jane is faced with the reality that speaking up for what's right could risk her dreams of "making it" in the film industry.

Julia Garner (Ozark) quietly commands the film as Jane, her performance is steadily impressive and authentic. Co-star Matthew Macfadyen (Succession) plays the intentionally ignorant HR representative with his signature "nice guy" demeanor despite sneaky intentions. In a unique display (and much to my delight), The Assistant is very ASMR heavy. It's a fairly quiet picture and largely dependent on setting up scenes with ambient sound and sound effects during Jane's solitary moments. The deep cleaning, office equipment, and buzzing of

The takeaway from *The Assistant* is a subtly gripping and timely portrait of power in the #MeToo/Harvey Weinstein exposé era. But as the workplace culture of The Assistant shows, there is still a long way to go before toxic masculinity and improper balances of power are halted and support is given to those brave enough to bring powerful predators to conviction. Kitty Green's defiant drama is the encouragement we need right now. The Assistant opens in select theaters this Friday. •

"With a small business like this," says Fou, "you have to be here all the time. Especially with food—you can't trust other people to be as dedicated, so it's a big job that I handle, but I love it. My husband and I have to be here all the time."

Funny enough, when Fou came to Los Angeles, she met and married Than who was already a baker. With her roots extending from China, her parents fled the rise of Communism only to wind up in Cambodia during the reign of Pol Pot and the Khmer Rouge. Luckily, Fou's older brother moved to California first in 1983 and set up his own donut shop before she arrived five years later. When she settled in, her brother gave her a job. Who knew that she would one day carry on that tradition with her own family?

"First, I learned from my brother, and he put me straight to work. Then I married a guy who was a baker-we started looking for our own donut shop and landed here," says Fou.

When asked if she would continue to carry on the family tradition, Brenda smiles and shakes her head.

"I'm not sure because I have plans of my own. I want to go into the FBI—I can't work like my mom. My mom is a very hard worker, but I'll still come in and enjoy the food."

Not only does the family crank out fresh

donuts on a daily basis, but they even manage to give back to the community by partnering with local restaurants, like Britt's BBQ, supplying them with desserts for their patrons.

"They always order Bavarian cream donut holes from us to serve as desserts," Brenda explains. "And we also donate lots of baked goods to the high school whenever they have breakfast events or community gatherings."

Before heading out, Fou goes on to share that she never took her husband's last name, clearing out the confusion about their Fou and Chau namesakes.

"I kept my last name because I didn't like my husband's," Fou laughs. "But we both agree on Lucky's-it's something we both feel being here."

Lucky's is open seven days a week, 24 hours a day with baking times at 8 AM and 8 PM-those are the windows to try it for yourself. •



Your Neighborhood Therapist

Dear Neighborhood Therapist: My partner is only speaking in rhyme and it is upsetting my parents. My friend is obsessed with taxidermy and it is embarrassing me. My child wears a three-piece suit to middle school and is getting bullied. What should I do? Is this normal?

- J. Q. Public, El Segundo

Is this normal? It is a simple and common question that usually comes from one of two places. The first is a concern that our own behavior or that of a loved one will invite mistreatment, bullying, or worse. The second is a desire to win an argument: we want our own position to be the "normal" one, as if normality equals morality and worthiness.

I hope you see it as good news that even if I had some authority on what "normal" is, I don't think devotion to normality will solve much, and I would never suggest pursuing it for its own sake.

While being "normal" can certainly make life easier, I'm not convinced that it's something we should aspire to. When we consider that smoking on airplanes, not wearing seatbelts, corporal punishment, bloodletting, perms, and popped collars were at one point considered "normal" by many people, it's a safe bet that future generations will look back on us today and shake their heads at much of how we live our lives.

We reserve some of our worst treatment for young people when it comes to "normality." Our institutions are set up to funnel them into silos of "acceptable" attire, interests, body type, activities, and ways of thinking. Some

argue this helps immunize them to a harsh world that will judge them and sanction them. "You will be bullied if you don't conform" is a powerful, effective message. It's also easier than saying, "I will stand with you."

Perhaps a better question than Is this normal? would be, Is this a problem? Assess whether it is harmful, including whether or not it is worth the social pushback. If it is a serious problem, then by all means work to make a change.

But perhaps your loved one will say, "I really love unicycling down Main Street wearing a polka-dotted tophat on Sunday afternoons. I know people will make fun of me, but I can take it."

So, what should you do? As usual, I have questions. If it's not harmful, and if it is worth the social pushback, then can you stand with them and support them? If you cannot do it, can you help them find people who are able to? Can we all look in the mirror and decide whether or not we want to be enforcers of normality or the enablers of diversity and, just maybe, a work of genius or two?

Summary of Adoption of Ordinance 2195 Enacting Section 2.41 of the Hawthorne Municipal Code ("HMC") Re: the Estab-lishment of the Reserve Police Officer

Program.
Pursuant to Government Code section 36933(c), the following constitutes a summary of Ordinance No. 2195 which was unanimously adopted by the City Council at its regular meeting on California Government Code section 36933(c) (1), the City Council has previously directed the preparation and publication of a summary of Ordinance No. 2195 which adds Section 2.41 to the Hawthome Municipal Code establishing

the Reserve Police Officer Program.

The Hawthorne Police Department supplements its complement with the Reserve Unit, which consists of police officers who are civilian members of the community, and who receive limited compensation in return for performing the functions of swom police officers. The reserve police officers assume all duties and privileges which are vested in regular police officers while on assignment. Reserve police officers are not exempt from the responsibilities charged to regular police officers by the Department, and are held to standards of conduct enumerated in the Hawthome Police Department Policies and Procedures Manual.

California Penal Code Section 830.6, et seq. sets forth authority to form a reserve unit, and provides guidelines and requirements for the designation of reserve officers. These designa-tions govern the scope of authority and duties of reserve officers. Section 830.6 requires a duly enacted ordinance that grants the Chief of Police the authority to appoint reserve officers to certain level designations. Ordinance 2195 fulfills the requirements of Section 830.6. The City Council finds and determines that there is no possibility that the adoption of this Ordinance will have a significant effect on the environment. Accordingly, this Ordinance is not subject to the requirements of the California Environmental Quality Act (CEQA) pursuant to Sections 15061(b)(3) and 15378 of Division 6 of Title 14 of the California Code of Regulations A certified copy of the entirety of the text of Ordinance No. 2195 is available both on the City's website and also in the office of the City Clerk, 4455 West 126th Street, Hawthome, California, and is open for public inspection.
