

An Uncle With A Few Dollars

Mike Talleda was nine years young. He, his mother (who was then 8-1/2 months pregnant), his father, and his siblings boarded a plane and flew out of Cuba. They came to Southern California, specifically Alhambra, California. "We were, and we remain, anti-Castro. We have a deep pride in being Americans. This country is the last best hope. So much good can be done here for so many."

I am sitting with Mike at his real estate

McDonnell, the widow of Michael McDonnell, who perished in one of the towers. "We explained what we planned to do, and she was on board. I think she understood that we needed to do this for our own mental state too."

A golf tournament was held on November 29, 2001, and \$10,000 was raised.

"We gave \$7,500 to Cheryl, and \$2,500 to Windows of Hope, a fund created to help the families of the culinary and maintenance

The family eventually moved to the South Bay. By age 23, Mike had a real estate license and came to work in the Hawthorne-Lawndale area. By 25, he was the manager of a real estate office, and at 27 obtained his real estate broker's license. He was then the youngest broker here. There were good, good times, and Mike's business grew, including quite a few agents. However, the economy took its toll, and by the early 1990s, Mike tells me, with a wry smile, "All the help left. Many went back from where they had been, such as Northrop Grumman."

Undaunted, Mike continued in the real estate field until so much changed on that fateful, infamous day: September 11, 2001. At that historical moment, he wondered how he could help a family who had lost a loved one. "If by some miracle we could pull it off, maybe we could show others – with real resources – what was possible, and maybe we could motivate them to help as well." Mike was introduced to a family: Cheryl workers who died that terrible day.

A few days later, we received a beautiful letter from Cheryl. Let me show you; I have it here, framed on the wall. We thought if we can have this impact on a person whose world has been shattered, what else is possible?"

It is now been going on for 22 years. Walking around Mike's office, I realize it is not a real estate office at all. It is the home of Wounded Heroes of America (abbreviated WHOA), and he is the ship's captain.

Mike puts in, on average, 50 to 60 hours a week. The walls are filled with photos, accolades, certificates of appreciation, and paddles (from Navy Seals, no less), among other items, to commemorate this man's and WHOA's devotion to helping those who have lost a loved one, or suffered a serious injury, be it physical, psychological or both, while serving the country.

(Note to the readers: If I step out briefly from the role of communicating a story. I want to share with you that Mike Talleda has been on a mission since the Fall of 2001.

He is not slowing down. I have to focus on what he tells me and take down what I am hearing and learning, but I am getting lost in my admiration and emotion about what he is sharing. Ok, back to the column.)

The work Mike and his helpers have done evolved. It began with assisting those adversely impacted by 911. Soon the group raised funds for those who lost loved ones serving in special forces and those who lost limbs or suffered trauma, illness, or serious injury. Since 2004, Mike's group has officially held non-profit 501 status. The focus has become assistance to conventional service members. One of the programs provides a monthly stipend, for example, to a young widow whose husband was killed in Afghanistan.



<u>Check It Out</u>

The Integrity of Joseph Chambers is a Psychologically Thrilling Backwoods Drama

If a tree falls in a forest and no one is around to hear it, does it make a sound? Or, in director Robert Machoian's case, if a man murders another man in a secluded nature preserve and no one sees it, is he guilty? Exploring themes of personal accountability and masculine fragility told through an intimate lens, The Integrity of Joseph Chambers is a methodical study of human behavior and the self-preservation tactics we default to when

Robert Machoian's previous feature film, 2020's Sundance-selected drama *The Killing of Two Lovers*, offered an introspective look into a fraught relationship from the perspective of a scorned ex-lover. Machoian once again re-teams with his lead actor Clayne Crawford (Hollywood Critics Association Award-nominee), who played the jilted ex in the slow-burn drama. That same ethos of exploring the darker sides of man's ability to rationalize hardships is very much on display here too, in his new film The Integrity of Joseph Chambers – available in select theaters and VOD this Friday.

Here, Crawford plays Joseph Chambers, an insurance salesman who, despite being an inexperienced hunter, challenges himself to catch a deer. Believing that his manhood is on the line if he can't provide for his family with his "survivalist instincts." he disregards his wife's (Jordana Brewster) numerous attempts to get him to bring a friend along. After all, what if something happened and Joseph was out in the woods, alone?

The day starts out smoothly enough, Joseph eats his packed lunch and plays with his hunting rifle. However, things take a dark turn when he shoots at what he thinks is a deer, only to discover it was a man. This revelation causes Joseph to spiral, jumping between scenarios that involve burying the body and hiding the evidence to coming clean to the police. Either way, his life is forever changed.

This dilemma gives the film its psychologically thrilling roots. We're left to ponder - what would we do if we were Joseph? Director Robert Machoian does so much with so little; the setting is bare, and the film's entirety rests on Clayne Crawford's performance. But it is the combination of sound editing and score that gives the film life and much-needed emotional catharsis. Composer William Ryan Fritch crafts a hauntingly visceral sonic language that perfectly adds to the slow burn of the visuals. Rounding out the film's small but mighty impact are supporting actors Michael Raymond-James and Jeffrey Dean Morgan.

The Integrity of Joseph Chambers is a psychologically impactful watch that faces an ugly truth. Are we really selfish beings, capable of lying and cheating when we think there are no consequences? Or does the thought of unraveling morality cause us to feel shame, making us own up to our mistakes? That's the chilling question at the center of this layered, pointedly crafted character study.


Lou by Breanna Carzoo


Gout Causing Winter Woes? Ways to Manage the Condition

(BPT) - Many people love to travel, celebrate and indulge in favorite foods during the winter months. However, overdoing it can have a big impact on your health, especially if you have a chronic condition like gout.

Gout is the most common form of inflammatory arthritis and is caused by an accumulation of uric acid crystals in the disease, meaning it runs in families."

as well as other health conditions associated with gout, such as kidney stones or kidney disease, diabetes, heart attack, stroke and more. Amid travel plans and gatherings with family and friends, be sure to take daily uric acid-lowering medications as prescribed by the doctor. These will help keep gout flares at bay so you can enjoy activities and make positive memories.

During the winter, it's common to indulge in extra treats, including purine-rich foods like red meats and alcohol, sweets and other help with managing gout or the DASH diet (which stands for Dietary Approaches to Stop Hypertension) that focuses on fruits, vegetables and low-fat foods.

- Step 4: Season the rice mixture to taste. Serve the chicken over the rice mixture, sprinkled with the remaining tomatoes and the crumbled bacon.
