### Rain Lifts and the City Council Meets

Tuesday March 11 was full of rain and chill. Shortly before 6 pm, however, the difficult weather lifted to show a bunch of sunshine glistening on the moist foliage. With that good spirit in mind, the City Council meeting began. Invocation was presented by Pastor Greg Guich of Hawthorne's Centinela Bible Church, thanking God and praying all good things for the City.

Mayor Vargas spoke briefly (one more time) about the vital importance of decorum among the city council, the public and all officials. It is particularly good to hear the significance placed by our Mayor and Council about treating each other and the community with genuine respect and consideration.

Police Sergeant Jarome Michalczak then came forward and described an outreach to those with special needs throughout Hawthorne. Nationally some 15% have special needs. The outreach will come in the form of a sticker that can be prominently placed at residences, if not businesses, as well, so there can and will be more empathetic and meaningful interaction with those who, in any given instance, are vulnerable. One positive aspect of the sticker is to enhance protection.

Next, Jan Vogel was asked to come forward. Jan has headed the South Bay Workforce Investment Board for decades. At this point it is hard to know which superlative to afford him and his group. Mr. Vogel shared a number of the Board's programs that, thankfully, are going well. One has been the placement of special needs individuals who work as "ambassadors" at Los Angeles International Airport. He said: "The goal is

to provide a friendly face and smile to help those having issues there..." Another goal now is to get this program going even more so with the advent of the Olympics here in 2028. Jan also emphasized the apprentice programs the Board Force is behind, with over seven thousand participating in just the last few years. These programs help individuals learn good work, a trade, and in turn, assist employers with developing personnel who become that much better workers. Of interest as well is a very recent program the Board has furthered with those individuals separating from imprisonment who helped during the tragic local fires. Some have since found good work and pay. Finally, Jan talked about helping the unhoused. To date, some 15 have

come through the Board's program, at least 8 of whom have found a level of housing, and nine of whom have been working.

Erika Lampkin, Director of Human Resources for the City, expressed appreciation and praise for Pablo, the "Jailer" for the City of Hawthorne since 1999. He has not just trained many, but has proven time and again to be very dependable. It is no easy task, as Mayor Vargas pointed out, because the jail here at times will house persons from other locations where there is no such facility. Kudos to Pablo, who receives the Good Neighbor Award.

Continuing with the positivity at hand, Council member Monteiro addressed his recent See City Council, page 5



### Rule Breakers Review: Some Rules Are Made to Be Broken

Angel Studios kicked off International Women's Day by releasing the inspiring historical drama Rule Breakers. Conventional in its storytelling yet powerful nonetheless, the film is based on the true story of Roya Mahboob, one of Afghanistan's first female IT entrepreneurs. It charts her relentless determination to give young girls the opportunity to study science and break free from the country's oppressive regime. In addition to correlating to Women's History Month, Rule Breakers is releasing ahead of National STEM Week, which begins on March 14th.

Roya Mahboob (Nikohl Boosher) is an iconoclast. As the founder of Afghanistan's women's robotics team and a global advocate for women's education, she lives to inspire others. Despite her country's belief that educating girls is an act of rebellion, Roya continues to defy naysayers and critics by championing STEM in the local school system. She understands the importance of introducing kids, especially young

girls, to science. It's no secret that educating the youth is their only way out of the current social oppression.

Despite Roya's good faith attempts to modernize the country, she is continuously met with the harsh reality that not everyone wants women to have autonomy. But this doesn't deter Roya. In fact, quite the opposite. Taking matters into her own hands, she organizes a small robotics team of four high school-aged girls. Together, they create a stunning mine detection robot made from old car parts. Their invention quickly earns them global attention. With all eyes on Afghanistan, Roya finally has her moment to prove to the world why education is not just a choice, but a right.

Rule Breakers is a classic underdog story with a happy ending. Academy Award-winning director Bill Guttentag (Soundtrack for a Revolution) tells this inspirational drama with heartwarming conviction, despite its formulaic, paint-by-numbers Hollywood structure. While there is nothing inherently wrong with this execution, it does feel too conventional and safe, especially for a story about a woman known for pushing the boundaries. However, giving Roya Mahboob and Afghanistan's first robotics team a platform to share their story is a film worth watching and supporting. •


### Check It Out

### Towed by Toad written by Jashar Awan and Cranky Makes A Friend written by Phuc Tran illustrated by Pete Oswald





authorized negotiation with City Manager Vontray Norris. The key details of Mr. Norris' revised, extended employment agreement were disclosed. There was much applause in the Chamber when it became clear that the deal was done: Mr. Norris would continue as Hawthorne's City Manager until 2030. He is well respected, so effective, and Hawthorne is better because of him. Mayor Vargas talked about the vital importance of continuity and that one of Mr. Norris' attributes is his ability to courteously say "No." This quality was described as akin to a parent showing affection for their child, but standing firm so that the child does not make unwise choices. By the way. Vontray Norris is a Hawthorne native.

Felize Lopez, Hawthorne's Director of Finance, presented considerable detail about the City's budget, revenues, increases, decreases,

and delinquencies, much of which shows the positive status in which the city thankfully finds itself. There is a concern, however, with three significant projects that are going forward (such as the redevelopment of City Hall). This relates to the impact on the overall economy with the change in administrations in Washington, D.C. If issues arise, one option would be to scale back smaller projects and seek to lock in contracts that carry a 12 to 18-month fix on costs. There is one particular number in all of what Ms. Lopez discussed that invariably creates a sense of hopefulness: In 2014, Hawthorne had \$14,076,078 cash on hand; as of December 31, 2024, that sum was \$89,693,489. Quite a big increase, and that figure was even larger by the end of January this year).

Council member Johnson brought up a discussion item with respect to difficulties

and burdens caused by trash and trash bins left on public rights of way. City Attorney Robert Kim addressed some of the ways this is being dealt with, and what might make sense in the way of enhancing the current ordinance. City Manager Von Morris will work with Republic Services and report back to the Council soon.

Council member Manning is asking the city to partner with the Los Angeles Sparks (women's basketball team) for a basketball clinic on July 13 and 14 at the Hawthorne Memorial Center. The Council's approval involved a fee waiver, but just for the first year, and also to add the Sparks to the community event list for the youth of Hawthorne.

Council member Manning next asked to give a directive to the City Manager to increase the budget for Hawthorne's Façade Program. This relates to "the look" (the appearance)

This relates to "the look" (the appearance) of areas in the city. Presently those funds are to end by June 30 this year. Council member Monteiro indicated, however, that several persons have expressed disinterest in the Façade Program and that it has not been successful. Mr. Norris, the City Manager, will evaluate if there are sources of funds.

Finally, Mayor Vargas brought the City's 311 App to the fore. He is pushing to promote the app wholly. The mayor's goal is to make sure the 311 Ap is prominently displayed because it provides excellent ways for the city to communicate with the public and with the public.

In sum: A busy and productive meeting. While I think the rains will return soon, this evening at this City Council meeting, the sky was clear.

Easy and delicious, it takes less than 30 minutes to get this saucy Asian inspired skillet dish on the table. The heat comes from chili powder, garlic and picante sauce cooled off with a burst of vibrant lime juice.



#### **Ingredients**

- 1 pound medium shrimp, peeled and deveined
- 2 tablespoons lime juice
- 1 tablespoon vegetable oil
- 5 cloves garlic, minced
- 1 can whole peeled tomatoes, cut up
- 1/2 cup Pace® Picante Sauce
- 2 teaspoons chili powder
- 4 cups hot cooked regular long grain white rice


