## Everything's Going to the Dogs

There is a philosophy which insists everything that has happened played some role in whatever comes next.

Based on this theory, the very recent opening of the Hawthorne Dog Park was actually in process for thousands (and thousands) of years.

To be sure, many ask: What is it about dogs that there is a genuine industry associated with them today that is worth billions of dollars? There are pet stores (online as well as brick and mortar); a variety of dog foods; all kinds of dog toys; medicines and supplements, some holistic;

Veterinarians, some of whom are mobile; dog trainers; dog groomers; dog walkers; dog clothes and leashes; photographers (some even under water); dog artists; dog books; and dog movies. Of course, there are television shows as well. Dogs, indeed, are very popular. Some have even participated in a human wedding, bringing the ring in a little basket to the altar.

Do you have a dog? If so, chances are they are not just a member of your family, but perhaps even the most spoiled, at least at times. In our household, for now anyway, the dog is our surrogate grandchild. Recently I took him to see a movie. After it ended, the folks behind me exclaimed: "I am so amazed at how attentive your dog was - he really seemed to enjoy the movie!" To which I replied: "Surprised me too, because he so disliked the book!"

Many have wondered and expressed dismay about why dogs do not live longer.

The oft-stated answer: "People need time to figure out how important it is to love everyone and to be happy every day. Dogs already know that, so they don't have to live as long...."

The first official dog park in America is said to date back to 1979 in Berkeley, California. It was initially called "People's Park," a parcel of unused U.C. Berkeley land. The area was officially named Ohone Park, after the Ohlone Native Americans who once lived there. In time, it was renamed Martha Scott Benedict Park in honor of Ms. Benedict, a Berkeley resident and one of the leading dog park proponents (which remains a notably popular place for dogs off-leash today).

Dog parks are among the fastest-growing segment of city parks. From 2009 to 2020, there was a 40% increase in the development of dog parks. That said, getting a dog park approved in any given instance often is very challenging. The land has to be found, and serious liability, safety, and health considerations must be very carefully evaluated; residents chime in, pro and con; and then, who will maintain it? One local example that is rather telling: For years, there has been an effort to carve out a part of a beach area in El Porto for off-leash dogs, but despite genuine interest and enthusiasm, that dog park still has not come to pass.

In sum, there is controversy and concern about dog parks: They are not clean enough and can create health issues; there have indeed been far too many incidents of dog attacks; and they are just too noisy. Certainly, many

say, there is a more important use of the land than for dogs! On the other hand, dog parks provide benefits: A lot of folks just do not have an adequate yard; in fact, many live in an apartment. Also, a dog park can be social and fun for the owners. Further, dogs themselves should have time to roam and scamper. After all, dogs bring so much comfort and joy to so many of us.

You may have noticed that dog parks often have tables, chairs, benches, and trees, so we humans enjoy them as well. Let's not forget, however, that dog parks invariably have a set of clear rules, including that each owner is responsible for their canine. Aggressive behavior by dogs is not to be tolerated or condoned. Dog parks are not "free-for-alls" by any means. In addition, clean up after your dog! Shovels and cans are provided, as are baggies as needed.

Against this backdrop, just a short while ago, a dog park opened in February at the Hawthorne Memorial Center (3901 W. El Segundo Boulevard in Hawthorne). The Memorial Center is a very central location and already includes a large human park, office building, teen center, senior center, and separate sports complex, among other facilities. There is now a new, well thought-out and nicely constructed, fenced dog park today. In fact, two fenced dog areas.

There is a section for smaller dogs and a section for larger dogs; all totaled, there are some 5,300 square feet. The idea came about with the Hawthorne City Council in

## Film Review

### New Oscar Winners The Daniels' First Feature Film, Swiss Army Man

Usually, fart jokes are associated with bad raunchy comedies or really uncreative family movies. But "Swiss Army Man" will entertain audiences for its ridiculous, and now infamous, farting dead body played by Daniel Radcliffe. This is only how the film begins, and let's just say it toots even louder from there.

Paul Dano plays Hank, a man lost and alone on an island. When he's about to give up on life, he discovers the aforementioned

farting body and finds an unexpected answer to why his life is worth living. He discovers that many elements of this body can help him survive and find a way back home, and keeps himself sane (or perhaps insane) by talking to it.

As Hank develops a relationship with the dead body who calls himself Manny (one that starts out similar to Wilson in "Cast Away"), the intriguing absurdity keeps you engaged for the rest of the film. This type of film is best seen with little information beyond the initial premise, as it is full of mystery boxes waiting to be uncovered. Thanks to the great use of locations and intricately beautiful production design by Jason Kisvarday, the world-building is fantastic and the wackiness becomes downright fun.

The writer/director duo Daniel Kwan and Daniel Scheinert, collectively known as "The Daniels," have a reputation for unique and highly entertaining work, and this feature represents a conglomerate of numerous ideas that, while may sound far-reaching and absurd, somehow all work. To get a small taste of what to expect from the mind of The Daniels, check out DJ Snake's music video "Turn Down For What," and the short film "Dog Boarding."

On top of being a silly movie that doesn't pretend to take itself seriously, "Swiss Army Man" sneaks in themes of societal behavior and what is considered weird vs what is

#### Half of Men Above Age 60 Experience Symptoms of Enlarged Prostate

ones you didn't use much this year or didn't enjoy using.

- 1 cup uncooked mini lasagna noodle-shaped pasta (mafalda) or campanelle pasta
- 2 cups coarsely chopped packed baby spinach
- 2 tablespoons grated Parmesan cheese
- 1/2 cup shredded mozzarella cheese

### Directions

- **Step 1:** Heat the oil in a 4-quart saucepan over medium-high heat. Add the sausage and cook until browned, stirring often to separate meat. Pour off any fat.
- **Step 2:** Stir in the broth and soup and heat to a boil. Stir in the pasta. Reduce the heat to low. Cook for 10 minutes or until the pasta is tender, stirring occasionally. Add the spinach and cook and stir just until wilted. Stir in the Parmesan cheese. Season to taste with salt and pepper. Spoon into bowls and serve topped with the mozzarella cheese.
