# South Bay Realtor Bill Ruane Continues to Crush the Competition



# Film Review

# Tilda Swinton Captivates in *The Human Voice*, Pedro Almodóvar's Deconstructed Short Film

At just thirty minutes long (the length of a TV episode), Tilda Swinton commands every second of the small screen in Pedro Almodóvar's beautifully staged and winkingly meta new short film, *The Human Voice*.

Based "freely" off of a play by Jean Cocteau, Almodóvar takes the concept of the "one-woman show" from Cocteau's play and re-tools it to fit within the times of which he made his film, which was during the middle of the pandemic last year.

With Tilda Swinton as the film's singular character, *The Human Voice* (which was also selected to play at last year's Venice Film Festival) is a devilishly playful bit of pop-art filmmaking that sees the director combine his source material's wonderfully satiric silliness and makes it a meta viewing experience that comments on both film production and how we communicate as humans.

In *The Human Voice*, Swinton plays an actress unhinged, at first silent and vacant as she sulks about her decadent and deadening modern apartment, but then firey and alive at the sound of her iPhone ringing, her lover on the other end of the line.

Over the course of their on-off conversation (of which we only hear Swinton's side of throughout the entirety of the film) she switches from depressed and pilling boozer, to desperately needy partner, to rage-filled and scorned woman of the world all in a moment's time.

It's a high task to have to create the entirety of a world when you're acting alone, but if there's anyone in Hollywood who can do the job, it's Ms. Swinton, whose talents and stamina make the film captivating. What she does so effortlessly–communicating an entire story and relationship of a fictionalized, passionately troubled couple–is accomplished all by way of using a singular element: her voice.

And she does this with gymnastic range, pitching up her voice to harken back to old Hollywood romantic starlets, and then down-shifting gears into a lower register to convey darker colors. Her voice work on display here is as vital and deadly as any of Almodóvar's beautifully composed hardware and tools that are so artfully composed within the background.

The Human Voice does communicate a narrative story (kind of), but just as Almodóvar makes a point of regularly reminding us that the apartment is in fact a set within a soundstage, and the actor alone within it all, the film should really be watched and appreciated for what it is: an exercise in filmmaking where the audience gets the rare chance to deconstruct, study, and understand all the parts that go into the art of filmmaking, which feels so special to get during a crossroads in film production when everything was flipped on its head. Personally, I think it's something worth shouting for.

30 minutes. 'The Human Voice' is now playing in Los Angeles at the Vineland Drive-In Theater. •

# New Survey: Americans Cut Prescription Costs By Ordering From Canada

(BPT) - Prescription drug prices are skyrocketing. For anyone who needs regular prescriptions to manage serious chronic health conditions, the soaring cost of their medications creates a real burden. Studies show that one in four adults skip medications primarily due to cost, which leads to bigger problems both for their health outcomes and for increasing medical costs as they suffer complications due to missed medications. But a new survey shows that a growing number of Americans are finding a workable solution: importing prescription medications from Canada.

In the survey, conducted by the Campaign for Personal Prescription Importation (CPPI), over 93% of the respondents cited the high cost of prescription drugs in the U.S. as the primary reason they ordered prescriptions from licensed online Canadian pharmacies.

Recent price comparisons show that online Canadian pharmacies consistently offer Americans savings of 50-90% on brand-name prescription medications compared to leading U.S. pharmacies as well as GoodRx and Amazon Pharmacy.

The effect of these savings is not just about the cost. Craig Barnes of Oregon has been ordering prescription drugs from Canada for about two years. "I have a heart condition that requires medication to regulate my heart rate," said Barnes. The U.S. list price of 60 tabs (a 30-day supply) is approximately \$500.00. On GoodRx, the price is a bit lower - about \$460.00. Even with his insurance, his out-of-pocket monthly cost in the U.S. would be about \$236.00. Buying from an online Canadian pharmacy, Barnes saves \$2,328 a year, getting the medication he needs for only \$42.00 per month.

"If I had to buy the medication in the U.S., I would have to stop treatment or split doses," said Barnes. And for most people managing a health condition like Barnes, that can result in a much poorer health outcome, leading to complications that could even be life-threatening.

In the CPPI survey, 62% of the Americans

who import their prescriptions said they were referred by a trusted medical professional, friend or family member, and 80% of the survey respondents knew how to identify "rogue" pharmacies and felt savvy about their ability to find a trustworthy online pharmacy. The upshot? A whopping 99% of those who currently import their prescriptions from Canada would recommend doing so to family and friends.

It's definitely a continuing trend - last year saw an increase from 8.1% to 13.3% of Americans who reported ordering prescription drugs from online Canadian pharmacies for the first time. Eighty-seven percent said they had been ordering from online Canadian pharmacies for a year or longer. Until prescription medications become more affordable in the U.S., it's a trend that is likely to continue to grow.

The pandemic has underscored the importance of everyone having access to safe, reliable and affordable medications. For those with multiple underlying conditions, this is even more crucial now.

The Campaign for Personal Prescription Importation (CPPI) recommends searching for licensed Canadian pharmacies on certified websites. CPPI is a national nonprofit patient advocacy organization that fights for Americans' access to safe, affordable prescription medications from Canada for personal use. On their website, PersonalImportation. org, you can find advice and tips, plus a link to the Canadian International Pharmacy Association (CIPA) website, CIPA.com, for a list of licensed pharmacies.

"All Americans deserve access to affordable prescription medications. The savings that American patients report finding from online Canadian pharmacies is significant and available to Americans right now," says Jack Pfeiffer, executive director of the Campaign for Personal Prescription Importation. "There is even a bill in Congress, the Safe and Affordable Drugs from Canada Act, which could make these savings even easier for Americans to come by." •

# Common Tax Myths, Debunked

(BPT) - As you look ahead to doing your taxes this year, there are a number of myths you may think are true for the 2020 tax year. If so, you are not alone - tax myths and misinformation are more common than you may think. And unfortunately, these myths can be costly if they lead to mistakes on your taxes.

Here are the top tax myths this year:

**Myth 1:** Anyone working at home can deduct their home office expenses

Just because you're working from home - as many taxpayers are now - doesn't mean you can deduct the cost and expenses of the space used for your home office. In fact, this deduction only applies to people who are self-employed. But, some taxpayers may also be eligible if they are employed by someone else but use the space to engage in self-employment activities. **Myth 2:** You can claim dependent exemptions for your children

In the past, dependent exemptions allowed taxpayers to claim deductions for dependents (such as children) on their federal tax return. Unfortunately, dependent exemptions are no longer a thing. However, dependents are

still very important for tax benefit purposes, including increased credits, child tax credits, filings status determination and many more benefits. Just not a simple tax deduction as in the past.

**Myth 3:** You must itemize to deduct charitable donations

This was the rule in prior years, but it changed for the 2020 tax year - you don't have to itemize deductions to take a charitable donation deduction this year. Under the CARES Act, you can deduct up to \$300 in charitable donations made to IRS-approved organizations when you take the standard deduction. But if you do itemize, you still get to claim the deduction anyway


**Myth 4:** You can file taxes on a postcard This is not true. When the tax regulations were revised, you may have read in the press about a new "postcard" tax return, but it was



Excellence" award, one of "only three agents in the entire RE/MAX network of 130,000" to be so honored, Sanders emailed. Ruane also picked-up the industry's prestigious "Pinnacle Award" in 2020. Both awards recognize high echelon, top producing agents.

On winning realty top producer accolades, Ruane chuckled and said, "staying number two or three is great, because if you are #1, the only way that you go is down, right?"

Sanders's mother, Sandra Sanders, established the RE/MAX Palos Verdes office in 1984, and, emailed James Sanders, "had the vision to establish a brokerage with an environment for the real estate agent that is positive, professional, and supportive in order to deliver the best possible service to their customers."

Ruane continues to embody the aspirations established by Sandra Sanders more than three decades ago. James Sanders said that, some 37 years later, he and his siblings have attempted to "foster the same values as their mother, and have gained momentum, a loyal following, and a shift to a more efficient online and digital support that has taken RE/MAX Estate Properties to new levels."

Sanders said that RE/Max Estate Properties "has been the #1 real estate firm in sale volume in the South Bay since 2010," and that the company "recently earned the Los Angeles Business Journal's distinction of being one of the Top-Family-owned businesses."

Ruane is not only a top producer in the South Bay and the United States, but in the entire world of real estate agents working under the RE/MAX umbrella. "Bill is amazing," Sanders said. "His production, and how he cares for his clients, is unbelievable. He is the number three agent in the world and number two in the United States out of all the RE/MAX agents. And has probably been in the top five agents, worldwide, for the past ten years."

Sanders believes that Ruane is successful because "he works hard, he gives good service, and he can 'compartmentalize' client's needs. Sanders said that Ruane is unique in that he "doesn't stress-out over anything," noting that Ruane constantly has multiple deals in the works. "He did over 100 transactions in 2020." Sanders said. "He seems to know the market better than anybody I know," continued Sanders. "He has specialized knowledge in the Beach Cities," Sanders noted, with Ruane expanding his empire to include listings in, among other areas, Westchester, Marina Del Rey, and Venice. "He is just a great guy," Sanders said. "We, as a company, as you can imagine, take care of him. He has a lot of balls in the air."

RE/MAX is a worldwide realtor network, boasting 130,000 agents. Of the approximately 70,000 stateside agents, Ruane ranked #2 in the U.S. in 2020 and #3 worldwide. "That is pretty impressive," said Sanders. "He is always thinking ahead, thinking what he can do to give back to the community and how to help others." Sanders noted that the RE/MAX team racked-up more than four billion dollars in sales in 2020 and completed more than 4,000 transactions.

Discussing the state of the real estate market in March of 2021, Sanders said that RE/MAX had approximately 500 properties in escrow, pre-pandemic, but that once the realities of COVID-19 hit, 30 percent of the proposed buyers, he said, canceled. "Scary times," he said. "The world was going to end...I think

a lot of people felt that way...We didn't know what was going to happen. Who knew that" he continued, as the COVID pandemic escalated, "people would actually realize the value of having a home?"

Sanders noted that, currently, the clamoring to own a home has led to a low inventory of available properties because many people now look at their home as their office, their work-out facility, and, at least at this point, their children's classroom, all the while (mostly) following social distancing guidelines, somewhat quarantining with their family members.

"Homes became (more) valuable," Sanders said. "People are really seeing the value of (homeownership), as more than just as an asset, but as a place to raise a family, go to school,

work-out, and cook. It has changed the whole perspective of what owning a home means. And that is why we have low supply, high demand, and prices are coming up."

Towards the end of our interview, Ruane was asked, if he had not chosen the real estate pathway, what other profession may he have pursued? He laughed and paused a bit, "that's a good question," he said, before answering that "I don't know in what other career they would have tolerated me."

Suffice to say that the buyers and sellers that Ruane has worked with and for over his career are very satisfied that he stuck to the field of real estate. Summed-up Sanders: "Bill is the consummate professional, always taking care of his clients." •
