Space Force Guardian Gives Insight to the South Bay Base

Across from El Segundo's quaint downtown and tree-lined residential streets, a complement of business complexes and aerospace companies make up the eastern border. This is where the Los Angeles Air Force Base makes its home and where the United States Space Force in part develops its technology.

One such developer is South Bay native First Lieutenant Oscar Chacon. Chacon's official title for the United States Space Force (USSF) is Product Manager of the Space Tasking Cycle Portfolio Team. He works for Space and Missile Systems Center (SMC) in El Segundo, under the Cross Mission Ground Directorate. All that to say: he builds apps and technology used by the Space Force.

Chacon was born in Wilmington, California, near Long Beach, and grew up in Palos Verdes. As a kid, soccer was his passion, and he dreamed he'd be a doctor, largely because of his desire to help other people. When it came time for college, he applied to the premed track at a number of colleges and was pursuing an athletic scholarship for soccer. It was during this recruiting process that the Air Force Academy reached out to him.

Being able to play soccer and ultimately serve in the U.S. Air Force drew him to the school, which he attended in Colorado until graduation in 2018. Given the opportunity to fly, code, and explore many careers before declaring a major, Chacon went for a business degree.

"If you had asked me in high school, 'where will you be when you're 24 years old?' I would not have been able to tell you that," says Chacon.

Space Force is a relatively new wing of the Department of Defense. It was established in December of 2019. Its official mission reads: The USSF is a military service that organizes, trains, and equips space forces in order to protect U.S. and allied interests in space and to provide space capabilities to the joint force.

Members of Space Force are called Space Guardians. While Chacon couldn't give specifics on what missions the USSF is working on currently for security reasons, he was able to explain who his work benefits and why.

Lt. Chacon's team interviews Space Operators. These are members who track and manage all space assets (all U.S.-owned satellites, antennas, missiles, rockets, etc.), as well as communications in space and from ground-based radars. Imagine the room filled with computers and screens and maps you've seen in movies about space. That's what Space Operators do.

Sometimes, the technology used to track and share data from all of these assets is not as advanced as the technology on the assets themselves. So, Chacon speaks with them, figures out which processes are taking unnecessary time and hours, and comes back to his team to develop an application that can streamline the process. His job makes everyone else's job faster and easier.

During the pandemic, these interviews have to be conducted via secure video calls, which Chacon says has been the most difficult part of his job. Typically, he'd get to talk to the Operators in person, see where they work, and get a better understanding of what his team should be building for them. However, post-pandemic, he believes this innovation in communication will ultimately aid Space Force, saying that being able to call instead of travel with every update can help with things like previewing prototypes.

Growing up in the South Bay and playing soccer, Chacon is very familiar with the area. In El Segundo, he says, the base has strong ties with the local community. Everyone on the base lives nearby and frequents El Segundo parks, restaurants, and attractions often.

"As a military member, it's easy to get stationed in a new city and feel alone or isolated," he says, "I've never felt that here. And my buddies who come from out of town definitely love living here, too." Since being stationed in

To Survey a Sapling: The 2021 **Community Trees Challenge**

It's veritably vernal outdoor these days and a perfect opportunity to unfurl your face from those onerous textbooks and studious eye-straining studying you students have been diligently attending to. And affix your eyes upward and get all arboreal this Spring with the 2021 Community Trees Challenge. Let's re-inject some fresh air into those wheezy lungs and indulge in an invigorating (and socially-



distanced and safe) activity that will behoove science at the same time.

The Community Tree Challenge provides intrepid science enthusiasts with a unique opportunity to shore up their observation skills and field experience as they contribute to a critical NASA-sponsored citizen science project. Additionally, your keen field notes and evaluations will bolster a global database that is free and open to all researchers and other environmental advocates.

The fastidious observation of trees can sound straightforward enough but thorough scrutiny and attention to detail will best serve the needs of this initiative. You can wander onto your very own lawn and examine the dendrologic denizens that might populate your property. A useful GLOBE Observer app can be utilized for this data collection. Your meticulous observations might include measuring the angle of the tree between the top and bottom along with the overall circumference of the trunk using a homemade clinometer. Photographs and reports of the surface conditions of the tree will also behoove researchers as well.

This is an ideal scenario for lugging on dusty hiking boots and girding those neck muscles craning upwards at the oxygen-producing sentinels that stand tall around Inglewood. All whilst improving your science observation skillset, acquiring new knowledge about native trees, and interacting hands-on with your landscape and community topographic features. These activities are suitable for anyone with access to the outdoors and a healthy dose of vigorous curiosity in tow. And together we'll learn and advance our understanding of the Earth's forests to the benefit of all.

And how does tree-gazing contribute to scientific study and why are your observations crucial, you thoughtfully inquire? Because trees play an invaluable role in cooling and moistening our air and rejuvenating the biosphere with precious life-yielding oxygen and can help maintain a sustainable balance in our ever increasing global carbon output. Verdant and healthy forests are considered one of the most significant banks for all the carbon bulging in our atmosphere via natural processes and human activities. And the collective height of trees are the most reliable indicator of any given ecosystem's capacity to keep pace and expand as time goes by. Keeping a close eye on the rate of growth and tree height provides NASA scientists a better understanding of the accumulated gain or loss of biomass in the ecosystem. Which in turn informs potential scientific calculations of the amount of carbon that forests can feasibly absorb and release into the atmosphere.

So let's start leering at leaves and brandish our binoculars at precariously high branches this Spring. And collaborate with thousands of other active professional and citizen scientists the world over together strengthening STEM education and providing inestimable data for tomorrow's vital student research.

Get gauging, eager arborists. •

for their next mission, it's helpful to think about a "transition plan" about three years before your anticipated discharge date. This gives you time to research, ask questions and create a plan to help achieve the civilian life you want.

"Like most things in life, having a plan to get you from where you are to where you want to go is a key to success," said Russell Simmons, Certified Financial Planner[®] at Charles Schwab and Army Reservist. "A military transition plan is no different."

Simmons suggests taking time to think about and plan for these five key personal finance matters to help you find solid financial footing going into your new career:

* Determine your profession: Will you stay in your current profession or look for a job in a different field? There are a number of online tools available, as well as resources available through the VA to help you create a resume, write a cover letter and find career opportunities. The Small Business Administration (SBA) offers special programs for veterans interested in starting a new business.

* Calculate income: Military vs. civilian pay are very different. In order to budget accordingly, it's crucial to understand the differences between military and civilian pay. With civilian pay, there are more taxes and deductions that you likely didn't have to pay in the military, and there are not the allowances and incentives that you may be **See Finance, page 9**

The 50th Birthday Gift I Never Wished For – Adult Shingles

(BPT) - Just two months after her 50th birthday, mother, dental hygienist, humanitarian and Florida native Caroline contracted shingles, changing her life in an instant.

"For me, turning 50 meant starting a new chapter of my life. I knew something was wrong when I began to feel a sharp pain in my back and legs and saw red, itchy bumps on my thigh."

Considering the Florida heatwave at the time, Caroline attributed the bumps to heat rash and, again, didn't pay it much attention. Soon after, her rash quadrupled in size and she rushed to a walk-in clinic and learned she had shingles.

"I was bedridden for nearly two weeks and I felt helpless. It was the most agonizing pain I've ever felt in my life," said Caroline.

Anyone who has gotten chickenpox is at risk of contracting shingles, also known as herpes zoster.[1] When chickenpox becomes dormant within the nerves, it can reactivate later in life, causing shingles.[2] Shingles typically presents as a painful, itchy rash that develops on one side of the body and can last for two to four weeks.[3]

"I've experienced everything from kidney stones to multiple back, neck and knee surgeries and I can honestly say that nothing compares to the pain I felt from shingles," added Caroline.

Today, Caroline still finds herself struggling with the aftermath of shingles, including loss of stamina and extreme fatigue.

"While I had shingles, I joined a Facebook support group to find ways to help manage the discomfort. Reading through the group posts, I was surprised to learn just how many people were suffering from shingles."

At just 50 years old, Caroline had no idea she could be at risk. In fact, approximately one in three people in the United States will develop shingles in their lifetime.[4]

"The pain of shingles is not something I'd want anyone to suffer from, especially because it's preventable. I never imagined that shingles could bring my life to a complete standstill at 50."

Caroline learned firsthand that shingles doesn't play favorites. As a GSK spokesperson, Caroline is committed to educating about shingles and the vaccine available to help protect against it. "Whenever I can, I encourage people to get vaccinated and am proud to say that, because of my story, five other people have been vaccinated."

If you're 50 years of age and older, talk to your doctor about vaccination against shingles. Vaccination will help reduce the risk of developing shingles and the potential long-term pain from post-herpetic neuralgia, a common complication caused by the disease.



AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF INGLEWOOD, CALIFORNIA GRANTING TO GOLDEN STATE WATER COMPANY, A CALIFORNIA CORPORATION, A FRANCHISE TO USE OR LAY AND USE PIPELINES AND APPURTENANCES FOR TRANSMITTING AND DISTRIBUTING WATER UNDER, ALONG, ACROSS OR UPON THE PUBLIC STREETS, WAYS, ALLEYS AND PLACES WITHIN THE CITY

OF INGLEWOOD.
WHEREAS, Golden State Water Company, formerly known as Southern California Water Company, a California corporation had a Franchise to use or lay and use pipes and appurtenances for transmitting and distribut-ing water under along, across or upon public streets, ways, alleys and places in the City of Inglewood pursuant to Ordinance No. 2364, which has now expired; and

SECTION I - DEFINITIONS Whenever in this ordinance the words or phrases defined in this Section 1 are used, they shall have the respective meanings assigned to them in the following definitions (unless, in the given instance, the context wherein they are used shall dearly import a different meaning): (a) "Act" means the Franchise Act of 1937 as set forth in Sections 6201-6302 of the Public Utilities Code.

(b) "City" means the City of Inglewood, a municipal corporation of the State of California, in its present incorporated form or in any later re-organized, consolidated or reincorporated form. "Code" means the Public Utilities Code of the State of California.

(d) "CPUC" means the California Public Utilities Commission or any successor thereto having jurisdiction over the supervision and regulation of public utilities (as defined in Section 216

of the Code).

(e) "Engineer" means the City Engineer of the City of Inglewood.

(f) "Franchise" means any authorization granted hereunder in terms of a franchise, privilege, permit, license, or otherwise to use, or lay and use, pipes and appurtenances for transmitting and distributing water for any and all purposes under, along, across or upon the streets in the City of Inglewood.

(g) "General Order No. 103-A" means General rder No. 103-A adopted by the CPUC, as in effect on the date hereof or as it may hereafte be modified by the CPUC, setting standards of water service, including standards for the design and construction of pipes and appurtenances "Grantee" means Golden State Water Company, a California Corporation, and its

successors and assigns.

(i) "Lay and use" means to lay, construct, erect, install, operate, maintain, use, repair,

(j) "Pipes and appurtenances" means pipe, pipelines, main, service, trap, vent, vault, man-hole, meter, gauge, regulator, valve, conduit, ditch, flume, appliance, attachment and other appurtenances located or to be located in. upon, along, across or under the streets the City of Inglewood, and used or useful in transmitting and distributing water.

(k) "Streets" means the public streets, ways. allevs and places as the same now or may hereafter exist within the City of Inglewood

"Water" means water of any type, including, without limitation, potable water, reclaimed

SECTION 2 - GRANT OF FRANCHISE (a) Subject to each and all of the terms and conditions contained in this ordinance, and pursuant to the provisions of Article XXX of the Charter of the City of Inglewood and the Act, a Franchise is hereby granted to Grantee for a term of ten (10) years from the date of approval of this Ordinance granting said Fran-chise. However, this Franchise shall terminate prior to the end of the ten (10) year term for any of the reasons set forth in Section 4 of

this Franchise Agreement. (b) This Franchise grants to the Grantee the rights and privileges to use, or to lay and use pipes and appurtenances for transmitting and distributing water for any and all purposes under, along, across or upon the public streets, ways, allevs and places, as the same may hereafter exist, within the City of Inglewood.

(c) The Franchise granted hereby is subject

to the terms and conditions set forth herein to the extent not inconsistent with the California Constitution, the Act, other applicable provisions of the Code and the rules, regulations, orders and decisions of the CPUC, including, without limitation, General Order No. 103-A, and to the terms and conditions set forth in the Act. (d) This Franchise grant is made in lieu of al (a) Inis Franchise grant is made in lieu or ail other franchises, rights or privileges owned by the Grantee, or by any successor of the Grantee to any rights under this Franchise, for transmitting and distributing valer within the limits of the City, as such limits now or hereafter may exist, except any franchise derived under Section 19 of Article XI of the Constitution of the State of California as that section existed prior to the amendment thereof adopted October 10, 1911, and the acceptance of the Franchise hereby granted shall operate as an abandonment of all such franchises within the limits of this City, as such limits now or may hereafter exist, in

lieu of which this Franchise is granted.

(e) The granting of this Franchise shall not be construed to prevent the City from grant-ing any identical or similar franchise to any person other than Grantee, so long as such grant does not interfere with the use of this

grant does not intender with the use of this Franchise by Grantee.

SECTION 3 – ACCEPTANCE OF FRANCHISE

(a) Pursuant to Section 6235 of the Act, this Franchise is section 6235 of the Act, this Franchise is granted and shall be held and enjoyed only upon the terms and conditions herein contained, and the Grantee must, within thirty (30) days after the passage of this Ordinance, file with the City Clerk of the City of Inglewood, a written acceptance of the Franchise including a statement to comply with the terms and conditions of this Ordinance. (b) Pursuant to Section 6235 of the Act, the Franchise granted hereunder shall not become effective unless such written acceptance has

been timely filed by the Grantee with the City Clerk of the City of Inglewood. (c) Pursuant to Section 6235 of the Act, when so filed, such acceptance shall constitute a continuing agreement of the Grantee that if and when the City shall thereafter annex or consolidate with additional territory, any and all franchise rights and privileges owned by Grantee therein, except a franchise derived under Section 19 of Article XI of the California Constitution as that section existed prior to the amendment thereof adopted October 10, 1911, shall likewise be deemed to be abandoned

within the limits of such territory. SECTION 4 – TERMINATION OF

FRANCHISE This Franchise shall terminate ten (10) year from the effective date of approval of this Ordinance granting said Franchise. However pursuant to Section 6264 of the Act, this Franchise shall terminate prior to the end of the initial term if (i) Grantee voluntarily surrenders o abandons the Franchise with the consent of the CPUC; (ii) the State or any municipal or public corporation duly authorized by law purchases by voluntary agreement or condemns and takes under the power of eminent domain all property actually used or useful in the exercise of this Franchise and located within its territorial limits or (iii) the Franchise is forfeited for noncompli

ance with its terms by Grantee. SECTION 5-AMOUNT OF FRANCHISE FEE (a) Pursuant to Section 6231(c) of the Act, Grantee shall pay to City at the times hereunder specified, in lawful money of the United States, a franchise fee annually which shall be equal to two percent (2%) of the gross annual receipts of the Grantee arising from the use, operation or possession of this Franchise, except that this payment shall be not less than one percent (1%) of Grantee's gross annual receipts derived from the sale of water within City limits.

(b) Grantee shall also pay to City a sum of money sufficient to reimburse it for all publication expenses incurred by it in connection with the granting of this Franchise, such payment to be made within thirty (30) days after the City shall furnish Grantee with a written statement

of such expenses. SECTION 6 - PAYMENT OF FRANCHISE FEES

(a) Pursuant to Section 6299 of the Act, within three (3) months after the expiration of each calendaryear, or fractional calendaryear, during the term of this Franchise, Grantee shall file with the City Clerk, a statement verified by an officer of Grantee showing the following: (1) The total gross receipts under Section 5 received by the Grantee from the use. operation or possession of this Franchise during the preceding calendar year, or fractional

(2) The total gross receipts under Section 5 received by the Grantee from the sale of water within City limits; and
(3) The method and supporting calculations

used to calculate the franchise fees which are payable to the City in accordance with this Franchise.

(b) Pursuant to Section 6300 of the Act, within fifteen (15) days after the filing of the verified statement, the Grantee shall pay to City, at the office of the City Treasurer, in lawful money of the United States, the sum of money required to be paid by Grantee to City under Section 5 for the calendar year, or fractional calendar year, covered by the verified statement.

(c) Pursuant to Section 6300 of the Act, any neglect, omission or refusal by Grantee to file the verified statement required under subsection (a) above, or to pay any required payments under Section 5 at the time and in the manner specified shall be grounds for the declaration of a forfeiture of this Franchise and of all rights and privileges of Grantee hereunder, provided that Grantee shall not have cured said neglect omission, or refusal to file or pay within ten (15) days following written notice from the City of Grantee's failure to file or pay the required amount, or, if such neglect, omission or refusal is not reasonably subject to cure within such ten (15) day period, Grantee has not commenced to cure such neglect, omission or refusal within such ten (15) day period and has not continued to prosecute such cure to completion.

SECTION 7 - INSURANCE

Grantee shall procure and maintain for the duration of this Franchise the following poli-cies of insurance from companies authorized to transact business in the State of California by the Insurance Commissioner of California:
(1) Comprehensive general liability insurance with a combined single limit of not less than \$1,500,000 per occurrence and \$3,000,000 in the aggregate or its equivalent in coverage; and (2) Comprehensive automobile liability insurance endorsed for all owned, non-owned and hired vehicles with a combined single limit of at least \$1,500,000 per occurrence; and (3) Workers' compensation insurance as

required by law.

(b) Grantee shall furnish the City prior to the commencement of any work pursuant to this Franchise Agreement, and immediately after the issuance of any replacement of any insurance policy required hereunder, either:

 (1) Certified copies of insurance policies or certificates of insurance from the company issuing the insurance policy with respect to the pursuant to subsection (a) hereof, including additional insured endorsements and notice of cancellation endorsements; or

(2) A certificate of consent to self-insure, issued by the Department of Industrial Relations of the State of California or any successor thereto. (c) Each insurance policy obtained by Grantee pursuant to the provisions hereof shall be primary to and not contributing with any other insurance maintained by the City, shall name the City and the members of the City Council and the officials and employees of the City as additional insureds, and shall require that writte notice be given to the City at least thirty (30) days in advance of any material modification or termination of any program of insurance required hereunder.

(d) The Grantee declares that it has a selfinsured retention in the amount of \$500,000 for General Liability and a self-insured deduction in the amount of \$350,000 for Auto Liability The Grantee shall be responsible for providing verification of the self-insured limits at the time

of the approval of the Franchise Ordinance unsecured debt rating of A- from the Standard Reports rating system.

(e) Insurance shall be placed with insurers.

A:VII. SECTION 8 – INDEMNIFICATION AND

(a) Grantee shall defend, indemnify, and hold harmless the City and its officers, employees, agents, representatives, and volunteers from and against all daims, demands, damages, liabilities, losses, costs, expenses including attorney fees, liens, or judgments arising out of the performance of any operations under this Franchise caused in whole or part by any negligent act or omission of the Grantee, any of its subcontractors, or anyone directly or indirectly employed by any of them or anyone of them or anyone for whose acts any of them may be liable, except where caused by the negligent or willful misconduct of the City.

(b) If any portion of any street or other public property shall be damaged by reason of defects in any of the pipes and appurtenances maintained or constructed under this Franchise or the operation thereof, Grantee shall, at its own cost and expense, immediately repair any such damage and restore such portion of the street, or other public property, to as good condition as existed before such defect or other damage caused by Grantee occurred to the reasonable satisfaction of the Director of

Public Works or his/her designee.
(c) In the event that Grantee neglects or fails to remove or relocate any pipelines and appurtenances in a timely manner after receipt of all permits necessary from the City or any other governmental agency that Grantee may be required to obtain in connection therewith in accordance with the provisions of Section 10 or fails to immediately repair any damage to any portion of the streets of the City as required by Section 8(b), the City shall have the right to remove or relocate such pipelines and appurtenances or repair such damage to the streets so long as such removal or relocation does not unreasonably interfere with the ability of the Grantee to provide water service to its customers and the Grantee shall reimburse City for all reasonable costs or expenses incurred by the City in connection with such removal location or repair promptly after the receipt

of a bill therefore. (d) If the Grantee shall fail, neglect or refuse to comply with any of the provisions or conditions hereof and shall not within ten (10) days after written demand for compliance, begin the work of compliance, or after such beginning shall not prosecute the same with due diligence to completion, then the City Council may declare this Franchise forfeited as provided herein, and the City may thereafter sue in its own name for the forfeiture of this Franchise.

SECTION 9 – CONSTRUCTION, INSTALLATION, MAINTENANCE, AND REPAIRS

(a) Pursuant to Section 6294 of the Act, Grantee shall construct, install, maintain, and perform any necessary repairs of all pipes and appurtenances and in accordance with all applicable federal, state and local rules or regulations in effect at the time of granting of the Franchise, or as may be later prescribed by the City Council, in the exercise of its police powers and in accordance with the terms and conditions of any permit issued by the Public Works Department, Any ordinances, rules and the City Council of the City in the exercise of its police powers shall be followed unless they are in conflict with the paramount authority of the State of California, including the Code and the rules, regulations, orders and decisions of the CPUC, and, as to State highways, subject to the provisions of general laws relating to the location and maintenance of such facilities. (b) Grantee and the City of Inglewood shall mutually enter into an agreement whereby the Grantee shall continue to: install, oper ate, maintain, repair and replace emergency connections between the City water system and the water system of the Grantee for the purpose of continuing delivery of water during emergency situations. (c) Grantee shall continue to: construct, install,

maintain, repair and replace the water lines with the least possible hindrance to the use of the streets for the purposes of travel, to the extent reasonably practicable and not unduly burdensome, and as soon as such work is completed, all portions of the streets which

have been excavated or otherwise damaged thereby, shall be placed in as good condition as the same were before the commencement of such work, to the reasonable satisfaction of the Public Works Department. The Public Works Department shall have the right to give the Grantee such directions for the location of any pipes and appurtenances as may be reasonably necessary to avoid sewers, water pipes, conduits or other structures lawfully in or under the streets to the extent not inconsistent with General Order No. 103-A or other rules regulations, orders or decisions of the CPUC and before the work of constructing any pipes and appurtenances is commenced by Grantee, the Grantee shall file with the Public Works Department plans showing the location thereof.

(d) All street coverings or openings of traps, vaults, and manholes shall be constructed flush with the surface of the streets; provided, however, the vents for underground traps, vaults and manholes may be constructed above the surface of the streets if such vents are located in parkways, between the curb and the property line, and are not, in the reasonable opinion of the Public Works Department, hazardous to the public.
(e) Grantee shall make such deposits of

money or shall file such bonds upon request of the City, with the City as may be reasonably required to insure satisfaction and completion of all construction within public rights of way.

SECTION 10 – REMOVAL AND RELOCATION

City shall have the right to change the grade, alignment or width of any street, including the construction of any subway or viaduct by the City. Pursuant to Section 6297 of the Act, Grantee shall remove or relocate any facilities installed, used or maintained under this Franchise if and when made necessary by any such lawful change in grade, alignment or width of the street, without expense to the City, provided, however, that Grantee shall not be required to bear the expense of such work done at the request of the City if and to the extent that such request is on behalf, or for the benefit, of any private developer or other non-governmental entity. SECTION 11 – STREET EXCAVATION

REQUIREMENTS

(a) Except in an emergency, the Grantee shall not excavate in a City street without having first obtained a Construction-Excavation Permit from the Public Works Department. The Grantee shall pay any fees required by such permit.
(b) Where it is necessary to lay any underground pipes through, under or across any portion of a paved or macadamized street, the same, where practicable and economically reasonable and not inconsistent with General Order No. 103-A or other rules, regulations, orders and decisions of the CPUC, shall be done by a tunnel or bore, so as not to disturb the foundation of such paved or macadamized street; and in the event that the same cannot be done, such work shall be done under a Construction-Excavation Permit to be granted by the Public Works Department upon application therefore, and Grantee shall restore such street, or portion of such street, to as good a condition as existed before such work to the reasonable satisfaction of the Public Works Department. (c) In no event may any permit granted by the Director of Public Works or his/her designee contain any terms or provisions inconsistent with the California Constitution, the Act, other applicable provisions of the Code and the rules, regulations, orders and decisions of the CPUC including, without limitation, General Order No. 103-A, or the terms of this Franchise. In no event may any fees charged by the City in connection with obtaining such permit exceed the actual costs to the City in processing the permit application, including but not limited to administrative and/or inspection costs. Nor shall any costs be otherwise unreasonable

or discriminatory.

SECTION 12 - EMINENT DOMAIN Pursuant to Section 6262 of the Act, the Franchise granted hereunder shall not in any way or to any extent impair or affect the right of the City to acquire the property of the Grantee hereof either by purchase or through the exercise of the right of eminent domain, and nothing herein contained shall be construed to contract away or to modify or to abridge the City's right of eminent domain in respect SECTION 13 - VALUATION OF

accustomed to with military pay.

Fish Tacos with Peach Mango Salsa




