## "Meet and Greet" and the Council Meets

March 25, 2025, is now officially the first "Meet and Greet" at Hawthorne City Hall before the City Council meeting. It will not be the last. The "Meet and Greet" was well attended, with three outstanding vendors: Panamericana Bakery, Launch Pad Learning, and El Boqueron Restaurant. Many folks dropped by, chatted, and tried the food from the Bakery and El Buqueron; the vibe was excellent. A "Meet and Greet" before the Council meeting is the brainchild of Hawthorne's newest Council member, Faye Johnson, and is off to an awesome start.

In that spirit, then, the Council had six initial matters on the agenda, most of which (it seems fitting) were proclamations.

April is Fair Housing Month. Council member Reyes and Mayor Vargas touted Hawthorne's Fair Housing Foundation. The right to reside in a dwelling of your choice is so fundamental. Yet, we all know affordable housing can be very challenging in this area, from tenants to buyers. The Fair Housing Foundation is a non-profit organization which is neither pro-landlord nor pro-tenant. Among other critical tasks, the Foundation investigates housing discrimination, assists four to five hundred persons per month with their rights, and provides outreach programs both virtual and in person.

The American Red Cross was then given a hearty proclamation of thanks. For over 140 years, this well-known organization has been guided by service to humanity without regard to race, religion, citizenship, or sexual orientation. The Red Cross seeks to assist in over sixty thousand disasters annually (on average), with over five hundred in Los Angeles alone. In addition, the Red Cross provides overnight shelters, meals, and

snacks, and last year logged over 200,000 volunteer hours.

Bob Jensen passed recently and will be greatly missed. Friends and family joined the Council and spoke very affectionately about Bob and all the good work he did for Hawthorne and the community. A Hawthorne High graduate, Bob devoted himself for many years as President of the Hawthorne Historical Society, promoting the City of Good Neighbors, its past, and its legacy. You know of his superb work, if you have ever visited the Historical Society. Speaking of which, should you or someone you know have some "nick knacks" stashed away that would show well at the Historical Society, by all means, bring them in! A Celebration of Bob's Life will go forward at the Memorial Center on April 19 (the time is not yet set, but likely in the late morning that day).

The Council then saluted the vendors who participated in the abovementioned "Meet and Greet". A photograph of smiling faces was taken (one of the images accompanying this column). I only wish there was room here to talk about each of those vendors - but there is just too much to say - so I will cover it in a future column!

A presentation was made about Hawthorne's My Civic 311 App, which allows you to contact City officials on a number of topics, from pothole repair to illegal dumping to graffiti removal. Remember, online, Hawthorne has a "virtual City Hall." More and more people, hopefully, will take advantage of this excellent resource. The 311 App is accessible through your computer at CityofHawthorne.org or on your phone (be it an iPhone or Android).

## Film Review

#### Thank You Very Much Review: Andy Kaufman: The Offbeat Anti-Comedian

Thank You Very Much asks a very simple question: Who is the real Andy Kaufman? The answer, however, is not as straightforward. With his controversial and gonzo style of comedy, Andy Kaufman was a provocateur. An iconoclast. He found pleasure in confusing and outraging audiences. Some people loved him for this while others found it incredibly annoying. He may not be everyone's cup of tea, but there's no denying that his tea was on a meteoric rise in fame. From the filmmakers behind Uncut Gems (Elara) and Won't You Be My Neighbor (Tremolo Productions), Thank You Very Much is a long overdue exploration into the all-too-short life of a one-of-a-kind comedic genius.

Filmmaker Alex Braverman sorts through never-before-seen archival footage and speaks with some of Kaufman's closest friends, colleagues, and family members to craft a portrait of the curious Andy Kaufman. The consensus among the group is that Kaufman is an artist in the truest sense of the word. His artform is his act, with an "always-on" persona that had everyone questioning the lines between reality and fantasy. Was he really an awkward guy with a high-pitched foreign accent? Or was he more like Tony Clifton, a rare steak-eating, womanizing drunkard? Through interviews, we learn that no one was ever 100% sure who the real Andy Kaufman was.

But there's a downside to being a full-time jokester... no one knows when you're telling



the truth. Andy Kaufman was diagnosed with and later died from lung cancer at 35 years old. And still, people thought he was faking his death. Danny Devito admitted to not believing it, thinking it was just another one of Kaufman's outlandish pranks. Some people even poked his coffin to make sure he wasn't messing around. In death, as in life, Andy Kaufman kept everyone on their toes. I'm sure he would have been thrilled to know that this would be the legacy he leaves behind.

Thank You Very Much brings to life an engaging timeline from Kaufman's early days, starting at NYC's The Improvisation in 1963. From here, we see tons of archival footage from his standup sets, all still hilarious and relevant today. Braverman makes it a point to also infuse the darker moments of Kaufman's life, including homelessness, addiction, and a traumatic childhood event about his family's decision to cover up the death of his grandfather. He overcame a lot of adversity in his short existence, thanks in part to his belief and practice of Transcendental Meditation. The film goes into more detail on how exactly this form of meditation literally saved him.

If Andy Kaufman were alive today, would he have liked his private life examined so publicly? Would he revel in the fact that some people still believe that he is alive and his death was just some elaborate hoax? While Thank You Very Much does an excellent job of reminding audiences of the once-in-a-generation talent that was Andy Kaufman, the real truth is we may never fully understand him. One thing seems clear though: he couldn't have written his legacy any better. •



#### The Handy Civics Answer Book: How to Be a Good Citizen by David L. Hudson, Jr.

I have worked in libraries my entire life and that is not an exaggeration! I was a "helper" in my elementary school library, I worked the checkout desk in my high school library and for a short time, I was a page in the local public library. As an adult, I have worked in a college library, special libraries (have you been to the Cabrillo Aquarium?) and of course, for the last 24 years, at the El Segundo Public Library. It's in my blood, too. My mother worked at the Euclid Public Library (a suburb of Cleveland, Ohio) before I was born. She started my life-long love of reading and learning. I feel that I truly had a "calling" to this work. I am happiest when I am able to share our library's collections of knowledge with our community and assist in the location of materials that will lead to better understanding, self-improvement and to being a good citizen.

I am happy to recommend a new acquisition to the library, The Handy Civics Answer Book: How to Be a Good Citizen by David L. Hudson, Jr. There is not a better time in our country's history to browse through and/ or read a book on this subject. Mr. Hudson is an attorney and law professor, teaching courses in Constitutional Law, First Amendment Law and bar exam preparation. He has

authored, co-authored and co-edited over 50 books and written many articles about First Amendment topics in his career.

Many topics are covered, including how the three branches of our federal government work and function. There are chapters on Congress, the Presidency, the Supreme Court ... This book examines state governments and addresses the Bill of Rights. But at its heart is explaining what it takes to be a good citizen in our world. And there's a bonus! There is a discussion of the Civil Rights Movements of the 1950s and 1960s and its impact on our history and its people. The author states that it is his hope that "... this book will help citizens to be even more informed about their government, their laws, [and] their freedoms [...] "

Each chapter follows a question and answer format (over 500 of them) covering the formation of our country, the functioning processes of each branch (Legislative, Executive and Judicial) and state and local government.

In this treasure trove of knowledge, the reader will also come across captivating historical trivia: Who was Gouverneur Morris and what was the story behind his wooden leg? What was the "Black Fear of Silence" that Justice William O. Douglas wrote about in 1952? What is considered "the matrix, the indispensable condition of nearly every other freedom?"

This engrossing resource to Washington, governance, and civic duties is ideal for anyone interested in American politics and

#### How to Boost Your Savings: Smart Strategies to Save With Intention

(BPT) - Savings can help meet unexpected expenses, fund short-term spending goals and protect against unanticipated life events. At the same time, leaving too much of your money uninvested can jeopardize long-term financial goals like retirement. Set a goal to be more intentional with your savings by getting clear on your savings goals, ensuring your savings earn a competitive return and putting excess cash to work for your long-term financial goals.

To determine your personal savings goals, consider your ability to withstand savings shocks and potential income loss, as well as any short-term spending goals such as buying a car or taking a vacation.

• Step 1: Start by ensuring you have a buffer for unexpected expenses. Aim to have at least \$2,000 or about half a month's household expenses, whichever is greater, set aside in a cash savings account. If you've navigated any changes in the last year that impact your income or spending, it's also worthwhile to revisit that emergency savings goal.

• Step 2: You might also have additional short-term financial goals. Perhaps you're planning a home renovation or saving up for a wedding. Money to fund these goals that are a year or two away probably shouldn't be exposed to much risk of loss and may be best kept in a cash savings account.

• Step 3: Think about building a more substantial financial safety net that can cover three-to-six months of living expenses. This

fund will help you manage financial disruptions, such as job loss or other longer-term income interruptions. This fund might also be used to help with longer-term goals like retirement savings, but such money, however it is invested, should be easily accessible if needed to bridge periods of income loss. Certain accounts like a 401(k) or traditional IRA with limited ability for early withdrawals likely won't be the best homes for these funds.

Get specific about why you're saving and create an action plan. Start small and build. Saving something is better than not saving at all, especially when saving in an account with a competitive yield. Yield, or annual competitive yield (APY), indicates how much interest or return you can expect to earn on your savings in a given account over a year. Put simply, the higher the APY, the more your savings can grow.

Many Americans aren't getting the return they deserve on their savings. Whether you're just starting to set aside funds for an emergency or you already have substantial cash saved, make sure you know how much that cash is "earning." Saving with intention means selecting the best savings vehicle for your personal savings goals. Consider whether you value FDIC insurance, ease of money movement or if you're simply looking for the highest return on your savings.

Letting your money sit in an average bank savings account might mean your money doesn't have much chance to grow. The average bank savings account yield as of Dec. 16, 2024, was 0.42% according to the FDIC National Rate and Rate Caps. That means for each \$100 you save you'll earn 42 cents annually. Compare this to a higher yielding account like Vanguard's Cash Plus Account, which offers a sweep program currently yielding 3.65% APY effective Jan. 6, 2025.\*

The cash you keep easily accessible does not need to sit idly on the sidelines. It can work for you in a high-yielding account. Keeping your hard-earned money in a lowyielding account could mean leaving money for short- and long-term goals on the table.

A well-funded emergency savings account can prevent you from taking on high-interest debt, tapping into a retirement account or turning to other sources that could slow your long-term financial progress.

While crucial for funding short-term financial goals, an intentional savings plan can also create the foundation for a longer-term financial plan. Once you have a solid savings plan in place, consider whether you can move excess cash - beyond the amount needed to meet your identified savings goals - into higher-earning-potential asset classes like stocks and bonds for long-term goals like retirement.

Whether your savings goal is to start your first rainy-day fund or shop around for higher returns on your well-funded piggybank, ensure you have clear goals and a plan for reaching them.

Mayor Vargas addressed the ongoing importance of learning and knowing more about who the Homeless Services agency is dealing with so that Hawthorne can best decide how to best assist and explain to the community what is being done.

Several members of the public came for-

ward during the "Oral Presentation" portion of the Council meeting. Topics were varied and included a recruiting company that is excited about jobs opening at LAX as the people mover we have heard so much about is getting closer to completion. Also, the Hawthorne Parks and Rec Department is having its fifth annual art show on May 1 at the Memorial Center; if it's anything like last year, expect the Memorial Center to be filled. Council member emeritus Olivia Valentine was next and cautioned the Council to prevent legislation coming from Sacramento that would allow for the construction of multi-family housing in areas that are not conducive, thereby usurping local control. Daniel Granados, the popular Head of Hawthorne's Library, announced a used book sale on April 12 from 10 am to 3 pm and expressed regret that a part of the library is under construction (but when done, will provide both better access for all and an improved community meeting room).

Consent calendars and remarks by each Council Member filled the remainder of the three-hour meeting. Indeed, there is a lot going on.

In closing, if we can meet and greet some vendors from the community before the Council meeting, all the better; and if they have delicious food, well, that is great too! You know, the meet-and-greet might be one of the reasons this was an uplifting night. •




