## South Bay's Debra Sullivan Will Not Take No for an Answer

El Segundo's Debra Sullivan's bio lists her as an "actress/writer/producer." I guess that in 2021 the term actress has been supplanted by the generic "actor," so we will go with that.

Sullivan, whose presence has graced the environs of El Segundo for nearing three decades, said she lives by the mantra of "a life lived in fear...is a life half lived," which is a line from the movie *Strictly Ballroom*, a 1992 Australian film that made a significant impact on the lives of Sullivan and her husband/writing partner Adam Marcus, and was a film that Sullivan and Marcus viewed on one of their initial dates.

As an actor, she has accumulated credits in countless films, plays, television shows, and commercials. Sullivan has notched lead or recurring roles in *Criminal Minds*, *Private Practice*, *Big Love*, *ER*, and *Cold Case*. Her resume also features roles in the daytime soap operas (no longer called soap operas, Sullivan corrected me, now referred to as daytime dramas), where she portrayed, among other roles, a businesswoman, a neighbor, and a hard-working OB/GYN nurse. Among her daytime drama credits are stints on *Days of Our Lives*, *The Bold and the Beautiful*, and *The Young and the Restless*.

In films, she has appeared in *Conspiracy* and *The Long Goodbye*, amongst other offerings. As well as appearing in a couple of films directed by her husband: *Let it Snow* and the cheeky and dark movie *Secret Santa*.

Sullivan said that she is the only one in her family who cultivated a fervent interest in the arts, sharing how some family members consider her "insane." As a child, Sullivan was all about performing, whether it be as a ballet dancer, singer, or budding actor. She would knock on neighbors' doors, she said, and offer to sing for them in exchange for the princely sum of a quarter. And when it rained, she would cloister up and write, which

led her to put pen to paper and producing plays and screenplays.

Sullivan said her celluloid turn as "the most horrible mother on the planet" in the 2018 released movie *Secret Santa*, in which she not only starred in, but co-wrote the screenplay, and co-produced the pic, was "the best time of my life, making that movie." She categorized *Secret Santa* as a horror-comedy, which allowed her to "use my comedy chops, and play a part that I am not normally cast in." *Secret Santa* was the initial foray into film production by Skeleton Crew Productions, a company formed by Sullivan, Marcus, and Bryan S. Sexton.

Not one to limit herself, Sullivan has also appeared in theatrical productions, including *One Quarter Cup*, and *One West Wacker*.

An admitted Valley Girl, Sullivan moved to El Segundo more than a quarter century

ago and is married to writer/director/producer Marcus of *Friday the 13th* fame. Sullivan said that she settled in El Segundo because her father mandated that, as an 18-year-old living in the Valley, it was time for her to fly the coop and learn to fend for herself while also counseling her to select a city that was "safe."

Sullivan's father's secretary lived in El Segundo and touted the town as a nice, safe city to move to, and Sullivan heeded the advice. She has not regretted her relocation to El Segundo.

"For the most part," she said, "everyone in town is very friendly." She also noted that many of her acquaintances are not exactly sure where our little town is located, and she is more than happy to keep them guessing. She said that when her friends would query whether El Segundo

## Brenda Newman Celebrates Fifty Years of Gemology in the South Bay

"You are literally given twenty stones, and you have to get one hundred percent identification on these unknown twenty stones."

Brenda Newman is a graduate gemologist and the CEO of The Jewelry Source in El Segundo. She discusses getting her education in gemology. "It's very difficult, but it does set you apart," she says. Her store is an American Gem Society store, a title for which less than five percent of jewelry stores in the nation qualify.

Newman's history with El Segundo begins with her grandparents, who moved to the city in the early 1940s for work at Chevron. Her mother graduated class of

'48 and married her father, a firefighter in the area. Growing up in El Segundo, she began to think about potential job prospects.

In her junior year of high school (1974), Brenda got a job at a jewelry store. Every working day of her life since has been spent in the jewelry business. After working for a couple of larger stores, and a small jeweler, she decided she wanted to open her own business. In the 80s, she explains, beading was very in fashion. So she started her own beading and repair business, selling her work at popups in places like Nordstrom and repairing broken jewelry.

## Film Review

### 'Gunda' Review: A Wordless Film of a Mother Pig Stuns in Black and White

executive producer role, Phoenix's passion in support of the film is clear, stating, "Kossakowsky has crafted a visceral meditation on existence that transcends the normal barriers that separate species. It is a film of profound importance and artistry."

Shot in black and white and with no dialogue or soundtrack, *Gunda* chronicles the unfiltered lives of a mother pig, a flock of chickens, and a herd of cows with masterful intimacy. This observational documentary sits in a class of its own with its quietly commanding message of animal symbiosis in the natural world.

Nothing pulls at my heartstrings more than a good animal documentary that is authentic in its storytelling and not set up to create maximum emotional impact. On the contrary, *Gunda*'s lack of any narrative whatsoever is what makes the film so devastatingly beautiful. It requires some mental stamina to sit through, at times I had to wonder if the camera was left accidentally rolling for minutes on end before any sort of action or movement appears in frame. Confident in its directorial choices and unique sensibilities, it's no surprise that Viktor Kossakowsky calls *Gunda* his most personal and important film he has made as a filmmaker and as a human being.

*Gunda* is the definition of an experimental film, and I've never seen anything quite like

white look. *Gunda*'s stark beauty resembles that of a high-fashion Vogue film, but instead of watching waif-like models describe what they eat in a day or give us a tour of their home, we're literally following a pig around a barn. It's not the most daring or visually stimulating film I've ever seen, but what gives *Gunda* its cinematic strength is the commitment to a bold aesthetic.

*Gunda* was apparently a 25-year project for Kossakowsky, and not once did his dedication to the project, or his vision, waiver. What he's created is an innovative documentary that breaks the traditional rules of making

### Planning Retirement Savings After COVID-19

(BPT) - Planning for retirement is an important step toward long-term financial wellness at any age. 

### Brenda Newman

This business, which she called The Jewelry Source with her then business partner, grew from an idea into eight square feet, which grew into a 450 square foot brick and mortar, and finally resulted in her buying the entire building and expanding the store into what it is today.

Working with trusted partners, Newman sells pieces that are classic and unique. She sells everything from earrings, to necklaces, to engagement rings. What makes her especially noteworthy is the way that she interacts with her guests.

Newman lives above the store. To walk into the retail space downstairs is to see an eclectic mix of cases, furniture, and a cozy feel. Brenda says she didn't like the idea of a counter between the jeweler and the customer, because ultimately, each piece is a collaboration.

For example, for an engagement ring, a couple might come in and discuss with her the center stone shape they are most drawn to. "Everything is based around the center stone," she says. Then the couple will discuss a setting that most interests them, and Newman and her team will come up with a selection of options for stones and settings and metals to fit their unique wants and budget. Before the ring actually gets made with metal, they create a mold of it to show as an example and get final approval. Truly, each experience is custom and a process that fits the specific needs of the customer.

Other times, Newman says, jewelry is brought into her store for repairs or reworking. This could be an inherited gemstone, an old wedding ring, a broken necklace, or something vintage to be recut. "It's all about emotion," she says, an element of jewelry not often considered. The most emotionally difficult project she's worked on was a jewelry assignment in the wake of 9/11. Douglass Mortuary had retrieved items from several victims of the tragedy and asked if Brenda could repair all of the jewelry that they found to be returned to the victims' families.

"I'll never forget, I said, 'Oh my god, this piece of jewelry. This band, it's flat as a pancake,'" she recalls. Among several wedding bands, many had names engraved in them, and many were completely destroyed in the disaster. She got all of the pieces in presentable condition and watched on the news as a husband's wedding ring was returned to his widow, who would now wear it as a pendant to remember him by.

"The world was in chaos at that time, and here we're holding a baggie of what remains of Todd Beamer's watch he wore that day," she describes. In her own life, her most personal piece of jewelry is a ring she keeps on her charm bracelet. After the passing of her father, she inserted an angel into his wedding ring, which her mother wore as a necklace for many years. At the passing of her mother, she combined the stone from her mother's ring with her father's band, and she wears it on her wrist every day.

On May 5th, her store is holding its annual estate sale full of vintage jewelry. From pieces cut back in the 1800s to a 14-carat gold toothpick given to Ryan O'Neal by Farah Fawcett, she sees the full range of jewelry come through her space.

Every piece of jewelry, old or new, has a story. That's what Brenda specializes in.

The stones can be learned, the metals can be shaped, but ultimately, each piece tells a story that uniquely belongs to the person wearing it. Brenda Newman uses her gem skills to help shape each story.

movies, notably to never work with animals to save unnecessary headaches and stress. Any film that relies on a wild animal as its protagonist is indebted with risk, regardless if it's a documentary or not. In *Gunda*, Kossakowsky's entire film rests on the presence of these animals. Plus, the absence of additional music or voice overs leaves so

much up to chance, and capturing that unpredictability in its raw, authentic state is the film's biggest strength. The decision to shoot in black and white was intentional for an interesting reason, and seemingly in opposition to how many filmmakers would have approached a film like this. Kossakowsky states, "I didn't want to show cute pink

piglets –and believe me, they are very cute indeed. I didn't want to seduce the viewer in that way. It felt to me like black and white makes us focus on their soul rather than their appearance."

Unlike some animal rights documentaries that are overly graphic and attention seeking, the message behind *Gunda* isn't forceful or

political. It's a simple message that asks us to slow down and experience life as the animals do. *Gunda* asks us to meditate on the mystery of animal consciousness and think about how we contribute to their way of life. Can we do better?

93 min. '*Gunda*' is now playing at The Landmark theater. •

ORDINANCE [ ] OF THE CITY COUNCIL OF THE CITY OF INGLEWOOD, CALIFORNIA ADDING SECTION 2-196.1 INGLEWOOD TRANSIT CONNECTOR PROCUREMENTS TO ARTICLE 5 OF CHAPTER 2 OF THE INGLEWOOD MUNICIPAL CODE AUTHORIZING USE OF ALTERNATIVE PROJECT DELIVERY METHODS AND ESTABLISHING CERTAIN REQUIREMENTS FOR PROCUREMENTS AND CONTRACTS RELATED TO THE PROPOSED INGLEWOOD TRANSIT CONNECTOR PROJECT.

WHEREAS, the City of Inglewood (the "City") is proposing to construct an approximately 1.6-mile-long, three station, fully elevated, electronically powered automated people mover system known as the Inglewood Transit Connector Project (the "ITC Project") that will connect passengers directly from the regional Metro Rail system to the City's new housing and employment centers, and sports and entertainment venues; and

WHEREAS, the proposed ITC Project is expected to increase transit ridership, reduce vehicle miles traveled and greenhouse gas emissions, and improve air quality throughout the region; and

WHEREAS, Article XXXIII, Section 1 of the City Charter provides that the City Council shall, by ordinance, prescribe the procedures and requirements for the City's awarding of public projects in a manner that preserves the integrity of the competitive bidding process, insures the protection of public funds, but at the same time provides opportunity to effect economies in the operation of the City which are in the best interests of the public; and

WHEREAS, Article XXXIII, Section 2 of the City Charter includes certain requirements and procedures for procurement and contracting related to public projects and such requirements and procedures are codified in Chapter 2, Article 5, Sections 2-196 and 2-198 of the Inglewood Municipal Code (collectively, the "Requirements"); and

WHEREAS, Article XXXIII, Section 4 of the City Charter authorizes the City Council to declare certain contracts to be exempt from the Requirements, provided such exemptions are consistent with the intent expressed in Article XXXIII, Section 1 of the City Charter; and

WHEREAS, the purpose of this ordinance is to authorize the use of alternative project delivery methods for contracts between the City and any successful contractors for procurement, pre-construction services, design, construction, finance, operations and maintenance, and related services for the Inglewood Transit Connector Project ("ITC Project") may be procured in accordance with the following subsections:

A. Alternative Methods. With respect to any procurement and contract under this ordinance, the City may utilize some or all of the following project delivery methods and procurement strategies:

(1) Alternative project delivery methods, including, but not limited to, design-build,

design-build-maintain, design-build-finance-

maintain, design-build-operate-maintain, con-

cession arrangements, early contractor involve-

ment, early works agreements, and other forms

of alternative project delivery, or any combina-

of any such methods.

(2) Use of a best value approach to procure and contract for delivery of the ITC Project, which approach shall generally set forth the criteria the City will evaluate when reviewing submittals, the relative weight of such criteria in the evaluation process, and the factors the City will consider in making its award determination, including, but not limited to, experience and qualifications, technical proposals and other related factors, in addition to contract price.

(3) Competitive solicitations using requests for qualifications, short-listing of qualified proposers, requests for proposals, pre-proposal procedures consistent with appropriate protocols including review and assessment of design and architectural components, meetings or interviews with individual short-listed proposers, and community engagement and reviews of proposer solutions, revised proposals, and best and final offers.

(4) Negotiations with proposers prior to award to allow clarification and changes in the proposals. Should the City elect to use a competitive solicitation in connection with any procurement or contract under this ordinance, the City shall have discretion to require some or all of the procurement procedures described in subsection B below.

B. Procurement Process. With respect to any procurement and contract under this ordinance in which the City issues a request for qualifications, request for proposals or similar solicitation document, the City may utilize some or all of the following procurement procedures:

(1) The City shall take adequate measures to treat each proposer fairly and employ reasonable precautions to prevent the disclosure of confidential or proprietary information contained in any one proposal with other proposers, except as may be required by law.

(2) The City may identify a process whereby proposers may request and receive authorization to deviate from technical and financial specifications, provided the proposer has demonstrated to the City's satisfaction that the proposed deviation will meet or exceed the applicable specifications.

(3) To the extent permitted by applicable law, the City may withhold proposals from release or disclosure until the award of the contract and the conclusion of any protest or other challenge to such award or the lapse of the protest period without challenge.

(4) The City may require that all proposals be submitted to the City's designated procurement manager for the ITC Project, who shall safeguard them in a manner and at a location the designated procurement manager deems appropriate to reasonably maintain the confidentiality and security of the proposals.

(5) The City may require that every proposal for any contract under this ordinance be accompanied by proposal security, subject to terms and conditions and in such amounts as determined in the City's discretion, securing the proposer's obligation to enter into the proposed contract if the same be awarded to it.

(6) The City may require the party directly under contract with the City, one or more of that party's prime contractors, or any combination thereof, to provide performance and payment security in the form of bonds, guarantees, letters of credit or any other type of financial instrument, or any combination of the foregoing for all or part of the cost of the ITC Project. To the extent permitted by applicable law, the City may set the amounts of such performance and payment security based on its determination of what is required to adequately ensure payment of subcontractors and protect the City's interests.

(7) The City may pay stipends or payments for work product on terms and conditions and in such amounts as determined in the City's discretion.

(8) In exchange for such stipend or payment for work product, the City may require the proposer to grant to the City the right to use any work product contained in the proposer's proposal.

(9) To the extent permitted by applicable law, the City may allow contractors identified in a proposal for a contract procured under this ordinance to delay compliance with applicable licensing requirements until contract execution or financial close, as determined by the City in its sole discretion.

(10) To the extent permitted by applicable law, the City may set a uniform rate of interest on payments due and owing but not yet made on contracts related to the ITC Project.

(11) To the extent that the City utilizes any of the procurement procedures described in this subsection, the request for qualifications, request for proposals or similar solicitation documents issued under this ordinance will specify relevant terms and conditions.

C. Contracting. Notwithstanding any other provision of law, the City may include in a contract entered into under this ordinance any provision that the City determines is necessary or appropriate. Examples of such provisions include, but are not limited to, the following:

(1) Provisions addressing the allocation and management of project risks including without limitation design, construction, geotechnical, delay, permitting, governmental approvals, change of law, change in utility costs, operations and maintenance, force majeure, inflation and financing risks.

(2) Provisions providing that the City may pay the contractor by making periodic payments to the contractor through the term of the contract or any portion thereof. Such payments may include: availability, milestone, progress, substantial completion or final acceptance payments; payments for costs related to design, construction, financing, operations and maintenance; payments for costs incurred from utilities, land acquisition, and any other project development costs; and a rate of return on the contractor's investment the City determines to be appropriate.

(3) Provisions providing that the City may make downward adjustments to payments owing to the contractor where the contractor fails to achieve performance specifications or otherwise fails to

comply with its obligations under the contract.

(4) Provisions requiring that either the City or the contractor provide the utilities required during construction and operation of the ITC Project.

(5) Provisions requiring the use of arbitration or other alternative dispute resolution procedures to resolve disputes between the City and the contractor. Such alternative dispute resolution procedures may include, but are not limited to, binding or nonbinding process, arbitration or mediation, the establishment of a board to hear disputes and/or resort to the courts.

(6) Provisions addressing the City's requirements for operations, maintenance, renewal, rehabilitation, reequipping, use and change in use of the ITC Project, flexibility to expand the ITC Project, and provisions allocating performance obligations between the contractor and the City with respect to such requirements.

(7) Provisions providing for compensation of the contractor upon early termination of the contract, including, but not limited to, termination by the City for its convenience, or termination by default of either the City or the contractor. Compensation on termination amounts and formulas shall be as determined by the City in its discretion.

(8) Provisions specifying events of default and remedies available to the contractor and the City.

(9) Provisions setting forth the technical standards and specifications with which the contractor must comply, including, but not limited to, performance standards and output specifications, together with provisions allowing the City to enforce, amend or waive such technical standards and specifications.

(10) Provisions requiring that the contractor obtain and maintain insurance with such coverages and deductibles as determined by the City to be appropriate in its discretion.

(11) Provisions regarding the maintenance and auditing of the contractor's books and records.

(12) Provisions requiring the contractor to waive certain rights and benefits conferred by Public Contract Code Section 7104, to the extent that it may be inconsistent with any provision of the contract.

D. Funding and Financing. The City may utilize any lawful source of funding and financing, or combination thereof, for the development, design, construction, operations, maintenance, and renewal of the ITC Project. The City is hereby authorized to:

(1) Require the contractor to arrange for all or a portion of the financing required for the ITC Project and the City may elect in its discretion to participate with the contractor in any gains realized through the refinancing of the ITC Project, as determined by the City in its discretion.

(2) Pursue and apply for and accept from the United States, any state, or any of their respective agencies, or from any regional or local governmental entity, such funds and credit assistance as are available to it for carrying out the purposes of this ordinance, whether the funds are made available by grant, loan, guaranty, line of credit or other financing arrangement, and pursue and apply for such funds and credit

assistance to the extent necessary to support the contractor's use of such mechanisms to arrange for all or a portion of the financing required for the ITC Project.

(3) Enter into such arrangements and other agreements with the United States, any state, or any of their respective agencies, or with any state, regional or local governmental entity, as may be necessary, proper, and convenient for carrying out the purposes of this ordinance.

(4) Accept from any source any grant, donation, gift, pledge, or other form of conveyance of land, money, other real or personal property, or other valuable thing made to the City for carrying out the purposes of this ordinance.

(5) Impose and collect fees, rents and charges from users of the ITC Project, as well as other project-generated revenue streams (including, but not limited to, advertising, corporate sponsorships, joint use and fiber optic technology).

The City may increase such fees, rents and charges and use lawful measures to enforce such fees, rents and charges and/or authorize a contractor or another public entity to impose, collect, increase and enforce such fees, rents and charges to the same extent as available to the City. The use, application and sharing of such fees, rents, charges and revenue streams by the City or the contractor shall be as determined by the City in its discretion.

(6) Consider and adopt other alternative strategies for increasing ITC Project revenues as a means to reduce long term ITC Project costs payable by City or its assignee.

(7) Utilize any other lawful source of funding and financing, or combination thereof, that the City determines is necessary or appropriate.

**SECTION 4. Severability.** If any section, subsection, sentence, clause or phrase of this ordinance is for any reason held by a court of competent jurisdiction to be invalid, such decision shall not affect the validity of the remaining portions of this ordinance. The City Council declares that it would have adopted this ordinance and each section, subsection, sentence, clause and phrase thereof, irrespective of the fact that any one or more section, subsection, sentence, clause, or phrase be declared invalid.

**SECTION 5.** The City Clerk shall certify to the introduction, approval, passage, and adoption of this Ordinance by the City Council and shall cause the same to be published in accordance with the City Charter, and thirty days from the final passage and adoption, this Ordinance shall be in full force and effect.


