South Bay Entrepreneurs Simplify Baby-Feeding

El Segundo residents Brandon and Lauren Stuart are co-founders of the innovative bokee bottle-feeding accessory product, which allows a parent to hold a young child or multi-task while quickly filling a bottle or sippy cup. Not quite hands-free bottle prep, but a definite, innovative step in the right direction.

The Stuart's are proud parents of 3 1/2-year-old twins, Owen and Elodie, who were born prematurely, at 32 months. After the birth of the children, the family decided that what was best for the Stuart family was for Lauren to not return to her job at Google, where she presided over sales strategies and did research on the "entertainment side of things," and become a stay-at-home Mom.

Brandon, who has a background working as a creative director and marketer, said he is always brainstorming ideas to make an existing product or idea better. Said Lauren: "Ever since I have known him (they started dating in 2007), he almost has... too many ideas."

Brandon said that, while participating in the bottle-feeding process for his young twins, he thought that "there has to be a better way to facilitate a process that young parents might be doing ten times a day."

So, he and friend Andrew Doan, who were, said Lauren, attending a bachelor party at the time, powwowed. Sure, why not, what else would you do at a bachelor party other than to brainstorm ideas about seamlessly securing baby bottles?

Doan, works in the tech industry, in Northern California with wife Nicole and children, said teaming with the Stuarts to develop the bokee has been a process he relishes, citing a "fantastic collaboration. My relationship with the Stuart's has been an incredible journey of playing-up our strengths," he said. "My family's technical depth married with the Stuart's brand and storytelling."

Doan's second child was born on the same August day that the Stuart twins arrived, and he was going through many of the same child-rearing tribulations as Stuart was. Doan's background is in engineering and was a childhood friend of Stuart's youngest brother Brady, who lives in El Segundo and works as an assistant equipment manager for the Los Angeles Lakers.

The two fathers pooled their collective entrepreneurial thoughts, and the bokee prototype was developed, with Lauren being chief

prototype tester.

Here is how the product works: First, push the bokee down on a smooth and dry countertop. It then suctions to the tabletop surface. Then, you place the bottle or sippy cup into the bokee, and apply gentle pressure as you loosen or tighten the bottle as needed. A substantial upgrade tool in the way youngsters have been fed since the first baby bottle was invented in 1841. And if you do not happen to have children who necessitate bottle-feeding or sippy cups, Lauren said the bokee makes a perfect beer can or beer bottle holder. So, there is that option.

The bokee hit the market in late September of 2019 and was recently recognized by the Junior Products Membership Association (JPMA), which touts innovative baby and children's products, as the 2020 "best product under \$25." Brandon said he was overwhelmed by the JPMA selection, saying that it was "one of the top-three moments for us, because we are such a small team." He said the co-founders "raised a celebratory glass," though it has not been discerned if they secured the glass in a bokee prior to the start of the celebration.



Summary of Proposed Ordinance 2197

On May 26, 2020 at 6:00 p.m., the City of Hawthorne is considering the adopting of Ordinance No. 2197, a proposed ordinance adopting by Reference the 2019 Editions Of The California Building Standards Code, California Residential Code, California Electrical Code, California Plumbing Code, California Mechanical Code, California Existing Building Code, California Green Building Standards Code, California Energy Code, California Administrative Code, California Historical Building Code, And 1997 Uniform Code For The Abatement Of Dangerous Buildings; Adopting Local Amendments To The Referenced Codes; And Adding Chapters 15.07 (Administrative Code), 15.13 (Energy Code), 15.30 (Historical Building Code) And 15.46 (Uniform Code For Abatement Of Buildings And Repealing And Re-Enacting Chapters 15.04, 15.05, 15.08, 15.24, 15.28, 15.32, 15.36, And 15.40, & Repealing All Prior Editions Of The California Building Code Previously Adopted By The City Council.

Pursuant to California Government Code section 36933(c)(1), the City Council has directed the preparation and publication of a summary of Ordinance No. 2197 as follows:

Ordinance No. 2197 regulates and governs the conditions and maintenance of all property, buildings and structures by providing the standards essential to ensure that structures are safe, sanitary and fit for occupation and use. The ordinance adopts and modifies 2019 edition of California Building Code to the greater requirements than those set forth in California State Building Standards and reasonably necessary

for the local climatic, geological, or topographical conditions. The said modifications are required due to the local geological conditions that include major earthquake faults and assure that new buildings are constructed in accordance with the scope and objectives of the International Building Code. This includes requiring more than the conventional framing requirements.

The ordinance also adopts in full the 2019 editions of the California Mechanical Code, Plumbing Code, Electrical Code, Existing Building Code, Residential Code, California Energy Code, California Administrative Code, California Historical Building Code, 1997 Uniform Code for the Abatement of Dangerous Buildings and California Green Standards Building Code. The aforementioned codes together with certain amendments, deletions, exceptions, and qualifications, generally deal with all aspects of building construction, specification of building materials, plumbing design, water supply and drainage systems, approved construction and plumbing techniques, electrical specifications, engineering formulas to be utilized during building design, fire safety systems for residential buildings, retrofitting techniques, energy conservation techniques, and special requirements dealing with fire and seismic safety.

In addition to adopting the various Codes set forth above, this Ordinance adopts certain fees and penalties.

Jonny Felker Reaching His Goals

The El Segundo high school class of 2020 is just a few weeks from graduating. I've had the opportunity to meet some of the class' top students and athletes. Jonny Felker is not only one of his class' top students scholastically but a standout runner on the cross country team and is an Eagle Scout.

Jonny is one of those extraordinary individuals who have leadership qualities to go along with a strong work ethic to achieve his goals. He has had tremendous success in the classroom and is helped motivated by his desire to be the best he can be. During this time of on-line classroom learning he says, "Staying current with all of my classes is really tough. It's harder to focus at home, so homework takes longer than it should. You just have to force yourself to not be distracted until whatever assignment is finished."

Naturally Jonny misses his friends as on-line schooling prevails and says, "It's weird from seeing your friends everyday, then going im-

mediately to not seeing them at all. So, I miss seeing all the people I went to classes with." He says he stays in touch with social media outlets and the old fashioned way, the telephone.

Jonny's success in the classroom has translated into one of the tops in his class. He has a 4.5 GPA with three AP classes that has made it a challenge. During the week of finals he found it necessary to block out all distractions to concentrate. He says that his favorite class this year is, "Biomed with Mrs. Tucker. It's easily my less stressful class. I had a really good table of classmates which makes it that much better."

With Jonny's leadership skills, personality and his high standing in his class he was selected as an OSS cabin leader. He was in charge of 11 sixth graders for a week and admits at times it was a challenge. His brother Mathew was a camp leader as a junior and senior so he wanted to follow in his footsteps. "While we were up there, we were working basically the whole day. It was always super rewarding when they'd just say how cool I was out of nowhere." It was an experience he says he'll never forget.

With his grades Jonny could attend just about any University in the country. He will attend the University of Utah in the fall majoring in Biology. He says ultimately he'd like to be a doctor and has an interest in Anesthesiology. "I feel like I would be good at that. I've also looked into physical therapy as a backup."

Jonny has had many influential people in his life. He says his father, brother, his cross country coach and two cousins Brandon and Bryce have all had a part in who he has become and what his future is shaping up to be.

His father, Todd, was in Boy Scouts as a boy growing up and made it to the rank of Life Scout. Only a family tragedy prevented him from becoming an Eagle Scout. Todd says it

was important for him to see that his sons reach the pinnacle of Scouting. Jonny says some of his best memories were Scout camping trips with his father. His Eagle Project was building a large shed for the Friends of the LAX dunes which restore the areas between the airport and the beach. Jonny's project taught him how to lead a group of people, organization and planning.

He says his cousin Brandon, a former Air Force Thunderbird pilot, was someone he looked up to. At family gatherings Brandon would encourage him to be the best he could be in whatever he decided. His cousin Bryce, who is a few years older than Jonny, is also interested in going into the medical field. "He's been able to tell me a lot about what I can expect in the near future." Jonny's brother Mathew was a big influence since they went through scouting together and achieved their Eagle rank the same year.

Jonny got into running thanks to his P.E. teacher in his sophomore year. There was

a run each week and Jonny impressed his teacher so much he related his thoughts to the cross country and track coach Marcos Bolanos. Coach Bolanos talked to Jonny and the rest is history.

Jonny started his cross country as a junior. "Cross country changed my life a ton since I joined. I think the biggest lesson I learned was how to set and work towards long term goals as well as dealing with failure." At the start of each season, for track and cross country, the whole team would do goal setting. For cross country Jonny's goals were less time-focused and more aimed at becoming a better runner in general. On the other hand his track goals were much more defined.

In his first season running cross country as a junior Jonny was named the team's Most Valuable Runner. He says it wasn't something he envisioned but something he takes pride in since it was an award voted on. As a senior he was one of the team's top seven runners.

The Stuart's have lived in El Segundo for eight years. Brandon's sister Taryn has been a resident of Candy Cane Lane for more than a decade, which is how he came to know the unique charms of El Segundo. Asked what brought them to settle in El Segundo, Brandon said that, other than the family connection, he had lived in different locales in the Los Angeles area, and that "this is the only place that feels like a community, and is a great place to raise a family."

Brandon, who is from Santa Clarita, currently works as an executive creative director for a San Diego company, mostly telecommuting from home or working at the local Uinta office-sharing building. He has also had stints working for DreamWorks and E! Entertainment.

Of the five varsity races he competed in he bettered his time in four of those races. He helped the Eagles advance to the California CIF State Cross Country Championships.

At the cross country awards banquet Coach Bolanos awarded Jonny the Coach's Award. It is in recognition of the runner who has improved the most, the hardest working runner and dis-

plays the most positive attitude on the team.

When Jonny decided to run track he focused on the distance events. He would set a time to aim for in his 1600 and 3200 meter races. About halfway through his sophomore year he ran a 5:39 1600 meter race with a goal of 5:30. As a junior at the end of the cross country season he ran a 5:12 during a time trial so of

he set a goal of breaking 5 minutes. During his junior year he ran a time of 5:02. "I was just short of my goal but on the bright side, in one of my favorite races, I hit my 3200 goal with a time of 10:58."

As a senior Jonny was looking to accomplish his goals he'd set for himself. To add to his motivation Coach Bolanos announced it would

be his last year teaching. This was the day before the Palos Verdes dual meet in which he was running the 1600. "I took my dad's advice and didn't start out too fast." In his previous races Jonny's first lap was always 10 seconds faster than his target pace was. "I would end up having a really slow mid-race, which would mess up my time."

Going into the second lap he was in dead last but was exactly on pace to go 5:00. He did that exact same thing for two more laps. He passed two big groups of runners who had slowed down from their first lap pace and Jonny came into the last lap feeling great. "I went all out and came in with the timer showing 4:55. This was by far my most triumphant moment." In the final meet of the season, before the Corona Virus shutdown all sports, Jonny bettered his 3200 meter goal by 23 seconds.

Jonny says he accomplished his goals he set out to do before it ended. He says running cross country and track for Coach Bolanos changed his life by making him more confident. "Knowing that I've made it through a ton of insanely hard workouts and races will serve as a reminder of what I'm capable of."
