Kyle Myers Enjoying his Fun Life

Kyle has been a good student throughout his four years of high school. He will take an impressive 3.6 GPA to San Marcos State to study Business Management. His AVID teacher, Mr. Whalen, says, "Kyle embodies

the AVID spirit, which is to bring your determination to succeed but to do it in a team framework. Kyle is a key component of a strong AVID class of 38 graduates this year. I cannot imagine his classmates feel anything but respect for him because he is a guy who shows care and concern for others."

Kyle comes from an athletic family, so naturally, he was interested in sports. His grandfather, Jerry Filson, was one of his class' top athletes. He was a two-year starter for the baseball team that won back-to-back CIF championships. In his only year of playing baseball as a freshman, Kyle became the lead-off batter and played centerfield. Kyle also played basketball, football and ran track.

Kyle played basketball and football for all four years and ran track his sophomore year. Kyle's love for basketball was noticeable, and he was one of the team's leaders

on each team he played on.

His basketball coach, David March, was impressed with Kyle and said, "He was one of the hardest working and toughest players I ever coached. Kyle epitomizes what El Segundo basketball is all about." Kyle was the team's Defensive Player of the Year his senior year.

Two-Legged: How Wolves Change Lives at The Shadowland Foundation

Paul Pondella couldn't fill out a job application.

His dyslexia was too overwhelming, and at the age of 18, he was kicked out of high school. Two weeks later, in 1978, he was arrested for growing marijuana. Standing in front of the judge, he was given a choice: get a job or go to prison.

Paul played baseball during school. He was an all-star for 12 of the 13 years he played, and remembering that McDonald's was one of his team sponsors in the past, he found a contact and met for an interview. The manager was happy to see him. Right away, he gave Paul a

free meal and an application to fill out, but panic set in.

"I was so embarrassed that I couldn't read the application," says Paul.

"I snuck out of the restaurant and left the food there, too. Then I went back home and the only place I knew where to go next was outside. I couldn't apply for a job, but I had enough courage to go and knock on neighbors' doors to ask if I could mow their lawns and clean their yards."

So after a failed interview at McDonald's, Tree King Tree Service was born and it evolved from there.

Located in Lake Hughes, CA, Paul and his wife, Colette Duvall Pondella, run the

Yes—You Should be Watching Netflix's New Jazz Drama Series, *The Eddy*

Note for note, *The Eddy* nails how life, in all of its free-spirited, surprising—and at it's darker core, chaotic and uncontrollable—moments, is like the beautiful harmony of jazz music.

And no other current filmmaker makes that musical leap to film better than Damien

But beyond all that, *The Eddy* is really at its best when the story builds to a musical sequence, at which point it stops to sink into the best jazz jams you've heard, and all from the walls of a real Parisian nightclub (and really, is there anything better than being transported to the heart of Paris while we're all locked down right now?). Chazelle, who first splashed onto the scene with 2014's *Whiplash*, only to follow that with the Hollywood musical throwback *La La Land*, which made Chazelle the youngest Best Director winner in Oscars history. With his newest project, Chazelle side-steps narrative features to get into the mini-series game, here making an 8 episode story for Netflix (now streaming). Centered around American nightclub owner and previously prodigious pianist, *The Eddy* (the name of the club) tells the story of Elliot (André Holland) trying to save his Parisian nightclub, as well as his band and singer (Joanna Kulig) from going under. Throw in a newly transplanted daughter (Amandla Sternberg) and a mob that's come around to settle their debts, and you get a show that's exciting, gripping, dramatic, and visually stunning (the series was shot on 16mm film, which lends a grain not typical for Netflix or any streamer).

Fans of the director will have already noticed how Chazelle centers his stories around gifted artists whose attempts to achieve greatness through their craft often consume their realities, and audiences will be happy to see similar themes here, with Holland's heartfelt performance driving the show (although each

Your Neighborhood Therapist

Dear Neighborhood Therapist,

I have been at my job for eight years. I used to really like it. When I first started, I was doing the kind of work I had always hoped to do. I still do some of that work, and I like my clients, but there has been a lot of turnover in these eight years, and it is an entirely different workplace from the one I joined. Now, the atmosphere is poisoned with backstabbing careerists, and that's just not me. The idea of talking to my boss and some of my co-workers terrifies me. I get actual nightmares. My income and the health insurance my job provides are both important to our family, but I don't know if I can take the stress anymore. It's affecting my physical health and our family life. It breaks my heart that the company I used to love has changed so much. I don't know what to do.

Dear Rock and a Hard Place,

Sometimes, if we are lucky in our work and career, we hit the trifecta: a job that pays the bills, offers work we find fulfilling, and has co-workers whom we like and respect. We too often undervalue this last aspect of our work life. Work you love can be ruined by the wrong people around you. Having the right people around you can make hard jobs more tolerable. You were lucky and caught lightning in a bottle, but organizations change just like people do. It sounds like you entered this job in good faith, and willingly gave it a part of yourself only to be betrayed years later. This stinks.

It is also something that happens with human relationships, and thinking of this as a relationship is a helpful way to consider your dilemma. People often stay in relationships because so much of their identity is connected

to what used to be the good parts. Eight years ago when you joined, you were happy to associate yourself with the job you did and the people around you. Now it's toxic. How can you square that? You can't. Nobody can, but we all try because we have invested so much, and it adds to the anxiety.

You hit on something important. Keep hammering at this: the place has changed. The place has changed. The place has changed. You are not the organization you work for. You don't share values. This is not what you signed up for. It is not who you are.

Only you will know if you should stay or quit. You may be stuck in a situation that you are powerless to change at least in the short-term. People stay in bad relationships or bad jobs for all kinds of reasons, including survival. You may find that in today's uncertain work environment, leaving is too risky, even in spite of the damage the job is doing.

Many of us, at some point in our lives, find ourselves in situations where none of our options allow us to be our best selves. No matter what, remember you said this about your situation: "That's just not me." You know who you are, and this job is not it.

It's also not forever.

Shadowland Foundation—a non-profit that hosts on-site events and programs to educate people about wolves.

Colette serves as Co-founder and Program Director of Shadowland, but her affinity for wolves began when she met Paul outside of a spiritual center.

“We were friends for about a month,” says Colette, “but we had similar stories of how our marriages ended and I felt bad for him.”

Before crossing paths with Colette, Paul went through a whirlwind of trauma despite becoming an arborist and building a successful business.

As a young man, he struggled with alcohol and drug addiction, but that didn't keep him

from working hard. Out on the job, he would often get calls from clients to remove cats and iguanas from trees. Even the SPCA would enlist him to help with rescue efforts in the Angeles Forest, and one day in the early 1980s, he got a call to rescue a wolf-husky mix that was sick with Canine Parvovirus.

“Everyone said to have it put down, but I took it to a veterinarian that I knew and he treated her—she lived. Her name was Panda and she was amazing, but time with the four-leggeds expires way too quickly,” says Paul.

After Panda died, Paul was called once again to the Angeles Forest in the early 90s to rescue a timber wolf named Kiva.

“We rescued her and I asked animal control

what I was supposed to do, but they just turned and walked away,” Paul explains. “Now, I don't know if that's what they were supposed to do or not, but the energy of the forest spoke to me and brought Kiva and I together. That's when I realized, too, that this was something I needed to bring back to the community to educate people about.”

There are four different programs that the Shadowland Foundation has to offer:

Playing with Wolves: Wolf Education for Children of All Ages—children have the opportunity to learn about the true nature of wolves and interact with them up close to help understand their beauty, majesty, and ensure their survival for the future.

Wolf Pack: Teen Motivation Programs—using the unity and power of the wolf to educate teens about community and self-acceptance. Teens are introduced to the wolves to help develop their individuality, passions, and purpose.

Summary of Ordinance 2202 Enacting Chapter 2.3 of the Hawthorne Municipal Code ("HMC") Re: Elected and Appointed Officials Disclosure of Ex Parte Communications. Pursuant to Government Code section 36933(c), the following constitutes a summary of Ordinance No. 2202 which will be considered for adoption by the City Council at its regular meeting on June 9, 2020 at 6:00 p.m. Pursuant to California Government Code section 36933(c) (1), the City Council has previously directed the preparation and publication of a summary of Ordinance No. 2202 which enacts Chapter 2.3 of the Hawthorne Municipal Code requiring disclosure of all Ex Parte Communications of elected and appointed officials as follows: **Purpose of Ordinance No. 2202.** Enactment of Chapter 2.3 will promote transparency, accountability, and full disclosure of attempts to influence City officials making decisions on legislative, administrative, and quasi-judicial matters. The reporting of and disclosure of certain communications by City officials shall be required. A City elected or appointed official shall disclose all ex parte communications with any interested person defined as any person who engages in promoting or influencing any administrative, legislative, or quasi-judicial action or any person with a financial interest in any administrative, legislative, or quasi-judicial action before the city council or any other city commission. Ex parte communication shall mean any direct communication between an interested person and a City elected official attempting to influence administrative, legislative, or quasi-judicial action that is not public testimony or made part of the public record. The following are not ex parte communications: 1) any communication between a staff member acting in his or her official capacity and any City elected or appointed official or interested person; 2) any communication which occurs on the record during an official proceeding of a state or local agency that involves a City elected or appointed official

who also serves as an official of that agency. In addition, Chapter 2.3 will prohibit any interested person from doing the following: A. Do anything with the purpose of placing any City official under personal obligation to the interested person. B. Deceive or attempt to deceive any City official with regard to any material fact pertinent to any pending or proposed legislative, administrative, or quasi-judicial action. C. Attempt to create a fictitious appearance of public favor or disfavor of any proposed legislative, administrative, or quasi-judicial action or to cause any communication to be sent to any City official in the name of any fictitious person or in the name of any real person, except with the consent of such real person. D. Represent falsely, either directly or indirectly, that the interested person can control the official action of any City official. E. Accept or agree to accept any payment in any way contingent upon the defeat, enactment, or outcome of any proposed legislative, administrative, or quasi-judicial action. The City Council finds and determines that there is no possibility that the adoption of this Ordinance will have a significant effect on the environment. Accordingly, this Ordinance is not subject to the requirements of the California Environmental Quality Act (CEQA) pursuant to Sections 15061(b)(3) and 15378 of Division 6 of Title 14 of the California Code of Regulations. All contractors and subcontractors must furnish electronic certified payroll records to the Labor Commissioner for all new projects awarded on or after April 1, 2015. The Labor Commissioner may excuse contractors and subcontractors on a project that is under the jurisdiction of one of the four legacy DIR approved labor compliance programs (Caltrans, City of Los Angeles, Los Angeles Unified School District and County of

Sacramento) or that is covered by a qualified project labor agreement. This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.
Attention is directed to the provisions of Sections 1777.5 and 1777.6 of the California Labor Code concerning the employment of apprentices by the Contractor or any subcontractor under them. The Contractor or any subcontractor shall comply with the requirements of said sections regarding the employment of apprentices. Information relative to apprenticeship standards and administration of the apprenticeship program may be obtained from the Director of Industrial Relations, San Francisco, California, or the Division of Apprenticeship Standards and its branch offices.
Notice is hereby given that the City Council has ascertained the prevailing rates of per diem wages in the locality in which the work is to be done for each craft or type of workman or mechanic needed to execute the contract in accordance with the provisions of Section 1770, et. seq. of the Labor Code; said prevailing rates are on file in the Office of the City Clerk and are incorporated herein by reference. Copies shall be made available to any interested party on request.
Attention is directed to the provisions of Public Contract Code Section 10164 concerning Contractor's licensing laws. Monitoring and enforcement of the prevailing wage laws and related requirements will be performed by the Labor Commissioner/Department of Labor Standards Enforcement (DLSE).
The Contractor and all subcontractors shall adhere to all the Federal, State, City, and Centers for Disease Control (CDC) guidelines in regards to work and community mitigation actions to prevent the spread of COVID-19.
Separate payment and performance bonds, each in an amount equal to 100% of the total Contract amount issued by a California admitted surety as defined in California Code of Civil Procedure Section 995.120, are required, and shall be provided to the Owner prior to execution of the Contract and shall be in the form set forth in the Contract Documents.
Bid Security. Each Bid Proposal shall be accompanied by Bid Security in an amount TEN PERCENT (10%) OF THE TOTAL BID AMOUNT. Failure of any Bid Proposal to be accompanied by Bid Security in the form and in the amount required shall render such Bid Proposal to be non-responsive and rejected by the District.
No Withdrawal of Bid Proposals. No Bidder shall withdraw its Bid Proposal for a period of ninety (90) days after the award of the Contract by the District's Board of Education. During this time, all Bidders shall guarantee prices quoted in their respective Bid Proposals.
Substitute Security. In accordance with the provisions of California Public Contract Code §22300, substitution of eligible and equivalent securities for any moneys withheld by the District to ensure the Contractor's performance under the Contract will be permitted at the request and expense of the Contractor. The foregoing notwithstanding, the Bidder to whom the Contract is awarded shall have thirty (30) days following action by the District's Board of Education to award the Contract to such Bidder to submit its written request to the District to permit the substitution of securities for retention. The failure of the Bidder to make such written request to the District within said thirty (30) day period shall be deemed a waiver of the Bidder's rights under California Public Contract Code §22300.
Waiver of Irregularities. The District reserves the right to reject any or all Bid Proposals or to waive any irregularities or informalities in any Bid Proposal or in the Bidding.
Award of the Contract. The Contract for the Work, if awarded, will be by action of the District's Board of Trustees to the responsible Bidder submitting the lowest responsive Bid Proposal.
Inquiries and Clarifications. The Bidder is advised that all inquiries and clarifications about the Bid Documents, Drawings, Specifications, etc., shall be submitted to the District in writing at least eight (8) calendar days before the Bid opening date. 
