ensus Count Builds Momentum

The once-per-decade count of people living in American households reached the midway point this week, and it appears at least three South Bay cities are headed for an undercount. The census-response rates for Inglewood, Hawthorne and Lawndale were slightly below the statewide and national averages, as of Sunday.

Census results are used to determine how much funding local communities receive for social services, including public health and housing. An undercount can be costly to local governments because of federal agencies' base funding on population and income data.

The 2020 count will be used to allocate seats in Congress - and it's a possibility California could lose a congressional seat. The household surveys also serve as a snapshot for drawing boundaries for congressional and state legislative districts, along with school districts. The pandemic added to the herculean task of counting everyone.

The U.S. Census Bureau, in March, mailed surveys to every home across the South Bay, asking how many people lived with them on April 1. The information about each individual, including their gender and nationality, is kept private and not shared with law enforcement or federal immigration authorities, the Census Bureau assures residents. And, the 2020 survey will not ask for a person's citizenship or immigration status.

The coronavirus put the census campaign three months behind when the governor and Los Angeles County health officer ordered all non-essential workers to stay home. As a result, the census campaign was given an extension until October 31 to finish the 2020 count. Despite the social-distancing

restrictions, this census has technology on

The 2020 census allows for online responses, which appears to be a popular feature. Even in cities with lower-than-average responses, a majority of residents have answered the 10-minute survey using the Census Bureau's web site. (For the security of households, a Census ID number was printed on the March mailing to U.S. households. That ID number is handy when logging on to the Census Bureau web site.)

For example, Hawthorne has a 58.8 percent response rate to the 2020 Census, as of Sunday. How many of those households skipped the mail and used the web? A very high 51.4 percent of all completed surveys were done electronically, according to the bureau.

Inglewood had the lowest response to date to start the July 4th week, with 56.6 percent of households reporting their occupancy numbers and relationship information. Almost 75 percent of the city's census forms were submitted online. The numbers for Lawndale were 60.6 percent answering the census - 87 percent done online.

Los Angeles County as a whole, isn't doing much better. With a 57.9 percent response, census field workers will be knocking on doors starting in mid-August at addresses that haven't replied either online, by phone or mail by then, according to spokeswoman Patricia Ramos for the census tracts in the

Responses are accepted by phone or return mail, too; however, the online feature is popular so far. According to Ramos, El Segundo residents by July 4 could surpass the response numbers from the 2010 Census. As of Sunday, El Segundo had a 65.2 percent return rate using the Internet, and a 71 percent response.

Culver City and Carson are in the upper echelon of California cities showing high enthusiasm for what some people consider an intrusion by the federal government on their privacy. Still, two-thirds of the households in El Segundo, Culver City, and Carson finished the survey without a census field worker's visit. Phone calls from the bureau are occasionally needed to clarify answers on a returned survey.

Gardena and Manhattan Beach were middle-of-the-pack among South Bay cities. With 64 percent of households answering the questionnaire as of Sunday.

However, the census will never ask for a Social Security number, bank accounts or credit cards. A U.S. Census employee won't ask for a donation or anything for a political party either, according to the bureau. There are criminals and identity thieves who will try to use the census-collection period to fool people into handing over money and personal information - so beware. Ask for their names and some photo identification.

Some people don't have a mailing address, and finding them and leaving a census questionnaire is the first task. According to Ramos, field workers with the U.S. Census have been out in communities since May 25, dropping off census forms. They won't start knocking on doors until mid-August so again, be wary of anyone who shows up before then claiming to be working for the

U.S. Animal Welfare Organizations Launch Human Animal Support Services Pilot

Human Animal Support Services (HASS), a new animal welfare organizational model, will implement a new range of services for pets and people in 12 pilot cities, helping keep more animals in their homes and communities and reducing the number entering the shelter system through programs and resources

The ideas for HASS were born during the early days of COVID-19, as the pandemic resulted in record numbers of pets being housed in the community through pet foster care.

"During the pandemic, we broadened the safety net for animals dramatically by asking the community for support, and they stepped up in a big way," says Amy Zeifang, Executive Leadership Team, with Maddie's Fund®, who is partially funding this endeavor. "Animals are being reunited with families by community members in numbers not seen before. By keeping animals in the community and not the shelters, we've all realized how much better for everyone it is to focus our efforts on keeping pets and families together," she continued. "Ninety-five percent of Americans with pets believe their pets are family members. Maddie's Fund is proud to see our energies spent supporting that important bond."

The HASS pilot organizations include Humane Rescue Alliance (Washington, DC), Charlotte-Mecklenburg Animal Care and Control (Charlotte, NC), Greenville County Animal Care (Greenville, SC), LifeLine Animal Project (Atlanta, GA), Cabot Animal Resource Center (Cabot, AR), Kansas City Pet Project (Kansas City, MO), El Paso

Animal Services (El Paso, TX), Pima County Animal Care (Tucson, AZ), Los Angeles Animal Services (Los Angeles, CA), Oakland Animal Services (Oakland, CA), Fresno Humane Animal Services (Fresno, CA) and San Diego Humane Society (CA).

"What we've learned throughout the pandemic, is that we can do more when it comes to providing community services to help people and their pets stay together," said project leader Dr. Ellen Jefferson, Executive Director of Austin Pets Alive! and American Pets Alive!. "Whether it's providing resources to help lost and stray animals get home, keeping cats and dogs with their families, or getting sheltered pets to foster and adoptive homes faster, HASS aims to provide the tools to support the pilot shelters and their communities achieve these objectives and more."

Thanks to support from Maddie's Fund, South Fork Foundation, Pedigree Foundation, Petfinder, Brandywine SPCA, and Michelson Found Animals Foundation, HASS will help pilot shelters test new resources and programs. These include remote services like veterinary telehealth and text support, comprehensive stray and lost pet return services, supported self-rehoming for people who cannot keep their pets, and community-based animal protection services.

More than 100 industry leaders including those from national organizations, shelter veterinarians, and animal shelter directors are part of this collaborative effort, with 20 additional animal shelters participating in phase two of this project in the coming months.

Today, parents often struggle to pay childcare costs equal to their rents and mortgages, even for sub-standard care. This is in conjunction with the undervalued field of early childhood educators, who are often referred to as glorified babysitters. Despite their financial challenges, many preschool teachers will find second sources of income in order to continue

incredibly timely, but another reminder that we cannot continue to ignore these issues facing our children. Increasing the focus on Early Childhood through parent education opportunities, as well as access to high-quality childcare in our most underserved communities, is an investment that will not only better our children's lives but will positively impact all of our futures. *No Small Matter* is more than a documentary; it is a movement that demands change, and I am hoping that this is the year we begin to see that happening.

Dear Neighborhood Therapist,

My partner and I have always had different political views, but now our views seem to have drifted so far apart that I have begun to wonder if I can remain in our relationship. I love my partner, but I'm not sure then I can continue with someone who seems to see things so differently from the way I do. I often hear people say that politics shouldn't matter, and I know many people of different political persuasions are in happy relationships, but I'm not sure I am up to it. Am I crazy to think this?

Politically Distressed, El Segundo

Dear Politically Distressed,

You're right: political differences do not always have to ruin relationships. Many of us have had loving relationships with people of different political persuasions. When the stakes are low (do we fund a new wing of the arboretum? do we restrict parking on Main Street? etc.), we have the luxury of supporting Red or Blue the same way we cheer for our favorite sports teams. It's easy enough to live with someone who roots for the Dodgers if you happen to root for the Angels (unless they meet in the World Series, at which time it would probably best for one of you to temporarily move out!).

You have also heard the talking heads on television screaming at us and at each other not to "politicize" what we think, or to "keep politics out of it." These are often the same folks who treat politics like a horse race. If

your relationship broke up over a horse race, then yeah, I might wonder how strong it was in the first place.

But what happens when the stakes are not low? There are plenty of times in our history - now might be one of those times - when the positions of political parties reflected deeply held beliefs about right and wrong.

Think of an extreme: what if your partner was pro-stealing, and you were anti-stealing? Are you supposed to sweep under the rug the fact that your partner thinks thievery is cool just because this very debate happens to be raging on FOX or MSNBC? What is the role that having differing values plays in your relationship?

Are your political differences mostly about the "horse race," based on preference, the way we root for a favorite team? If so, I suspect you will work it out. But what if your values differ, and that's what shapes your politics? That may be a longer, tougher conversation.

THE PREAMBLE TO THE CONSTITUTION OF THE UNITED STATES





A valid ID will include the person's photo, an expiration date, and a U.S. Department of Commerce seal.

It is the law that everyone living in the United States is counted once per decade. Because it's important to be counted, the Census Bureau will send a reminder postcard to households that have not responded by July 22. The census takers will follow up, starting two weeks later.

It's estimated that \$1.5 trillion in federal spending will be divided up and shared with governments, nonprofits, businesses, and households across the nation - all based on the census results. With small businesses struggling to recover from forced closures from March to June to slow the spread of the coronavirus, federal contracts awarded based on census data could provide stimulus to the South Bay and regional economies. •

ORDINANCE NO. 20-09 An ordinance of the City of Inglewood, California Amending Chapter 3, Article 2 of the Inglewood Municipal Code to Establish a Citywide Permit Parking Districts Program, Authorize the removal of vehicles parked in a permit parking district without a permit, and adopt other regulations reasonable and necessary to ensure the effectiveness of the Citywide Permit Parking Districts Program.

WHEREAS, California Vehicle Code section 21 provides that the provisions of the Vehicle Code are applicable and uniform throughout the state and the city may not enact or enforce any ordinance on matters covered by the Vehicle Code unless expressly authorized therein; and WHEREAS, Vehicle Code section 22507

authorizes the City to adopt a preferential parking program which prohibits or restricts the parking of vehicles on public streets and to issue permits to residents, merchants, and their guests exempting them from the parking prohibition or restriction; and

WHEREAS, the City may adopt regulations that are reasonable and necessary to ensure the effectiveness of a preferential parking

program; and WHEREAS, Vehicle Code section 22651(n) authorizes the City to remove a vehicle that is parked where the City has prohibited parking, authorized the removal of vehicles, and posted

signs giving notice of the removal; and WHEREAS, the City of Inglewood has a total area of approximately 9 square miles and 109,000 residents; and

WHEREAS, the City currently has 17 permit parking districts to address the parking needs of its residents, merchants and their guests; and WHEREAS, the City of Inglewood is developing into a preeminent sports and entertainment center because of the Forum, LA Stadium and Entertainment District at Hollywood Park (LASED), and Inglewood Basketball and Entertainment Center (IBEC); and

WHEREAS, the Forum, which reopened in 2014, has a capacity of over 17,000 people; and WHEREAS. LASED is the home of SoFi Stadium and a concert venue, which have a capacity of over 70,000 people and 6,000

people, respectively; and WHEREAS, the Inglewood Basketball and Entertainment Center includes a proposed 18,000 seat arena set to open in 2024; and WHEREAS, the combined capacity of these sports and entertainment venues is over

110,000 people; and WHEREAS, there is a shortage of parking for the City's residents, merchants and their

guests during Forum events; and WHEREAS, the City expects the parking issues to increase dramatically when SoFi Stadium opens in July 2020, because SoFi Stadium guests and employees may use onstreet parking spaces needed for City's residents, merchants, and their guests unless the City adopts a Citywide Permit Parking Districts

WHEREAS, the City desires to amend various sections of Chapter 3, Article 2 of the Municipal Code to establish a Citywide Permit Parking Districts Program, authorize the removal of vehicles parked in a Permit Parking District without a permit, and adopt other regulations reasonable and necessary to ensure the effectiveness of the Citywide Permit Parking

Districts Program;
NOW. THEREFORE. THE CITY COUNCIL OF THE CITY OF INGLEWOOD, CALIFORNIA, DOES ORDAIN AS FOLLOWS:

SECTION 1. Inglewood Municipal Code section 1-18.1 is amended to read as follows: "Section 1-18.1. Specific Violations Deemed Infractions.

(b) Notwithstanding Section 1-18, and pursuant to California Vehicle Code Sections pulsual it of california verifice Code Section's 40200 through 40273, any violation regulating the standing, stopping, or parking of a vehicle declared to be punishable as an infraction shall be subject to a civil penalty as set forth in the City's Schedule of Parking Penalties (IMC, 3-81.2)

SECTION 2. Inglewood Municipal Code section 3-76 is amended to read as follows: "Section 3-76. Establishment of a Permit

Parking District. A Permit Parking District may be established in any of the following manners:

(a) Upon the receipt of a petition from the

residents and/or business persons of a particula neighborhood requesting the establishment of a Permit Parking District and citing the reasons for such request, the Public Works Director or designee shall study the request and the site of the request to determine if a district is warranted and if there are alternative means to resolve any neighborhood parking problems that instigated the petition. The Director or

designee shall further determine the appropri ate boundary of any prospective district. The petition must bear the signatures of adults from a minimum of ten different households and/or businesses as evidence of a neighborhood desire to establish a district.

The findings of the study and recommendations of the Director or designee shall be presented to the Parking and Traffic Commission at a public hearing. Both petitioners and owners of those properties fronting on the street(s) that may be included within the district shall be duly notified of the public hearing. After receiving the recommendation of the Public Works Director and the comments of the public, the Commission shall determine if the establishment of a Permit Parking District is warranted and what the boundaries of the district should be. If determined to be warranted by the Commission, the Public Works Director or designee shall mail or otherwise deliver one questionnaire to each readily known address within the proposed district (properties fronting on any street or portions of streets that will be subject to permit parking) requesting approval or disapproval of the establishment district. If a minimum of seventy-five percent Works Director, within a minimum period of thirty calendar days, support the establishment of the district, an ordinance establishing the Permit Parking District shall be submitted to the City Council for consideration and adoption to amend the Municipal Code accordingly. (b) City staff may recommend the establish-

ment of a Permit Parking District to the City Council and introduce an ordinance for the City Council's consideration.

(c) The City Council may, at its discretion, direct City staff to study the establishment of a Permit Parking District and introduce an ordinance for the City Council's consideration." **SECTION 3.** Inglewood Municipal Code section 3-76.1 is amended to read as follows Section 3-76.1. Amending or Terminating

a Permit Parking District. The procedures by which an existing Permit Parking District can be amended or terminated shall be pursuant to any of the procedures set forth in Section 3-76 of this Article."

SECTION 4. Inglewood Municipal Code section 3-77 is amended to read as follows: "Section 3-77. Posting Requirements.

The City shall not enforce any Permit Parking District prohibition or restriction unless signs or markings giving adequate notice have been placed in accordance with Vehicle Code section 22507. It shall be the duty of the Public Works Director to cause such signs or

markings to be placed."

Applicants for a parking permit shall be required to present such proof as is required by the City, including, but not limited to, proof of residence, employment, or ownership of a business in the Permit Parking District for which a parking permi is sought; ownership of the vehicle, license plate number, and proof of current registration. An application for a renewal of a parking permit shall conform to the requirements of this Section

(b) Types of Permits and Fees. City staff shall prepare a chart specifying the various types of parking permits the City may issue, including, but not limited to, residential, business, or guest permits; daily, monthly, or annual permits; the maximum number of permits that may be is-sued to each residence or business, by type of parking permit, the fees for each type of parking permit, and any other rules governing the use of the parking permits. The chart shall be presented to the City Council for adoption by resolution and the parking permit fees shall be made part of the Master Fee Schedule.

A residence or business applicant shall have a street address located in the Parking Permit District for which a permit is sought located on a street that is the border of two or permit to park a vehicle on either side of the bordering street.

(c) Full Payment of Fees. All parking permit applications shall include full payment of the parking permit fee. Furthermore no parking permit shall be issued to any applicant until the applicant has paid all outstanding parking citations, including any civil penalties and related fees.

(d) Issuance and Use of Permit. A parking permit may be issued and enforced using either a virtual or physical permit. A virtual permit shall be issued to the license plate number of the applicant's registered vehicle and enforced through an Automated License Plate Reader System (ALPRS). Each virtual permit holder shall be responsible for ensuring that their license plate is capable of being read

The City may issue a physical permit, such as a sticker or hanging tag, to the applicant. The holder of a physical permit shall be responsible for making sure that the physical permit is displayed in accordance City's rules so as to be clearly visible from outside of the vehicle.

A parking permit is valid only for parking in the specified Permit Parking District and it does not guarantee the availability of a parking space. The parking permit holder shall be subject to each and every condition and restriction set forth in this Chapter and as provided for the Permit Parking District for which it was issued. The issuance of a parking permit does not exempt the holder from compliance with any other parking regulation, including, but not limited to, vehicle type, height or weight restrictions;

zones that prohibit the stopping, parking or standing of vehicles; and street sweeping parking restrictions.

(e) Revocation of Parking Permit. A parking permit holder shall not sell, rent or otherwis transfer a parking permit to another person, unless authorized by the City, or present false or fraudulent information to obtain a parking permit. A parking permit may not be altered or reproduced. A violation of any City rule regulating the application for or use of parking permits may result in the revocation of the park ing permit, the revocation of any other permits issued to the permittee, and the disqualification of the permittee from being issued any future

(f) Replacement of Permit. A permittee seeking replacement of a lost or stolen permit shall pay a replacement permit fee as established by City Council resolution and set forth in the Master Fee Schedule." SECTION 6. Inglewood Municipal Code

section 3-79 is amended to read as follows:
"Section 3-79. Exemptions from Permit Parking District Prohibitions. Only the following vehicles shall be exempt from enforcement of the Permit Parking District

(a) Any vehicle displaying a valid parking permit.

(b) Any licensed physician's vehicle parked while making a professional call.

(c) Any vehicle parked in an individual curbside parking space governed by a parking mete (d) Any vehicle parked in an individual curbside parking space that is specifically exempt by a posted sign or marking, so long as said vehicle is in compliance with all other

parking conditions or limitations specified on the sign or marking. (e) Any vehicle exempt under any other applicable law, including, but not limited to, Municipal Code sections 3-65(c), 3-65.1(b), 3-65.2(c), and 3-80(b)."

SECTION 7. Inglewood Municipal Code section 3-80 is amended to read as follows: "Section 3-80. Permit Parking District Restrictions. Tow Away Authorized.

Upon designation of a Permit Parking District, the Public Works Director shall determine whether permit parking restrictions apply 24 hours a day, 7 days a week (24/7), or any portion thereof, based upon the needs of the Permit Parking District, and cause appropri-ate signs or markings to be placed indicating prominently thereon, the parking limitation, period of the day for its application, and the fact that vehicles with valid permits shall be exempt therefrom. Unless an exemption in Section 3-79 applies, it is unlawful for a person to park a vehicle on a City street located on or in Permit Parking District, at any time, without displaying a valid parking permit.

As authorized by Vehicle Code section 22651(n), the City may cause to be removed any vehicle parked in violation of this section and the registered owner thereof shall be responsible for paying the impoundment and storage fees established by the City. It shall be the duty of the Public Works Director to identify areas where signs giving notice of removal for a violation of this section shall be placed and cause such signs to be placed. No vehicle shall be removed for a violation of this section unless signs giving notice of removal have been placed in accordance with Vehicle Code section 22651(n) and Municipal

Code section 3-58."

SECTION 8. Inglewood Municipal Code section 3-81 is amended to read as follows: "Section 3-81. Parking District Boundar ies Defined.

The boundaries of each Permit Parking District are defined by the Permit Parking Districts map presented to the City Council for adoption as part of Ordinance No. 20-09. All City streets located on or within the boundaries of a Permit Parking District shall be subject to the permit parking prohibitions or restrictions of that District only when appropriate signs or markings giving

adequate notice have been placed.

The Public Works Department shall be Parking Districts map and any subsequent changes to the map shall require City Council

approval by ordinance."

SECTION 9. SEVERABILITY. If any section, subsection, subdivision, paragraph, sentence, clause or phrase of this ordinance, or its application to any person or circumstance, is for any reason held to be invalid or unenforceable such invalidity or unenforceability shall not affect the validity or enforceability of the remaining sections, subsections, subdivisions, paragraphs, sentences, clauses or paragraphs of this ordinance, or its application to any person or circumstance. The City of Inglewood hereby declares that it would have adopted each section subsection, subdivision, paragraph, sentence, clause and paragraph hereof, irrespective of the fact that any one or more of the foregoing sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases hereof be declared invalid or unenforceable.

SECTION 10. The City Clerk shall certify to the approval, passage and adoption of this Ordinance by the City Council and shall cause the same to be published in accordance with the City Charter; and thirty days from the final age and adoption, this Ordinance shall be in full force and effect.




