He Made the Right Decision

Imagine growing up in a neighborhood where it simply was not safe for children to go nearby to play or even be outside. Although you are the second oldest, it falls on you to ensure all your younger siblings, brothers, and sisters keep out of trouble and stay safe and well.

Some good news: You learn you can go to a park not too far away and safely play there. It starts with a once-a-week gentleman who comes in a "recreation truck." He visits the rather modest area, referred to as "a pocket park". You are introduced to checkers, baseball, basketball, and some other fun activities. You will look back on this and refer to it as "recreation on wheels".

Your mom stays at home to raise you, your brothers and sisters. Your dad is the sole wage earner and means very well, but his earnings are not sufficient given the size of the family. And, to this day, your mom and dad do not speak English.

What you discover is that you really enjoy the recreation, not just for yourself, but the chance it gives other kids for fun that is safe and good for them. You wind up doing volunteer work to cover the required fees and expenses, not just for you but for your brothers and sisters. Then, by the ripe old age of 13, you are given the role of coaching kids just a little younger, even though parents wonder how someone at such a tender age could already have become "the coach".

Today, Gerry Iriate is a full-time Recreation Specialist with the City of Hawthorne and has been since 2018. Through financial aid, scholarships, and plain determination, Gerry graduated from Cal State Long Beach with a major in Recreation, and after that, obtained a Master's Degree in Public Administration. Of course, nothing got any easier over time. The recession was still with us when he graduated college and sought work. Job opportunities, particularly in the recreation field, were not plentiful. What did Gerry do? He worked several part-time jobs, including teaching Spanish


to high school students. He persevered. He stayed the course.

But, as a kid, Gerry had another profession in mind – architecture. It was not a simple choice to go into the field of recreation. He did so for two key reasons: (a) recreation provides opportunities to help youth take the high road, and (b) It makes him feel good to do good. Much of the work Gerry has done to promote recreation is in locations where too many young people otherwise wind up in gangs, drug issues, or both.

Clearly, the Hawthorne youth sports teams, including soccer and baseball, have grown considerably since Gerry got on board with the City. There also is ballet, hip hop dancing, and slot car racing, among the activities in which kids can engage. There is swimming and a whole lot of classes you can find online. Just go to <https://www.cityofhawthorne.org/home>; once there, click on "recreation activities" (your eyes will feast). Basketball, boxing,

Film Review

In 'Fire of Love,' Even Volcanic Dangers Can't Extinguish Love

"This is Katia. This is Maurice... tomorrow will be their last day." Making its World Premiere in the U.S. Documentary competition at this year's Sundance Film Festival is *Fire of Love*, the incredible true story of a couple whose passion for chasing danger eventually caught up with them, but whose legacy made a lasting impact on their tight knit community.

In an effort to show the world the strength and beauty of the misunderstood natural phenomena of volcanoes, wife and husband Katia

beanies, Katia and Maurice are as goofy as they are brilliant, and were as close to soul mates as you can get (if you believe in that sort of thing). Their shared passion to educate the world on these natural wonders enabled life-saving research. It would prove to be bittersweet, as that same unwavering passion and fascination with danger ultimately led to their deaths.

In telling the Krafft's story, director Sara Dosa took inspiration from French new wave films with fun and light-hearted editing tech-

and Maurice Krafft routinely put themselves in the path of danger. One day, they inadvertently found themselves caught in the middle of an unexpected volcanic eruption. Although their love story ended too soon and their contribution to the scientific community feels incomplete, what they did leave behind is hundreds of hours of in-depth and deep archival footage, which director Sara Dosa weaves together fervently to create a sweeping portrait of two people passionately in love with science, nature, and each other.

"Have you ever loved something so much, you would sacrifice your life for it?" We're left to contemplate this stirring hypothetical question as we're led through the vividly rich life of French scientists Katia and Maurice Krafft. Voiceover narration is provided by filmmaker and performance artist Miranda July, who so sensitively captures the couple's self-proclaimed "outsider" and "weirdo" personas. From their first meeting in 1966 to the very last image before their untimely death in 1991, the common thread throughout *Fire of Love* is the Krafft's commitment to curiosity and exploration, which overrode any sense of fear.

Katia and Maurice documented volcanoes from all over the world, capturing some of the most breathtaking images in the process. Dressed like extras from Wes Anderson's *The Life Aquatic* in light blue onesies and red

niques (Dosa makes volcanoes and science fun!). Aesthetically, *Fire of Love* looks like it was pulled from a time capsule from the 70s with its retro fonts and text color, and it totally works.

If Katia and Maurice were alive today, I'd imagine they would be absolutely humbled by the attention this documentary will bring to their life's work. It encapsulates everything they sacrificed their lives for: an unfiltered look at the unmatched beauty of volcanoes and the mineral world, and how connecting with the earth can help us connect with each other, too.

City of Hawthorne Republic Services Waste Collection

To comply with SB 1383 Republic Services rolled out an organic recycling program. In implementing the program Republic is charging my property \$63.60 for a 35-gallon container. Inquiries to Republic on cost projections to derive at this monthly amount have been unsuccessful. Erick Garcia, Republic Recycle Coordinator, does not have knowledge of proforma cost projection financials existing. He was unable to provide details on how the monthly charge was derived, or the total revenue projection for all properties

in Hawthorne.

My solid waste collection was also increased by \$86.47, or 26.9%. So far Republic has not been able to substantiate such an increase for one property. Inflation has affected most goods and services, but this increase is out of the norm. Inquiries to the city if Republic submitted cost analysis to justify this have also been unanswered.

If your rates have substantially increased, please contact the city and inquire. Possibly answers will be provided if enough of the citizens inquire.

Staying Socially Active May Enrich Mental Fitness

(BPT) - When you think about exercise, you likely think about the physical health benefits of working out. Many people exercise regularly to lose or maintain weight, improve muscle tone and strength or increase flexibility.

For seniors, physical activity can help them stay mobile and, as a result, stay independent for longer. However, the benefits of exercise go beyond the physical and can potentially enrich your social life and mental state.

Staying social as you age

Loneliness is a common problem for seniors and can have serious consequences on their overall well-being. According to the Centers for Disease Control and Prevention (CDC), more than a quarter of adults over 65 are socially isolated. Older adults are more likely to live alone and lose friends and family as they age. The CDC also reports that social isolation in adults 50 or older has been associated with higher risks of dementia, depression, anxiety and other health problems.

While these facts may be grim, there are many ways to combat loneliness, including group exercise. Health psychologist Kelly McGonigal in her book *The Joy of Movement*, explains that endorphins (the feel-good hormone) released during exercise also help

us bond with others. If you've ever played team sports or regularly attended yoga or other group fitness classes, you've probably felt a camaraderie with those around you.

Programs like SilverSneakers by Tivity Health offer many types of group activities that make a difference in the lives of seniors. The company's 2021 Annual Member Survey revealed that 88% of members said that the program improved their quality of life and 52% made new and valuable friendships by participating.

To further improve seniors' social engagement, the program has partnered with Stitch, the world's largest social community helping older adults create enriching social connections. The platform is now available to SilverSneakers members in participating health plans and allows them to connect around shared interests, like traveling, books and physical activities, virtually and in person.

Boost your brain health through exercise

Movement and activity can also improve your mood and prevent mental health and mood disorders. The SilverSneakers Annual member survey found that depression among participants is 64% less prevalent than the Centers for Medicare and Medicaid Services
