## More than Just Bread & Butter

The restaurant scene has been quiet in El Segundo for the past few months. There haven't been any busy tables or bustling sidewalks with sprawling nightlife, but lately, residents have been leaving their quarantines and enjoying meals in public places. And if eating in public isn't available, one place, in particular, serves a variety of dishes that offers customers a sense of normalcy-Bread & Butter.

Located on 630 N. Sepulveda Blvd., Bread & Butter features a mostly American-style cuisine that spans across a few different cultures. You can order tasty tacos and their "World Famous" classic burrito, but aside from Mexican favorites, seafood dishes, and Italian pastas, B&B is best known for their breakfast and brunch items.

Dubbed as their "Breakfast Delights," B&B is a local favorite with a full breakfast menu and bakery. For a simple meal to start your day, the "Sunrise Breakfast" includes two eggs any style, your choice of ham, bacon or sausage links, and two pancakes topped with fresh fruit and powdered sugar. If pancakes aren't your thing, you can order fluffy french toast instead, with two eggs and a protein choice—and all of these items range anywhere from \$11 to \$14.

Run by Marco and Sophia Awada, B&B is a family-owned restaurant that's been serving El Segundo for more than 30 years. "We do things the old-fashioned way," says Marco ."Our pancakes are always fresh. We use fresh veggies for breakfast, french toast

made from scratch—pretty much anything we can do to better the community and offer them something delicious and consistent."

And B&B is no stranger to overcoming changes in the community, let alone the world as a whole. In fact, before becoming Bread & Butter, the restaurant was originally a burger spot that Marco and his wife started, serving classic hamburgers on their menu for the town to enjoy. However, once In-N-Out Burger moved in, they had to adapt their menu to provide a unique experience for their customers. To make matters even more challenging, El Pollo Loco, Carl's Jr., and even a Chinese takeout restaurant surround them in the plaza.

Over the years, the competition has been tough, but Marco has been able to thrive. "We have loyal customers here in El Segundo, and I wanted to focus more on breakfast items so that change made it even better for us since we provide what customers are looking for daily. We get terrific crowds on the weekends, too. "Even amid COVID-19, Marco has been able to formulate a plan that has kept their doors open throughout the pandemic, while taking safety precautions to protect the community. "We do patio service now for sit-down guests, and we partner with third-party delivery platforms to serve customers anywhere we can."

B&B partners with GrubHub, Uber Eats, Door Dash, and Postmates to make their menu accessible for anyone nearby. Plus, they've also changed their hours to accommodate customers and keep employees on staff. "We never closed during the pandemic," says



## Ski Bum: The Warren Miller Story Celebrates the Life of a Snowbound Legend

If, like me, you have never skied in your life, the name Warren Miller is likely a name that you haven't heard before. If however, you are an avid skier, or winter sports fan of any kind, then the name Warren Miller is a legendary one, synonymous with the very sport of skiing itself. As I found after watching the new documentary Ski Bum: The Warren Miller Story, even though I fall into



Ski Bum: The Warren Miller Story courtesy Gravitas Ventures. the former category of having not known of Miller, afterwards, I was left moved by the story of a man who - like Steve Jobs, or Henry Ford, or his idol, Walt Disney before him - became a titan of their industry and popularized an entire sport itself.

Directed by Patrick Creadon (Wordplay, Catholics vs. Convicts), Ski Bum tells the story of Warren Miller and his 55-year career as a skier and filmmaker, which Miller himself recounts for the film (as Miller would pass away a few short months after sitting for the interview, his presence gives the documentary even more significance). As he remembers at his Orcas Island, WA lodge, growing up a surfer in Hermosa Beach, he would eventually hear the calls of the nearby Californian snowy mountains and shortly thereafter dedicate his life to hitting those slopes – soon proudly calling himself a "ski bum" by dedicating his weekend to sleeping in his car and hunting rabbits to stay up there. Miller would also take his 8mm camera and shoot his skiing, eventually making movies that would snowball (pun intended) into Warren Miller Productions, with Miller shooting, editing, narrating, and marketing these new ski movies himself. His eventual road shows would turn into annual events, gaining legions of fans around the world that would popularize the sport of skiing and in the process, immortalize his name with it.

With interviews from Olympic skier Jonny Moseley and skier/filmmaker Greg Stump, among others, Ski Bum isn't short of subjects willing to sit for the film to celebrate their idol. Yet the most striking part of Ski Bum is the film's use of archival footage, which features never before seen pictures and videos from the Warren Miller Entertainment library. As associate producer and assistant editor H. Nelson Tracey notes, "we accessed film reels that had never before been digitized! There are some unbelievable shots unearthed specifically for this film. In many ways, making this documentary was a bit of a scavenger hunt." This beautifully rendered early-50s and 60s footage transports audiences not only to just beautiful mountain slopes, but to another time altogether.

And while Ski Bum is a gorgeous celebration of the man, the film also digs deeper, past the surface-level snow, to reveal darker moments in Miller's life, including having an alcoholic father, the passing of a first wife, and financial hardships that would at one point bankrupt Warren Miller Productions. It's these moments that his children (who also sit for the film) speculate as to why he himself was a figure who wasn't always there for his family, pursuing his life's mission and larger goals. One thing's for sure: Ski Bum will make you realize the magnificence of a man who saw not just the beauty in mountains, but shared that magnificence to the world, who will celebrate him on the slopes for all time.

## Your Neighborhood Therapist

Dear Neighborhood Therapist,

I have been under a lot of stress lately, and I think it would help me to talk to someone, but I am a little bit nervous about calling a therapist. I am not sure what to expect, and I am not sure if I am ready to spill my deepest and darkest secrets to a stranger. I'm also not sure how I will know if it is "working." I have anxiety about finding a therapist on top of the anxiety I am already experiencing!

- Doubly Stressed, Manhattan Beach

#### Dear Doubly Stressed,

I am very glad that you asked these questions. Making that initial call to a therapist can be intimidating and stressful. I'll take your questions one by one, and hopefully this will clear things up a little bit.

What to expect: expect somebody who is kind and is genuinely interested in you and in helping you confront the problems that have come into your life. If you get the sense that they don't care, or that they are uninterested in what is happening in your life, or if they promise to solve unsolvable problems, try somebody else. The good news is that most therapists do care, most are genuinely interested (that's why they do this work in the first place), and most won't promise you easy or formulaic solutions.

Trust your instincts in this department: you should like your therapist, and they should like you. If you're not feeling it, that's totally fine. Nobody is a perfect fit for everyone else.

Regarding your deepest, darkest secrets: you may find you end up wanting to tell your therapist about all of them, but you might not. While it is part of a therapist's job to ask hard questions sometimes, these questions should always be in service of facing the problem at hand, and never designed to voyeuristically elicit gratuitous details. You don't have to - and shouldn't be expected to - answer questions that make you feel worse. Even in the most delicate situations, you should never, never, never feel shamed by your therapist.

How will you know it's working? If the problems that you or your family are facing begin to look slightly different, further away, or less powerful. Not all problems can be solved, and not everything is always going to be okay (I wish this was not true, but it is). Some problems are just too big or insidious, but you will not be alone in facing them.

Looking at a list of therapists can be intimidating. If you are anxious about choosing, just call the first one, or the last one, or use any criterion you like. There is no such thing as a perfect fit, but spending a few minutes on the phone so that you can get a sense of who we are is part of the job. So is answering any questions you may have about working together. Helping the people who call us find a good fit - even if we are not that person - is, yes, also part of our job.



## Stay Safe From COVID-19 Scammers

(BPT) - While you take care to limit social interactions and wash your hands to prevent the spread of the coronavirus, you also need to take steps to protect your finances and identity. Scammers are now taking advantage of the COVID-19 pandemic to lure victims in with new phishing scams.

"We know consumers are managing their money and finances online, so it's more important than ever to raise awareness of smart security practices," says Vice President of Security at Navy Federal Credit Union, Chip Kohlweiler. "Being proactive and learning about your security is a great step toward keeping your accounts and information safe.

Phishing remains one of the top ways cybercriminals get access to your identification and financial information. Using phone calls, emails and even copycat websites, scammers are creating content that appears official and related to COVID-19 - tricking you into revealing personal information like bank account numbers, login IDs and passwords. At the same time, by clicking a link, you may also unknowingly download malware that infects your computer and captures your data.

"Just because caller ID shows your financial institution is calling, do not provide information such as one-time passcodes or PIN to the caller. Additionally, phony links in emails can be a major threat to your system. If you don't know the sender, a general rule of thumb is don't click any links in the email," says Kohlweiler.

Phishers often use legitimate company names and copy the look of official websites and emails to fool you. Right now, they're even sending out correspondence that looks like it's from the World Health Organization, local governments or other trustworthy sources.

"Urgency is a big red flag. While you may have an urgent need, you should always validate it. If it's in regards to one of your accounts, call the company associated with the account from a number on their official website, or on a recent paper statement, to confirm if urgent action is needed," Kohlweiler advises.

Sometimes the URL (web address) will look right, but instead of taking you to your intended website, it will lead you to a copycat website. Check to see if the URL begins with https://, which indicates a site is secure. Most phishing scams won't have a secure website. Never click on a URL within an email; instead, type the official URL into your browser.

In these scenarios, a scammer sends what appears to be a legitimate email requesting a wire transfer to cover title, escrow or any number of other costs. Unfortunately, money you transfer as a result of the fraudster's email ends up in the fraudster's bank account - and you're not likely to get it back. If you receive such a request, call your financial institution to verify that it has made this request.

Using strong passwords (never the same for different sites), setting up transaction notifications and ensuring your contact information stays up to date with your financial institution are all easy ways to enhance your online security.

It pays to be wary of emails you're not expecting. If you're suspicious of an email, don't click on any links or buttons in the email. Hover your mouse over the link and see if the address that appears matches the link typed in the message. If you find fraudulent transactions on your account or suspect your info has been compromised, use a different computer to change your passwords. And, make sure you notify your financial institution right away.

Stay up to date on news of phishing attacks to protect yourself. Anti-phishing organizations, such as Anti-Phishing Working Group, provide lists of new and current phishing scams. •

### ORDINANCE NO. 20-09

An ordinance of the City of Inglewood, California Amending Chapter 3, Article 2 of the Inglewood Municipal Code to Establish a Citywide Permit Parking Districts Program Authorize the removal of vehicles parked in a permit parking district without a permit, and adopt other regulations reasonable and necessary to ensure the effectiveness of the Citywide Permit Parking Districts Program. WHEREAS, California Vehicle Code section 21 provides that the provisions of the Vehicle

Code are applicable and uniform throughout the state and the city may not enact or enforce any ordinance on matters covered by the Vehicle Code unless expressly authorized therein; and WHEREAS, Vehicle Code section 22507 authorizes the City to adopt a preferential parking program which prohibits or restricts the parking of vehicles on public streets and

to issue permits to residents, merchants, and their guests exempting them from the parking prohibition or restriction; and WHEREAS, the City may adopt regulations that are reasonable and necessary to ensure

program; and WHEREAS, Vehicle Code section 22651(n) authorizes the City to remove a vehicle that is parked where the City has prohibited parking, authorized the removal of vehicles, and posted giving notice of the removal; and

WHEREAS, the City of Inglewood has a total area of approximately 9 square miles and 109,000 residents; and

WHEREAS, the City currently has 17 permit parking districts to address the parking needs of its residents, merchants and their guests; and WHEREAS, the City of Inglewood is developing into a preeminent sports and entertainment center because of the Forum, LA Stadium and Entertainment District at Hollywood Park Entertainment Center (IBEC); and

WHEREAS, the Forum, which reopened in 2014, has a capacity of over 17,000 people; and WHEREAS, LASED is the home of SoFi Stadium and a concert venue, which ha a capacity of over 70,000 people and 6,000

people, respectively; and
WHEREAS, the Inglewood Basketball and Entertainment Center includes a proposed 18,000 seat arena set to open in 2024; and WHEREAS, the combined capacity of these sports and entertainment venues is over 110,000 people; and

WHEREAS, there is a shortage of parking for the City's residents, merchants and their guests during Forum events; and

WHEREAS, the City expects the parking issues to increase dramatically when SoFi Stadium opens in July 2020, because SoFi Stadium guests and employees may use onstreet parking spaces needed for City's residents, merchants, and their guests unless the City adopts a Citywide Permit Parking Districts

WHEREAS, the City desires to amend various sections of Chapter 3, Article 2 of the Municipal Code to establish a Citwide Permit Parking Districts Program, authorize the removal of vehicles parked in a Permit Parking District without a permit, and adopt other regulations reasonable and necessary to ensure the effectiveness of the Citywide Permit Parking Districts Program;
NOW, THEREFORE, THE CITY COUNCIL

OF THE CITY OF INGLEWOOD, CALIFOR-NIA, DOES ORDAIN AS FOLLOWS: SECTION 1. Inglewood Municipal Code

section 1-18.1 is amended to read as follows: Section 1-18.1. Specific Violations Deemed Infractions.

(b) Types of Permits and Fees. Each virtual permit holder shall be responsible for ensuring that their license plate is capable of being read by the ALPRS.

The City may issue a physical permit, such as a sticker or hanging tag, to the applicant. The holder of a physical permit shall be responsible for making sure that the physical permit is displayed in accordance with the City's rules so as to be clearly visible from outside of the vehicle.

A parking permit is valid only for parking in the specified Permit Parking District and it does not guarantee the availability of a parking space. The issuance of a parking permit does not exempt the holder from compliance with any other parking regulation, including, but not limited to, vehicle type, height or weight restrictions;

A parking permit holder shall not sell, rent or otherwise transfer a parking permit to another person, unless authorized by the City, or present false or fraudulent information to obtain a parking permit. A violation of any City rule regulating the application for or use of parking permits may result in the revocation of the park ing permit, the revocation of any other permits sued to the permittee, and the disqualification of the permittee from being issued any future

(f) Replacement of Permit. A permittee seeking replacement of a lost or stolen permit shall pay a replacement permit fee as established by City Council resolution and set forth in the Master Fee Schedule."

SECTION 6. Inglewood Municipal Code section 3-79 is amended to read as follows: "Section 3-79. Exemptions from Permit Parking District Prohibitions.

Only the following vehicles shall be exempt from enforcement of the Permit Parking District prohibitions in section 3-80:

All City streets located on or within the boundaries of a Permit Parking District shall be subject to the permit parking prohibitions or restrictions of that District only when appropriate signs or markings giving adequate notice have been placed.

The Public Works Department shall be responsible for maintaining the official Permit Parking Districts man and any subsequen changes to the map shall require City Council approval by ordinance."

SECTION 9. SEVERABILITY. If any section, subsection, subdivision, paragraph, sentence, clause or phrase of this ordinance, or its ap-plication to any person or circumstance, is for any reason held to be invalid or unenforceable. such invalidity or unenforceability shall not affect the validity or enforceability of the remaining sections, subsections, subdivisions, paragraphs. sentences, clauses or paragraphs of this ordinance, or its application to any person or circumstance. SECTION 10. The City Clerk shall certify to the approval, passage and adoption of this Ordinance by the City Council and shall cause the same to be published in accordance with the City Charter; and thirty days from the final passage and adoption, this Ordinance shall be in full force and effect.
