Remembering Bill Field

His name was Bill Field, and for those who knew his passion of playing an elaborate organ, they will never forget his well-known talent. He didn't just play any organ; he enjoyed the fruits of his enthusiasm on a Mighty Wurlitzer. It is quite frankly the holy grail of organs with its more than 2,000 pipes and 244 keys arranged on four keyboards. Along with stop keys that trigger the sounds of bells, cymbals, trumpets and drums, it is in short, a full orchestra. Bill passed away on June 28, his death likely a result of a stroke he had suffered many months ago; he was 80.

To trace Bill's connection to El Segundo, you have to go back to 1951 when he was 12 years old. He found his avocation and future while wandering through a Barker Brothers Department store in downtown Los Angeles. He was captivated by the sound of a pipe organ roaring and mesmerizing in the background as shoppers browsed. His obsession with learning and playing the organ consumed him. Soon after, he was hired as the organist at the Los Angeles Theatre on South Broadway Street, and he would also play in church and at community centers.

As he got older Bill's interest in music and the organ increased even more. He'd made friends with Bill Coffman, a fellow organ enthusiast, and together they purchased the Mighty Wurlitzer built in the 1920s. In 1968 The Fox West Coast Theater chain was disposing of all the instruments they had at that time. The West Coast Theater in Long Beach had the largest and the most intact collection of vintage instruments, including the cherished Wurlitzer. So the two Bills

made the necessary contacts and ended up purchasing their prized organ for \$2000.

Now that they had their Mighty Wurlitzer, they needed to set it up. Luckily, they knew the right people who worked for the Wurlitzer Company to help reassemble the behemoth instrument. Initially, they set the Mighty Wurlitzer up at relative's studio, but they had bigger plans for their treasured instrument.


They saw a newspaper ad for a 'theatre for rent' in El Segundo. What they found at 140 Richmond Street couldn't have been more perfect. This former theatre, which was built in 1921 and the community's only theatre house, had also been home to a community center, storage building, and used as a church over the years. It was on the perfect tree-lined street in an ideal vintage building and was just what they envisioned.

After making some well-needed modifications and remodeling the inside of The Old Town Music Hall, it was transformed back to its 1921 elegance, beauty, and glory. Thanks to Bill Field and Bill Coffman's vision, it transcends patrons of the theatre back to the silent picture era with its royal carpeting, ornate moldings, oversized chandeliers, and the Mighty Wurlitzer sitting center stage behind the thick golden curtains. Part of Field's vision, for his theater, was re-creating an early American tradition of spending an afternoon or evening at the movies set in the 1920s and 1930s.

For nearly fifty years, the Old Town Music Hall has been the home for silent movies, ragtime concerts, and grand organ performances, all because of Bill Field. At each show, audiences experience a pipe organ medley followed by a sing-along, short comedy, and a feature film. It didn't matter whether Casablanca or It's a Wonderful Life came to life on the theatre's screen or silent films. For instance, Charlie Chaplin's 'Gold Rush' transformed on screen, Field was at the keyboard serenading visitors with whimsical song renditions of the period.

The Mighty Wurlitzer transformed Field's passion into a magical moment for those in attendance. He became this fun-loving uncle of the music world as he playfully put together tunes from yesteryear. Instead of keeping the organ's mechanics enclosed as some theaters do, Field used glow-in-thedark paint and black lights to show off its insides. With Field in charge, the mallets on stage danced, hitting chimes and drums of all sizes transform the room into a musical


<u>Film Review</u>

You Aren't Ready for Palm Springs

Now available to stream on Hulu, Palm Springs (theatrical distribution from Neon) is one of those movies that's better going into blind. Starting with Nyles (Andy Samberg) as he shuffles through a Palm Springs rental on the day of a friend's wedding with apathetic that ranges from love, mortality and our place in the universe.

Brought to the screen with applause-worthy comedic chops as well as deft emotional hand by screenwriter Andy Siara and director Max Barkabow (his first feature!), check out this Sundance entry (and nominee for Grand

energy, you'll likely feel as if you might've missed something (don't worry, you haven't). But soon enough, with the unexpected introduction of Sarah, who throws Nyles' day - and world - out of wack, you're now settled in for an all-out, joyous, and hilarious comedy from the wacky, deranged mind of The Lonely Island (*Popstar*).

The top-billed pairing of Andy Samberg as the beer-cracking Nyles and Cristin Milioti as manic and insecure Sarah make for a delightful onscreen duo, whose chemistry ranges from their having to navigate insane waters together to finding a real romantic connection as well. And beyond the film's "every day's the same" gimmick – which is executed wonderfully and earns real laughs (with J.K. Simmons getting in on the fun too) - there's also a surprisingly thoughtful and unexpected heart that the film derives its energy from, that of each character's personal insecurities and existential dread Jury Prize) instantly before you'll want to watch it again.

TIPS AND TRICKS ON SELF/MENTAL CARE

If you aren't willing to download the app previously mentioned, here are some alternatives! One method I am doing is



Your Neighborhood Therapist

Dear Neighborhood Therapist,

My job performance review is next week, and I am dreading it. My boss has said I "lead with empathy," but she did not mean it as a compliment. She was explicit that she expected me to be harder on the team I manage and prioritize my own needs over theirs more often. I don't think I can do that: a lot of my team members are vulnerable both financially and emotionally, especially in a pandemic. I am afraid I'll get a bad review because I'm too "nice." How should I think about how to handle this situation?

Too Nice, El Segundo

Dear Too Nice,

As you well know, almost every organization and every person claims to value kindness. But that claim does not make it true. Organizations, especially, appreciate kindness. They encourage it. But they do not value it in the sense of assigning a monetary or other worth to it. And because that is the case, kindness is often expendable, somewhere down on the "nice to have" list.

The same is often true with people. Everywhere from the schoolyard to the sales team to the boardroom to government, we see that people who are unkind to others sometimes hold positions of power. Perhaps this is part of why so often, kindness is mistaken for weakness or powerlessness.

Nothing could be further from the truth. Here's why:

People, who are kind, often get sandwiched, trying to protect the less powerful from the impulses of the more powerful. I see this every week in the people I meet with: there is a heavy price for being nice.

I suspect you know this already - or at the very least, you feel it - because you are quite literally "taking one for the team" as your boss tries to pressure them, through you. People do not always realize when they are choosing kindness, but that is exactly what you have done so far. And in this case - as is far too common - it is coming at a cost. That requires a great deal of strength, indeed.

I am not saying, "stay strong and keep taking it for the team." Each circumstance is different. Even if you are the most considerate person on earth, it's not always worth it. So that is the question you have to answer: what is the price that your commitment to kindness is asking you to pay, and is it worth it?

And while we're at it, remember it's not just a commitment to kindness or decency that carries a price. So does any commitment to support a value or a lifestyle that may be different from others in your community. Being different, or outspoken, or even quiet - these are not signs of weakness. It's just the opposite.

Good luck with your review. No matter how it goes moving forward, the people who work on your team are better off for having you, even if they may never know it.

What To Do If You're Losing Insurance Through Job Loss

(BPT) - During these difficult times, millions of Americans have been furloughed, laid off, or may yet lose employment due to the pandemic. And because insurance is tied to employment for a vast majority of workers, this can mean facing the loss of insurance coverage as well as your income.

What can you do if you've already been impacted, or if you are likely to be soon?

Here are some options available if you are coping with this difficult situation.

Plan Ahead if Possible.

If a layoff may be in your future, it's a good time to prepare. In today's environment, it is possible that in some states insurers may allow you to obtain a larger-than-usual supply of prescription medications, for example.

Also, if your health care provider recommends it, this could be a good time to take care of vital health care screenings. Consult your provider about which screenings are essential for you, and proper safeguards to take during doctor visits.

Ask About COBRA.

Talk to your employer about the possibility of getting COBRA to continue coverage. With COBRA, you may be able to keep your current job-based plan for a limited time (usually 18 months). This may even be the case if your hours are simply reduced rather than being let go entirely. Make sure to ask questions about the full cost of this coverage, as it can be expensive to maintain.

Talk to Your Spouse

Discuss being added to your partner's health insurance coverage if that's possible. Insurers may allow changes outside the open enrollment period for circumstances such as these.

Check the Health Insurance Marketplace

Visit healthcare.gov to see if you are

eligible for enrolling in a state or federally subsidized health plan, or if you qualify for Medicaid. Coverage options vary greatly, depending on where you live and your individual circumstances.

Losing your coverage due to job loss may mean you can benefit from a "special enrollment period" rather than waiting for the normal open enrollment period that occurs each year. Be prepared to provide detailed financial information as part of the lengthy application process for subsidized health insurance.

Opt for Individual Vision and Dental Insurance.

If you need to be seen for your annual eye exam, to get new glasses, or to maintain your contact lens supply, you may worry about not having these crucial vision services covered when you lose benefits or have them reduced.

Fortunately, there are convenient, low-cost options available for both vision and dental insurance. Check out VSPdirect.com for information about their vision plans, which start as low as \$13 per month.
