Kimberly Bredberg Explores Alternative Learning Methods for South Bay Students

The public school system in El Segundo is notoriously renowned. El Segundo high school ranked in the top 5% of high schools in California for math proficiency and reading proficiency, and the graduation rate is top tier. But what if the traditional method of learning doesn't work for your child? Standardized teaching methods have worked for decades, but what happens to the children who don't work well under these methods? This is a question Kimberley Bredberg set out to explore for her own child in the form of a new K-12 micro-school called Waterhouse Guild.

A mother of four children, Bredberg's present journey began with her oldest daughter in the first grade. "My daughter was a super curious and precocious firstgrader," says Bredberg. Her daughter was in a classroom of only eight students at a school Bredberg worked at in San Luis Obispo. Having a heavily pencil-and-paper policy at home, straying away from electronics, her daughter was already very versed and excited about reading and writing. The problem, she explains, was that her teacher would not let her read above the first-grade level.

"That made me so sad, because at the time she was reading at a high level, chapter books, and she would sit on the swing with a book in one hand and a slice of watermelon in the other," she says. So, in the transition to second grade, she pulled her daughter out of her school and decided to experiment with homeschooling.

Her methods appealed to many parents

going through similar struggles with their children. So about twenty years ago, she began developing Waterhouse Guild, a microschool program with roots in homeschooling based here in El Segundo. The idea was to individualize education while still requiring rigorous academics, all based around the humanities.

Though all academic fields are studied in the program, Bredberg specifically wanted to focus on reading, writing, and critical thinking. Along with her other business, a publishing company, Bredberg and her team developed their own language arts curriculum. Class periods are in longer blocks to encourage focus and allow subjects to be fully explored. Teachers are experts in their field, be it chemistry or art, or music. "I think one of the sad things happening in our culture is that we seem to think that children have short attention spans when they really don't. I sometimes feel like two hours for science isn't enough," Bredberg laments, explaining her choice to go with longer learning periods.

Of Bredberg's multiple degrees, she has a particular love of science, in which she obtained a degree. Because of her experience in the field, she sought to find a way to make science more integrated and taught with context so that each subject wouldn't be taught in a vacuum with no relation to other courses or real-world application. She uses the human body as an example, explaining that it isn't only related to biology but also to chemistry, physics, and electricity. When a child comes out of school and into the working world, she says, science isn't segmented and separate like it was in school. So to her, it's important to teach children from a young age the way they'll be interacting with subjects outside of school.

Parent Josette Murphy describes her child's experience with math at Waterhouse Guild. Having gone to public school for a few years, her daughter was doing relatively okay in math but struggled to switch over to the Waterhouse method. Her teachers immediately saw the holes that needed to be repaired in her understanding of mathematics and asked that she stay an hour extra a week to work one on one with them. After going back and getting a firm understanding of past ideas and how they correlate with current lessons, her daughter felt comfortable moving on to the next level. This kind of individualized help to ensure a complete understanding before leveling up came from Bredberg's own experience in math.

Despite having a background in science, Bredberg describes math as her "arch-enemy" all the way up into high school. In the traditional system, students are required to finish each math level, but this doesn't always give them a firm grasp of all the concepts. Bredberg finally went to a teacher and just started crying because she couldn't understand what she was missing. This teacher sat down with her and figured out where the holes were, and worked with her until she could not only finish but understand the work required to pass her current course. This experience

Film Review

Enemies of the State Review: How a Teen Anarchist Became America's Worst Nightmare

Matt DeHart may not have the same name recognition as Julian Assange or Chelsea Manning, but his self-proclaimed capability to expose the U.S. government for what they truly are: emotionless, ruthless, international murderers is just as feared as the actions of the aforementioned WikiLeaks founder and US Army vet turned whistleblower. In the new documentary Enemies of the State, viewers are introduced to the DeHart family, a nerdy and frantic unreliable, biased narrators, which makes for an anxious watch. While Matt's parents are in the film playing themselves, Matt is played by actor Joel Widman (the reason for Matt's absence is explained in the film). Interviews with government officials, lawyers, and reporters are all real, including the sound recordings from Matt's court trial, but set to a fabricated recreation of those court scenes.

The aesthetic of *Enemies of the State* feels as sterile as the maximum-security prison cell Matt was kept in, stripped bare and unforgiving.

family of three, who find themselves at the center of espionage accusations when Matt's ties to Anonymous and the dark web are exposed.

Convinced of Matt's innocence, the DeHart's believe that they're being unfairly targeted by the government in a wild conspiracy theory, which sends them to seek asylum in Canada. Perhaps they're on to something, but their claims weaken when evidence of child pornography on Matt's computer (plus victim statements) directly point to him. But Mr. DeHart, a current pastor, and Mrs. DeHart are in denial; instead of confronting the possibility that their son might be guilty, they come up with varied excuses. Many times throughout the film we are left wondering, are they really that oblivious, blinded by a parent's love? Or is the truth really stranger than fiction?

Nominated for "Best Documentary Feature" at the 2020 Tribeca Film Festival, Enemies of the State was brought to the screen by some heavy-hitters. Directed by Sonia Kennebeck and executive produced by Errol Morris, the film is a hybrid blend of documentary and fiction storytelling from the perspective of It's a twisty story that I found myself rewinding a couple of times throughout my watch both out of fascination and confusion, the delivery here not being as strong or punchy as its cinematic counterparts like *The Imposter* or *The* Thin Blue Line. However, Enemies of the State is thrilling enough to satisfy that true crime craving.



5 Finance Tips To Consider Ahead Of Fall Tuition Deadlines

(BPT) - The second half of summer brings a welcomed sense of familiarity for families across the country as back-to-school season approaches, and enthusiasm is particularly strong after more than a year of uncertainty upended the education system as we know it. While a widespread return-to-campus is a particularly exciting time at the college level, some families may also feel a sense of apprehension, especially in the wake of COVID-19.

• Encourage your student to take full advantage of work-study opportunities if available as part of any financial aid package. • Resist the temptation to borrow extra money for discretionary spending. led to extremely considerate math teaching in her program.

Another Waterhouse parent, Christa Engelskirch, also describes the soft skills side of the school. One of the things she loves about this alternative teaching style is the focus on practicing compassion and mastering empathy. "We can offer opportunities for children to problem-solve on their own, and not have to feel bad just because there is a squabble going on in the corner of a playground," she says, "Whether it's an error in judgment or their emotional maturity is just not quite there yet, it's not a punishable offense. teaching situation."

Bredberg built her school on a three-prong system: the spiritual (it's a non-denominational Christian-based school), the intellectual, and the social-emotional. She wants every child learning under her program to be cognitively present and recognize their value as a human being. She leaves on a hopeful note: "If I have any goal for Waterhouse Guild, it's that we can look at Waterhouse and we can change people's minds about the potential of education for younger children. And I think that we can, because we've already been doing it." •

Southwestern Chicken Salad
