## Rams Player Closes a Digital Gap

A Los Angeles Ram player’s gift cast new attention on a problem that South Bay families without Internet access must confront again as local school districts start the new year with distance learning. Defensive lineman Sebastian Joseph-Day bought computers and wifi hot spots over the summer for 11th graders in the Dreamer Scholars program organized by the “I Have a Dream Foundation-Los Angeles.”

The team announced Joseph-Day’s donation to four promising high school students and their families who would be without access to online learning for the 2020-21 school year. “At the end of the day, everyone deserves a fair chance in life, and that includes a good education regardless of your race, socioeconomic status or creed,” said Joseph-Day, who played at Rutgers University in New Jersey before the Rams drafted him in 2018. He grew up in Pennsylvania in a school district where more than one-third of the students came from low-income households.

The Rams’ player’s gift also highlights the importance that educational foundations play in public education. The “I Have a Dream Foundation-Los Angeles” has demonstrated that intervention starting in first grade and continuing up into high school can boost graduation and college attendance rates. It happened two consecutive years in the Inglewood Unified School District. South Bay foundations plug school funding gaps.

El Segundo public schools benefit from annual support from the El Segundo Educational Foundation. The nonprofit group raised \$1.8 million last school year for programs at Richmond Street, Center Street, and the middle school and high schools. The foundation is prepared to match the \$1.8 million grant amount in the upcoming school year, too. The group has listed several upcoming

fund-raisers for 2020-21 on its web site.

In El Segundo, donations from corporations and individuals have made a difference in classrooms by lowering class sizes in the lower grades and offering more counseling services for young teens. The needs in Inglewood and Hawthorne tilt more toward academic services, including wifi for the families of all schoolchildren in those districts. The lack of technology and a connection to the Internet for some, has created a digital divide, and Assemblywoman Autumn Burke-D-South Bay is on a task force to study the issue ahead of what looks to be another school year with some - or all - distance learning.

State Superintendent of Schools Tony Thurmond formed the task force just as the coronavirus pandemic’s societal effects were exploding. Schools closed and universities sent students home to finish the semester with video instruction from their teachers and professors. For many years, rural communities had been the lone voices asking for state government and the Public Utilities Commission to pressure Internet providers to cover the entire state, not just metro areas. With the closing of schools and the quick switch to online learning, Thurmond, Burke and other elected officials are in hot pursuit of telecommunications companies, which critics say have dragged their feet for years about making wifi access more affordable or free to low-income households.

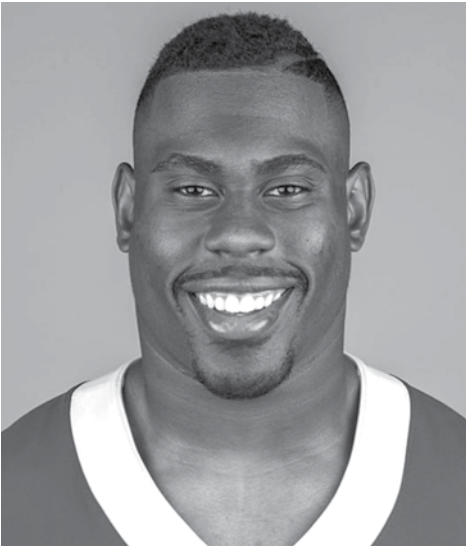
“This task force signals a new era, that California is now working with focus and urgency to close the digital divide in the most concrete way we have ever seen,” Thurmond said in April. “COVID-19 is a public health crisis in California and all around the world, but it’s also revealed other crises like the technology gap that has persisted for too long, leading to opportunity and achievement

gaps for California’s students.”

Joseph-Day, who is a defensive lineman with the Rams, saw the gap and decided to fill in for four students through the I Have a Dream-LA. Together, they identified four students who needed the technological resources to keep up in the upcoming school year. His contribution didn’t stop there. He also sent each of the students in the Dreamer Scholars program a note of encouragement and to wish them bright futures.

Students will return to their studies starting in August, facing much uncertainty about what the future will look like for them, their classmates, teachers and coaches. Even the Dreamer Scholars who’ve been supported from first grade to high school need the reassurance that tough times don’t last, but tough people do. The access to wifi at home is a game-changer for those kids, says the chief executive of the local “I Have a Dream” team.

## Film Review

### Robin’s Wish Reveals What Led to the Actor’s Suffering and Demise: Lewy Body Dementia

On August 11, 2014, news reports broke the tragic news that the beloved comedian and actor, Robin Williams, had died. Major media outlets had globbed on to the news that he had taken his own life, leading to an incredible amount of press that stunned the world.

It was unthinkable to feel why Robin Williams would have taken his life, and people soon started to ask questions. People wondered if a years long battle with drug abuse contributed, if deep-seeded depression

are many), but an intimate and sympathetic look at the late actor at the most painful moments of his life. With unseen footage of Robin from Marin County, including his home, as well as interviews with neighbors and friends. An additional moment includes Shawn Levy, who recounts for the first time the struggles that Robin endured on the final *Night at the Museum* movie, with great reverence and respect.

*Robin’s Wish* is a very rewarding watch, if only to learn about the disease that would overtake his body and see the pain that he

played a part (and the media spun up endless more stories). But a new documentary, *Robin’s Wish*, looks to clarify the reason for Robin’s death.

Although Robin Williams had unmatched performance energy—a tornado of improvisational comedy—offstage, and offscreen, he was incredibly private. His secrecy extended through the end of his life, when the actor (as the documentary shows) began to suffer from debilitating bodily ailments, such as forgetfulness, paranoia, and emotional instability, which would be known as Lewy Body Dementia, but not by the actor.

It’s sad when we learn anyone experiences conditions of this kind; it’s collectively worse when that person was one of the most celebrated performers of all time. In *Robin’s Wish*, the harrowing, saddening experience is recounted firsthand by his widow, Susan Schneider, who illuminates and shares this all.

*Robin’s Wish* is certainly not another broad assemblage of Robin’s greatest hits (and there

Los Angeles County Public Works and Los Angeles County Sanitation Districts conduct more than 50 free Household Hazardous Waste and E-Waste Roundups annually throughout the County to provide residents with a convenient way to rid their homes of unwanted hazardous materials. The Roundups are part of a campaign to promote public awareness of proper disposal practices of household hazardous and e-waste and to provide a convenient, free disposal option.

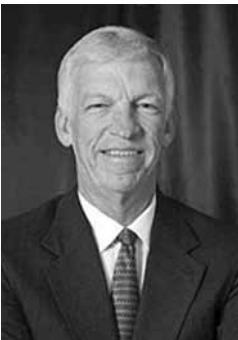

“Our students will bridge the pandemic gap with this technology, ensuring a successful kickoff to the upcoming school year,” said CEO Pamela Miller.

The “I Have a Dream-Foundation Los Angeles” provides long-term support to youth living in under-resourced communities, enabling them to achieve their potential. All chapters nationwide Project Lead the Way (PLTW),” its hands-on science and tech-oriented curriculum, to begin in kindergarten. “promote values of higher education and career success and providing opportunities through financial resources, enrichment programs and more,” it says.

That academic, emotional and experiential support is given to students from underserved Greater Los Angeles communities beginning in the first grade and continuing through college graduation and even though the start of their careers.

The Ed! Foundation in El Segundo is a supporter of technology-based learning, too, though Internet access among district students is less of a pressing issue than in Inglewood and Hawthorne. More than \$200,000 in grant money from the foundation paid for biomedical curriculum, computer science and robotics. “Project Lead the Way” continues annually with hands-on science and tech-oriented teaching, beginning in kindergarten through El Segundo corporate partners and individuals and families’ generous donations.

Inglewood and Hawthorne schools also receive funding from their respective educational foundations. The “I Have a Dream Foundation-Los Angeles” adopted two first grade classes at Daniel Freeman Elementary School, back in 2006 and 2007. The programs collectively served 95 percent African-Americans and five percent Latino youth. The foundation’s investment and follow-up with the Dreamer Scholars were successful, as measured by college attendance data. Three-fourths of the first group attended colleges, and the remainder

joined the military or went to work out of high school, the foundation reported. In the second group, 80 percent enrolled in college after graduation in June 2019.

The Closing the Digital Divide Task Force also wants to locate and direct grants and donations from corporate and grassroots sources. Thurmond says the goal is to facilitate donations, create more publicity, and “cast a bigger spotlight on those who can help,” according to Thurmond’s mid-April announcement.

The task force and the El Segundo Education Foundation accept donations and welcome corporate and individual supporters. The Los Angeles Rams also are involved with COVID-19 relief and community-based programs.

California officials estimate one in five California students lacked broadband or a computer to access distance learning. The digital divide is widest in rural areas, where only 34 percent of households are subscribed to an internet service. Nearly eight in 10 households in urban areas are connected to the web, according to an analysis of 2018 data done by EdSource.

Before the pandemic, one-quarter million Los Angeles County households lacked the basic tools for their children to participate in online learning, found associated professor Hernan Galperin with the USC Annenberg School for Communication. Los Angeles Unified Schools lost connection with thousands of students after the March shutdown, it was reported. Teachers just never heard again from those students.

That could happen again in the 2020-21 school year, which is what the educational foundations are working feverishly to avoid. “Without equitable access to distance learning technology while students are at home, California risks exacerbating education inequality across the state,” Ed Source warned in a May article spotlighting the state’s digital divide. •

### Directions

- **Step 1:** Heat the oven to 375°F. Line 1 baking sheet with parchment paper (When it's time to bake, you will need 1 additional baking sheet and parchment paper).
- **Step 2:** Sprinkle the flour on the work surface. Unfold the pastry sheet on the work surface. Roll the pastry sheet into an 11x14-inch rectangle. Place the pastry onto a parchment paper-lined baking sheet and top with another layer of parchment paper and another baking sheet (This will create a thin, crispy pastry when baked).
- **Step 3:** Bake for 25 minutes, removing the top baking sheet and parchment during the last 5 minutes of the baking time. Remove the baking sheet from the oven and place on a wire rack. Replace the second baking sheet to keep the pastry from curling as it cools. Let the pastry cool completely.
- **Step 4:** Cut the pastry into 12 (3 1/2-inch) squares. Spread 1/2 cup ice cream onto each of 6 pastries. Top with the remaining pastries. If desired, dip the edges of the sandwiches in sprinkles, chopped nuts, crushed pretzels or whatever you like to coat the ice cream. Place on baking sheets and freeze for 1 hour or until firm.

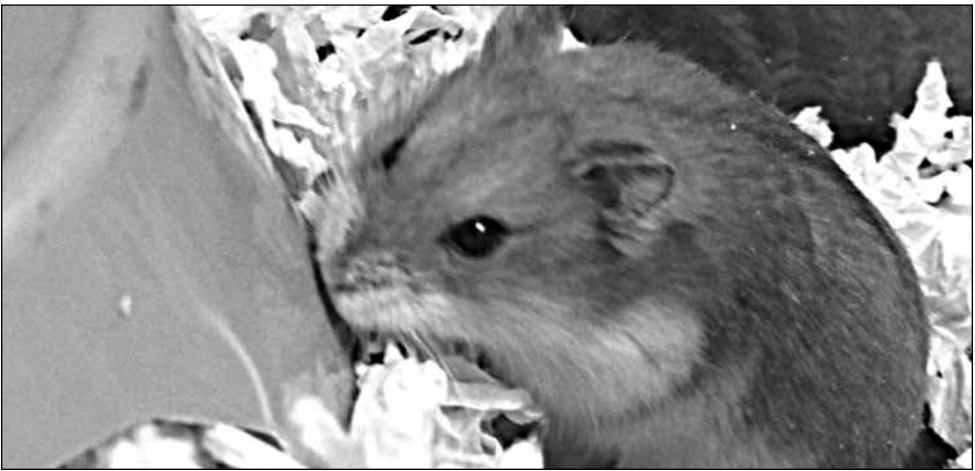
