Moon Zoom and Beyond: The NASA Artemis I Mission

As we traipse into November, we find the days insufferably shortened and we're buffeted by complete darkness at earlier and earlier hours. Which provides ample opportunity to steer that unsinkable curiosity upwards and ponder the constellations and what heretofore discoveries lay await. And NASA's Artemis I mission should sate that incisive inquisitiveness most handily.

This particular mission is slated to launch in a few months and will ring a hat-trick of scientific firsts. Artemis I will have the distinction of being the first integrated test flight of NASA's Orion spacecraft, Space Launch System (SLS) rocket, and the ground systems at Kennedy Space Center. This mission hefts a prodigious amount of ambition with its lunar orbital trajectory. Artemis I will be an uncrewed test flight that will provide a critical foundation for deep space exploration and propel NASA's capability to return to the moon and beyond. In addition, Orion has been devised to remain in space longer than any spacecraft designed for astronauts without having to dock at an interim space station thus prolonging the potential duration of future lunar missions.

Stuff in those noise-dampening earplugs if you got 'em. For Orion will launch from Cape Canaveral on the most powerful super heavy-lift rocket ever constructed and speed farther and faster than any spacecraft designed for humans has ever ventured tallying a distance of 280,000 miles from Florida. This

mission will slingshot Orion thousands of miles beyond the moon over the course of a three-week mission. And hopefully there's enough Tang to last throughout the orbit.

The initial launch breaking the surly bonds of earth will be a sonic boom of a spectacle. Propelled by a pair of five segment boosters and a gaggle of brawny RS-25 rockets, the blast off will punch the atmosphere and produce approximately 8.8 million pounds of thrust and haul a behemoth vehicle weighing nearly six million pounds into the inky

blue-black obsidian of space.

Orion is then scheduled to slalom around a veritable gauntlet of orbital objects. The spacecraft will pass through the Van Allen radiation belts, whizz past the Global Positioning System (GPS) satellite constellation, and above and beyond miscellaneous communication satellites embedded in Earth's orbit. Throughout this perilous journey, Orion will be flexing its unique communication systems design and ability to navigate and operate in

Stromboli:

The evening ferry from Sicily was near-empty. The island was no more than a

Eventually, we found longitude and latitude marks for our destination on a smartphone. When we called the phone number, a voice protested that they'd been looking for us all over the island. We ended up with the mini-palace to ourselves for two gorgeous days, before a winter storm flew up



Check It Out

The Cruel Prince by Holly Black

The Cruel Prince by Holly Black exceeded my expectations. The plot was captivating from start to finish, so much so that I finished the entire novel in one day. The story focuses on Jude Duarte, a human girl who was forced to live in the land of the fey after her parents were murdered right in front of her. Throughout the book, she is faced with numerous obstacles starting with the cruel Prince Cardan and his friends, who insist on making her life as difficult as possible, along with family drama and the burning desire to create a place for herself in a world she was thrust into.

A few qualities that I absolutely adore in Jude are that she is headstrong, fierce, and courageous. To state it simply, she is all that a warrior and independent woman should be. The only part of her character that I disliked was her excessive thirst for power during some parts, but this exception makes her feel more realistic, given that she's certainly not without her flaws.

As for the other characters, my original perceptions of them were far different from my final opinions since, as with all things faerie, not everything is what it seems. One must read carefully and in between the lines to avoid falling for their tricks and mind games. Additionally, I appreciate the way that each of the characters play a significant role in the story, regardless of it being centered around Jude. Consequently, some of them become progressively more likable while others transform into the worst version of themselves.

This is a story of sudden twists and turns, a fight for power, the challenges attached to being royalty, magic, betrayal, and romance. There were many events that took place that I had predicted, along with some that were so unexpected that my jaw immediately dropped while reading. As such, it was lovely to experience a book as enthralling and enchanting as this one. I absolutely recommend *The Cruel Prince* and the remainder of the series to anyone that is a fan of the genre fantasy.

Film Review

In Bergman Island, an Artist Couple Express Their Love Through Film

Do you love beautiful-looking arthouse films? Are you prepared for a film to pluck at your empathetic, tender heartstrings for an hour and a half? Then *Bergman Island*—a filmic love letter by French director Mia Hansen-Løve (*Eden*) to famed Swedish director Ingmar Bergman—is for you. Not only is

pages and meet her protagonist, a young filmmaker named Amy (Mia Wasikowska). In Chris's story, which she narrates, Amy is forced to work through complicated emotional entanglements when she runs into her first love Joseph (Ander Danielsen Lie) on the Fårö island. Amy's struggles don't seem so far off from Chris's, giving the impression that

the film a respectful and enlightening look at the late filmmaker's career (whose seminal works like *The Seventh Seal* and *Persona* have no doubt inspired all of cinema), it is also a reflection of melancholia and how invisible things can cause real-life effects within a couple.

Tim Roth and Vicky Krieps play Tony and Chris, a filmmaker couple who embark on the opportunity of a lifetime, attending an artist's residency in Fårö, a Swedish island where Ingmar Bergman shot some of his most celebrated films. Upon arriving at the island, Chris (Krieps) immediately is suspicious of its beauty, claiming that she finds the island's calm and perfection depressing.

The duo takes up residency in the house where Bergman was said to have written the screenplay of *Scenes From a Marriage*, the film that "made millions of people divorce." Upon arriving, they immediately sense that they are in the shadow of an idol. The pressure for perfection intensifies the longer they stay, however, Tony (Roth) seems to have no trouble letting his ideas flow like running water. Chris, on the other hand, struggles with her unfinished screenplay.

Art imitates life in the second act of the film, when Chris begins to share her work in progress screenplay with Tony. Her words come to life as we're transported into her

Chris is working through her own struggles via her surrogate protagonist.

Bergman Island has a lovely warmth to it. It also has a sun-drenched breeziness that *Call Me by Your Name* also perfectly captured. Further, it's enhanced by its transfixing harp melodies and score by Raphaël Hamburger. Not only do the idyllic coastlines elicit a sense of calm, they also act as a mini-history lesson for cinephiles young and old. *Bergman Island* is a film lover's movie, paying tribute to an icon, by an up-and-coming icon.

Distributed by IFC Films, *'Bergman Island'* is now playing in theaters and available to rent. •

Dear Neighborhood Therapist,

Some of the people around me whom I love seem to live their lives as if everything is perfect. They don't want to hear bad news. They don't want to know about anything negative. They dismiss me when I try to bring up events that are happening in the world and in our community, and tell me I'm silly and I'm lucky and that I shouldn't "complain." My life is pretty good now, but I have experienced a lot of adversity and I know I am stronger for it. I sometimes wonder if my loved ones have any clue about the "real" world, and I am starting to feel like I am the crazy one. How can I tell them that their "perfect" lives have yet to run into reality? Is there anything I can do to prepare them for that moment?

Dear Shaking My Head,

With the airport to the north, the beach to the west, PCH in the east, and Chevron to the south, El Segundo can feel like a closed community. This can be very comforting, especially when considering the vast and seemingly endless concrete sprawl that characterizes so

much of Southern California. Unlike many communities, those living and working in El Segundo have a strong sense of the borders of their own community.

At times it may feel like news of the rest of the world is an intruder to our walled garden. But of course, the rest of the world is out there, and it intrudes if it wants to. This applies not only to our community but to our individual and family lives as well. Tempting as it might be, we cannot simply keep the "real world" out of our lives.

a deep space environment.

And Orion's eventual return back into the Earth's atmosphere will be no small feat either. The vehicle will implement a sequence of precisely-timed engine firings in conjunction with the moon's gravity to accelerate back toward Earth at tremendous speeds. The spacecraft's trajectory will puncture our azure-emerald planet's stratosphere traveling 25,000 mph emitting temperatures upwards of 5,000 degrees Fahrenheit. Perhaps some popped popcorn kernels to go along with that Tang?

And after a grand total distance of 1.3 million miles traveled to and fro, Orion will make a precision-perfect landing off the coast of Baja California. Splashing into the ocean and sending towers of foaming waves rippling through mankind's capacity for wonderment

and interstellar curiosity simultaneously.

So, bundle up and spare a stare at the sky tonight after sunset. And be benignly bewildered by where in the solar system we might just venture next. •



Ordinance No. 2226 is amendment of several ordinances and policies to facilitate compliance with SB 1383, including, but not limited to, a mandatory organics service ordinance, an enforcement ordinance, a CALGreen C&D ordinance, a Model Water Efficient Landscaping Ordinance (MVELLO), and procurement policies aligned with the state's Public Resources Code. **SUMMARY MUNICIPAL CODE CHANGES:** The following is a summary of the updates made to the City's Municipal Code for compliance with the legislation and other City policy decisions. • Enforcement of the Code has been reviewed for compliance with SB 1383 and did not require updates. • Recyclable Materials, Organic Materials,

and Solid Waste Collection and Disposal modifications:

- Definitions have been added and updated to align with SB 1383.
- Sections were inserted to aid organization of the Chapters.
- Includes requirements for the City's franchise hauler and limitations for self-haul/back-haulers.
- Prohibits generators from placing incorrect materials in containers, such as organic materials in the recycling container.
- Includes the requirements for single family, multi-family, and commercial businesses as separate sections.
- Adds the requirements for issuance and approval of allowable waivers from collection service under SB 1383. Allows City, with proper documentation, to automatically issue waivers.
- Updates enclosure space requirements to include space for an organics, recycling, and solid waste container.
- Gives the City authority to inspect and investigate complaints or confirm compliance for SB 1383.
- Includes provisions that City cannot take enforcement action before required date in SB 1383 (January 1, 2024).
- Adds the edible food recovery requirements for commercial edible food generators to comply with the requirements including arranging for edible food donation services, record keeping, etc.
- Adds requirements for food recovery organizations to comply with the requirements including implementation of written agreements,

record keeping, reporting, etc.

• The Landscape Water Efficiency chapter has been reviewed for compliance with SB 1383 and required minor updates. • Building Standards Codes and Administrative Provisions Pertaining to Building and Construction has been reviewed for compliance with SB 1383 and required minor updates. • Sample language was provided to align with the procurement requirements for internal administrative policy update and is not required to be included in the Municipal Code. • Other Notable Revisions/Updates: • Clarifies the responsible party for participation or subscription to collection service that was ambiguous in prior legislation. The City Council finds and determines that there is no possibility that the adoption of this Ordinance will have a significant effect on the environment. Accordingly, this Ordinance is not subject to the requirements of the California Environmental Quality Act (CEQA) pursuant to Sections 15061(b)(3) and 15378 of Division 6 of Title 14 of the California Code of Regulations. A certified copy of the entirety of the text of Ordinance No. 2226 is available both on the City's website and also in the office of the City Clerk, 4455 West 126th Street, Hawthorne, California, and is open for public inspection. Pursuant to Government Code section 36933(c), the summary Ordinance No. 2226 was published at least five (5) days before the ordinance was considered for adoption on October 26, 2021 at a duly convened regular meeting of the Hawthorne City Council. the Tyrrhenian Sea and forced our evacuation.

Luzern:
After a few glasses of champagne, we realized we'd never done the adult thing at the presumably sharp tippy-top of an alp. We set out into the moonless night and eventually found ourselves winding up a steep country road. Except it was more a cow path than an

Autobahn, and the gentle slope to our right soon disappeared into a precipice to nowhere. With inches to spare, we had no choice but to keep going. And then, by pure luck, we came to a barn built into the cliff. After a half-hour of turning the car and catching our breath above the glittering lights of the valley, we crawled back to civilization and sanity.

East Jerusalem:

Two weeks after the Second Intifada insurrection, it didn't help that we were evacuated from the bus station in Eilat for a bomb scare. But we climbed aboard the Jerusalem bus anyway and traveled with a full complement of heavily armed IDF troopers (younger than our children) into the city. We wanted to walk the Twelve Stations of the Cross, but the entire hike lay beyond a narrow gate down a steep, crowded, overhung, chariot-sized alley in the Arab enclave.

We'd managed a hundred meters or so, when a blind panic seized both of us. At least we didn't run, but it was definitely one of the power walks of our lives. Back in the Jewish quarter, we glanced at each other and realized how silly we must have looked. So, we turned back and spent the rest of the afternoon wandering down through the Arab quarter and chatting with all manner of friendly Palestinians. They might not care for some of their neighbors, but to our surprise, couldn't get enough of Americans.

Istanbul:

You can't climb up to the towering Pera District peak from the Galata Bridge, and the funicular closes at 10pm. So, when we showed up after dinner at 10:16, we were stuck. I refused to take a taxi, so we ended up wandering for three hours around to the back of the mountain. Centuries ago, the Ottoman Sultans carved this area into compact commer-

cial communities to keep tabs on their foreign merchants. The alleys and arcades—none of them bothered by a street light—had changed little when we tiptoed through in the eerie, silent dread of that January night.

Mexico City:

We only include this one because of the sheer volume of knowledgeable advice we'd

received from gringos who had probably never visited the city. Never take a bus or a green taxi and, above all, stay away from the red lights of the Zona Rosa. As it happened, our hotel lay on the edge of the Zona, and from the day we arrived, we took buses and green taxis everywhere. But the high point was a political demonstration that erupted on la Reforma. A local news cameraman spotted Glinda taking photographs and started a conversation. We peppered him with questions, until he offered to park his wife with me, while he guided mine into the middle of the chaos. In case you were wondering, our Glinda is no wallflower. The point being...

Most travel risks fall into four broad categories: Disease, crime, anger, and your own fear.

The first two exist everywhere and can be contained with intelligent preparation and reasonable precautions. Long before COVID-19, there were yellow and dengue fevers, malaria, rabies, grisly infections, and all manner of hypothetical medical mishaps. And yet the world continued to turn, human beings slept, ate, and rode trains and buses—and toured the world. Crime will probably be with us until we're uniformly poor and satisfied with a drab equality. But criminals spend more time than you think picking their targets. Your job is to avoid gifting them with a nice, juicy target.

Anger, on the other hand, shifts with the winds of religion and culture and the global competition for resources, but mostly with the leadership cycle in a given country. Right now, is probably not the best time for an American to go people watching in a bar in Kinshasa or Caracas. Probably not the best time to try out your new bikini on the beaches outside Riyadh or Casablanca. Beirut was a paradise in the 1950s and a catastrophe from the 1970s

onward—but who knows what will greet you in another few decades? Vietnam has gone from American bugaboo to the best kept vacation secret in Asia.

In other words ... When gossip and paranoia edge out research and common sense, when you pull back from true experience because of the ugly thing that almost happened to

foolhardy. And you have much more control over where you land along that line than you might want to think.

And no, there is no sharp point awaiting you at the tippy-top of a Swiss Alp. But keep trying—we certainly will.
