Final WUSD Candidates Q&A

With the implementation of distance learning, what are your thoughts on the best way for the District to move forward?

Joanne Kaneda: The COVID impact to education is unprecedented. Safely educating our WUSD students is always a priority, mandating the distance learning model during the pandemic. All provisions for returning to our classrooms must follow LA County health regulations and be approved by WUSD leadership.

While LA County remains in the "purple," most restricted tier, distance learning continues as the safe education solution for *most* students. However, with full approval by the LA County Health Department and WUSD leadership, WUSD is launching the first phase of our plan to return some students with specialized learning needs for in-person assessments starting November 2. WUSD will of course require health screening protocols and other safety measures for staff, students, and visitors.

As your WUSD Board Member, I am proud that WUSD is ready with a Five-Stage Reopening Plan to be implemented when our LA County COVID tier level improves. More info at <https://kaneda4wiseburn.com/>.

Neil Goldman: WUSD is in the Education business. Like any business today, we must contend with myriad COVID-19 constraints, competition, new technologies, legacy practices, employee safety/engagement, and, of course, limited budgets. Most vitally, we *must* serve our "customers" (students and families) well.

As such, we must provide rigorous and robust hybrid learning options moving forward. This means bringing back in-person learning *options* ASAP (especially TK-2 – through a waiver), with investments in PPE, and all safety precautions. We must (and are) investing in tools (like digital screens) that enable teaching to students in class and at home simultaneously. We should also leverage new technologies to drive increasingly personalized education plans and resources for each student. And we must continually bolster our teachers with supports and training. We need to simultaneously move *back* to the classroom and *forward* to the future with flexible, responsive practices that best provide a "life-ready" future for our students.

Jessica Daugherty: First, I want to thank the administration for working through the

summer in order to have an entirely new learning system, teaching process, and content available this fall!

Even so, distance learning is extremely difficult for teachers, students, administrators, and families. As a working mom with two elementary students, I have been bumbling my way through distance learning and I think we can improve. Teachers have been asked to entirely change their curriculum, process, and expectations. We need to ensure that they feel supported, heard, and valued. Provide in-person supports and learning for students with disabilities, English-language-learners, and students with IEPs. Provides families with flexibility that is necessary while juggling working and schooling our children by providing lower-elementary grades with a weekly packet that is stapled and clear.

Provide app-based tools and subscriptions that can be set to each individual student's competency.

What didn't I ask you that you think is important to address?

Jessica Daugherty: As an engaged community member who has sought out opportunities to get students involved, I wish you had asked about my engagement with students. In the

words of current/former students:

"Jessica has given students like me a real voice in our community and has guided us on how to achieve real impact in our community without limiting us just because we are not "adults!" If I was old enough to vote, I would definitely vote for Jessica for the Wiseburn Board."

People Can't Agree on Halloween

It's decision week for El Segundo citizens, with the opening of local polling places from Friday through Election Day for registered voters who want to cast their ballots in person. But politics aside, there is another decision to be made about trick-or-treating this Halloween, and a lively discussion on social media over the weekend exposed a difference in opinion this year on whether handing out candy at the door is allowed.

Do we pass out candy? Are trick-or-treaters encouraged to don costumes and make the rounds in El Segundo's neighborhoods? Does the city have an official policy on whether to open the door if there's a knock on Saturday? The short answer is just like Memorial Day, July 4th and Labor Day; this next holiday will look and feel differ-

ently. Haunted houses and outdoor festivals are banned in Los Angeles County, which remains in the purple tier that indicates COVID-19 remains a widespread threat.

The county Public Health Department discourages trick-or-treating this year. It's not possible to avoid close physical contact with people who aren't members of a household, making it unsafe. Local health officials made the argument for safe, alternative Halloween activities in a bulletin issued October 18; however, that recommendation wasn't enough to persuade everyone to go dark this Halloween night.

Trick-or-treating isn't banned, per se. It is discouraged in favor of the trunk-or-treat and other community activities planned this year by El Segundo Parks and Recreation,

Hi Hawthorne! As of lately, I have been writing articles passionately which talk about small businesses in Hawthorne, especially in the BIPOC (Black, Indigenous, People of Color) Community. I do this to give the owners the recognition they deserve but I also hope they feel some sort of accomplishment in themselves and see their growth. For today's article, I sat down with family business owners Sandra Alfaro and Jose Padilla, the new owners of what used to be the restaurant "The Falcon Inn" but now changed to Big Old Fish Brews and Grill, a Mexican restaurant and bar in Hawthorne, California. Although they seem like regular business owners, underneath they are outstanding residents with community outreach intentions.

BIPOC INDIVIDUALS HELPING OUR COMMUNITIES

Hawthorne's Community Advocators

As I said before, Sandra Alfaro and Jose Padilla are one of the few that enjoy in changing their communities for the better. Believe it or not, there are a lot of individuals in the BIPOC communities trying to improve their cities, whether it's food insecurity, school supply giveaways, or even sharing resources on their social media. As most of them have said, it's "by the people, for the people". Their goal is to give mutual aid to everyone, despite their race, sexual orientation, religion. They attempt to be inclusive as much as they need to. For example, here in Hawthorne, we have Brody Rodriguez, co-founder of the Hawthorne Community Fridge, a mutual aid project to fight food insecurity. We also have the @GudneighborsofHawthorne, a social media page whose goal is to show more representation/advocacy of BIPOC communities, and as of right now encouraging others to vote. Therefore, these underground community advocators are all around us and we should all support them.

Dear Neighborhood Therapist:

I'm struggling with roles as a partner, a parent, a teacher, a friend and a citizen. I can't seem to find the balance. It feels like one week I get it right, then the next I try too hard in one and ignore the others and get in trouble with the people I care about. One day I feel fine, then the next I feel lost, and worried, like I'm the only one going through this. Am I?

Dear It's Tough Out There,

You are not at all the only one. We ask ourselves: when will it end, if at all? Will I stay healthy? How long do we have to live this way? Is there permanent damage being done to my child, my relationship, my family, my community? We are in the most divisive election in our lifetimes, with real differences

Introducing to Sandra Alfaro
and Jose Padilla

As I said before, Sandra Alfaro and Jose Padilla are business owners of Big Old Fish Brews and Grill. Previously, the restaurant was named The Falcon Inn, as everyone in Hawthorne calls it, but 5 years ago, the couple acquired the location and turned it into a family business! However, like Brody and Gudneighbors, they aspired to do more and turn Hawthorne into a better place. According to Padilla, he and Sandra were constantly involved with community outreach through involvement with high school kids, raising money for their yearbooks, etc. However, he wanted to do something real and interact with more of the community since the Covid-19 outbreak has begun. They started by raising money for those who have unfortunately passed away with the virus and provide food for the families and targeting low-income families. Even with this, he wanted to do more. Because he constantly saw kids affiliated with gangs and doing graffiti, he and his wife held an event where kids could paint a mural on the brick wall of their business. He believes that people can change their lifestyles into more positive ones and painting these murals was the first step.

THE SIT – DOWN INTERVIEW

Q: What type of community outreach have you done?

A: (Sandra) As my husband said before, we have donated our walls (from their business) to do an event called La Arbolada, a Van Gogh painting, and our inspiration to hold the event. Many kids and adults came in to paint and it was a great effort in bringing the community together, specifically targeting people who live in Hawthorne. We did get a lot of people to come in and even during the pandemic 3 months ago, we were able to make it possible and it turned out successfully. As of right now, we are helping a community kitchen. We are serving 30 meals a day for 30 people who are of low income and those who are having a rough

time during this pandemic. Our friend Dulce is running the whole program and oversees it. Because they work within a certain budget, we help by assisting with the rest of the budget in and as well as providing the food for the meals. If by chance, one of the 30 does not show up, Dulce and the rest of the volunteers will go around Hawthorne and donate it to the homeless or to anyone who needs food. We are also starting the Good Neighbors Kitchen at our business. We have another location, however, it shut down due to the pandemic. We are going to open next month and through there, we are trying to expand the program and work hard to gain as much money as we can so it can be successful. We will be hiring the elderly, those who are unemployed, and generally creating jobs for the community.

A: (Jose) The joy of people when they get helped and leave.

(Sandra): They come to get their food and they're happy because they're hungry. When everyone was participating in La Arbolada, everyone was having a good time. There was food and many people from other restaurants nearby donated. Therefore, it's fun and it brings happiness to us seeing people smile.

(Jose): You know, the pandemic taught us something. It's not just about making money, it's about living life. When you live the life you got, you learn to give and help others. For me, that makes me feel good that I am capable to give. Not a lot of people can do that. The pandemic is what pushed us to make this change more rapidly. Q: Any significant memories? If not, what's your favorite thing about community help?

A: (Jose): You know life is too short. We've seen one of our employee's family member died because of Covid-19 in a matter of hours. So, you got to do whatever you got possible in a time bomb. You never know when you're going to die, so you must see the blessings around you and be grateful. When our employee's wife died, it made us realize that we are here today but we might not be here tomorrow. What you do today is what's going to matter tomorrow. That's my goal to teach people. Don't just wait to receive, give out.

Q: Have you created any potential bonds or new relationships with community members along the way?

A: (Sandra): Yes, with Dulce. She was a customer here at our restaurant. It all started with the mural over there (a different mural). She always came in and said, "you know I have a vision of this place and I want to paint something there to make your place look prettier. You got to add art to your place". And I just let her paint and trusted her with the outcome. Once it was finished, it impacted people. I would get customers and they complement how the restaurant looks cleaner and looks different in a good way. She painted and brought many artists to illustrate the cute flowers, the butterflies, and all of that. You know, it brings life to your place. So, when I've seen that, I guessed "well I think we can work out a relationship with this lady".

(Jose): Ever since that mural, more people have come to us interested because we are doing something good for the city, essentially opening more doors for us.

(Sandra): Honestly, this has worked out for us because it has allowed us to know our city more. We've got to know these people when they come to our fundraisers. We're business owners so we don't have time to walk out into Hawthorne and meet people. Doing community supportive things has brought their attention that we're trying to do something good for all our city.

Q: In what way has this changed you personally?

A: (Jose): Well, it's making us better human beings. In a way where you see life differently, you know? You don't see it like you just got to work and make money. As I said, it's making us see life from a different perspective. We're grateful for everything.

(Sandra): Like Saturday, we donated a lot of vegetables and fruits to families and to see the happiness in their faces. At the end of the day, we're tired but we see that we lifted off a weight from their shoulders. It made us realize that we can help but also have a support system, such as asking help from others in businesses, the city, a little bit from everyone. So, these experiences taught me to be much more appreciative of the little things.

Q: Any last words you want to give?

A: (Sandra): Anything is possible. Anything. Just by you wanting to, you can make it happen.

(Jose): What I want to pass on to people



We love our stories of bootstrapping our businesses and self-reliance. They work very well as inspiration to work hard and always do our best. But despite their individualistic ideals, these stories are not built for a population in isolation. Sitting at home reminds us of all the projects we wanted to do but didn't have time for, except now we get to feel guilty or inadequate because we still don't want to do them. We feel bad when we are not "productive," as if "producing" was something that we as human animals are required to do.

Personal, social, and economic uncertainty is at all time high. It is totally fine to feel lousy.

There are some things you can do. Connection eases many woes, and connection has suffered dearly this year. It is not just the connections with our friends and loved ones, but the smaller ones, too: at the coffee shop, the dry cleaners, in church. Are you able to work at connection, perhaps calling up an old friend or two? If not, let me know. I can help connect you to others who are eager to connect safely.

As these strange times stretch on, you may find it helpful to change or eliminate certain practices. For example, if you value learning, focus on learning instead of on grades. If you value friendship, focus on the friendships that are most important to you. If you value time together as a family, perhaps it's less stressful to spend it eating popcorn in bed than it is to corral everyone for dinner at seven.

Finally, remember that this is hard. Mental work is real work, and many of us are doing much more of it than ever before. You may

be exhausted and exasperated and by yourself, and in that you are in very good company.

community groups and churches. Last week, Fire Chief Chris Donovan acknowledged that COVID fatigue is real, making people feel restless and ready to return to normal life. Donovan warned against complacency and taking risks that could create a spike in cases in El Segundo. Overall, residents and employees at local companies that remain open have flattened the curve as officials asked them to do. Last week, there were seven active cases in the city, requiring the patients to remain quarantined until they test negative for the virus. Since the pandemic began in March, the city has had one death.

The fatigue described by the fire chief includes the thought of giving up another holiday celebration after the annual hometown July 4th and nightly fireworks show was canceled for public safety. Judging from some social-media messages left over the weekend, some people are reluctant to slam the door on a tradition they look forward to annually. Keeping groups of kids six feet apart on porches is admittedly difficult to do.

One resident on Concord Street said he had 1,200 visitors to his front door last Halloween. If El Segundo residents defy the county's recommendations and word gets out, it could attract significant numbers of trick-or-treaters from outside El Segundo. One person said she liked seeing the children in costume and noted that the county only advises against handing out candy. "Nobody is telling you what to do or not," her post read.

There are some banned activities, along with those the county Department of Public Health says are to be avoided. All Halloween carnivals, festivals and haunted houses are banned this year. Live entertainment also made the list. Trick-or-treating is listed under "Not Recommended" because of the added responsibility of ensuring everyone on the porch is masked. Also, sharing food is risky and handing out treat tends to attract crowds.

El Segundo will host numerous events that comply with the county's wishes for a safe and socially distanced Halloween. And though it won't look the same (or feel the same from

inside a car), kids and their parents have trunk-or-treats to look forward to, including one Joslyn Center on the day of Halloween. For a listing of events, check the city and Parks and Recreation Department web sites.

"We ask everyone to exercise caution and safe distancing while enjoying Halloween. Our city staff has planned some incredible events to enjoy the holiday in a safe environment," Mayor Drew Boyles said.

The Kiwanis and Rotary clubs, along with the El Segundo Police Officer Association, are converting a Santa's Sleigh to the Great Pumpkin and will deliver candy to children curbside. The Giant Pumpkin will be driven through neighborhoods. Children will need to wait at the curb and stay socially distanced unless they're from the same household.

A candy drive hosted by the Bridge South Bay church will adhere to the county's recommendation that prepackaged bags - and not loose candy - be handed out. The "Candy Crew Drive" will take place from 10 a.m. to noon

in front of Richmond Street School.

The fewer people you and your household have in-person contact with, the lower your risk of getting COVID-19, the county health officials said. Limiting family celebrations to two households and two hours are considered best at this time.

Face covering still should be worn around relatives who visit, and close contact should be avoided, according to the pre-Halloween bulletin. Anyone feeling sick or showing symptoms should skip the party and stay at home, according to county officials.

The Centers for Disease Control advises people who decide to pass out candy prepare bags and stand on the driveway to avoid crowds on the porch. Wear a mask and avoid direct contact with the little ghouls and goblins that walk up the driveway. For children, their cloth masks should be considered part of their costumes. The CDC says that a Halloween mask is not as safe as a face covering at preventing airborne transmission of the virus. •
