
of a deal the city made to entice a particular aviation entrepreneur to build his factory there. Just who was that aviation entrepreneur? None other than Jack Northrop. The one-milelong, 700-foot-wide landing area - nestled between Prairie Avenue and Crenshaw Boulevard - was built for him. Mr. Northrop had recently formed a new aviation manufacturing firm (then known as Northrop Aircraft, Inc.), so the airstrip was christened Northfield Field. It was critical to his plan to roll planes off the nearby factory's assembly line and then fly them to the Mojave Desert for testing.

With World War II, however, the United States government took over Northrop Field to utilize as part of the war effort, returning control in November 1946 to the city of Hawthorne.

In April 1948, Northrop Field was renamed Hawthorne Municipal Airport and opened to private aircraft. Then in October 1961, a new 50-foot control tower was dedicated, and five years later, more hangars and a twostory airport terminal (housing a good-sized restaurant) became a reality.

## **Film Review** 'Aftersun' Remembers That Perfect Childhood Vacation With Dad

There is a heartbreaking recognition that *Aftersun* confronts us with: even the best moments of our lives are temporary. Eventually, they will pass and become memories.

*Aftersun* takes place during a week-long vacation between Sophie (Frankie Corio) and her young dad, Calum (Paul Mescal). Set in a sunny Turkish beach town (more specifically, at a modest resort that the young dad can afford), Aftersun shows the simple yet

However, through subtle storytelling, we soon feel a psychic disturbance that this idyllic vacation may be covering a deeper conflict. Early on, Sophie grimaces while seeing Calum's "weird ninja moves," but his Tai Chi practice–photographed more saddeningly later on–suggests that he's struggling to tamp down an inner conflict that Sophie isn't aware of, and too young to be to understand anyways.

As days pass and the vacation starts to reach its inevitable end, Calum–as if anticipating something we're not aware of–becomes in-

The small, overlooked moments between parent and child–such as having your sunscreen rubbed in at the pool, lazily hanging around the hotel room, and snickering together throughout cheesy dinner shows–are rendered with incredible observation and an authentic heart that is emotionally moving.

The entirety of the film is naturalistic, unflashy, and full of warmth, due in large part to the nostalgia of the '90s time period. We return to the pre-cell phone, pre-digital distraction age (of which my own childhood vacations also took place).

The special bond that Sophie and Calum have can unmistakably be attributed to their shared youth. She's eleven, he's thirty-ishsomewhere between a child and an adult himself (his arm cast might imply that he too might still have some growing up to do). Sophie's young maturity and Calum's natural playfulness create an incredibly close relationship. They are each other's worlds. creasingly unsteady. We're left hoping for the best despite the red flags, but the optimism is hard to sustain, especially in the film's final shot. I'll proceed without going into further detail, as I found that *Aftersun*'s emotional impact comes from the slow reveals.



# One Hundred Saturdays: Stella Levi and the Search for a Lost World by Michael Frank

I had heard of the island of Rhodes ... but I didn't know where it was, I certainly didn't know of its history. Since it was situated in the Aegean Sea, I had a vague feeling it might be Greek?

One Hundred Saturdays: Stella Levi and the Search for a Lost World gives us a window into the past of the island of Rhodes, through the eyes of a former resident, Stella Levi. In her nineties, she tells the story of her life to author Michael Frank.



### One Hundred Saturdays: Stella Levi and the Search for a Lost World by Michael Frank

Stella and Michael met at an Italian Studies lecture in New York City in 2015. Through an intermediary, Michael arranged to visit Stella to help her "fix up" her English for a public talk she would give at the Centro Primo Levi, an organization that explores the Italian Jewish past. And that began an association that stretched into six years of Saturday conversations that included stories of her youth in Rhodes ---old traditions, folk remedies and recipes, the intricacies of her family relations, anecdotes of everyday life, like the weekly visits to the Turkish baths with her mother and sisters, celebrations of marriages, religious ceremonies such as

Purim, Passover, Yom Kippur ... and gossip! Everyone knows each other's business in such a small area.

Rhodes is the largest of the Dodecanese islands of Greece and is also the island group's historical capital. The Colossus of Rhodes (a statue of the Greek sun-god Helios), was erected in 280 BC and was the tallest statue and one of the Seven Wonders of the Ancient World. Conquered by a succession of foreign powers over the centuries, the Ottomans took control in 1523 and Rhodes remained in their possession for nearly four hundred years.

When Stella began to speak of her family, friends and neighbors in the Juderia (the Jewish Quarter), she explained that many ethnic groups shared the island including Greeks, Turks and later, Italians. Sephardic Jews were banished from Spain and found their way to Rhodes. It is from these people Stella and her family descended, speaking Judeo-Spanish, Castilian that evolved into some Portuguese, a touch of Greek, some Turkish and mixed with Hebrew. The differing cultures expressed a tolerance for each other ... until Italy's Fascism came to the island in the mid-1930s and soon imposed racial laws.

Stella's father's place of business was moved at the whim of Cesare De Vecchi, the new governor. Yehuda Levi was getting older, See Check It Out, page 4

## Your Neighborhood Therapist

### Dear Neighborhood Therapist,

I meet with a group of people on a weekly Zoom meeting that is part of our professional development. In the past few weeks it has become increasingly toxic, and last week some downright unkind things were said about one of the members. I think it was incredibly unfair, and I have spoken to a few other members who share that view, but none of us feel free to speak up without incurring the wrath of the accuser, so we stay silent. None of us can really just quit without consequences or delays for our careers. If this is what this profession is like, I don't think I want to do it. Should I start to look elsewhere?

### Dear Swimming,

The good news is that you probably can't tell much about your profession from the interaction of this one group. Therapists are generally very nice people, for example, but I assure you that when you get a bunch of them together there can be ugly rancor and toxicity. I would say that it's a homo sapiens thing, not a profession thing.

are. It is going to take some time for society to articulate and disseminate the benefits of being in the same room together. The words that we produce are important, but they do not tell us everything we need to know about a person or a situation.

Until we went massively online, we didn't have to account for the role of non-verbal cues in our interpersonal interactions. Now, we are feeling that loss.

These non-verbal cues also restrain toxic behavior.

In environments where difficult subjects and topics may come up, we must do better to create the conditions where we have better opportunities to recognize one another's dignity and humanity. It is harder to say nasty things to someone if they just held the door for you, or if they just brought cookies for the whole group, or if you shared a laugh about the latest celebrity news as you waited for the coffee to brew. We miss a lot of social cues



It's a bit more complicated than that, of course.

Much of the world has spent the last three years learning many of the benefits of "going remote." In times when we would have boarded a plane or made a long drive in order to close a deal are now done through our computer screens. People whose job functions never fully required them to make daily commutes are now able to work from home, or anywhere else they choose. The convenience is tremendous, as anyone who has put on a nice shirt for the webcam while still wearing their pajama bottoms can tell you. We save gas money, we save commuting time, we lower traffic, we spend more time in the places we want.

But there is also a loss, and we're still figuring out what its dimensions and consequences by staying online. We miss the opportunity to create a level of friendship for which there may not be any substitute.

Zoom interactions are often better than nothing, but - for better or for worse - we should not pretend that the interpersonal dynamics are the same as being together in a room. Toxic behavior in any setting is difficult and sometimes impossible to police. Are you able to find another group within your profession? Is there a moderator that you can collectively reach out to? See if you can find a group that fits better, but don't worry that you're in the wrong field because of this situation.

### **Film Review**

Bringing this story to the screen is firsttime feature filmmaker Charlotte Wells. This directorial debut is such an impressive accomplishment, as it's easily one of my favorite films of the year. Wells' natural ability to capture and realize profoundly small moments also makes sense when you consider that Aftersun was inspired by her own childhood. The act of rendering a troubled past onto the big screen reminded me of Johanna Hogg's The Souvenir, another emotionally wrought and devastatingly personal film.

One of the best parts of the film is Wells' choice to weave in the recorded home video

### As Sophie gets ready to board the plane back home to stay with her mother, Calum uses his camcorder to capture the last few moments he has with his daughter. He records Sophie waving goodbye, and can't help himself from rewinding, fast-forwarding, and replaying that moment as soon as she leaves his line of vision. It's heartbreaking. There's an ambiguousness to what might have happened following that.

Aftersun creates incredible depth in showing just how impactful the subtle moments between a parent and child can be. Understanding that although moments don't last, no matter how badly we wish we could pause time, there is a sense of optimism when we realize that we'll always have the ability to keep those memories alive.

falling into ill health (he would later begin to lose his sight), so this act was detrimental to his well-being. Also, because De Vecchi wanted to install new gardens, he commanded that the Jewish cemetery be relocated, which involved weeks of disinterring remains and causing extreme distress in the community. This was just the beginning.

In 1938 Jewish children were no longer allowed to go to school. Jews could not own businesses: Stella's father was forced to sell his business to an Italian man --- in effect, he was now an EMPLOYEE, of that man. Even the local library was shuttered. Then Germans took control of Rhodes in 1943. All 1,650 Jews were deported from the island ... to the concentration camps in Europe. From time to time Michael asks Stella whether the island's inhabitants realized what was happening, why didn't they leave, why didn't they DO something. How could they not SEE, not KNOW what was coming and the evil being perpetrated? At one point Stella answers, quoting Primo Levi, an Italian chemist, partisan, writer, and Jewish

"We should beware of the errors of judging eras and places according to the prevailing standards of here and now."

Holocaust survivor:

I feel that this observation is just as important today.

This book is about the reconciliation and re-integration of a woman's many selves: the happy-go-lucky child, the willful teen, the young woman who had to become a survivor under the most horrific conditions. It reveals the loss of a world --- how the Jewish people have suffered atrocities and attempts to erase them from the earth. It is about understanding that there are differences of perception in times and eras of the past. Stella confronts the paralysis of her feelings and her abhorrence of being a victim. She still has a question: "I ask myself why, but there is no answer. You do not find a reason. You tell the story, as I have done to you. It's all that you can do."


