New Staff and Superintendent for Inglewood Unified School District

With the formal contracts and compensation affirmed at last week's meeting, the transformation of the Inglewood Unified School District Board is complete. All three executive positions on the administrative cabinet are now filled, as is the position of State Administrator.

Chief Human Resources Officer Hedieh Khajavi replaces Nora Roque. Dr. Bernadette C. Lewis is Chief Academic Officer, replacing Dr. Carmen Beck, and Christine Dacanay replaces Eugenio Villa as Chief Business Officer.

The top position, vacated with the retirement of Dr. Thelma Melendez de Santa Ana, is being covered by Deputy Superintendent of Los Angeles County Schools, Dr. Erika Torres. Torres becomes the sixth state appointee to helm the District in as many years.

Melendez' exit, after two years, fell shy of her stated goal of returning the District to local control. While making some gains in stabilizing budget deficits and a small uptick in test scores, the District still faces challenges -- including a shortage of credentialed teachers and an influx of charter schools.

Torres announced a restructuring of the organizational chart for District leadership, and the creation of an executive position— Director of Operations. "The position will focus on safety in our schools and in the community," said Torres. "School safety will be moved under Operations."

Additionally, Torres talked about refocusing efforts on enrollment. "We have to be strategic in monitoring our charter schools," she said. "We want to find ways to reengage students who have left our schools."

The advisory wing of the Board is also undergoing change, with Area 5 Trustee Dr. D'Artagnan Scorza moving into the role of Board President. The other continuing members include Immediate Past President Dr. Carliss McGhee, Trustee Area 2; Board Vice President Dionne Faulk, Trustee Area 1; and Board Member Margaret Evans, Trustee Area 4. Mrs. Alice Grisby holds a provisional appointment to the seat vacated by Board Member Melody Ngaue-Tu'uholoaki, Trustee Area 3. Scorza thanked Melendez for her service, saying, "We are on the rise and have made significant progress."

Board Member Evans announced a 5K Walk and Run to be scheduled for the spring. "Our goal is to get 100 participants from each school," said Evans. She said the event will be part of an initiative to promote strong attendance as a component of health and wellness throughout the district.

Student representatives from City Honors and Inglewood High gave updates on campus activities. Montana Lemonious-Craig is helping to organize a Blood Drive at City Honors on Dec. 4. The senior wide receiver and captain of City Honors basketball and football teams, carries a 3.9 GPA. In his spare time, he is involved with the Dodgers RBI program and the Robotics Club.

Virginia Williams is ASB President at Inglewood High. She reported on a successful college and career fair last month, with over 45 colleges and companies participating. Williams congratulated the Inglewood Sentinels on their undefeated season (10-0) and their drive to the playoffs.

The Inglewood Unified School District Board meets once monthly. The next regular meeting is scheduled for Wednesday, Dec. 11, at 5:30 p.m. at 401 S. Inglewood Avenue, in the Dr. Ernest Shaw Board Room. •

Film Review

Scandalous Documentary Tells the True Story of the National Enquirer

The news. "Is it entertainment, or is it information?" asks Fred Friendly in *Scandalous*, a question at the heart of this feature-length documentary about the National Enquirer.

The first half of the film covers the history of the Enquirer and how Italian-American businessman Generoso Pope allegedly bought the newspaper with Mafia money, part of his plan to develop a publication that would communicate to mass-market America. After witnessing a gory car accident -- and the

would often call the paper using fake names to drop stories about himself. The Enquirer considered him such a good subject that they assigned Trump his own journalist.

Much of this story is nothing new. We know that Donald Trump is president, and we know the media had a lot to do with it. But what is interesting is watching the interviewees, mostly ex-employees of the Enquirer, bounce between pride and mild concern that they may hold some responsibility. "How did we get a tabloid subject who's now President of

crowd of passersby stopping to watch -- he realized he "gotta make a gore rag." Circulation boomed, but then the subject of gore was abandoned when the newspaper became a staple at the front of every supermarket checkout.

In 1988, their definition of a lucrative story expanded to include politics, when the Enquirer published photographs proving Democratic presidential candidate Gary Hart had lied about having an affair. The Enquirer, we learn, either exposed or backed politicians -- and was prepared to pay generously for either information or silence. Enter Donald Trump and the story of how he used the newspaper to propel himself into the limelight. Trump was so intent on becoming a star that he

the United States? And do I have any shame in this or potential guilt of my own?" asks Larry Haley, the employee who was assigned to cover Donald Trump in the '90s. "Hell, you're just trying to get a page one that will sell next week," he concludes.

Scandalous, opening this Friday at the Laemmle Royal, offers a thought-provoking look into a style of journalism that has greatly influenced the culture we live in today. But, at a time when the subject of the media is often the media itself, I wonder if *Scandalous* lacks a particular element of self-reflection that is required, now more than ever, by all branches of the press. It is, after all, a film by a media company about another media company. •

The Way Home: Tales from a Life Without Technology by Mark Boyle


Mark Boyle has written columns for *The Guardian* (a United Kingdom publication), contributed to international press, radio and television, as well as being the author of *The Moneyless Man*. He is a former business graduate who lived entirely without money for three years.

In this riveting book, Mark describes 'going back to the land', by living on a three

acre *smallholding* in County Galway, Ireland, near a village called Knockmoyle. A *smallholding* is an area of land that is used for farming, but is much smaller than a typical farm. This tale is actually a collection of observations and reflections that help him realize that "... instead of spending my life making a living, I wanted to make living my life."

Mark Boyle has taken on something far more than a challenge from a publisher: journaling about his life with no "conveniences" (he would term "distractions") from this modern age, "... to discover what it might feel like to become a part of one's landscape, using

Three Simple Words Keep Online Accounts Safe, Secure

A strange e-mail appeared in my inbox this week, and the timing of it almost fooled me. Earlier in the week, I had posted an article on LinkedIn about how the U.S. Census Bureau understands working adults make an excellent addition to a workforce. They're reliable, experienced and their local knowledge is a huge asset.

LinkedIn is a social media site that is like Facebook for business professionals. People use it to promote their subject matter expertise. Some professionals use LinkedIn to search for jobs, while others promote their appearances at trade shows and speaking events. Birthdays, job promotions and work anniversaries are shared on it too.

Getting back to the email that dropped into my inbox this week, it looked suspicious but it came from LinkedIn. And I had just posted a new article on the site, so the timing of the email made it seem legitimate. The subject line of the email was "Action detected on your LinkedIn account." Since I'd used my account just days before, I was curious.

However, I'm not gullible either. Friends of mine have had their LinkedIn and Facebook accounts hacked before after clicking on a malicious email. That's the trouble. An innocent-looking email can be a Trojan horse programmed to spread using one's contact list. In social media circles, an email virus spreads faster than the flu in January.

My guard was up, thanks to National Cybersecurity Awareness Month held every October. Stop. Think. Connect. Those three words are sound advice for anyone who uses a computer at home or work, and mobile devices. We're all playing defense these days.

All it takes is one careless click to unleash unintended consequences: identify theft, bank fraud, Social Security fraud, credit card purchases, cash advances and ruined consumer

credit. Or, a takeover of your business or entity's computer data.

Here are some everyday situations that will text even the most cyber-savvy citizen:

Q: You receive an email from an online shopping site claiming that you were incorrectly charged for your last purchase and are due a refund. The email asks you to click a link to start the refund process. What should you do?

A: Do not click on the link. Tip: Check the sender's address and search the document for spelling or grammar mistakes. If you notice anything suspicious, the email is likely a scam. Navigate to the site yourself rather than clicking any links.

Q: You post a picture of you and your best friend on your favorite social media platform. Later, you take it down. Will this ensure no one else sees the picture?

Answer: No. Once an image is posted on the Internet, it is virtually impossible to remove it from circulation. Taking it off of your social media page will help, but others have already seen it or downloaded it.

Q: Automatically updating your machine poses a significant security concern, as it could install unwanted programs/features that disrupt your network or harm your computer.

Answer: No. Updates contain vital patches to help protect your machine against attackers. Keep your machine up-to-date and install new patches as soon as possible.

Q: Cell phones, tablets and other mobile devices are not full computers and do not require software, such as anti-virus, to be secure.

A: False. Cell phones and tablets are simply miniature computers. They contain important data (contacts, financial information, calendars) and require protection like any other device.

only tools and technologies ... that do not make me beholden to the institutions and forces that have no regard for the principles and values on which I wish to live my life."

He had to clarify the rules of life without "technology"- no smartphone of course, but what about an axe or using fire? Even the pencil he was using to write can be described as a form of technology. In fact, how would he write it with no computer --- no online research capabilities, word processing or spellcheck?

Mark first lived in the farmhouse on the smallholding, but then after a year, decided to build a cabin. He allowed wanderers to

use the farmhouse rent-free as a hostel, now called The Happy Pig.

He started a vegetable garden in order to live on what the land can naturally provide. He was a vegan who became aware that the protein he needs to survive in this manner he has chosen will call for a shift in his belief system: he must capture (and kill) a living protein source. He foraged in the woods for wild greens, edible mushrooms, etc. The reader can empathize when he discovered that one of those nearby forests has disappeared within the week he had last been there! "The machines" descended upon

the woodland and eradicated the homes of mammals, insects, fish, and plants: It resulted in a sort of animal Armageddon.

Little lessons pepper the pages - making fire from friction, not matches or lighters, communication is in the form of letters, walked (or biked) to the post office 12 kilometers, round trip (nearly 7 1/2 miles), a camping trip trick to wash dishes without running water. One hardship confronted was Mark's inability to talk or be with his distant parents. He also lost touch with friends scattered across the globe since social media and email were no longer available to him. The local pub, however, was a place of community, welcoming neighbors and musicians who played traditional instruments: guitar, fiddle, tin whistle, bodhran (an Irish drum) and accordion. Everyone can join in and a good

time is had by all.

I listened to the book on CD format and enjoyed narrator Gerard Doyle, a native Irishman. His lilting voice enhanced the story and his pronunciation of some Gaelic words was appreciated.

This book has given me a lot to think about. Mark Boyle is an environmentalist and lover of Nature. I am also attracted to the natural world and feel frustration about those things that interfere with our world: pollution, species endangerment, climate change and deforestation. I also am concerned that advances in technology may be taking us down a frightening path. Maybe tongue-in-cheek, but I'm sure the quote on *The Way Home's* first page is deeper than that: "Everything not saved will be lost," from the Nintendo 'Quit Screen' message. •

Q: A scammer creates a fake email and sends it to thousands of people. What is this type of attack called?

Answer: Phishing: a type of social engineering that often manipulates human impulses, such as greed, fear, or the desire to help others.

Q: What is the term for harmful software that seeks to damage or exploit the machines that run it?

A: Malware, which is short for malicious software. Tip: stay of sketchy websites.

Q: An attacker goes to a local coffee shop and creates a wireless network using the shop's name. And unsuspecting customers

log on. What is this type of attack called?

A: Spoofing. Before logging onto a public network, be sure it is the correct one.

Q: After clicking an advertisement on an unsecured website, your computer freezes. A message appears demanding money to unlock your computer. What kind of attack are you experiencing?

A: Ransomware. These attacks are aimed at institutions and large organizations that need access to their data and payment systems restored immediately.

Q: Which federal agency has been tasked with improving national cybersecurity?



Summary of Adoption of Ordinance 2192 Amending Chapter 8.20 of Title 8 of the Hawthorne Municipal Code ("HMC") Adding Specified Conditions Accompanied by Prolonged Vacancies in a Residential or Commercial Building Constitutes a Condition of Public Nuisance, Related Changes to Definitions and Enforcement Pursuant to Government Code section 36933(c), the following constitutes a summary of Ordinance No. 2192 which was adopted by the City Council at its regular meeting on November 12, 2019 at 6:00 p.m. Pursuant to California Government Code section 36933(c) (1), the City Council has previously directed the preparation and publication of a summary of Ordinance No. 2192 which adds that specified conditions accompanied by prolonged vacancies in a residential or commercial buildings will constitute a public nuisance. Ordinance No. 2192 adds a new section 8.20.030(A)(36) providing that specified conditions, e.g., dilapidated buildings, overgrown vegetation, graffiti, etc., accompanied by prolonged vacancies of ninety or more consecutive days constitutes a public nuisance. It also makes related changes to the definitions and enforcement. Under section 8.20.030(A)(36), the specified conditions to deem a prolonged vacant residential or commercial building a public nuisance are when there exist two of the following conditions (summarized): a. Property which is not kept substantially clean and free from accumulations like overgrown, dead or decayed trees or vegetation, or trash. b. Buildings or structures which are unpainted or the exterior paint is worn off. c. Buildings or structures or its sections, e.g., exterior stairs, roofs, foundations, walls, fences, etc., which are substantially broken, deteriorated, or defaced with graffiti, or windows which are missing or broken. d. In a residential property, outdoor display of unused appliances, furniture and other items other than those commonly stored outdoors, for a period of time in excess of seventy-two consecutive hours. e. Where property is vacant and otherwise required to be boarded up, the boarding shall be done in a manner approved by the building

official and which does not itself have a significant adverse visual impact on the neighborhood nor substantially contribute to the dilapidated or deteriorated appearance of the neighborhood. f. Buildings designed for human use or occupancy that stays vacant for more than ninety consecutive days unless the City Manager finds the following: • It is offered for sale, lease or rent. • It is in the process of repair that is progressing diligently. • It is actively maintained and monitored by the owner and thus not contribute to blight. The above (a) through (e) describes conditions visible from a public right of way and/or neighboring property that have a significant adverse visual impact on the neighborhood. Ordinance No. 2192 also amends section 8.20.020 "Definitions" by adding/revising the following subsections (summarized): (L) Commercial buildings/structure/property shall mean any commercial, industrial structures affixed to or upon real property used for the purpose of conducting a business. (EE) Real Property or premises shall mean all residential, industrial, commercial, and other real property including, but not limited to, vacant lots, front yards, side yards, back yards, driveways, walkways, alleys and sidewalks, and any building or other structure whether fixed or movable, located on such property. (FF) Residential building/structure/property shall mean any structure including, but not limited to, any house, garage, duplex, apartment, condominium, stock cooperative, mobile home, or other residential structure, whether or not such structure is occupied. Section 8.20.030(D) also amends by referencing marijuana related uses as currently defined in the Zoning Code thus maintaining consistency with the two Titles. Ordinance No. 2192 adds the following provisions related to enforcement: •Section 8.20.280, "No duty to enforce," provides that the City is under no duty to enforce any provisions of the Chapter. •Section 8.20.290, "Violations-penalties and remedies" provides that the violations of the Chapter can be prosecuted as misdemeanors and that a separate offense occurs each and every day. Subsections "D" authorizes the City

Attorney to bring an action for injunctive relief. Subsection "E" allows enforcement through the issuance of administrative citations. •Section 8.20.300 provides for the City to seek inspection warrant where the owner does not give consent for inspection. •Section 8.20.310 provides that the City may establish fees for the inspection of properties found to be in violation of the ordinance. This proposed ordinance is exempt from CEQA review pursuant to State CEQA Guidelines, Article 18: Statutory Exemptions, Section 15282(h) because this section of CEQA establishes a statutory exemption for "the adoption of an ordinance regarding second units in a single-family or multifamily residential zone by a city or county to implement the provisions of Sections 65852.1 and 65852.2 of Government Code as set forth in Section 21080.17 of the Public Resources Code. 

Mac and Cheese with Pecan Breadcrumbs

PREP TIME: 20 minutes • COOK TIME: 30 minutes • Servings: 6 to 8



Ingredients

- 1/2 cup raw pecan pieces
- 8 ounces cavatappi pasta
- 1 tablespoon butter
- 8^o-ounce block of cheddar cheese
- 15 ounces part skim ricotta cheese
- 4 tablespoons sour cream
- 1 teaspoon salt
- 1/4 teaspoon ground pepper
- 1 large egg, lightly beaten
- 2 to 4 tablespoons pasta cooking water

Directions

- Preheat oven to 375 Fahrenheit.
- Cook cavatappi in salted boiling water. Drain, reserving 1/2 cup pasta cooking water. Return pasta to cooking pot and stir in butter.
- While pasta is cooking, shred cheddar cheese on a box grater.
- Using a food processor, combine 1/4 cup of shredded cheese with pecans. Process until a coarse breadcrumb consistency.
- Add remaining cheddar cheese, ricotta, sour cream, salt and pepper to the warm pasta. Stir until thoroughly combined. Add egg, stir. Add 2 to 4 tablespoons pasta water to loosen mixture, stir until smooth.
- Pour into a buttered 9-inch square or round casserole dish and top evenly with pecan/cheddar topping.
- Bake for 30 minutes.
