

Absent Council Members Delay Wrongful Eviction Ordinance

A light agenda and a holiday week meant a brief Hawthorne City Council meeting and the absence of two members from the dais. Though excused from attending the session, the missing Mayor Alex Vargas and Councilmember Mike Talleda unexpectedly resulted in postponement of a key vote that shocked the remaining trio present.

The group was set to pass an urgency ordinance to prohibit no-fault evictions without just cause through December 31, 2019. A state bill, AB 1482, goes into effect on Jan. 1 to prevent such evictions as well as rent gouging (capping rent increases at no more than 5 percent annually plus consumer price index bump-ups), so the urgency ordinance intended to protect Hawthorne families until that time. Councilmember Alex Monteiro cited recent votes from the cities of Redondo Beach and Los Angeles to address the same issue. He noted that local landlords have been evicting residents for no good reason as of late because the former can get away with it until the state law kicks in next year.

But to the Council trio's surprise, the item had to be continued to Dec. 10 because an urgency ordinance requires four votes for adoption. Three wasn't enough. The situation drew the ire of Councilmember Haidar Awad. "I think this pisses me off just a bit," he said, noting the ordinance was something the Council was "doing for the residents" and that he was "shocked" this required four votes. He added that he doesn't want to see a family that is "living paycheck to paycheck" wondering if they will be able to sleep at home during the holidays. Awad went on to state that the vote needed to have "an entire council pushing" for it. "That's lack of leadership," he said, adding that fighting wrongful evictions was one of two items residents had asked him for the most during his tenure on the Council.

The other item asked of Awad did pass during the meeting, as it only required three yes votes. This was to establish a blight fee that penalizes negligent property owners who leave vacant lots in poor visual condition. Mayor Pro Tem Olivia Valentine reported that she received numerous complaints from local citizens about blighted properties and that

the new ordinance amendment can assess a \$1,000 fee (City Attorney Russell Miyahara confirmed fees can be imposed daily if not addressed by the violators) or even jail time if ignored for six months in both commercial and residential areas. She noted that the beefed up code will "add teeth to enforcement" to charge misdemeanors "if not taken seriously by business owners."

Awad said he was glad to see the enforcement come to light so "landlords know Hawthorne is coming in heavy." He also argued that the updated code is not anti-business but rather

Campuses Joining Together to Send Students Onto Careers in Aerospace

Two high school districts and El Camino College next year will join a technical training program that the college's president envisions becoming a job pipeline from the classroom to the South Bay's world-class flight and space industry. The public-private partnership coming to the area aims to inspire teens and young adults to pursue careers in technology, including manufacturing which is the number one job creator in the airport area.

Jose Anaya, dean of Community Advancement with El Camino, last month revealed the details of the partnership to the college board of trustees. NextFlex, a research institute that develops flexible technology nationwide, is a central partner in the workforce development project.

Centinela Valley Union High School District and Inglewood Unified School District have agreed to partner with El Camino to launch NetFlex's pilot program in the South Bay. High school students will be recruited to join, starting in the spring, according to Anaya.

Teachers in the two districts will play an instrumental role in the startup program. They will learn a program developed by NextFlex to attract young minds to think about careers in technology, and blend the concepts of it into class learning objectives, according to the presentation. "We're hoping that we capture and inspire young people to look at careers in technology and make their way to El Camino College," Anaya said. College officials say they are fulfilling the mission of community colleges to prepare a skilled workforce for local employers that meet the changing demands of the South Bay's core industries.

The aerospace industry in the South Bay and elsewhere in the nation can't find enough skilled workers to replace its aging workforce. El Camino President Dena Maloney said recently the partnership is good for local industry and for the Torrance campus. "It's very important to our students for employment and it's very important to our companies for economic growth," she said, adding "and it's very important to the college that we're seen as a solution to this workforce dilemma that we're facing."

The aerospace manufacturing and parts industry employs 75,000 people statewide,

according to state employment data. That number has held steady the past 23 months.

A future-of-work report released in June has sounded a call for more young people to attend community colleges and prepare themselves for middle-skill careers that offer higher-than-average pay, career advancement and maybe, most importantly, jobs that aren't going to a robot anytime soon.

South Bay employers and recruiters over the next five years can expect skills shortages for positions that require an Associates degree or some college coursework. The labor economists with the L.A. Center for a Competitive Workforce in their report say that middle-skilled professions -- nursing, bookkeeping, auditing and managing production and planning -- offer the best opportunities in Los Angeles County's wideopen workforce.

Community colleges are employers' best hope for getting out ahead of the coming skills gap, the report's authors say. Jobs in warehousing, data collection, and labor physical are being replaced by machines and trusted to artificial intelligence. Automation won't be a "pressing threat" to local employer for another 10 or 20 years, however, according to the labor economists.

When the door closes on these familiar jobs in South Bay's aerospace and defense companies, another door is expected to open. Some technical training -- not necessarily a four-year degree, and an ability to manage people and processes -- are expected to be in high demand. "Recent advancements in robotics, artificial intelligence and machine learning are poised to cause greater levels of disruption in the future, not only in manufacturing, but also across numerous other industries. Individuals will need skills that can be employed in conjunction with the functions of machines," the authors noted.

"This puts enormous pressure on community colleges and other education systems to create programs that will do just that."

What lies ahead are opportunities for local community colleges to adapt their coursework and training programs with more emphasis on STEM (science-technology-engineeringmathematics) fields of study and soft skills

Film Review

Knives Out Is a Sharp, Smart Whodunit

Like any good whodunit film, the excitement lies not only in the peculiar nature of the crime but also in the equally kooky cast of characters who toss around suspicions like hot potatoes. A sassy and stylish homage to its murder-mystery predecessors, *Knives Out* (now playing in theaters everywhere) is 130 minutes of pure thrills, adrenaline highs and avant-garde home decor. Rian Johnson – who recently directed *Star Wars: The Last Jedi* –

self-righteous prerogatives. Because no one trusts the intentions of another, these complicated family dynamics are expressed in both a war of words and physical altercations that blend to create comedy gold. Combined, they create an undeniable force of talent that is pure hilarity to watch on screen.

Knives Out offers a wildly entertaining escape from reality, like an Agatha Christie murder-mystery come to life. It does a wonderful job of introducing new twists --

creates a compelling atmosphere of suspense that will have audiences on edge until the very last frame.

Christopher Plummer plays the patriarchal Harlan Thrombey, an accomplished mystery writer and collector of gaudy art and selfportraits. In celebration of his 85th birthday, his fractured family congregates in his mansion estate to reconnect, eat cake and unavoidably stir up drama. When Harlan is found dead the following morning, the local detectives assigned to the incident (LaKeith Stanfield, Noah Segan) initially believe this is an open and shut case of suicide. However, private investigator Benoit Blanc (Daniel Craig) senses otherwise. With his bourbon-glazed Southern drawl and sharp line of questioning, he enlists the assistance of Harlan's caregiver, Marta (Ana de Armas), to help him catch the killer (or killers?). In the Thrombey mansion, everyone is a suspect.

The main draw here is the stellar ensemble cast. Chris Evans, Jamie Lee Curtis, Toni Collette, Don Johnson, Michael Shannon, Katherine Langford and Jaeden Martell all play exaggerated versions of entitled teens and adults with flamboyant attitudes and

and subsequently increasing the stakes with every new scene. *Knives Out* doesn't reinvent the wheel, but it feels fresh in its execution, which is mostly due to the hilarious script. The humor is the film's selling point. It's fast-paced and specific with every single joke landing hard. Despite the warning of "mature content," *Knives Out* is the perfect film to watch over the holidays for a good laugh. •

Also during the meeting, Monteiro asked for and received his colleagues' support to direct the Public Works Department to install a four-way stop sign at the intersection of Doty and 115th. He pointed out that "cars fly through" the current sign. Monteiro also announced that the 2020 Census Complete Count Committee will hold a meeting open to the public at the Hawthorne Memorial Center on Dec. 17 at 3:30 p.m. "We need to count every resident," he said of Hawthorne's approximately 90,000 population. Monteiro additionally invited the public to attend the annual potluck (Dec. 18 at noon) at the Hawthorne School District building and said he will cook Portuguese food for those inclined to try the cuisine. He also lauded Golden State Water for giving the City 28 turkeys to hand out to local families and mentioned 200 gift cards (Ralphs and Food4Less) given away

through the Hawthorne Presidents Council at Moneta Gardens.

Valentine made an early announcement for her upcoming Hawthorne Business Expo, set for Jan. 29 from 2:30-6:30 at the Memorial Center. She said last year's event drew 62 exhibitors and hopes that the 2020 program will feature even more participants.

In his report, Awad spoke of the Dec. 14 event to attempt to break a Guinness Book record by having 10,000 people dressed as Santa Claus. The California Great Santa

that day from 10 a.m. to noon with proceeds going to the students of the Hawthorne-based Mychal's Learning Place. Awad urged Hawthorne to come out in numbers for that event. Instant Pot® Smothered Pork Chops

When done, press Cancel and use the quick release method to release the pressure. While the pork is cooking, cook the rice according to the package directions.
- Step 3: Season the pork and sauce to taste. Serve the pork and sauce over the rice and sprinkle with fresh chopped parsley, if desired.

Recipe Tips

- **Recipe Note:** Multi-cooker settings and features vary widely across different models and brands. Refer to the manual for your cooker to learn which functions will produce the cooking methods (pressure cook) needed for this recipe.
- For Thicker Sauce: Remove the cooked pork from the pot, cover and keep warm. Select the Saute setting on the pot and cook, uncovered, for 5 minutes or until the sauce is slightly reduced.

that managers need to be successful, says the team at the competitive workforce center. The new venture is a partnership of 19 Los Angeles and Orange County community colleges and headed by the Los Angeles Economic Development Corporation.

Other members include the L.A. Chamber of Commerce, Southern California Leadership Council, and the Center of Excellence for Labor Market Research at Mt. San Antonio College. The work admittedly is a balancing act. With this first report, they've identified what the greater L.A. labor pool is lacking in training, talents and experience. And, they've given administrators at community colleges a roadmap to support local business.

There were 776,000 students registered at Los Angeles-area community colleges for the 2014-15 academic year, according to the center. Two-thirds of those students enrolled in career education programs, which prepare them for health care, automotive, business and financial service careers. Students can choose from more than 200 career education programs offered by 19 community colleges in Los Angeles County and nine Orange County campuses. "Since community colleges play a leading and vital role in training students to enter these target occupations, it is incumbent that more attention be given toward meeting forecasted employer demand," the future-ofwork report said.

Closing the supply gap by aligning the talents of community college graduates with talent gaps in Southern California industries is critical to the growth and prosperity of L.A. County's diverse economy, the LAEDC authors stressed. There are 52

community colleges in greater Los Angeles, including our local campuses: El Camino College in Torrance, Santa Monica, Harbor in Wilmington, and West Los Angeles in Culver City.

Middle-skill jobs can pay close to \$100,000 per year and they require only an associate's degree from a community college. LAEDC's workforce alignment team is bullish on six local industries for people with some college or a two-year degree: aerospace, biomedical manufacturing, entertainment, health care services, ports and related transportation support activities; and professional and technical services.

Employers in these six core industries will be looking to hire 55,000 people with middle skills between now and 2021, the LAEDC forecast said. "The demand for workers with technical skills, as well as indepth knowledge of mathematics and science will continue to remain a high priority for aerospace establishments. Simultaneously, many workers in the industry across all occupations are nearing retirement age, including those in middle-skill occupations such as aircraft mechanics and service technicians, representing critical training opportunity for local community colleges," it predicted.

The other core industries counting on the community college system for the next generation of technicians, installers, mechanics and other professions crucial to the area are biomedical, entertainment, health care, the Port of Los Angeles, and professional and technical services.
