The City of Hawthorne's Year in Review: A Recap of 2023

The City of Hawthorne is proud to ring in another great year of innovative programs, memorable events, and exciting initiatives. Read on to learn about a few of our city's standout moments throughout 2023. "From exciting celebrations to innovative programs, the accomplishments of the past year reflect the collaborative spirit of our City of Good Neighbors," said City Manager Vontray Norris. "As we look ahead, our dedication to fostering a vibrant, inclusive, and thriving City remains strong as we take the leap into 2024."

Celebrating Our Community

During the summer, the city launched diverse family-friendly programs, including Movies in the Park, aquatic programs, sports clinics, and arts-based classes, providing a well-deserved break for Hawthorne families. In June, the city hosted a vibrant Juneteenth celebration at Holly Park, highlighting the historical significance of Juneteenth and promoting unity within the community.

The first-ever Skates in the Park event at Memorial Park brought joy to over 350 attendees, fostering community connections through the distribution of approximately 500 pairs of skates. And, in August, the National Night Out event at Memorial Park strengthened community bonds, bringing together residents, businesses, schools, and organizations.

September featured another roster of significant events, such as a 9/11 Memorial Ceremony, our 3rd Annual World Festival, celebrating Hawthorne's diversity, and a Household Hazardous Waste Event dedicated to responsible waste disposal. We also celebrated

the sixth anniversary of our partnership with the Dodgers Dreamteam program, which continues to serve over 300 children across the city. Additionally, we welcomed autumn with our Halloween Spooktacular event and Halloween Home Decorating Contest, which provided spine-tingling fun for the community.

Throughout the year, we were proud to celebrate these events, milestones, and more across the City's social media platforms. So far in 2023, we've gained over 1,500 followers across Facebook, Instagram, and X (formerly known as Twitter). This year, we've increased our number of posts by 40%,

giving our community more opportunities to learn about City resources and connect with each other. Additionally, we've invested in creating accessible video content, resulting in a 250% increase in video views across social media platforms.

Expanding Resources for People Experiencing Homelessness

This year, we took steps to address homelessness. The Bridge of Hope Community Housing development celebrated successful occupancy of all 12 pallet homes, offering interim shelter to unhoused individuals.

Fluffing Up for the Cockatoo Inn

Just what is it about the Cockatoo Inn? How much is a myth? How much is embellishment? How much is even accurate? Bottom line, people still talk about the Cockatoo Inn. Some get a sly smile on their face, others a bit of

In the 1940s, the Cockatoo Cafe was a non-descript, modest location. Mr. Andrew J. Lococo came into the picture. He is a definite (major) part of the lore. Mr. Lococo was colorful, and there are rumors, stories if you will, about his activities, but what is and is not true is for others to decide. Bottom line: he purchased a stake in the establishment around 1946 and soon had full control. Andrew J. Lococo himself was nicknamed "Mr. Cockatoo".

A cockatoo is an iconic bird, which can be quite noisy. It also is considered to be gregarious, very intelligent, and social. Cockatoos are identifiable by a head crest of feathers, which, when fluffed up, can serve as a communication device with other cockatoos. Seems a fitting symbol, then, all things considered, with respect to the Cockatoo Inn.

In fact, that may be part of the ongoing interest here.

Mr. Lococo was indeed larger than life, and the Cockatoo Inn stood out. It was seen and heard. The hotel (the Cockatoo Inn) was built in 1958. By the 1960s, it was quite popular. Guests included Marilyn Monroe, Mickey Rooney, Betty Grable, and both John and Robert F. Kennedy.


Check It Out

The Switch by Beth O'Leary

I want to advocate for the library's varied and treasure-filled Books on CD this month. I know I have written reviews in the past that included audio versions of books, but The Switch by Beth O'Leary, needs to be singled out!

I have a pretty lengthy commute to my job and audiobooks have certainly eased that pain much of the time. I had finished our "new" books on CD, so I took a deep dive into some older ones I have missed and discovered The Switch. When I read the short synopsis on the case, I wasn't sure ... it sounded like another

"switching bodies" story --- like "Freaky Friday" --- and I was skeptical. But, elements of it were appealing: it took place in England (Yorkshire, particularly, as well as London), had a lively senior citizen as one of the main characters and seemed like it would be also quite humorous (fighting traffic on the freeways, it helps to listen to something funny.)

What a gem of a tale! Seventy-nine year-old Eileen Cotton lives in a quaint cottage near the Yorkshire Dales and is getting a bit bored with her small town life of committees, her never-ending war with her next door neighbor Arnold and the looming May Day celebration, for which she needs to locate a sponsor. She's also grieving her granddaughter Carla's death ... and her husband left her for a ballroom dance teacher!

Her granddaughter Leena (Carla's sister) comes to stay with her after she's given an unwanted vacation from work (she had a panic attack and nearly lost her company's account.) Leena has not been coping well after Carla's death and she is extremely angry at her mother. As Leena and Eileen compare notes, Leena has a brilliant idea --- she and Eileen can swap lives for a couple of months! Eileen is looking for some male companionship (there seem to be no eligible older gentlemen in her small village) and would also like to see what it would be like to live in the Big City (London.) Leena concedes that she might need a rest and agrees to fill in on various projects for her grandmother. Eileen is hoping that Leena might even be able to patch up her relationship with her mother. Leena will stay in the cottage in Hamleigh and Eileen will move into Leena flat in London (which contains some young roommates.) They even switch phones --- Leena has a modern

smart phone, of course but Eileen's phone is

an ancient mobile version. This device opens

up much ensuing hilarity.

In alternating chapters, Leena and Eileen reveal what it's like to live each other's lives. Of course, it's a "fish-out-of-water" premise, but utterly delightful in its telling. Voice actor Alison Steadman is superb as Eileen, sounding quite like Maggie Smith. I was surprised at her facility with many other characterizations, as well. Daisy Edgar-Jones voices Leena and she is spot-on as she conveys the character's evolution. Leena is a young modern who underestimates her grandmother's "projects" as well as the neighbors she encounters. She grows and is better for it.

Expertly written and acted dialogue moved me to tears and then, before I knew it, something ridiculous happened and I was laughing out loud. The Switch makes some cogent observations --- how difficult it can be to navigate grief and anger, how easy it can be to disregard an aging population, and that family relationships take careful and present tending.

The library has this and many other books and materials to whet your appetite for knowledge and entertainment. Our friendly staff will assist you in your search. •

<u>Film Review</u>

The Delinquents Is A Life-Affirming Bank Heist Comedy

A "delinquent" can be either someone who violates the law or someone who is overdue in an action. In Rodrigo Moreno's film The Delinquents, the meaning applies to both. In this case, those who break the law to rectify something they are crucially overdue in doing: finally living their lives. What starts as a dryly funny bank heist comedy, The Delinquents ends as a poignant meditation on the sacredness of life that will inspire those

who seek out this special film.

The film opens with a hilariously drab shot of a colorless suit laid over a chair. It's the sad uniform of Morán (Daniel Elías), a lifeless bank teller who handles large amounts of money each day for a living, without the faintest trace of joy on his face. One day, Morán nonchalantly enters the main bank vault alone. Staring into the security cameras, he casually proceeds to put over \$650,000 in cash into his bag and walks out of the building.

Morán then meets up with an unsuspecting colleague, Román (Esteban Bigliardi), informing him of the illegal act he performed earlier that day. Román also learns of Morán's grand plan: that if he looks after the stolen money while Morán serves out his sentence (which

he's calculated to be just over three years; less with good behavior), he'll receive half of the money-which Morán reasons would equal five years' worth of salaries working at their soul-crushing bank job. Initially reluctant, Román agrees, and takes the money to hide. After all, what could go wrong?

What begins as an impulsive agreement to accept a sizable fortune turns into full-on anxiety for Román-especially after a strongwilled detective enters the picture and signs start to point to his involvement. Román decides it's not worth it, visiting Morán in prison to inform him he can no longer keep the money. Morán-experiencing the unexpected roughness of prison life-tells him of a hidden nature reserve where the cash can be stashed. Román buries their fortune, but not before meeting a group of friendly strangers at the lake: Norma (Margarita Molfino), Morna (Cecilia Rainero), and Ramón (Javier Zoro) (yes, they are all anagrams, signaling a cosmically fated connection that we all share).

It's here where the first act ends, and where the film takes on an entirely new tone in its second act: one that's less comical, and more observant about life's beauty when you're finally outside of the system. Rámon embarks on a new passionate life path with Norma, avoiding the stresses of his job and the family he left behind. The film moves from the busy city into the wide expanse of nature, where Rámon, Norma, and his new

friends live (and where Morán may still be connected to this new group of strangers).

Rodrigo Moreno's film is an incredible work of art, ultimately revealing how people can let their jobs become their life's meaning and forget the source of true happiness. Moreno's ways of slowing the movie down to reflect this, such as dancing to a long song, hearing a full-length poem read aloud, and simply witnessing beautiful shots of rolling mountains, are flourishes that remind us as viewers to slow down and experience these "unproductive" but beautiful moments without a "productive" value.

The Delinquents is a long movie. At 3 hours and 9 minutes—complete with two chaptered parts—it's something of an odyssey to endure. Ironically, the film (Argentina's official entry to the 2024 Academy Awards) is about the preciousness of passing time, and how we shouldn't waste a single minute of it. To that end, you might think that watching a three-plus hour movie might go against its message, but I'm here to say that you'd be wrong. The Delinquents accomplishes its mission in the final scene, proving it has the impressive and magnificent power to make you reconsider how you live your life. •

SBWIB Gets Grant to Prepare Students With Disabilities For Employment

A collaboration between the California Department of Rehabilitation (DOR) and the Foundation for California Community Colleges has awarded the South Bay Workforce Investment Board (SBWIB) a \$150,000 grant to provide work readiness training and paid work experience opportunities for students with disabilities under the Student Training & Employment Program (STEP).

This project will serve 30 students with disabilities recruited in partnership with three school districts including Torrance Unified, Gardena and Carson High Schools in the Los Angeles Unified School District, and Inglewood Unified School District. SBWIB will work directly with the Districts' Special Education Departments and the Special Resource Center at

El Camino College to recruit eligible students.

"With over 1,000 students with disabilities in high schools in our service area, this program will help provide more resources to additional students and prepare them to become part of a diverse and prepared workforce in our nation's evolving economy," said SBWIB Executive Director Jan Vogel.

Students enrolled in the program will receive work readiness training through SBWIB's Blueprint for Workplace Success curriculum, and the paid work experience component will last a minimum of 120 hours starting early in 2024. To ensure that the students' career interests are addressed, they will be able to access the SBWIB's more than 300 training and employer partners. •




While unconfirmed, I have been told there was a Villa adjacent to the Inn where many private parties took place, and possibly there was a tunnel from the kitchen to the Villa to allow for privacy. As already asked above, how much is a myth? How much is embellishment? How much is even true?

A good friend, who is a longstanding Hawthorne resident, tells me from the 1960s to the early 1990s when an event was to be arranged (banquet, wedding, and meetings), "the Cockatoo was the first place the locals thought of..."

Located on Imperial Highway at Hawthorne Boulevard, the Cockatoo Inn was built in the "Olde English style ."It served as a meeting place for many people and groups in the community. This included service clubs,

which some may sardonically refer to as "just a group of do-gooders."

After all, this business, owned by the inimitable Mr. Lococo, was also reputed to be visited by horse racing insiders and gamblers. In sum, it can rightfully be said that the Cockatoo Inn had a wide wingspan and a dedicated, diverse clientele.

You can find online an excellent website about the Inn at: https://cockatooinn.com/ history/. If the link does not work for you, type "Welcome to the Cockatoo Inn" on your web browser. Once the website is opened, you will find photos, shared memories, history, anecdotes, and other items. The website pays respectful homage to this unique and memorable part of Hawthorne's past. Driving by there today, little reminds you of the fabled Inn, although nearby is a place named the Comfort Inn Cockatoo.

Just recently, a photograph of the memorable Cockatoo Inn was posted on Facebook under the heading "You Know South Bay If..." Numerous comments were posted, including "Had my first cocktail there @ 18"; "My sister had her wedding reception there,"; and "My husband and I would meet up there after work to enjoy the free snacks with our delicious cocktails. It always felt like I was in a special place. Those type restaurants/ cocktail lounges just don't exist anymore, and that's such a shame. I miss them."


Quentin Tarantino, the well-known, wellregarded film director who grew up in the South Bay, filmed at the Cockatoo Inn. This included his movie "Jackie Brown," which starred Pam Grier, with such luminaries in supporting roles as Michael Keaton, Robert DeNiro, Bridget Fonda, and Samuel L.

So, what is it then, just what is it, about the Cockatoo Inn that still resonates today? The building burned down in 1958 and was reconstructed, but was abandoned by the mid-1990s and demolished in 2006. Well before then, Mr. Lococo had legal issues and sold his interest before passing in 1973. I am told as people left his funeral (held at St. Joseph's Catholic Church in Hawthorne), the FBI was across the street with all kinds of cameras on tripods and hand-held cameras. Once more, then, how much is myth, how much is embellishment, and what is even true?

Nostalgia is described as a sentimental feeling about the past. The emotion, this longing, may be for a period of time or a place that has happy associations.

There is a desire to return to a former time. Perhaps it seems that most everything was simpler then.

Having given this thought, it is fair to say the Cockatoo Inn may be a reminder of something very important: Cherish what we have. Don't take anything for granted. This includes each other, let alone places we frequented or so enjoyed in times gone

by. With the holidays at hand, during which we often are with family and good friends, it is wise to remember that what is here today may not be with us tomorrow.

So, then, let's fluff up our head crests like a cockatoo. Let's stand on our perch and make a little noise. If anyone complains, just say, "I'm only imitating a cockatoo in honor of the Cockatoo Inn!"

Sometimes we just don't know what we had, until we no longer have it..



Sprucing Up Our Public Spaces

Various City improvements were made, including modernizing the City Council Chambers, securing \$4.1 million funding for the Crenshaw Boulevard Improvement Project, and installing electric vehicle charging stations in several locations across the city. We also completed enhancements of parks and recreational spaces, including the opening of the Memorial Dog Park, conversion of tennis courts into pickleball courts, creation of a community garden at Holly Park, and construction of a sound wall near Glasgow Park.
