Big Red: A Novel Starring Rita Hayworth & Orson Welles by Jerome Charyn


Classic film stars gallivanting in Old Hollywood – what could be more exciting? Author Jerome Charyn does not let the reader down in this marvelous tale revolving around the relationship between femme fatale Rita Hayworth and "The Boy Wonder" Orson Welles.

Columbia Pictures head honcho Harry Cohn hires a "spy" to be placed near this power couple of the day. Rusty Redburn, a budding gossip columnist who works in the publicity department of the studio is selected to keep tabs on Cohn's creation: beautiful dancer Margarita Carmen Cansino, transformed into "The Love Goddess" --- Rita Hayworth.

Cohn places Rusty into the position of Rita's personal secretary. She will gather "information" and report back to the Boss on a weekly basis. Almost immediately, Rusty becomes an advocate for Rita by tutoring her in literature so she can overcome her intimidation of Orson's intellect. As she is incorporated into their household, Rusty is swept along into their adventures, including Orson's spectacle, the Mercury Wonder Show.

Using the character of Rusty as narrator, the

author achieves quite a feat. Rusty becomes Charyn's alter ego. Jerome Charyn has taught film history and his extensive knowledge of his subject informs Rusty's savvy observations as she navigates the seamy side of the movie business while cracking wise in the faces of the rich as well as those on the long slide downward.

There is so much information for those who enjoy history of the Golden Age of Hollywood. Quickly turning the pages, I questioned how much was fiction and how much was reality. I found myself fact-checking much of the asides and backgrounds only to find how much was TRUE! Sure, there's some manufactured humor, manipulation of events, exaggeration of characters and situations, but much of what you read in Big Red can be verified. There's a melancholy associated with Rita throughout the novel that is rooted in truth regarding her childhood. The author uses that information to imagine later interactions with her parents that are truly painful to absorb. Rita never seems truly able to harness her own star power and allows her lack of self-confidence to put her on a path to ruin. Rusty tries but fails to protect her friend and is forced to watch Big Red's sad slide.

Once you open this book, it will be very difficult for you to put it down.




Sisterhood is Survival in Women Talking, **One of the Year's Most Powerful Films**

It's been a minute since we've seen a memorable arthouse output from Orion Pictures, the production company behind box office classics like The Terminator (1984), RoboCop (1987), and The Silence of the Lambs (1991). Their re-introduction to the art-centric, indie crowd hits a high note with writer/director Sarah Polley's powerful feminist drama, Women Talking. Based on Miriam Toews' 2018 novel of the same name, Women Talking is an unapologetic statement of radical awakening and action, where feminine needs are the focus and sisterhood is an act of self-preservation.

At first glance, it looks as though we've been transported to a remote compound in the early 1900s. Kids running around outside free from screens, conservatively dressed women unloading goods from horse-drawn buggies, and pencils and paper taking the place of

computers. But this is not a time-period piece. This is what an isolated religious community looks like in 2010, as close to Amish as one can get without directly saying so. The audience is dropped into the middle of heightened tension as soon as the film begins - clearly, there are disturbing issues that must be dealt with. A group of women from the community's most prominent families are appointed to sort out the impending dilemma.

The men of the community, who have been mysteriously absent from the compound since the beginning of the film, are accused of sexually violent acts towards the women and children. Outraged and disgusted by their predatory and vile behavior, there is no disagreement from the women the men need to stop. Where it becomes a point of contention is how – or

come back to their interpretation of the Bible, which some take literally while others interpret it more vaguely. Everyone is sensitive to the religious element but that doesn't stop the women from candidly voicing their opinions, no matter how divisive. Acting as the group's secretary is the affable school teacher (and sole male) August Epp (Ben Whishaw), who writes down the points and arguments made by the passionate and illiterate women. Shot almost entirely in the hayloft where these conversations take place, the tension builds like a pressure cooker until a decision is finally reached.

Women Talking derives its strength and staying power not just from the eloquently-voiced script, but also from its phenomenal ensemble cast. Rooney Mara, Claire Foy, Jessie Buckley, Frances McDormand, Judith Ivey, Sheila Mc-Carthy, Michelle McLeod, Kate Hallett, Liv McNeil, August Winter, and Ben Whishaw give some of the year's best performances. Like a delicately woven web, the characters' lives intertwine amongst heartache, elation, and love. Despite their differing views, they continue their heated conversations for the greater good and immediate future of the women of their community (a gentle reminder that earnest communication can de-escalate many problems).

Resilience is the backbone of Sarah Polley's script adaptation, beautifully realized on the big screen. The film lacks saturation, giving off cool blues and greys, perhaps in an attempt to show how devoid of color and joy this moment is in all of their lives. The trauma these women are dealing with is both felt and seen. Behind the scenes is another strong female force in composer Hildur Guðnadóttir. Her layered, transcendent score builds throughout the entire film until it culminates in a glorious final sweeping shot that will evoke goosebumps.

Explosive, euphoric, and powerful, Women Talking is a passionate piece of filmmaking from all sides. It broaches difficult subject matter with empathy and compassion and encourages audiences to do the same.



Screening for Colorectal Cancer Can Save Your Life - Making **Sense of Your Options**

Recent news reports have caused confusion about recommendations for colorectal cancer screening. "Media reports inaccurately implied colonoscopies are ineffective at reducing colorectal cancer deaths," said Dr. Paul Limburg, Chief Medical Officer of Exact Sciences, the maker of Cologuard®. "Those headlines glossed over the finding that colorectal cancer mortality risk was estimated to be cut in half for people who completed their screening colonoscopy." Colorectal cancer is the second leading cause of cancer death in the U.S., but it doesn't have to be. It's also the most preventable. When caught in early stages, colorectal cancer is more treatable in 90% of patients. Despite these encouraging statistics, only seven in 10 adults aged 50 to 75 are up to date with colorectal cancer screening.

For parents and college and graduate students (both prospective and current), the idea of completing the Free Application for Federal Student Aid (FAFSA®) might seem daunting.

The FAFSA application must be submitted every year a student hopes to receive any form of financial aid, including federal student loans, grants and Work-Study jobs. Many states, schools and scholarship programs also require FAFSA information for their award decisions. One of the common misconceptions out there is, "I don't qualify because my family earns too much." Don't let this deter you from considering your financing options - apply regardless of how much your family earns, as there is no income cut-off for federal student aid.

The online application is available on the Office of Federal Student Aid's (FSA) website. In the past couple years, the FAFSA

taxes, so no need to wait until your 2022 taxes are complete; you can use your 2021 taxes to complete the FAFSA for the 2023-2024 school year.

For the upcoming academic year, you can submit the form now. Generally, the federal deadline is June 30 for the current application cycle. However, states and schools may have earlier deadlines for awarding state-specific grants. To find out the deadline for your state, check the official FAFSA website and reach out to your financial aid office for schoolspecific deadlines.

And if you're curious about how FAFSA applications are doing in your state, be sure to check out this #FormYourFuture FAFSA Tracker, an interactive dashboard that tracks and ranks states' progress toward 100% of their high school seniors completing the FAFSA application.

to take time off work." She screened with Cologuard, an at-home screening test, and much to her surprise, received a positive result. That positive result led to a colonoscopy and a diagnosis of cancer. The good news was that Snow's cancer was discovered before it spread to her lymph nodes and was effectively treated with surgery.

The U.S. Preventive Services Task Force (USPSTF) has endorsed several methods for screening for colon cancer and it's important to work with your clinician to choose the one that's right for you. The USPSTF is an independent, volunteer task force that makes recommendations about preventive services based on clinical evidence. Recommended USPSTF tests include certain non-invasive stool-based tests (including tests like Cologuard), and direct visualization screenings like colonoscopy.

"If you're 45 or older, it's crucial that you get screened," said Dr. Melinda Cail, a family medicine specialist. "When performed with See Seniors, page 6

A recent study presented at the American Society of Clinical Oncology meeting showed that blood-based tests result in detecting fewer colorectal cancer cases compared to stoolbased tests due to differences in sensitivity and lower detection of pre-cancerous tumors.9 Colonoscopies and stool-based DNA tests remain the standard of care.

"In coming years, more evidence will be developed to appropriately determine the clinical impact that blood-based approaches to screening for colorectal and other cancers might have," said Dr. Limburg. "Until then patients and their doctors need to focus on the many available options that are within the guidelines." •




