# **Council Agrees to Replace Marquee Outside Civic Center**

The Torrance City Council approved an agreement to purchase and install a digital sign at the city's Civic Center. The approval also included the appropriation of funds in the amount of \$50,000 from the Cable TV Fund Balance.

For several years the discussion of replacing the marquee outside of the city's Civic Center on the corner of Torrance Boulevard and Madrona Avenue has been discussed. With the new digital sign, it is expected that the city would significantly enhance the ability of the city to disseminate information is delivered from the marquee. "I would like to state that the replacement of the existing outdoor marquee has been a longtime coming. I am very, very enthusiastic," Councilmember Kurt Weideman said during the Dec. 23 council meeting. "I'm looking forward to this digital sign that will increase the effectiveness of information delivery and the promotion of events here in the city of Torrance." The current sign used by the city to promote events and activities requires the routine removal and placement of letters on the stationary, two-sided display that is backlit. Furthermore, the current marquee requires that two city employees climb ladders in order to change the message. This newly approved digital sign, which will be located in front of the Victor E. Benstead Plunge, "will include a two-sided full-color LED, capable LED, capable of

showing video clips, animation and graphics as well as up to six lines of text" stated the staff report.

Furthermore, the new sign will match the dimensions of the current marquee and will have a protective cover with anti-graffiti coating. In order to update the new sign, city staff will use a "secured web-based interface" through the city's network. The Office of Cable and Community Relations will be responsible for managing the content on the marquee and will serve as the clearinghouse for the display. In addition to all of the departments in the city would having the ability to submit content, the Torrance Events Calendar is also going to be used as a source of content for information. The staff report indicated that there will be no additional operational costs associated with operating of the marquee since the new sign is part of a replacement project. In addition to the electronic digital sign, the city has six additional directional signs, none of which are electronic, throughout the Civic Center grounds. Upon the finalization of the digital sign, city staff will be directed to explore the process of updating the six signs on the Civic Center grounds. The updates will be reflective of the new sign and include similar art and the color scheme to match the grounds. The six signs in question were installed more than 15 years ago and are constantly "refreshed for paint and lettering," as well as an "update of

current names or functions of the buildings" said the staff report.

City Approves Lease Agreement of Public Parks with Local Little Leagues

A five-year lease agreement, recommended by the Parks and Recreation, was approved by the city council during the Dec. 23 council meeting. The approval of the lease agreement came one week after the same item was returned to staff in an effort to clarify issues relating to the maintenance of the fields, a traffic and parking plan and the requirement for each league to pay for a portion of the water used for each league's activities. The new lease agreements are with Torrance American Baseball, Torrance Little League, Riviera Little League, and West Torrance Little League and are for their use of properties owned by the City of Torrance beginning Jan. 1, 2015-Dec. 31, 2019 and will require no additional funding by the City, rather the agreements will revenue \$1 per year, per lease agreement. Each lease specifies the actions to be taken by the respective little league that has entered an agreement with the city in order to ensure the safety of its players and spectators. In addition, each lease specifies that the league in the agreement is responsible "to the greatest extent possible" for minimizing the impact of on street parking for participants and spectators. This can include providing adult supervision to direct traffic during events, a policy indicating speed limits and other rules respecting the neighboring communities. •

# A Look Back at 2014 in Sports

A new year is upon us in High School athletics. While many athletes have come and gone from the local schools that we hold dear to our hearts, the end of the year is a perfect opportunity to look back and reflect on what those athletes and their teams have done in the world of sports. From basketball, to soccer to baseball and back it was a successful year in High School sports around Torrance. Let's take a look at the teams that stood out the most.

Way back at this time one year ago, the North High Saxons were starting their basketball season in a rather successful fashion. Wins over St. Bernard and Gardena to start the year eventually led to three straight wins over Torrance High, two over South High a second place finish in the Pioneer League standings and a trip to playoffs. Behind leading scorers Koh Flippen, Mo Nwodili and Chad Ashimine, the Saxons took our Grand Terrace in the first round of the playoffs, but eventually lost to El Dorado. While North was semi-dominant in basketball, South, Torrance and West High had year's to forget. The Warriors lost their last 12 games of the season while South struggled to a last place Pioneer League finish. While the Tartars made the playoffs with a fourth place finish in the standings, Kyle Polk, Abdullah Nazarkhan and company couldn't get over the hump with a first round loss to Savanna. The season is still young this year, but the usual suspects are back at it again, this time with Torrance and South leading the way early on in the year.

Last year in girls' basketball, the Torrance teams dominated the Pioneer League standings. The Lady Saxons lost only one league game all season to their rivals from South High but managed to make it into the playoffs and into the semifinals where they were faces with a rivalry matchup against the West High Warriors. The Warriors ended the Saxons season this time around and behind Bailey Kurahashi's 17 points advanced to the final where they beat El Dorado by 13 points to become Bay League and CIF Southern Section Division 2A champions. The Warriors dominated the Bay League and their opponents' all season long, losing only five games on the year. Jasmine Jones is the player to watch on this team as she will look to help the Warriors towards success again this year. The Lady Tartars were able to make it to the second round of the playoffs, eventually losing against El Dorado while the Lady Spartans took South High to the quarterfinals where they narrowly missed out on a chance at the semi's, losing to Patriot 48-45.

In boys soccer, it was the South High Spartans who led the way for city of Torrance rounding their season off with wins against North High and Torrance. North High struggled through the season to a 2-16-1 record while Torrance and West High were the only two clubs to make the playoffs. Torrance lost in the first round vs. Santa Paula while West advanced to the second round, beating Jordan 1-0 but losing to Loyola 0-3. The girls showed the boys how to do things in the game of soccer last season. The Lady Tartars won their last nine games of the season before making a playoff run to the quarterfinals while West High advanced all the way to the semifinals before suffering a heartbreaking loss to Hart. South High did both team's one better. The Lady Spartans caught fire winning their last four games of the year and taking their momentum into the playoffs where they just couldn't lose. A win against Serrano brought home the Southern Section Division IV CIF championship for the ladies of South High, a task they will be looking to complete once again this year, already out to an outstanding 6-2-1 record.

In baseball, it was the year of the Torrance Tartars and Kyle Smith. Smith led his team to a 9-1 league record and wins over St. Bonaventure, La Sierra, San Dimas, Laguna Beach and finally South High in the championship to capture his team the Southern Section **See High School Sports, page 6**



# **TerriAnn in Torrance** Unbroken: A Celebration and Review



There was a break in the beating rain as a huge rainbow gleamed above Torrance as I walked toward the AMC Theatre in Del Amo for a special screening of the film Unbroken on Tuesday, December 16. The story of our hometown hero, Louis Zamperini, is the subject of the film, directed by Angelina Jolie, sparked by the bestselling book *Unbroken*, written by Laura Hillenbrand.

Excitement filled the lobby as Janet Payne and Debbie Hays from the Torrance Historical Society organized the logistics of this special evening. Unbroken Producer Matt Baer and Louis Zamperini's children, Luke and Cinthia, were on hand to both introduce the film and then take questions and answers afterwards. I caught up with both Luke and Cinthia prior to the screening and asked them how it felt to finally have their father's story told on the big screen.

"It feels wonderful. It is 57 years in the making and we didn't want to miss the screening in the ol' town of Torrance here. We felt we should be here. We can't wait to see the reaction of everybody when they see it on the big screen finally," said Luke Zamperini. "This was a long time coming and the book Unbroken paved the way for the film to be done. With Matt hanging on to the project and then Angie coming along and having a vision of how to bring it to the screen, I think it is just - everything happens at the right time when it comes to my father's life and this is just the perfect time for it. The film is wonderful. I've seen it five times. I love it," added Luke. He went on to tell me, "It is just beautifully shot by Roger Deakins and the soundtrack by Alexandre Desplat is just mesmerizing."

Cinthia told me, "[I] just can't believe it's really happening even after all this time. It's been underway for the last two years and it is just a dream to us. The people at Universal – they have all told us, head of publicity, Michael Moses told me, 'something like this movie comes along once in a career for us and this is our one time'. [I am] excited, heartbroken,



elated, grateful, and sad Louis is not here. I feel his essence with me, I feel he is with me still and I have to believe he is aware of all this."

After speaking with Luke and Cinthia I was able to speak with Unbroken Producer Matt

Baer who shared with me, "Last night was the premiere in Hollywood where Lou spent a lot of time in his life. But in the 17 years

that I knew him and got to know every tale of his life, the power of Torrance, the belief that Torrance had in Lou was without a doubt the most important foundation that he had. This is the most satisfying, professional moment in my life. It is a very powerful, emotional feeling for me and it certainly would not be happening if not for Laura Hillenbrand's remarkable book, Unbroken, where she was able to tell Louis' story in such an accessible, powerful, and creatively fulfilling way - and then from a producer's point of view - you have to have the right director. So Angelia coming into the project as the captain - she brought so much of her heart and her personal spirit, her own interest in the world, so it was a very powerful combination of Donna Langley, Chairman of Universal Pictures, who also believed in the project - who bought the book - is also a big fan of Angelina's as a director. So I am very satisfied that three women of force came together to finally push Lou's story over the hill so it is very satisfying. So much of being a film producer is out of your control. All that you can control is your own passion and your own belief for what you think can make a good film. The struggle has always been the same thing, how much of the story can you include? Finally we have a director with a vision of what to include and what not to include, the studio is in alignment with that and the producer is to balance what he/she thinks is right. In the years before Laura's book I tried to sell it as a miniseries, and they said no. It could be a four-hour movie, but it wasn't an option."

Walking into the theatre I noticed several familiar Torrance faces. Former Mayor Frank Scotto was a volunteer usher in Theatre 10 where I was sitting. Behind me sat Karl and Geralyn Standifer. Karl told me, "We are here with my parents, Jim and Jo Standifer and my dad – he, Pete and Louis – were friends with my dad." Jim Standifer added, "I was Louis best friend all my life. I have known him forever. I sure miss him and sure wish he could have lived long enough to see this film. We were together all the time or on the phone."

Sitting nearby, former mayor Ken Miller told me, "He [Louis Zamperini] was the greatest guy in the world. I wouldn't miss this for the world. I lived almost 9 years next door to them, so I was a 9th grader when he was a senior. I was a punk kid and knew the family very well. It was during prohibition and everybody shared everything. I had spaghetti dinner [at his house] – Mrs. Zamperini was a good cook!"

Vickie Vega remembered, "Louis Zamperini had a home in Lake of the Woods in Frazier Park four houses down from my brother and sister in law. He had an adorable little cabin. One of his neighbors was in elementary school and she did a report on him and he came to the school, Frazier Park Elementary and spoke to the class about his life."

Unbroken was introduced by Torrance Mayor Pat Furey, acknowledging the Torrance Historical Society, AMC Theatres, and city staff for helping with the screening. Then Luke and Cinthia Zamperini, and producer, Matt Baer spoke briefly, followed by Debbie Hays, from the Torrance Historical Society who reminded guests the screening was a fundraiser with proceeds going to maintain The Torrance

Historical Society Trust Collection of Louis Zamperini. Also, the t-shirts and wrist bands given out at the screening are still available for purchase and the proceeds will go to Louis' Victory Boys Camp. Louis' grandson, Clay Zamperini, just quit his job and will be carrying on the Victory Boys Camp for Louis. "Louis loved his hometown of Torrance so much. He did see the film in 20 minute increments with Angelina on his bed in the hospital. Thank you for coming," said Cinthia. "Universal bought the rights in 1957 and things happen at the right time for the right reasons and I believe God is in control of everything and this film could not be made until Matt Baer and Angelina Jolie took the film on. It's my new favorite movie," said Luke. "I have waited many, many years to say these 2 words...hello Torrance... We made the film in Australia but you'll see that we were able to recreate what Torrance was like with a high degree of accuracy... The experiences that Lou went through in his life are really incredible and we did everything that we could to tell Lou's story the way he wanted told which is the truth, its highs, its lows, but most importantly, its inspiration... Angelina has done a magnificent job - everybody in the cast is terrific but most importantly, your hometown hero is aptly represented. Thank you for coming and enjoy the film," said producer Matt Baer.

The lights dimmed and I sat back in my seat and watched the story of Louis Zamperini begin. Laura Hillenbrand's book, Unbroken was swimming in my head as the story began to unfold on the screen. Realizing the entirety of the incredible life of Louis Zamperini could never be told in 137 minutes on film, I watched as each frame, captured nuggets of this inspiring man's journey on earth while I filled in the gaps in my mind. I wanted to see more, but maybe that was because the book gave me insights into the nuances of this American hero's story that could never be included in a film due to time constraints. English actor, Jack O'Connell is seamless in his role as the adult Louis showing the prankish, delinquent kid turned Olympic athlete, then bombardier. 47 days on a raft in the middle of the ocean is nothing short of a miracle. But being rescued by the Japanese, and then becoming a prisoner of war under the psychopath commander, brilliantly and disturbingly played by Takamasa Ishihara is a tale you have to pinch yourself to remember is true. It is a lot to take in. Powerful, moving, and inspirational are the words to describe this film. Sometimes difficult to watch? Yes, but incredibly more difficult to live through. Louis' faith is woven through the film and the story of his inner strength shines. Although the film didn't show the dramatic conversion after the war Louis experienced at a Billy Graham Revival meeting in Los Angeles, his faith, tenacity, and then forgiveness come through in the film, nonetheless. His "If I can take it, I can make it" spirit fills the screen. War is hell. I am not the first to say it but too few know the 'forgiveness' story of men who, through faith, find the ultimate courage to forgive their enemies. Such was Louis Zamperini. This film meets the magnitude of the true story and portrays it accurately. Unbroken is the story of a man who proved his faith was unbroken.

After the film, I walked out to a clear sky. The rain had passed. Some say rain is good luck and I believe that. From the promise that is a rainbow - that I saw on my way to the film, to the scene where gentle rain falls on Louis' head as he fights to survive with starvation and salt sores plaguing his body and with swollen, sunburned lips he promises God to serve Him if he is saved, to the ending of the premiere with a clear sky – the lucky rain blessed Torrance to have Louis Zamperini as our hometown hero.

# New AB 60 Law Allows Undocumented Drivers to Apply for Licenses

In 2013, Governor Brown signed AB 60 into law, and it goes into effect on January 1, 2015. This statute directed the Department of Motor Vehicles (DMV) "to issue an original driver's license to any California resident who is eligible for a driver's license, regardless of immigration status," according to the DriveCA coalition at DriveCA. org. Further, "An AB 60 license will have a visible distinguishing feature and cannot be used for certain federal purposes, such as to enter restricted areas of federal facilities." The DMV has issued a list of answers to questions a new applicant might have. For appointments or other information regarding AB60 visit ab60.dmv.ca.gov.

Q: When is a person eligible to apply for a

driver license under the new AB 60 law?

A: Undocumented applicants can begin applying for a California driver license on January 2, 2015. During the initial visit, applicants will be required to prove their identity and residency, and take a driver knowledge and vision exams. A behind-the-wheel test will be given at another time.


Q: Do AB60 customers need to make appointments to apply for a driver license?

A: Anyone planning on visiting a DMV field office to apply for a first time driver license is required to schedule an appointment. However, the DMV has set up four temporary Driver License Processing Centers in Granada Hills, San Jose, Stanton, and Lompoc, where anyone can drop in without making an appointment. Q: Does the driver license being issued under the AB 60 law have any limitations?

A: Yes. A driver license, under AB60, only allows an individual to legally drive a car and cannot be used to verify or provide legal or documented status. The face of the driver license clearly states that "Federal Limits Apply" and on the back disclaimer reads "This card is not acceptable for official federal purposes. It does not establish eligibility for employment, voter registration, or public benefits." In other words, a person cannot use this driver license to board an airplane or enter a federal building. However, it is important to point out that police officers in California cannot discriminate based on immigration status or the fact the driver holds an AB60 driver license. Q: I plan to apply for a California driver license under the AB60 program. As an applicant without legal presence, will my information be used for anything other than a driver license application?

A: We are sensitive to the fact that many applicants without legal presence may be fearful of this review process and/or possessing this new driver license. Discrimination against an individual based on possession of an AB60 driver license is a violation of law, including the Unruh Civil Rights Act (Section 51 of the Civil Code). An AB 60 driver license shall not be used to consider an individual's citizenship or immigration status as a basis for an investigation, arrest, citation or detention. •

# Preparation

Preheat the oven to 400 F. Heat the oil in a large oven-safe skillet over medium-high heat. Season the chicken with salt and pepper and add it to the skillet with the shallots. Cook for 10 minutes, stirring and turning the chicken occasionally, until it and the shallots are nicely browned.

Add the grapes, vinegar, honey, and garlic and bring them to a boil; cook and stir for five minutes more. Place the skillet in the oven and roast for 10 minutes, or until chicken is cooked through. Sprinkle the top with rosemary. Serves four.






