



# AAUW Torrance Kicks Off Year Focusing On Women In Government

## By Cristian Vasquez Councilwoman Speaks at General Meeting

Councilwoman Heidi Ann Ashcraft kicked off the American Association of University Women of Torrance's 2016 programs with an address where she shared her experience as an active community member and an elected official.

The AAUW's general meeting took place Saturday, Jan. 9 in a meeting room at Zamperini Field and highlighted the AAUW Campus Leadership Program and "Elect Her," which is described as the only program across the country that encourages and trains college women to run for student government and future political office. With AAUW members and League of Women Voters representatives in the audience, Ashcraft shared a few historical facts about former first lady Eleanor Roosevelt before diving into what it entails to be a leader. "I think that each organization is a very important organization because they are very active in the City of Torrance. One of the ideas was to give information to them in order to support young women in the universities, their leadership skills and teach them what they can do to formulate their lives to be leaders in their communities," Councilwoman Ashcraft said. "Whether it be elected officials, heading a corporation, or whatever it might be, I feel that this is very important and this group of ladies is involved with that pursuit."

fill a vacancy left by former Councilman Cliff Numark and by June of 2014 she was elected to her council seat. However, her experience with as an elected official dates back to her days as an active parent at West High School, which led to the first elected position she would hold: Torrance Unified School District Board Member.

"One thing that you will find about Torrance is that the PTA group here is very strong so you have a groundswell of women who might not want to go into an elected position but that are being leaders in other ways," Councilwoman Ashcraft said. # **Torrance Unified Shares CAASPP Results**

In August of 2010 the California State Board of Education adopted its new K-12 California Common Core Standards for school districts across the state. For the Torrance Unified School District, like all other districts across the state, those new testing standards have taken effect.

"It is a little bit different than it has been in the past years because of the change in the testing system," TUSD Chief Academic Officer Dr. Tim Stowe said. "We no longer give the CST (California Standards Test) because we now give the Smarter Balance Assessment Test, better known as CAASPP (California Assessment of Student Performance and Progress."

Designed to provide a more detailed and

accurate description of student achievement, the new testing assessments are aligned with the states new content standards for English Language Arts/Literacy (ELA) and math which are tailored to measure critical thinking and problem solving skills rather than recording memorization abilities. Another difference in state's new testing is that achievements on the CAASPP are reported along different standards, including: Standard Exceeded, Standard Met, Standard Nearly Met or Standard Not Met. Second, achievement on more specific topics [referred to as claims] within the subject area test is reported as being either Above Standard, At or Near Standard, or Below Standard. well ahead of the county and the state and we expect to be, even with us having such a diverse population," Dr. Stowe said. "We always compare our numbers to the local South Bay populations and we did very well. I think it's good to share that information and the fact that this is the first year we did it [test], we now have something to compare with next year."

In every of the grade levels tested, TUSD students were either at Standard Met or Standard Exceeded at higher rates than the state average. Overall, in the English Language Arts/ Literacy test, 63 percent of TUSD third through eighth graders, and 11th grade students, met or exceeded the test standards; in comparison to 37 percent of the same students falling in the Standard Nearly Met or Standard Not Met. Of that group, only 14 percent of the students registered at Standard Not Met.

Math results for those same students determined that 55 percent of test takers registered in Standard Met or Standard Exceeded. In the Standard Nearly Met there is a total of 26 percent of TUSD third through eighth graders and 11th grade students. Only 19 percent of students tested were part of the Standard Not Met category.

Academic priority areas used as part of the Local Control Accountability Plan [LCAP] include: analyzing areas of implementation of state standards, course access, pupil achievement and other pupil outcomes, and embedded in all of this are the performances on the standardized exams. There is no academic performance index for CAASPP, as was provided by the CST,

"The CST was about memorizing facts and vocabulary but we want teachers to do things that will address critical thinking and get students to read more non-fiction, or maybe read literature that will allow them to make connections to real-world situations," Dr. Stowe said. "We want kids to critically analyze the text and not just read a chapter and look for fact-based answers; we want them to maybe look at things more holistically and think about why a character acted a certain way and if there is maybe an example they see in history that they can connect it to."

Despite the new state-imposed testing standards, state officials are imposing few requirements as to how school districts assist students who fall below the established standards. Unlike the days of No Child Left Behind, the state is now allowing district administrators the flexibility and responsibility to bring students who do not meet or exceed testing expectations up to par. District officials were open with teachers about discovering what students respond to in the classroom and what doesn't in preparation for this new testing system.

"Our focus is still on teacher and administrator training," Dr. Stowe said. "We are less concerned about the numbers right now as opposed to getting teachers to change their instruction so that they are not doing things that were being done ten years ago."

With CAASSP, which only tests for English language arts/literacy and math among third through eighth graders, and 11th grade students, test are administered on a computer that gives the student a follow-up question based on their previous answer. This is a significant departure from the multiple-choice, paper-based test used for the STAR testing, which had been the norm since 1998. Aware of the changes to come, district officials were as proactive as possible to prepare students. The district also took steps to inform parents about the changes that have taken effect.

"Our schools and principals did a really good job at communicating the change and making sure that parents understood why there was no testing [for a few years]," Dr. Stowe said. "It has been an educational process for the parents and for the past couple of years all the schools have been doing common core parent nights. We just want to emphasize that when we look at certain numbers and how students are doing, we really can't compare it to the old exams." •

# Earbuds Plugged into Driving Law for 2016

Listen up if you're a driver who likes to wear earbuds to talk on the phone or listen to your music downloads while you're behind the wheel. A new law for 2016 says you have to have one ear free, or you're going to be ticketed.

California Vehicle Code Section 27400 already existed before Jan. 1 of this year. It needed some clarification that the popular earbuds worn in both ears pose a traffic danger for drivers of motorized and nonmotorized vehicles alike, according to Officer Siara Lund with the California Highway Patrol's division office in Glendale.

Drivers of four-wheeled vehicles aren't the only ones affected by the 2016 headset-earbud traffic law. Bicyclists are under the same restrictions and will be cited the same as drivers and motorcyclists, Lund told me.

"The way that we can tell obviously is if both earbuds and headsets are in, the officer will pull that driver over," said Lund, adding that the headset law for 2016 isn't new. It just added language to the existing law that wearing two earbuds while operating a car, motorcycle or bike is illegal.

The Southern California Automobile Club explained on its web site that the change in law was done to "ensure drivers and bicyclists can hear sirens, horns, and other safety alerts while driving." There are exceptions for drivers of heavy machinery and garbage trucks who require noise-cancelling headsets for protection. Drivers of emergency vehicles, such as a fire engines or ambulances, are exempt. Wearing hearing aids while driving is permitted, the law says.

The CHP and local law enforcement have the discretion to begin enforcing the headset and earbud restriction immediately. In the past when new traffic laws, such as handsfree cell phone use, became law, the CHP and police departments issued warnings to drivers who were caught talking or texting on their cell phones.

Will that be the case if an officer spots a driver or cyclist bee bopping down the road without a free ear? No, said Lund, because the ban on headsets and earplugs has been law in California for a decade.

No doubt, many California drivers were surprised to hear that one of the new traffic laws for 2016 involved earbuds. They probably presumed, like I did, that the tiny in-ear listening devices for cell phones and iPods were outlawed a long time ago.

Enforcement of the new "old" traffic law means this for drivers who insist on wearing their headphones or earbuds in both ears or covering them:

The next sound they hear could be the whoop of a police siren, which isn't music to any driver's ears.

Pleading ignorance of the new laws may not result in a warning instead of a ticket. So, here are other traffic laws for 2016 that California drivers and vehicle owners are expected to know, courtesy of the Automobile Club of Southern California and the California Highway Patrol:

Slow vehicles on the highway - Bicycles are added to the law about slow-moving passenger vehicles on the highway. All vehicles, including cyclists, should pull over safely to let faster traffic pass on a highway. Any slow-moving vehicle that is holding up five or more vehicles must use the next available turnout or available area to let traffic pass.

Electric bicycles - An electric bicycle with a maximum speed of 28 miles per hour can only be operated by a person 16 years or older, and a helmet must be worn. The new law also creates safety restrictions for See Earbuds, page 10

# **Social Services Agency Grant Program Approved**

In a unanimous yes vote, the Torrance Mayor and members of the City Council approved the 2016 Grant Funding for Non-Profit Services Agencies. The recommendation by the Parks and Recreation Commission and Community Services Director John Jones was to approve funding for six non-profit social services agencies in the amount of \$20,000 form Feb. 11 to Dec. 31, 2016.

"When this item came before us last year I asked staff to work with the commission and try to improve any processes if pos"We have a whole list of eligibility requirements that are included in this year's grant program, some of them are from years past," Jason Minter from the Community Services Department said. "Just to mention a few of them: they must be Torrance-based or provide services to Torrance residents, we do vet [vetting] all applicants to make sure the have a current 501(C)3 license and we will also verify them through the California Revenue Tax Code."

The most recent application period, which opened Sept. 16, 2015 and closed Oct. 6, 2015,

sible on the vetting of the organizations to which we are giving money," Councilman Tim Goodrich said. "Just trying to avoid a situation where we are handing this money out by default and make sure that there is a competitive process. I'm sure you guys will come up with a plan in order to publicize it."

The six non-profit social services agencies approved include: Cancer Support Community, \$5,000; South Bay Children's Health Center Association, \$2,500; Healthcare & Elder Law Programs [H.E.L.P.], \$5,000; South Bay Literacy Council, Inc., \$2,500; Switzer Learning Center, \$2,500 and Torrance-Lomita Meals on Wheels, \$2,500.

On Sept. 1, 2015 the council gave approval to 2015-2016 Non-Profit Social Services Grant Program, as recommended by the Parks and Recreation Commission and the Grants Committee. The program included changes that revised the application process, modified grant criteria, pre-determined funding levels and a transparent scoring system for the grant review process. netted nine applications that were accepted as complete for a total request of \$32,500. By Oct. 14, 2015 the Grants Committee began reviewing the rating process and other criteria.

"We want to make sure that the projects or the programs that we are funding are ongoing and not just for operating costs or administrative; that it is actual programs that help people directly," Minter said. "We also want to make sure that it's happening during the fiscal year. One of the other areas that we added was that we will be doing a six month check up just to see how the funding is being spent instead of waiting until the end of the fiscal year."

The nine applicants were categorized as either a health services or human services organization. Of all the applicants, Casa de los Angelitos, Family Promise of South Bay and Project NEEDS were not awarded grant money.

"We definitely had fewer applicants this year than in years past; I believe we were See City Council, page 10



a suspenseful and intriguing character study of a charming yet overbearing philanthropist who meddles in the lives of a newly married couple in an attempt to relive his past.

The film opens with Franny (Richard Gere) discussing design plans for a children's hospital project on which he is collaborating with his married college friends Mia and Bobby (Cheryl Hines, Dylan Baker). Unfortunately, Franny's horsing around while driving (with his previously mentioned friends) leads to a fatal car accident.

Five years later, we see Franny sitting alone in a lavish hotel surrounded by bottles of medication and sporting a cane along with an appearance resembling an elderly Howard Hughes. Out of the blue, he receives a call from his late best friends' daughter, Olivia (Dakota Fanning), whom he lovingly calls "Poodles". She is pregnant and newly married learn that all of the expensive gestures come with a price. Franny shows little regard for personal boundaries; the red flags surrounding his shifting intentions begin to alarm Luke.

It becomes more and more clear that Franny is addicted to morphine, which he uses to medicate not only his pain but also his guilty conscience. We watch his descent from charming philanthropist to an erratic and desperate addict.

The film creates an uncomfortable level of tension for the viewer. Along with the rising suspense, The Benefactor almost takes on the direction of a psychological thriller before pulling back in the last scenes- perhaps in an attempt to appeal to a wider audience.

# **Up and Adam** Torrance Continues Hot Play, Topples West

You know the boys High School basketball season is getting good when you see matchups like Torrance High versus West High on the schedule. If the two teams aren't by chance meeting in a tournament, you know they're meeting because league play has at last begun. When league play starts, that means only one thing - rivalries. The Tartars and the Warriors have nothing short of a rivalry, sharing the same city and competing in the same league. Whenever the two teams meet, like they did last Friday night in the Pioneer League opener at West High, records go out the window. Unfortunately for the Warriors, so too did their chance of winning the game. The Tartars put on a clinic in the third quarter and behind Justin Hino's eight points in the period, caught fire and eventually ran away with a 52-42 victory to open up league play with a bang.

The first half of the game between the two rivals belonged to West High, in large part thanks to Noah Carroll. Carroll has been steady for the Warriors all season long and in this one, scored eight of his 15 total points in the first quarter to pace West. The Warriors wound up taking a 26-17 lead into halftime and were feeling quite good about things. When Carroll came out to start the third quarter by sinking a three-pointer to give West their biggest lead of the night at 29-17, head coach Neal Perlmutter and his home crowd started believing it might just be their night. That's when the Tartars stepped up their play.

A 12-0 run by the Tartars that took the third quarter clock to below 3:00 got the team right back in the game. "Our sense of urgency and the intensity on the defensive end really ramped up," Torrance head coach Paul Nitake explained. "It led to some fast breaks and some good easy buckets." Not only did the Tartars finally begin to put some points up on the board, but they also clamped down on defense. Aside from Carroll's

three points to start the third quarter, the Warriors managed only four more in the period as they were eventually outscored 17-7. Before the fourth quarter began, the Tartars found themselves leading for the first time at 34-33. Giovonni Jackson took over from there and led his team to victory. "I knew I had to get going and I had to get in my groove," Jackson said. He certainly got his groove back and proved it with a two handed jam that blew the Warriors right out of the gym and gave his team every last ounce of momentum. "I took all my anger out on the dunk and started scoring more after," Jackson continued. With 12 of his game-high 16 points scored in the fourth quarter, the Tartars came raging back from an early deficit and ultimately came away with a 10 point, 52-42 victory.

"We didn't execute well in the second half," Perlmutter said of his team. It wasn't so much West not executing as much as it was Torrance finally performing in the second half. The Tartars outscored the Warriors 35-16 in the final two quarters of play. Torrance (11-7, 1-0), already leading the way in the Pioneer League standings, will go on to face off against a struggling South High team this week. West (6-11, 0-1), on the other hand, will be looking for their first league victory as they welcome Leuzinger (8-6) to their home gym.

## North High vs. South High

On the other side of the city, there was yet another rivalry game going on as the North High Saxons took to the busses and traveled South to take on the Spartans in another Pioneer League opener. A 10 point win wouldn't seem like a small margin of victory at first glance, but while the Saxons (9-8, 1-0) are enjoying one of the more successful years out of the majority of the teams in the Pioneer League, the Spartans are detesting their rather horrid 2-13 start. # **TerriAnn in Torrance** The Aerospace Players

For nearly three decades, The Aerospace Players have presented a summer musical, and every other year, they produce a winter show as well. Last week, I dropped in on a 'set building party' at the James Armstrong Theatre, where dedicated members of The Aerospace Players were spending their Sunday morning donating their time, their painting skills, and their building and designing acumen, preparing the stage sets for the musical, *Annie Get Your Gun*.

I caught up with Jason Stout, the musical director for the show, who also happens to be orchestrating the set supervision for the day. He proudly told me, "We're going to rent one 'drop', and the rest we are going to build ourselves." (Anita Moisen, Booking Manager for the James Armstrong Theatre told me, "A 'drop' is heavy canvas because it has to absorb paint and is probably 30 feet tall and 48 feet wide [for the Armstrong]. They have scenes painted on them.") In his sixth production, Jason told me the Aerospace Players function entirely by volunteers. The director for Annie Get Your Gun is Angie Asch, who had the vision for Annie Get Your Gun and has been the catalyst for this major production. Co-producing the show are Lisa Stout (Jason's wife) and Susan Tabak. I found out that it was Lisa who encouraged her husband to begin auditioning for singing parts. It all began five years ago when Jason encouraged Lisa to try out for a show. "The first time he told me about it I thought it was the silliest

thing ever – engineers doing theatre didn't seem logical to me, however I was excited to get out and try something new." Married 13 years Lisa and Jason love participating in the productions together. Last summer's musical, *The Music Man*, featured Jason as Harold Hill, Lisa as Mrs. Paroo, and their son, as Winthrop Paroo. Truly a family affair! Chuck Gustafson has been involved with the group since 1988. to do it and most of the people in the group, like Jason and myself, have other jobs, so it is strictly on your free time," said Chuck.

Inside the scene shop Susane Button was busy painting sets and told me, "I have been in lots of shows. I've done hair, make-up, and was met with a pleasant surprise. Angela Asch, who is directing and choreographing *Annie Get Your Gun* told me, "We haven't done a western in this group since...I think Oklahoma! which was 2000, and it has songs that people know that they don't know they

costumes, and also been in a lot of different parts. I do everything." Also painting was Mark Eggert who told me he found out about the group from a friend and this is his first show. Catherine Webb moved to the South Bay last February, saw the Aerospace Players production last year, and decided to volunteer. "I have a minor degree in Theatre, and this is my first production. I like doing backstage stuff so I am helping Ida with props," said Catherine. Ida Miller-Krause has been in charge of props since Oklahoma! in 1992. "I love what I do. It's fun. I used to be on stage once in awhile and as long as I am in the ensemble, then it is okay. I rather do props," said Ida.

Just how did The Aerospace Players begin? "It started out as a small group organized through the Aerospace Corporation. They initially started with small productions. I think they started off in the cafeteria. Then they moved into a small theatre and they have gradually grown into the Armstrong Theatre, which is really great. It is a really wonderful theatre," said Jason. Since its inception, the Aerospace productions have grown, as well as the number of participants. Auditions are open to everyone and their last show, The Music Man, listed a cast of fifty. For decades this group, largely of engineers, rises to the challenge of a Broadway musical. You heard me right. This is a group of cleaver engineers who open themselves up to the challenge of theatre.

Inside the Scene Shop located at the back of the theatre, The next day, I checked in on this band of know. There is a familiarity and is kind of one of those classics that doesn't have to be updated 'cuz it's great as is." Angela has been involved with The Aerospace Players since she was for the shows. That is what makes the shows so special. "I really enjoy doing musicals. I play with a number of orchestras in the area and I freelance. I am an engineer and do the music semi-professionally," said Debbie. The Aerospace Players moved into the James Armstrong Theatre in 1994 with Guys and Dolls. "We have had full orchestras and it is a real treat in this day and age of either synthesized music or tracks, or reduced orchestras - to be able to field a full orchestra. We will have a full orchestra for Annie Get Your Gun. There will be close to thirty people in the pit," added Debbie. Now I am very impressed. Usually, one has to head downtown to see a play with a full orchestra, and pay a huge ticket price. I also found out Debbie met her husband through participating in The Aerospace Players.

Veteran performer, Kevin Wheaton, who plays Buffalo Bill in this show, has been part of the company for 15 years. Kevin said, "We had our kids in *Oliver!* and I brought them to all the rehearsals and since I am an Aerospace employee, I escorted them in, and we were rehearsing on Aerospace grounds back then... and they said, "Why aren't you in this with the kids?"" Kevin joined the group and hasn't looked back.

Playing Frank Butler in *Annie Get Your Gun* is Stephen Cathers, who has been involved with The Aerospace Players since 2008. "I actually work at the Aerospace Corporation and it is sponsored by the corporation as an employee club. After I minored in Musical Theatre at

about ten years old because her father, Taylor Thompson, and step-mother, Tina Tucker started the group back in 1988 when Angela was a child. Taylor worked for the city of Torrance, and Tina worked for Aerospace. Angela shared with me, "They decided – wouldn't it be great to have this forum where engineers could do something artistic - and their first play was a sort of Broadway review in the courtyard and USC, I happen to find the only Aerospace engineering themed theatre club that I know about so...I love the community and people are so welcoming...and we are the only group that has more cast parties than performances – we have fun," said Frank with a smile.

My visit with some of the participants of The Aerospace Players was enlightening. This group is different than any other group I have

then they decided to do a full-on play. They did *Grease* in the TRW cafeteria and it has grown from there...it is very much a family, literally and figuratively for a lot of people."

First timer, Julie Hinton, is playing the lead in *Annie Get Your Gun*. She used to babysit Jason and Lisa Stout's children while they participated in the shows and now she is a member of the group. "I am an actor and knew them both years ago, Lisa and I have done shows and Jason and I have sung together... it is so much fun. I am a singer and actor. What really impresses me the most is – these are engineers. This is not their training or their background and they are so committed and this is a production of the heart and they love it." Julie feels that the 'heart' the engineers put into each show make the difference – that and the full orchestra.

Since Bye, Bye, Birdie in 1993, performed at the El Camino Recital Hall, Debbie Minnichelli has participated as the percussionist for the shows, the resident rehearsal pianist, and has been in charge of coordinating the orchestra See TerriAnn, page 10

# **MVP** Chili

# Ingredients

- 2 packages of Hot Italian Sausage Links (use mild links for less spicy chili)
- 1 large onion
- 3 cloves garlic, minced
- 2 tablespoons chili powder (use mild chili powder for less spicy chili)
- 1/4 teaspoon cumin
- 1 bottle (12 ounces) dark beer
- (OK to substitute light beer or 1 cup beef stock)
- 1 can (28 ounces) crushed tomatoes
- 2 tablespoons tomato paste
- 1 can (15.5 ounces) red kidney beans
- 1 can (15.5 ounces) black beans
- 1-1.5 cups corn (frozen or fresh off the cob)
- salt and pepper

# Preparation

- 1. De-case sausage and saute in large pot; use wooden spoon to crumble sausage as it cooks.
- **2.** Once sausage is nicely browned, stir in onion, garlic, chili powder and cumin and continue cooking until onion softens, about 5 minutes.
- **3.** Add beer and allow it to simmer for an additional 5 minutes scraping up any brown bits from the bottom of the pan.
- **4.** Stir in tomatoes and tomato paste and allow it to simmer, uncovered for an additional 10-15 minutes on medium-low, stirring occasionally.
- 5. Taste and adjust seasonings with salt and pepper.
- 6. Finally, stir in beans and corn.
- 7. Let this come to a simmer and it's ready to serve! (Can be prepared a day ahead.)


