Summer Reading Program Donation Accepted, Appropriated by Council

The Mayor and City Council accepted and appropriated a \$27,478.97 donation made to the Summer Reading Program, along with a \$5,325.25 donation made for the DVD/Blu-Ray resurfacing machine from the Friends of the Torrance Library.

Funded by the Friends of the Torrance Library, the Summer Reading Program continues its efforts to serve children and teenagers by preventing the "summer slide," which is when students' reading skills dip due to their time away from school during summer break. The Friends of the Torrance Library, a group volunteers, is dedicated to making the city's libraries the best possible for the community. Through the organizing of used books sales, this non-profit gathers funds to assist the library in obtaining materials not attainable to the library's regular budget.

"The Friends of the Torrance Library Continue to generously support Library programs and activities, and have voted to fund the Summer Reading Program for 2016, and the purchase of a machine that will resurface DVDs and Blu-ray discs," states the staff report signed by Community Services Director John Jones. "This very popular seven-week program includes programs at all six libraries, incentives for tracking reading progress, and the chance to engage with Librarians over books, reading, and learning activities."

In addition to the reading activities, the donation funds will be used to purchase all of the incentive prices that readers will earn, as well as a paperback book for every child and teen that completes their reading goals.

Funds will also be dedicated to the funding performers, craft supplies and other activities at the library, which are designed to encourage regular use of the library.

The donation made for the DVD and Bluray discs resurfacing machine will allow staff to resurface and extend the shelf life of both entertainment formats.

"The Friends also purchased the initial DVD/CD resurfacing machine, and having this machine in-house has saved thousands of dollars worth of materials from scratches and wear, enabling these popular items to circulate longer and survive heavy public library use," states the staff report. "From thematic t-shirts for staff and all teen volunteers for this program, to decorations and promotional banners, the Friends of the Torrance Library continue to be a major sponsor of this vital library service."

Council Approves Agreement with Honeywell International for Groundwater Monitoring Wells

A license agreement with Honeywell International, Inc. of Torrance was approved by the city council for two ground water monitoring wells for the former Honeywell facility on Early Avenue.

"The Los Angeles Water Quality Control Board (LARWQCB] has directed Honeywell International, Inc., as former owner of the property located at 23215 Early Avenue, to install two (2) monitoring wells," states the staff report signed by Community Development Director Jeffery W. Gibson. "The purpose of the wells is to monitor for possible hydrocarbon migration contamination, which may have migrated from the site."

LARWQCB indicated that there is the potential for plume migration to the north of the site that is to be monitored. As a result, Honeywell International, Inc. requested the installation of the ground water monitoring wells to be located in the public right-of-way. The wells are scheduled to be installed in Kashiwa Street, in the parking lane, and are expected to have a minimum impact or disruption to any traffic.

"The agreement exempts the city from any financial or legal encumbrances associated with the construction, operation, or relocation of actions required as a result of test data obtained from said wells," states the staff report. "The term of this agreements ten (10) years, subject to renewal at the discretion of the City. At the end of the term of this agreement, the proposed wells will be either abandoned in place or removed in accordance with approved standards."

Currently city staff is obtaining information necessary to create a database that will allow for the monitoring of the wells in order to track location, reporting requirements, status and the number of wells that exist within city boundaries.

"The drilling, installation and development of the proposed wells will take approximately four (4) days. The monitoring wells will be two (2) inches in diameter and approximately 90 feet deep," states the staff report. "A traffic vault well lid will be set flush with ground surface and contain a locking watertight cap. A construction and excavation permit will be required by the Community Development Department to regulate work in the public street. •

What Happened to **Customer Service?**

You'd think that American companies would have learned by now that poor customer service is killing business. Surveyed buyers say that customer support is as important to them as the price and quality of the product or service. A frustrated customer isn't going to keep quiet.

People will talk when they feel they've been poorly treated by a business, says the head of a consumer-service trade group. One bad experience is multiplied every time it's retold.

"The reality is that our negative customer service experiences are far more memorable than our positive ones and we typically embellish those negative events to anyone that will listen," said Bill Crutcher, president of the National Customer Service Association.

Consumers lately have been telling anyone who'll listen that dealing with customer-service agents is frustrating and time-consuming. If the customer is always right, they wonder why customer-service agents seem to go on the defensive rather than try to resolve the issue.

The Harvard Business Review found that 84 percent of people expected more from their last customer-service experience than what they received. Hearing negative words like "can't" or "won't" or "don't" add to customer dissatisfaction scores, the Review reported.

Another 82 percent of customers have stopped doing business with a company because of poor service, a Zendesk survey found. Two-thirds of people said they'll switch companies because of poor customer service. That survey by Accenture also found that 82% said their service provider could have done something to keep them from switching.

Stephen Burnett, a business professor at Northwestern University, has noticed a "painful" decline in customer service. "I do not even bother to call an airline if there are weather problems in the U.S," he said. Getting a person on the phone is nearly impossible, he explained.

"First of all, companies, by and large, like to have as few employees as they can. People are expensive, emotional and you have to supervise them," he said.

Companies have over automated customer service, and in his opinion made a miscalculation about dealing with people. They aren't robots. There is a fundamental difference.

"A robot deals with things completely uniform. When dealing with a customer, he is anything is but uniform," Burnett said.

Today's automated customer service phone systems are a one-size-fits-all design, the Northwestern professor said. Not everyone shares the same level of sophistication and enthusiasm for using technology to report a complaint and have it resolved quickly.

"That's the problem with these automated systems. They're forcing everybody to use the same system regardless of their sophistication.

And, they over-automate to the extent that you can't talk to a person."

American Express surveyed customers and learned that 46 percent prefer to talk to customer service by phone about complicated issues. In a separate survey by NewVoice, 75 percent reported that calling is the most effective way to get a quick response to their concerns.

Automation is one direction that companies have taken to reduce their employee costs. Another is outsourcing customer-service duties so that complaints are handled by a non-employee.

"Instead of talking to an employee of Macy's, you may be talking to a person who handles who-knows-what. All they're going to know is what they reading off a computer screen," Burnett said. "They know what the script says, but no authority to do much about what you're calling about."

A former customer-service employee for a home-security company confirmed in an interview on "20/20" that he lacked authority from their bosses to help resolve customer

"You're just entry-level position," Jacob Curtis told "20/20." At the home-security company where he worked, "you just do what you're told."

Customer service suffers, too, when companies outsource the responsibility for resolving customer issues to other countries, the Northwestern professor believes.

"You're talking over a tremendous distance to the Philippines, for example. What language you speak is not their first language. You spend a lot of time on the phone, and once you get them, they have no authority and you can't understand them anyway," he explained.

The frustration isn't just with call centers. Finding a store employee when you need assistance is becoming as difficult as talking to a person by phone. Price scanners have replaced employees in retail stores, where shoppers more and more are being asked to forgo customer service.

As much as \$41 billion per year is lost by companies because of poor customer service, according to one estimate. Surveys have found customers will switch stores or brands because employees are rude or unhelpful, or because they don't know as much as the customer does.

Amazon top the list of best companies for customer service in surveys. Subscription television and Internet service providers receive the worst customer-service ratings among 43 industries from the American Customer Satisfaction Index. Time Warner was the least popular cable provider, followed by Comcast and MediaComm, which serves smaller markets in the Midwest and South.

Internet service providers rank at the bottom

Manning Manages, Defense Defeats

Yee-haw! The old sheriff hopped on his white bronco and rode it off into the sunset. Right when you doubted him, the 39-year-old quarterback for the Denver Broncos led his team to a 24-10 victory over the Carolina Panthers in last Sunday nights Super Bowl 50. Well, Peyton Manning didn't really lead the team. The defense did, all night long. But you have to believe that his presence under center in what was very likely the last game of his entire career gave everyone on the Broncos that much more motivation to dig deeper, play harder, and sweat-out just one last game. In the end, it worked. Now Manning is a two-time Super Bowl champion and the oldest quarterback to ever start, and then win, an NFL championship.


With 194 yards of total offense, the Broncos tallied the fewest yards ever of any other Super Bowl champion in NFL history. That, alone, will tell you the story of the game. It wasn't Manning, coming out of the locker room guns-a-blazin', slinging the football all around the field like it was a shootout in the Old West. There were even times in the fourth quarter when Denver was desperate for a first down on third-and-long that Manning, instead of throwing the ball, simply took the snap from under center and handed it to his running back, C.J. Anderson, for a modest gain of one or maybe two yards. "We weren't going out there to throw it 50 times and do those types of things," Broncos head coach Gary Kubiak explained. "Peyton knew that. He hung in there and just kept battling for us. He knew what it would take for us to win this championship." Anderson finished the night with 90 yards and a touchdown on 23 carries while Manning threw for 141 yards on just 23 attempts. It wasn't either of those players that won a game that featured exactly zero passing touchdowns. It was the Denver defense that won the championship.

I'll spare you the cliché that defense wins championships - although I immediately just went back on my promise. Von Miller totaled six tackles on the night to go along with 2.5 sacks and two forced fumbles. He was the MVP and caused havoc almost every single time the ball was snapped. "It wasn't about me," Miller said. "I just wanted to play at a level that would influence my team to play to the best of their abilities." They certainly did. The entire Broncos defensive front had Cam Newton on his back all night, leading to one of the worst (if not the worst) games that Carolina and this year's MVP have played all season long. "We were able to get pressure on the quarterback and make the team one dimensional," defensive end Spencer Ware said. Ware was a major catalyst in that effort, but so were players like Derek Wolfe, Brandon Marshall, Danny Trevathan, Malik Jackson and many more who combined to form what might go down as one of the best defenses in the history of football. If not, they certainly played the part when they needed to the most against what was the NFL's highest scoring offense this season.

10 points. That's all that the Denver defense allowed a team that averaged 31.3 points in the regular season and 40 during the playoffs. The Panthers all but annihilated the Seattle Seahawks Divisional Round and then danced all over Carson Palmer and the Arizona Cardinals in the Championship Round to make it to the Super Bowl. Denver was a different beast, though. The Broncos completely took away the run game of Carolina (who's leading rusher was Newton with 45 yards), forced them into 12 penalties on the night, four turnovers, and one missed field goal. "We picked a really bad day to have a meltdown," Panthers tight end Greg Olson relented. "Right when we started to get something going, something bad would happen." Maybe the biggest reason for that was because Cam looked flat. Mainly because he was being steamrolled by Broncos defenders all night. The typical flashy smile and cool, calm demeanor was literally non-existent from the start of the game and the only dancing being done was by Broncos defenders as they returned fumbles into the end zone for touchdowns. He was nervous. The Broncos had been to the Super Bowl before. Almost everyone on the team had. The Panthers, on the other hand, had no clue what they were getting themselves into. In the end, it was Manning managing the game and the Denver defense winning it.

With the win, Peyton became the first starting quarterback to win a Super Bowl with two different teams. The defense tied a Super Bowl record with seven sacks on the night and while Newton only threw 15 incompletions during the team's first two games of the postseason, he threw 20 in one game against Denver. He had only been hit three times in the first two rounds of the playoffs against Seattle and Arizona. He was hit 10 times against Denver. In three postseason games for the Broncos, they went against Cam, Tom Brady and Ben Roethlisberger, who threw a combined 92 regular season touchdowns. The trio combined for just one touchdown pass against Denver. In addition to the players, don't forget to give defensive coordinator and former head coach, Wade Phillips, all of the credit in the world. •

Torrance Tanking at the Wrong Time

Right when it looked like the Torrance High boys basketball team had the Pioneer League locked up, they hit what has appeared to be a string of late season bad luck. Only two games remain in regular season, yet for the first time in league play all year, the Tartars have experienced a losing streak to take their record down to 6-2 in league play. The two straight losses gives the team their first losses of the year within their own league, all in the same week.

The Tartars bad luck began last Wednesday night when they welcomed the Leuzinger Olympians into their home gym. Leuzinger, attempting to make a late playoff push and climb up in the Pioneer League standings themselves, certainly came to play. "The key was our defensive pressure," Leuzinger coach Arturo Jones explained. "Our defensive pressure on their guards was a lot better than the last time we played them." That last time that Jones spoke of saw Torrance go on the road to beat the Olympians by a final score of 56-45 in what seemed like a relatively simple matchup. This time around, it was anything but. Damani Washington put up 19 points to lead the way for Leuzinger and teammate Davion Crowder put up 11 as the Olympians held the Tartars off down the stretch for a 55-54 victory that gave Leuzinger their fourth win in a row.

Just two days later, the Tartars went on the road to visit North High with the intent of

turning their fortunes around. A victory would have clinched the Pioneer League title for the Tartars, but cross-town rival North High and their starting power forward, Isaiah Holmes, had much different plans in mind. The Saxons held a 12 point lead in the first half of play before going into the break clinging to a 34-27 advantage. The Tartars weren't done yet. A 14-0 run in the third quarter brought Torrance all the way back and actually gave the team a 47-43 lead. North's defense kicked into gear shortly thereafter, however, holding coach Paul Nitake's club to just five fourth quarter points. "We like playing our big guy, but North is so fast-paced," Nitake explained. Ultimately, it was that fast-paced tempo that ruled the day for the Saxons. "We have to be fast," Holmes said. "That's how we play our game." Holmes finished his game with 12 points, 12 rebounds, two blocks, and four steals to lead the way on the night for North. Meanwhile, Giovanni Jackson once again starred for the Tartars with 17 points. Justin Hino added 13.

The logjam in the Pioneer League standings has now gotten just a bit tighter with only two games remaining in the regular season. Centennial, North, and Leuzinger are now only one game back of Torrance High (16-9, 6-2) going into the last week of play. Fortunately for Torrance, they close out the season with a game against West High, but Centennial, who is right on their heels, will

<u>Film Review</u>

Wacky, Wonderful Hail, Caesar! is the Coen **Brothers' Valentine to Classic Hollywood**

Around the halfway mark of the Coen Brothers' newest film, Hail, Caesar!, an audience member was heard voicing his thought that, this was the weirdest movie he had ever seen-and this reviewer wouldn't say his evaluation was all that far off.

Yet it's exactly this sort of "weird-ness" that defines any Coen Brothers' movie, where colorful but mentally clouded characters are typically confronted with cosmically coincidental events, leading to a type of larger, dead-pan comedy, that's dripping in drop-dead seriousness that forces them to question the meaning of life

the Dixie-whistling cowboy turned bumbling big screen star Hobie Doyle (Alden Ehrenreich), twice-divorced movie star DeeAnna Moran (Scarlett Johansson), twin sister newspaper journalists Thora and Thessaly Thacker (Tilda Swinton), and tap-dancing Gene Kelly inspired Burt Gurney (Channing Tatum), who all amount to being an embarrassment of riches in Coen-land.

The Hollywood send-up may be much more divisive than the directors' other films, and likely because its packaged as a mainstream movie with the likes of George Clooney and Channing Tatum cartooning around as old-timey

and their place in the universe.

The universe at large in Hail, Caesar! is the 1950s backlot of the fictional Capitol Pictures, an MGM-like Hollywood studio whose theatrical world offers such wonderfully wacky tangents as bumbling cowboy movie stars lassoing with their spaghetti, as well as looming scares of Communism and learning of the first Hydrogen bombs.


At the center of this world, the ringleader of the Circus, is Eddie Mannix (Josh Brolin), a Hollywood fixer whose job it is to keep the studio's stars in line, but whose own personal certainties are less assured. As if trying to quit a light smoking habit wasn't the biggest hiccup in his day (the film covers a twenty seven hour day), Mannix learns of the kidnapping and ransom demand of the studio's biggest star, Baird Whitlock (George Clooney), during the shooting of his lead role in the grandly epic big-picture event, titled, 'Hail, Caesar!'

Mannix proceeds to bop around from one looney tuned character to the next, including Hollywood move stars. But the Coens' only take the shell of old Hollywood and collapse the facade, exploring stories of kidnapping and hijinks, as well as much larger, universal themes of exploration and questioning, such as Politics, Religion, and other head-scratching questions akin to, What Does It All Mean? This search for meaning in a world so ridiculous, that it allows its audience to see the coded philosophic themes and lessons that its harebrained characters can't, makes this another winning outing for the Coen's.

The Coen's continue to eschew conventions of narrative structure, allowing their incredible style to drive the film here. Audiences expecting a more classic kidnap comedy will most likely be disappointed by the odd tangential storylines, but should know that the minds of this machine are operating on a top-tier level of intelligence that makes a minute long scene, of Hobie Doyle fumbling the phonetics of a sophisticated line like, "Would that it were so simple," give resonance to the entirety of the story-if only life were so simple. •



Ceres: Celebrating 215 Years of Planetary Discovery

New Year's Day, 1801, the dawn of the 19th century, was a historic moment for astronomy, and for a space mission called Dawn more than 200 years later. That night, Giuseppe Piazzi pointed his telescope at the sky and observed a distant object that we now know as dwarf planet Ceres.

Today, NASA's Dawn mission allows us to see Ceres in exquisite detail. From the images Dawn has taken over the past year, we know Ceres is a heavily cratered body with diverse features on its surface that include a tall, cone-shaped mountain and more than 130 reflective patches of material that is likely salt. But on that fateful evening in 1801, Piazzi wasn't sure what he was seeing when he noticed a small, faint light through his telescope.

"When Piazzi discovered Ceres, exploring it was beyond imagination. More than two centuries later, NASA dispatched a machine on a cosmic journey of more than 3 billion miles to reach the distant, mysterious world he glimpsed," said Marc Rayman, mission director and chief engineer for Dawn at NASA's Jet Propulsion Laboratory, Pasadena, California.

Piazzi was the director of the Palermo Observatory in Sicily, Italy, which has collected documents and instruments from the astronomer's time, and published a booklet on the discovery of Ceres. According to the observatory, Piazzi had been working on a catalog of star positions on January 1, 1801,



when he noticed something whose "light was a little faint and colored as Jupiter." He looked for it again on subsequent nights and saw that its position changed slightly.

What was this object? Piazzi wrote to fellow astronomers Johann Elert Bode and Barnaba Oriani to tell them he had discovered a comet.

"I have presented this star as a comet, but owing to its lack of nebulosity, and to its motion

being so slow and rather uniform, I feel in the heart that it could be something better than a comet, perhaps. However, I should be very careful in passing this conjecture to the public," Piazzi wrote to Oriani.

By July 1801, Piazzi had calculating the object's orbit and made public his observations, announcing it as a planet, and naming it "Ceres"—after the Roman goddess of agriculture, was also the patron deity of Sicily, where Piazzi then lived and worked.

The news was especially interesting to Bode because he had championed the Titius-Bode hypothesis: that the positions of planets in our solar system follow a specific pattern, which predicts each planet's distance from the Sun. The pattern demanded that there be a planet, yet undiscovered, between Mars and Jupiter—and this is exactly where Ceres orbited.

In March 1802, Heinrich Wilhelm Matthias Olbers discovered a second, similar object: Pallas. William Herschel, discoverer of Uranus, then wrote an essay proposing that both Ceres and Pallas represented an entirely new class of objects, which he named "asteroids."

The door had opened for many more asteroids to be observed. The discoveries of Juno in 1804 and Vesta in 1807 reinforced Herschel's notion that asteroids are a class of their own. Today, we know there are hundreds of thousands of asteroids in the main asteroid belt between Mars and Jupiter.

Now, as we commemorate the 215th anniversary of Ceres' discovery, Dawn is observing the dwarf planet from its lowest orbit ever: 240 miles from the surface. The many craters and other features that Piazzi could not see with his telescope are being named after agricultural deities or festivals, extending the theme that Piazzi began with the name "Ceres." •





Tips for Going Green, Saving Green, with **Greywater Recycling**

(BPT) - Water conservation isn't just for Californians and others who live in dry climates. Although the Golden State's water woes grabbed headlines last summer, it's not the only state potentially facing water shortages. Nor is it the only one where conservationminded homeowners are turning to greywater recycling to reduce water bills and preserve the environment.

Greywater - also called gray water - is all the water that goes down the drain from bathroom sinks, showers, tubs and washing machines. While you wouldn't want to drink it because it contains traces of dirt, hair and household cleaning products, greywater is safe to use for outdoor irrigation. By rerouting greywater outdoors, you can keep your lawn green and your vegetables growing without increasing your water bill.

"We're seeing increasing demand for products that facilitate greywater recycling," says Chris Peterson with Saniflo. The company specializes in above-floor plumbing, including greywater pumping systems and macerating toilet systems for residential and light-commercial applications. "Homeowners are realizing that recycling greywater is an effective way to lower their water bills, meet outdoor water needs and do something good for the environment."

What's more, municipalities and counties in California are blazing trails by rewarding homeowners and businesses that recycle greywater. Many are offering rebates for property owners who use greywater systems to irrigate their landscapes.

While California's drought conditions have been prolonged and extreme, the state is not alone in being concerned about water consumption. A 2014 study by the U.S. Government Accountability Office found 40 out of 50 state water managers expect shortages in at least part of their states within the next 10 years. States have begun taking a number of steps to improve how they manage water, the GAO said, including enacting conservation measures and creating drought preparedness plans.

"Homeowners who begin recycling greywater now could be well ahead of the curve if and when their states begin requiring water conservation measures," Peterson says. "Meanwhile, they'll decrease their water and sewer costs by irrigating with recycled water, rather than fresh.'

Greywater recycling systems can be installed in homes under construction or existing homes undergoing renovation. In fact, says Peterson, many Saniflo customers who add greywater systems to their homes do so as part of a kitchen or bathroom renovation. "The compact size of our Saniswift pump makes it easy to tuck away inside a cabinet for a kitchen or bathroom sink, a clothes or dishwasher, shower, laundry or bar sink. Like all Saniflo products, you don't have to open the floor or break concrete to plumb the Saniswift, so it can go virtually anywhere."

If you're interested in greywater recycling



for your home, Peterson offers some basic information:

- Although some areas may allow you to recycle water from kitchen sinks, greywater is typically considered the water that comes from showers, bathroom sinks, dishwashers and clothes washers. Water from toilets is not greywater.
- Experts estimate about 40 to 50 percent of the waste water generated by the typical American home qualifies as greywater and could be recycled.
- Not all greywater is the same. The water from bathtubs, showers and bathroom sinks is relatively cleaner than the water from kitchen sinks, clothes washers and dishwashers, which may contain food scraps and cleaning products. It's important to choose a greywater filter and pump system that's made to handle the type

of greywater produced by the utility you're connecting it to.

· In addition to lowering your water and sewer bill when you install a greywater recycling system, you may be eligible for a rebate. Check with your local water utility to see if it offers a rebate in your area.
