# **Torrance Chamber Keeps Businesses and Leaders Informed, in Touch with Issues**

Del Amo Fashion Center. American Honda Motor Corporation, Inc. Torrance Bakery and Sandwich Shop. Palos Verdes Bowl. Van Lingen Towing. Frank Scotto Towing. Sunrider International. Dal-Tile Distribution Inc. Dandoy Glass Company. Du Bunne Salon. Rainforest Flora Inc. Southwood Pre-School. Fox Drug of Torrance. Bobit Business Media Inc. Sushi Boy. Antique Attic. West End Tennis and Racquet Club, Inc. Ideal Upholstery Company. Ganahl Lumber. Torrance Airport.

These are just a few notable landmarks and businesses that demonstrate the diversity found in the Torrance's 21 square miles. Add in the city's six libraries, two medical centers, art museum, parks and recreation facilities, one-and-a-half miles of beach, and a population of approximately 146,860 residents that grow to some 250,000 people during the day when shoppers and workers descend on the city and it's easy to see what a wide swath the Torrance Chamber of Commerce needs to embrace as it works to support the local business community. Enter Donna Duperron, the Chamber president and CEO since 2010 who leads an organization that has grown since its inception in 1913 to count some 751 businesses among its members. "The multitude of different businesses who are a part of the Torrance Chamber makes the organization very unique," Duperron said. "From small business to large business, the Chamber partners with the individuals within these businesses to create a chamber that continually remains relevant." And what is relevant today in 2018? For starters, the city is preparing to hold an election on June 5. Seats up for grab include the position of mayor, three city council slots, city treasurer, and city clerk. And since the actions city government may take impact businesses in town, the Torrance Chamber strives to inform and play a role in those decisions. Chamber leadership meets

bi-monthly with the mayor, mayor pro tem, the economic development director and city manager. In addition, the Chamber and the City of Torrance work closely on a number of events and activities to enhance the partnership between the two, said Duperron.

Leading up to the June election, the Chamber will host a forum to give candidates running for mayor and city council the opportunity to answers questions from members of the business community. Prior to that forum, the Chamber's Government Affairs Program (GAP), led by Rob Van Lingen, will create a list of business-related questions. Topics may include minimum wage, health care, affordable housing and workforce readiness -- subjects that impact businesses and their employees.

The Chamber also keeps an eye on state government and issues and legislation that could impact businesses in the city. On Feb. 22, Congresswoman Maxine Waters and Congressman Ted Lieu will address Chamber members during the annual State of the Region luncheon. Attendees will hear the congressional representatives' views on infrastructure, housing, health care, immigration and other topics that affect business.

"Advocacy is so important," said Duperron. "The Chamber's leadership is actively involved with BizFed, the Cal Chamber and South Bay Association of Chamber of Commerce. The Chamber will testify in support or opposition to business issues -- specifically those brought to us by our members. The Government Affairs Policy (GAP) program meets monthly to analyze local, regional and statewide issues."

GAP examines a diversity of subjects, including the local housing market and affordable housing. At the January GAP meeting, held at the Chamber office, David Kissinger of the South Bay Board of Realtors was welcomed by GAP co-chair Van Lingen and presented facts and figures about the

**Presidents' Day in Torrance: A Time for Celebrating, Reflecting and Honoring**

Monday, Feb. 19 we will celebrate Presidents' Day. As we all learned in grade school, we are a republic under three branches of government, which include the Executive Branch -- the President of the United States; the Legislative Branch that makes laws and is divided into two parts -- senators and representatives; and the Judicial Branch, which is our Supreme Court. All three branches have equal power and work toward representing the nation, we the people. But it is the president who sets the tone and leads our country. Every year, we honor that leadership with a special day. Now, the only president with his own day is our 16th, Abraham Lincoln.

Abraham Lincoln was born on Feb. 12, 1808 and I found out different states celebrate this federal holiday in a variety of ways. Some cities, including Torrance, celebrate Lincoln's birthday on the Monday (due to the Monday holiday bill) near the 12th in addition to celebrating Presidents' Day on the third Monday in February. # **Drivers Need to Wake Up** and Sleep Better

The Automobile Club has a few words for area drivers about sleep: You're not getting enough.

That recommendation follows the AAA's startling discovery that as many as 10 percent of injury crashes are being caused by drowsy drivers who can't stay awake. A Southern California official with the group says no matter what tricks they try, drivers can't fool their bodies into feeling rested. Drowsiness is as bad as the other D-words -- like drinking alcohol and distraction -- that are associated with injury crashes involving drivers and passengers.

Jake Nelson, the director of Traffic Safety Advocacy and Research for AAA said that "missing just two to three hours of sleep can more than quadruple your risk for a crash, which is the equivalent of driving drunk."

Traffic safety researchers with the AAA looked at dashboard-mounted video of 700 injury crashes and they detected obvious

signs of driver fatigue and sleepiness right before impact. Their observations led the AAA to conclude that drowsiness is hugely underreported as a cause of injury crashes on streets and highways.

"There is not a test that clearly shows when someone is too sleepy," says the UCLA Sleep Disorders Center on its website. In the aftermath of a sleep-associated wreck, the driver who caused it can appear wide awake.

That's because their body is pulsing with adrenaline, the sleep experts at UCLA say. The logical, but often mistaken conclusion by observers and law enforcement officers is that the driver also was alert before the crash.

Seven hours of sleep per night goes a long way in keeping drivers from nodding off at the wheel. The body can't be fooled into feeling refreshed with caffeine, which only masks the fatigue and slower reaction times, according to a Southern Californiabased club official.

# olice Briefs **Paintball Shooters Identified**

and Apprehended On Sunday, Feb. 4 at about 9 p.m., a 65-year-old Torrance resident was assaulted when he was struck by numerous paintballs -- some of which struck and injured his eye. The crime occurred in the area of Hickory Park. Officials later learned that two other victims were assaulted within the same vicinity and time frame resulting in a minor injury.

Within 48 hours, Torrance police investigators identified and apprehended three individuals suspected of the offenses. Detectives spent numerous hours searching for possible surveillance video and following up on investigative leads. Some of the tips were provided by the public. On Feb. 6 at about 3:45 p.m., patrol officers along with investigators located the three suspects and their vehicle in the area of Cabrillo Boulevard and 233nd Street. Their lengthy investigation ultimately led to the recovery of several paintballs as well as the paintball gun. The suspects are Tyler Walters, 20, of Torrance; Lynn Johnson, 20, of Hawthorne; and Gabriella Semana, 18, of Lomita.

The Torrance Police Department thanks the community for all of the tips received. "See Something Say Something." This case is being investigated by the Torrance Police Department's Detective Division under the command of Captain Martin Vukotic, Commander of the Special Operations Bureau.

# **Torrance High Tartars Conquer Warriors, Capture Share of Pioneer League Title**

The Torrance Tartars may not have won the Pioneer League crown outright, but they sure came close. After a thrilling 51-49 victory at home against the West High Warriors last Thursday night, Torrance accomplished what seemed to be impossible at the beginning of this year's regular season. Head coach Paul Nitake and his team began the year in the dumps by losing each of their first six games. Now, with the regular season officially in the books, the Tartars have valiantly fought their way back in the standings to take home a share of this year's Pioneer League title.

Now that the regular season is officially over, the Tartars can look back and say that they dominated every other team from their hometown city of Torrance in divisional play. The Tartars swept South High, West High and North High on their way to an 8-2 record in Pioneer League play with their only two losses of the year coming to the Leuzinger Olympians. "We swept all of the Torrance schools, so our boys are super proud and happy," a jubilant Nitake explained after the game. "At the beginning of the year, we had to deal with some injuries. We took our lumps early. We went 0-6 to start the season -- but since then, we've won 16 of our last 21 games."

It was obvious to see that Nitake's team was at full strength last Thursday night on its home floor against the Warriors. Despite only mustering seven total points in the first quarter of play, the Tartars more than doubled that output in the second quarter to take a slight 22-21 lead at the half. Ken Asai and West High came out of the break on a mission, though. The Warriors took the lead to start the half with a three-point basket by Asai, who had 10 points and led his team in the quarter. The Tartars knew they had their work cut out for them when they trailed 37-32 to begin the fourth.

That's when the Tartars began to feed their big man. "We saw a mismatch, threw it in and tried to see if they would double-team," said Torrance senior guard Kofi Asante. "We took care of our size advantage." That size advantage was due to the length of junior forward Abdul Ahmad. Ahmad had four key buckets in the fourth quarter along with two free throws to put up 10 points for his team. He was the catalyst for other players like Asante and Tyler Morimoto, who came up with a clutch three to get going in the quarter. It was obvious that West had no answer for Torrance's big man, who gave his team a 51-49 lead with a bucket in the final minute of play. The Tartars clung to that twopoint lead in the final seconds of the game to beat the Warriors for the second time this season.

Asai led the Warriors in the loss with a game-high 24 points. His teammates Justin Hight and Nick Snyder each chipped in with nine and eight points respectively in what turned out to be a valiant loss for West High. The Warriors had been on a roll recently, notching victories in each of their last four games before the loss to Torrance. West finished the year in third place in the Pioneer League standings and will likely receive a spot in the Division 3AA playoff bracket.

Torrance will now roll into the playoffs with all possible momentum on their side. Ahmad led the Tartars with 20 points on the night, while Asante racked up 14 in what was Torrance's second straight win and sixth in the last seven games. The Tartars finish the regular season in a first place tie with the Leuzinger Olympians for the Pioneer League crown and will now turn their focus onto doing damage in this year's CIF Division 3A playoffs.

North High vs. South High

The North High Saxons traveled to South High to take on the Spartans in what was an inner-city rivalry game to round out the regular season for the two last place teams in the Pioneer League. North was looking for its first divisional victory of the season and first win in the last 13 games of play. The Spartans had lost four straight coming into the game and most recently notched a win against this very same Saxons team in an overtime battle three weeks ago.

Despite putting up a decent effort, North was outmatched from the start. The Spartans' defense held the Saxons to just six points in the first quarter of play, as South ran out to an 11-point lead to begin the game. The lead grew to 13 at the half, but the Saxons put together a couple of nice quarters in the second half to bring things a bit closer. Even still, the Spartans always seemed to hold the game firmly in hand and eventually ran out the clock to take home a 59-50 victory in the final game of this year's regular season. Neither North High nor South High will make it into this year's CIF playoffs. – Aserrao6@yahoo.com •



a day when we celebrate *all* presidents, past and present. Not everyone likes celebrating all our presidents on one day. However, that is what we do.

What do you do on Presidents' Day? Do you think about our presidents? How many of the 45 presidents can you name? In grade school, I remember my mom helped me learn all the presidents with making up a story, which included all their names. Some remember the names of the presidents with a song. 

Melissa Vega, manager of the Automobile Club of Southern California's Driving School, warned against trusting caffeine, opening the windows or singing to keep from nodding off in traffic. "Your body's need for sleep will eventually override your brain's attempts to stay awake," she said. The AAA had dash cam video to analyze. Law enforcement officers investigating traffic collisions on scene must rely on the drivers involved to explain what led up to a crash. With the video evidence, the AAA's new research estimates that operating a motor vehicle without enough sleep is eight times higher than traffic safety experts believed. The U.S. Centers for Disease Control and Prevention reports that 35 percent of U.S. drivers sleep less than the recommended minimum of seven hours daily. Shockingly, 29 percent of drivers admitted in a separate survey by AAA they had trouble staying awake while driving within the past 30 days. 
The Chamber also offers Leadership Torrance -- a program focused on developing effective leaders from across the South Bay. The program is designed to give emerging


