# Council Reviews Procedures Following ExxonMobil Explosion, Discuss Future

A week after the explosion that shook the Torrance area the area due to an excessive build up of pressure in the refinery's electrostatic precipitator, the city council kicked off their meeting Tuesday night with a presentation by the Torrance Fire Department.

At the meeting were TFD Assistant Fire Chief Martin Serna and Deputy Fire Chief David Dumais, The presentation detailed the response by TFD personnel while working alongside ExxonMoblil fire personnel to control the situation.

In addition to TFD's moment-by-moment breakdown of the morning's emergency situation, members of the city council as well as the community voiced concerns regarding the effectiveness of the city's notification systems.

"When the incident occurred I found out through my daughter, who has a friend that lives a few blocks away from the refinery and whose boyfriend works at the refinery," Councilmember Geoff Rizzo said. "Thank God he was safe. I was a recipient of the notification from Torrance Alerts but my concern is when I saw the caller ID, which was very generic, it just said City of Torrance. Maybe it should be modified to where the caller ID can identify it as Torrance Alerts."

The city's alert notifications weren't the only systems questioned at the council meeting.

"Concerns I heard about the community were that several people received a notification that they no longer had to shelter in place [after the explosion] but they never received the initial call to shelter in place," Councilmember Heidi Ashcraft said. "I got home and found that I had a missed phone message but I clicked it off without listening

the first time because it was a recording: our delivery of that needs to change."

Another concern for the councilwoman was the absence of the sirens sounding when the explosion occurred. Located on the refinery's property are sirens, which can be used for an emergency situation at the refinery as well as at other facilities not related to the local refinery.

"As we recall, a big concern was not hearing the siren when we are testing the siren on the first Wednesday of every month," Councilmember Ashcroft said.

City Manager LeRoy Jackson assured the council that all issues in the communication

systems the aftermath of the explosion are of concern to staff and are being analyzed.

"We are going to be following up on that since there are constraints but we will see what we can do," Jackson said.

While a report by the South Coast Air Quality Management District indicated that the ash material that was scattered on the closest communities to the refinery were not toxic nor contained asbestos, several residents expressed concerns and skepticism about how safe they were after the explosion and the subsequent kicking in of the refinery's flare system.

GO-Biz has partnered with the Torrance Area Chamber of Commerce to host a free workshop for local businesses to learn how to apply for the California Competes Tax Credit, a leading component of Governor Brown's newly established Economic Development Initiative.

The Governor's Economic Development Initiative (GEDI) is a redirection of approximately \$750 million from the state's recently dissolved Enterprise

Zone Program. The reapportioned funds will serve to establish three new business incentives: a statewide sales tax exemption on all manufacturing equipment and research and development equipment purchases for biotech and manufacturing companies, hiring credits for businesses in areas with the highest unemployment rate and poverty, and establishment of the California Competes Investment Incentives. GO-Biz, the organizational brainchild of Governor Brown to serve as the state's primary line of effort for economic development and job creation goals, is charged with implementation of the GEDI and negotiating the California Competes Tax Credit





# Ask DMV: Questions and **Answers for February 2015**

The DMV is now using TouchScreen technology to administer the driver knowledge exam. How is it different from the written version?

Instead of using a paper and pencil to the take the exam, you now simply touch the correct answer on monitor screen. The TouchScreen system guides you through the testing process and gives you immediate feedback if you answer a question incorrectly. It is currently offered in both English and Spanish. Additional languages will be added.

This technology reduces test times, improves field office wait times, minimizes fraud by randomizing test questions and answers, and provides easier maintenance of test questions, currently conducted manually.

Make sure you review the California Driver Handbook. You can find it at www. dmv.ca.gov. Do not forget to make an appointment. Good luck!

#### Do I need to visit a DMV office in order to renew my driver license?

Most drivers are not required to visit a DMV office each time they need to renew their driver license. Most of the time, a driver license can be easily renewed online at www.dmv.ca.gov, by mail, or by calling 1-800-777-0133.

However, the DMV generally mandates individuals with a clean driver record to visit a DMV office once every 15 years in order to provide an updated driver license photograph and a vision test. You should carefully check your DMV notice to find out if you must appear in-person. If you are required to visit a DMV office, you are encouraged to schedule an appointment.

The DMV recently expanded the number of appointment opportunities available. Please be considerate of others. If you do not show up for your appointment, you prevent someone else from being able to use that time slot.

Are you required to make an appointment at the four Driver License Processing Centers to apply for an AB 60 driver license?

Appointments are not required, but strongly recommended, if you plan to visit one of the four Driver License Processing Centers located in Granada Hills, Stanton, San Jose, and Lompoc. These centers only process driver license transactions. They are open Monday through Saturday from 8 a.m. to 5 p.m.

Remember, that if you are applying for an original California driver license and plan to visit one of the other DMV field offices, and not a Driver License Processing Center, appointments are required.

The DMV lists several passports as acceptable documents to be used when applying for a California driver license under the AB60 law. Why is the country of Colombia not on the list?

The DMV continues to work with countries and their consulates not identified on the current registration list. This list is not final. The DMV must go through the regulatory process to add documents to the current list of acceptable documents. Please keep checking our website, ab60.dmv.ca.gov, for updates on additional documents that will be accepted. DMV also offers another option for people from countries whose documents are not accepted. Under that option, applicants can present one of several documents which are available in this country and be interviewed by a DMV employee who will attempt to verify the applicant's identity. California is the first state in the nation to offer a secondary review process for applicants that lack typical identification documents to prove identity. # Turnovers Spell the Night, Season For South

It wasn't a very pretty week in Torrance for boys basketball last week. Three teams made it to this year's CIF Southern Section playoffs and not one of them advanced to the second round. The South High Spartans came into the playoffs on a roll and feeling good. Three straight wins, including two over their rivals from West High and North High, had head coach Leo Klemm's team riding high. That was, unfortunately, before Compton came to South. A mixture of poor defense and inefficient offense had the Spartans reeling from almost the start. Ultimately, the Spartans ended the night with a 75-43 loss last Friday night in their home gym, drawing their season this year to its conclusion.

When you're careless with the basketball it's hard to win a game in the regular season, let alone the playoffs. Unfortunately for South High, that was the story of the night for the team. With 14 turnovers in the first half and a total of 21 on the night, you can probably imagine how it was hard to keep up the pace with a Compton team that never really turned the switch off. The Spartans began the opening minutes of the game keeping pace with Compton, but it wasn't long before their opponents' speed and athleticism forced South into making mistakes. A 16-8 deficit after the first quarter grew into a 41-19 lead for Compton at the half, all but deflating South High and their home fans cheering on from the stands.

"Our game plan was simple," coach Klemm explained. "We wanted to go possession by possession and sustain our offense. We did it for a while and then we weren't real poised." The Spartans didn't have many possessions coming out of halftime as Compton went on a 13-0 run down the stretch and outscored South 21-6 in the period. "If you don't have the ball, you can't score," said Jordan Tang, South's leading scorer on the night with 11 points. "Trying to get the ball back is just hard." The Spartans did a better job of things in the fourth quarter, keeping pace with Compton's up-tempo style of play, but unfortunately by that time it was too little too late. The rout had already begun and gotten too far out of hand as the Spartans fell by a final score of 75-43.

All in all it was a successful season outside of the playoffs for South (15-11, 7-3). The team enjoyed sweeping their season series against both of their rivals from West High and North High and split their series with Torrance. Their second place finish in the Pioneer League standings beat out all of their rivals from around the city.

#### North High

Before the Spartans began their journey in the playoffs, the North High Saxons got started on their own in the Division 3AA brackets. Last Wednesday night, the Saxons (12-14, 5-5) took to the hardwood with hopes of attaining a win as they took on the Buena Park Coyotes (21-7, 6-4) in Buena Park. It would prove to be a tough challenge, as the Coyotes have lost only 11 games all season long. The Saxons stuck in there and gave

their opposition a good challenge, but ultimately Buena Park proved to be too much for North as our team from Torrance went down with a 89-82 loss.

The Saxons started the game off strong and kept pace with Buena Park throughout what proved to a high scoring first quarter. It was in the second that North actually began to pull away from the Coyotes. At halftime, the score was 42-37 in favor of Luke Dupperon and his Saxons and things were looking up for North. While their offense and tempo was on point, if you asked coach Dupperon at the half what the team could improve on, he would tell you defense. That's exactly what came back to bit the Saxons in the third quarter.

Buena Park scored 29 points in what was a pivotal and game-changing third quarter that saw the Coyotes storm back from five down to taking a seven point lead going into the fourth quarter at 66-59 in favor of Buena Park. Just one quarter can change the complexion of an entire game. North learned that the hard way. After a fourth quarter where each team scored 23 points, the Saxons, after leading for the majority of the game, found themselves on the losing side of things. A three-headed monster came alive, specifically in the third quarter for the Coyotes. Cedric Dashiell II came out of the game with 26 points, seven rebounds, 12 assists and 10 steals while his teammate Deonte Beckham had 23 points, 14 rebounds and four blocks. Rocky Watkins also put up 26 points for the Coyotes.

North's season ends on a low note as the team lost their two last games of the regular season before falling to Buena Park in the first round of the playoffs. With a squad full of young talent, however, Dupperon should have his team back at it and competing in no time.

#### **Torrance High**

The Torrance Tartars followed in the footsteps of their rivals from South and North when they took on the Hart Indians in the first round of the Southern Section Division 2A playoffs last Friday night at Hart High School. Hart was the better team on paper coming in to the game and average more points per quarter throughout the season. The Indians lived up to their hype as they put it on the Tartars from the beginning. Devin Kalthoff and Kousha Modanlou tried to keep their team in, each contributing a team-high 10 points to the effort. Needless to say though, it was too little too late for the Tartars as they took a discouraging 23-point (69-46) loss to exit the playoffs in the first round of play.

The Tartars wound up losing four of their last five games of the season, with a sole two-point win against their rivals from West High standing out as a bright spot. Torrance also attained victories over both South and North High this year in key rivalry games. With a fifth place finish in the Pioneer League standings this season, head coach Paul Nitake will have some work to do this offseason to get his Tartars (11-16, 4-6) back to being a premier team in their division. •






# The Reluctant Gardener



As I was putting the food and bucket back into my garage, I felt lucky. You see, had I not decided to spruce up my garden today and feed the plants I would have never known my two buckets were cracked. So my mission for the coming week will include buying two new buckets and another crinkly hose. Yes, I will invest in another crinkly hose because they are lightweight. One never exploded on me like that before, and all in all, it is a good hose.

Now I won't go as far as Claude Monet who said, "My garden is my most beautiful masterpiece," but I will say, for me, my garden is a place where I take a deep breath, drop my shoulders and listen to the water splash in my tiny fountain. There might just be a gardener somewhere in my soul - and I am not as reluctant as I was a few days ago. •

was made a captain and discovered that she had a natural talent for leadership. Sports team captains, of course, are responsible for the morale of the team and are also expected to set examples of fair play and good spirits. While in school, Petit also worked part time for the Agoura Hills parks and rec department. When she graduated, she began attending Northern Arizona University in Flagstaff, AZ. She initially was looking for a job in forestry, but realized that she didn't have the deep scientific interest or the desire to spend time in the deep woods. Her interest leaned toward what she called "learning to implement programs in a community where people get some benefit," a type of program known as municipal management.

Managing parks and recreation sites can be quite a lucrative business. For instance, people whose expertise is in the commercial side of Parks and Rec can end up with jobs at Disney parks or resorts like Sanibel Island in Florida. Petit interned at Sanibel Island, running a program that kept the children busy while parents were off at the spa, but by the end of the internship she realized that the commercial side of the business wasn't her focus either. Her interest was less in amusing day visitors as it was in building lasting programs to improve communities. She returned to Agoura Hills and worked in the Parks and Rec department as a recreation leader and camp director, and then was hired full-time as a community services coordinator.

After six years in Agoura Hills, and after having earned a masters degree in public policy and administration from Cal Lutheran, she applied for a job at El Segundo's parks and rec department and was hired as a recreation superintendent. She supervises a few direct employees, as well as a staff of part-time workers and volunteers. Her office is not on the top floor of a high-rise. It's in the middle of Rec Park, and she can look out the window and watch the fruits of her efforts: baseball players on the fields, babies taking their uncertain steps over the grass, walkers and joggers and bikers and scooter riders of all ages enjoying the paths and playground.

Petit admires the efforts that El Segundo city government has expended to offer so many services to residents. The city has augmented its budget with grants from county sales tax allocations and LA County parks loans, which help fill in fiscal gaps. In the lean years some programs have had to be cut, but the city still invests in as many programs and events as it can. Petit oversees budget concerns, allocates resources to where they're most needed, attends city council meetings and works closely with the city management department to ensure that the department stays within budget but that the parks don't deteriorate from lack of upkeep. It's a matter of "finding the balance between wanting the parks to look good, and wanting them to be used to death." This balance involves constant juggling of each service, its budget and schedules, making sure that residents aren't disappointed or put out by lack of services.

But Petit enjoys the shifting aspects of the job, where every day is different and new challenges constantly present themselves. For instance, the Parks and Rec department is moving forward with an agreement to help fund a pool in Wiseburn school district. That project has been in the works for a long time, and will not be done for a long time more, but Petit looks forward to the day when the Plunge can be open longer to residents, when more swimming lessons can be offered. Other wish-list items for her would be replacing some of the older playground equipment to make it safer, and expanding parks programs to El Segundo Beach, since the city has jurisdiction over the sand area.

Petit is also trying to get the word out about El Segundo TV, which is based at the high school and televises city council meetings as well as producing 20-30 other shows such as "Your City, Your News" and "Business Matters." Found on AT&T on channel 99 and on Time Warner on channels 3 & 22, this local channel also has a Youtube page (ElSegundoTV) and Petit notes that it's a place to go for local programming, information about events happening in the community."

Petit loves being a Beach Cities resident, and enjoys getting out to talk to the people who use our parks system every day. "Sometimes I don't feel like it's a job," she says of the time she gets to spend at holiday events and with volunteers who love El Segundo's parks as much as she does. "It comes down to helping people and building relationships." •

"Flaring, although it is inconvenient and makes a lot of noise and throws stuff in the atmosphere, as far as a safety tool, it is probably good thing to see," Torrance Mayor Pat Furey said. "It does not mean that everything is great because there has probably been an incident when you see the flare but when we see flaring that means that pressure is being released."

Also noted at the meeting was the support that TFD received from surrounding fire departments while all 47 members of the city's fire department rushed to the refinery. Those agencies included Redondo Beach, Manhattan Beach and Hermosa Beach Fire Departments.

The council reassured the community that they will share any information they receive regarding the incident and that so far the city has been transparent with its information. However, Mayor Furey pointed out that things can definitely change as the days go by and more is learned about the explosion, especially causation.

"Clearly the people at ExxonMobil did not want to have an explosion," Mayor Furey said. "They want to have a safe property there because the only way they make money is by processing the crude oil into the products that they sell. I feel very secure that they are doing their best to run a safe ship there." •
