## City Takes Additional Steps to Conserve Water

With the ongoing water drought afflicting the state, Governor Jerry Brown signed an executive order implementing the first-ever state-mandated restrictions water reduction efforts and the City of Torrance is ready to take the steps necessary to do its part to save water.

Given the state's fourth year of a drought and the recent record-low snowfalls during the winter, Gov. Brown is seeking to reduce water use throughout the state by 25 percent.

"What you are going to see is many communities affected differently than us," Senior Analyst for the City of Torrance Public Works Chuck Schaich said. "There are communities that use a lot of water and we are generally one of the more efficient water-using communities."

During Tuesday night's council meeting, Schaich gave a presentation briefly discussing the state's goals as well as the city's current efforts to save water and what additional steps the city could take to contribute to the statewide, water-saving effort. The first ordinance by the city was established in 2014 when the council approved raising its water conservation awareness to Level 1, which is the current status that requires residents to water their lawns no more than three times a week, for no more than 15 minutes at a time and that all leaks be fixed within seven days. At Level 1 it is asked that residents refrain from watering lawns between 9 a.m. and 5 p.m.

These requirements will change if the level to ordinance gets adopted, which seeks a 30

percent water reduction and asks that lawns be watered two days a week, between the hours of 6 to 8 p.m. and only for a period of 10 minutes. The executive order by Gov. Brown directs the State Water Resources Control Board to impose the 25 percent reduction goal on the state's 400 local water supply agencies. The agencies will be responsible for developing restrictions to reduce water use and for monitoring compliance.

"We supply about seventy-five percent [water] for the City of Torrance. The other water company, California Water Service Company, provides the other twenty-five percent and we are reaching out to the community and we are having conversations with residents and we will be working with them fairly closely on them," Schaich said.

There has been a big focus on residential savings but there are also expectations from local businesses to do their part.

"It is different but to the extent that they [businesses] have restrooms, or kitchen facilities or landscaping, there are those similarities and we would certainly encourage them to put in low flow toilets, low flow fixtures," Schaich said. "They have kitchens then they can sign up to some of our programs."

Developing details as to how to preserve water and enforce compliance is in the hands of the water agencies. Currently, the state and city provide several water conservation programs that would also result in financial benefits to homeowners.

For landscaping, there are several programs, including a turf removal program which pays

\$2 per square foot to remove a lawn and put in California Friendly landscaping.

"The reason we offer that program is because California-friendly landscaping takes one quarter to one half the water that a traditional lawn takes, so it is a big saver," Schaich said. "In a single family home in Torrance, to put it into perspective, the average single family residence has the traditional lawn on the outside and just by doing the front lawn, they can cut water use by twenty percent."

The presentation by Schaich is just the first step for the city to develop more water saving techniques, and the issue will be addressed during the upcoming council meetings.

"Right now this is informational and we will be coming back in a week or so," Torrance Mayor Pat Furey said. "It looks like we will be going to a different level with the water in the City of Torrance. I think there are a number of things that people can do aside from the mandated things, as well. There are proactive efforts we can do ourselves such as changing to drought friendly landscape. On the website the city offers rebates to scrape lawns and put in drought tolerant plants."

The City of Torrance is part of a regional network, and is a member agency of the Metropolitan Water District. The Metropolitan Water District is the wholesaler of 55 percent of all the water in Southern California. As part of their program they have established a regional website, [www.bewaterwise.com](http://www.bewaterwise.com) that provides a large amount of information regarding ways to cut water use, both for residents and businesses. •

# Crushing Malaria

Malaria is one of those sicknesses I only hear about in the movies or when a friend travels to an exotic place, like Africa and has to take along malaria pills. I imagine Humphrey Bogart and Katharine Hepburn in John Huston's African Queen worrying about malaria, but that is about it. Webster New College Dictionary defines malaria as "Unwholesome or poisonous air, as from marshy ground, miasma. (From the former notion that it was caused by the bad air of swamps.) An infectious disease, generally intermittent and recurrent, caused by any of various protozoans (genus Plasmodium)

that are parasitic in the red blood corpuscles and are transmitted to humans by the bite of an infected anopheles mosquito: it is characterized by severe chills and fever." After reading the definition, I was glad we don't have malaria in Torrance.

You might ask why this interest in malaria? Well, first of all there are millions of people who die needlessly from this awful disease transmitted by mosquitos. This disease is very preventable. The problem comes with the cost of making the medication. According to the World Health Organization (WHO), around 584,000 people died from malaria in 2013, and 90 percent of the deaths were in Africa.

Right here in Torrance, the seeds of inspira-

tion were inadvertently planted, that in the end, highlighted a discovery to fight this deadly disease. You may remember the Torrance Tribune story "Phenomenal Phenomenex," October 24, 2013, about Phenomenex, the company here in Torrance that is a global leader in the research and manufacture of advanced technologies for the separation sciences. They help keep everything in your refrigerator safe to consume with the filters they produce through (chromatography). How does this tie into finding a less expensive way to produce a malaria medication?

A couple weeks ago, I read about an award launched in 2014 by Phenomenex and *The Analytical Scientist* (a scientific journal), rec-

ognizing breakthroughs in analytical science that has truly changed lives for the better. This award was presented to two men who had found a way to produce cheaper antimalarial medications, thereby making them available to everyone on the planet. This perked my interest and I wanted to find out more so I met with Kari Kelly, Manager, Corporate Marketing, Alex Gharagozlow, Executive Director, Operations, and Fasha Mahjoor, President and CEO of Phenomenex.

As it turns out, it all began with the dynamic President and CEO of Phenomenex, Fasha Mahjoor. In business for thirty-three years Fasha observed all the dry scientific journals


# Film Review

## Kill Me Three Times is a Humorous, Self-Referential Thrill Ride

Kriv Stender's *Kill Me Three Times* is a very interesting take on the classic botched murder storyline. Screenwriter James McFarland infuses this thriller with a sense of self-referential farce, with Simon Pegg's (*Shaun of the Dead*) British wit-fueled performance

could win a beauty contest, but far more impressive and important is that both of them gave powerful and unique performances as displeased and unfaithful romantic partners. In fact, both Palmer's and Bragga's characters are so strong that they help to make clear a distinct choice in a reversal of traditional

as the cherry on top. However – don't be fooled by this casting choice. While Pegg strings a comedic thread through most of his films, *Kill Me Three Times* is an exciting "who's gonna get it next?" type of film, and his comedy serves well as a way of greasing the wheels for this action flick to maintain the audience's focus.

gender roles seen in most action flick shoot-em-up's, which is made even more explicit by the very emotionally erratic and sensitive performances of Sullivan Stapleton and Callan Murphy. This gender reversal makes for a much more interesting action story than the traditional male-driven noir stories.

Another aspect that helps keep this focus is the use of colored lighting through neon lights, shades, and other movie magic cheats for source light. Stender's fellow Australian cinematographer Geoffrey Simpson takes a cue from classic '70s Grindhouse films to create a postmodern aesthetic that reminds viewers that they are watching a movie, not real life. It is a simple concept, but in order for the violence not to be taken as truly grotesque, they must remember this truth: Simpson's use of his on-screen stylizations is key in allowing the audience to accept the hijinks of murder, maybe even with a laugh or two. Simpson also takes advantage of a beautiful Australian backdrop to set the story. The gorgeous isolated island setting is established early in the film, however – the catch is that, besides the people involved in murder (this includes being a killer, victim or extortionist), there seems to be no one else around. Who knew that such ugly crimes and motivations would look so great with a sunny beach paradise behind it?

Stenders addresses his playing with traditional character roles to be a direct distinction of the film's postmodern style. *Kill Me Three Times* plays upon peoples' past film experiences by referencing classic film styles and characters, such as the crooked tough cop and the femme fatale. While the film also adds new dynamics to the traditional nihilistic tale of murders gone wrong, and by choosing a plot template that is so deeply rooted in chance, its goal of creating a new version seems reachable.

Speaking of looking good, the cast does just that. Both Teresa Palmer and Alice Bragga

However, while the film has style and entertainment value, it lacks enough of a signifier to really stick to an audience's palate for very long. There aren't any overly-memorable action moments or trademark lines or catchphrases that fuels the film here. Nor are there any moments of outrageous comedy or snappy one-liners to steal and use on your friends later. It's still fun to watch though, and while it remains a very technically proficient film, it most likely won't be on people's top ten list in a month or so. But for a film whose influences are so entertaining, perhaps the film is doing just what it was meant to do after all. •



### Historic Call to Action Not Over Yet

Tuesday, March 31 was one of our lesser-celebrated holidays; it was Cesar Chavez Day. I still remember the day that he died. My mom and I were driving home, she had just picked my up from school, and we were listening to the radio. It's hard to recall what was being played that April afternoon in 1993 on KLOVE, but what is clear is that we were crossing over the railroad tracks on Eucalyptus and Florence Avenue when the music stopped and the breaking news was broadcast. At the time, I knew what the average middle-school kid might know about the farm worker turned civil rights leader: he led boycotts, had support from Robert Kennedy and wanted better wages, working conditions and the right to unionize for farm workers.

As a teen that meant little to me but by the time high school ended, his struggle made sense; it was noble and a worthy endeavor for him to take. Sadly, after I graduated high school, much like today, Chavez's fight is far from over. The abuse of workers in the fields continues and the working conditions are still horrific. Many field workers today are underpaid, overworked, exposed to cancerous chemicals and in many cases the women are victims of sexual assault. And no, these aren't isolated incidents as legitimate news organizations such as NPR have reported and documented said abuse. It is worth noting that there are still groups of people dedicated to improving the working

and living conditions for farm workers, but the challenges are great and the fight far from over.

I didn't grow up in a family of farmworkers. The immigrants in my family worked in the service industry and in construction; however, they knew what it was like to work long and hard hours for not the best pay. As a result, they always stood in solidarity for those less fortunate than us. So when Chavez died, I knew it was a big loss but didn't grasp the significance of his death. Today, thanks to the humanity in my parents, I can see beyond Chavez's death and appreciate the goals he had in life. Furthermore, his death is a reminder to me that the fight he took on in the 1960s and 1970s is still relevant today.

It's common practice to honor people who made an impact on society by designating a day to pay tribute. If we want to honor the man's legacy, we should apply at least a fraction of Chavez's humanity to those around us that are in a world of hurt and struggle and stand up for them. If we see an injustice, no matter how small, we should act to correct it. We don't have to start a nationwide boycott, nor do we have to take down any corporate entity to make a difference. Let's just take the time to care for our neighbors much like Chavez did decades ago. Chavez made a choice, as did the thousands of people who supported him, and that decision was to help others. What better way to honor the human spirit than by emulating such kindness? •



What has become of the Los Angeles Lakers? It seems that not long ago, we were watching as Kobe threw alley-oops to Shaq and the purple and gold were bringing home trophy after trophy back to L.A. Those were yesteryears Lakers. Our Lakers today,

much older in (NBA years) body from injury to cling to what will certainly be the final year of his much prolonged pro-basketball career. So, how do the Lakers fix it?

You don't need a crystal ball or a magic "Jeanie" to figure out that answer. It's right in front of you for everyone to see. That's

In what is now the worst season in franchise history, team president and boss Jeanie Buss is working with no Kobe Bryant, almost no promising prospects in the organization, and a team that seemingly gets worse and worse as the years pass on by; a team that clearly just doesn't know when to do the right thing. It may be a long, long time before we see the Los Angeles Lakers back on top of the Western Conference once again.

When Dr. Jerry Buss came to his unfortunate passing from this world, a tiny piece of the Lakers went with him. Scratch that, a humungous piece of the Lakers went with him. Ever since his exit from this world, the Lakers have been a mockery at the hands of Jeanie Buss and her older brother, Jim. While Jeanie is the acting president and oversees business operations, Jim controls basketball operations. Some job he's done of that over the past five years, huh? No matter who's really at fault for the failure of the Lakers of late, it is clear that a Jim and a Jeanie are no Jerry. Dr. Jerry Buss was widely respected inside and out of basketball forums. The top-5 draft pick looms in the balance for the Lakers, who could certainly use more help in the draft to build the team with young talent from the ground up. With every win that Clarkson leads the Lakers to, the organization's hopes of holding on to

of his profession. They were interesting, yes, but dry. Fasha said, "They were all the same but a new journal started several years ago out of the UK called *The Analytical Scientist*. They wanted, naturally to provide the same thing...in their publication but they wanted to put a bit of flair so they started to do a lot of interviews," said Fasha. The new publication included interviews with scientists, managers, etc. and highlighted what companies around the world were doing with regard to philanthropy, which made the publication that much more exciting. Since Phenomenex does an incredible amount of philanthropy, they were featured in *The Analytical Scientist* where Fasha was interviewed on December 5, 2012. Between Fasha and the publication, they decided to come up, as Fasha says, "We decided to do something for scientists who have done something recent for humanity, sort of like the Oscars of analytical science. They wanted a company to be the sponsor of this award. Who did they come to? They came to us because of our philanthropy; we naturally try and do a lot. We do charity in many parts of the world. We said absolutely we would take this on, and it became a joint award between *The Analytical Scientist* and Phenomenex." Several press releases were sent out and hundreds of scientists applied for the award. Seven judges, highly respected scientists in the field, chose the winner. The basic theme was 'how it helped humanity.' This is the first time the Humanity in Science Award was presented.

Fasha then told me the most amazing story. While Alex Gharagozlow was in New Orleans

presenting the Humanity in Science Award to the winners, Dr. Peter H. Seeberger and Dr. Andreas Seidel-Morgenstern, Fasha was at the same time in Britain during the celebration of 'red nose day,' which has been going on since 1985, where the entire country wears red noses and people donate to help charities. The way it was explained to me was it is similar to our telethons to raise money à la Jerry Lewis. "I am watching this [on TV] and there were comedians and celebrities, and I hear the whole thing is about malaria. This is the ironic thing - [they asked] if you sent 5 pounds in, [via text] you would buy a tent to prevent malaria and they were showing stories of horrific . . . there was a guy in a village in the middle of nowhere, and a famous English comedian who was actually in tears. An African guy takes him to the backyard of a shed and says, 'that was my son, that was my daughter,' and he had to bury them! I started texting . . . simultaneously I hear the news from New Orleans [about the Humanity in Science Award winner] - and [of course] I didn't know what the award was for [or who had won]. These two gentlemen created something that makes [malaria] tents obsolete!" At that moment I got chills. Wow, can you imagine how Fasha must have felt? How an idea to honor scientists resulted in a way to help the world. At this point, these brilliant scientists need funding and backing.

Alex Gharagozlow, Executive Director of Operations at Phenomenex went to New Orleans for the Pittsburgh Conference (Pittcon), which is the world's largest annual conference and exposition for laboratory science, to present

the Humanity in Science Award to Dr. Peter H Seeberger and Dr. Andreas Seidel-Morgenstern of the Max-Planck Institutes in Potsdam and Magdeburg, Germany. "Basically, they both bring two different aspects of the technology together. One is more on the actual malaria drug itself [Peter] and Andreas is more of the chromatography technique that they need to do the extractions to bring purity and the cost so they would be able to do it," said Alex. He went on to tell me that Peter got involved building malaria tents in Africa. Then Fasha said, "Right now, more people in Africa in particular are killed because of malaria than in any other part of the world." To desperately try and prevent these deaths, and because mosquitos are generally the way malaria is transmitted, people sleep with nets/tents over their beds at night. Fasha went on to say, "Mosquitos are generally out in the evenings, therefore, most people - to prevent it - [use nets/tents]. Obviously, vaccination would be good, or a cure would be good in the Western world - but not there - it is too expensive. So you build a tent that you sleep in so the mosquito can't penetrate." Alex told me that a lot of the drugs sold in Africa for malaria are counterfeit drugs and they don't contain the active ingredients they need to have. They can actually contain other components that can create other side effects for the patients. The real drugs that do work, if they manage to find their way to the patient, are very, very expensive.

"Malaria can easily be contained, but unfortunately in many poor countries the reason people die is because these medications are very expensive and the governments, people,

and villages, can't afford it, therefore they end up with the consequences of it and more people die than not. So the ultimate benefit of what these two gentlemen did was to produce the drug, making the manufacturing and producing of it very cheap," explained Fasha. Also, I might add here that chromatography (purifying) keeps the drug pure and clean.

Alex explained, "So the whole genesis of this work started in the Vietnam War. They found out that more North Vietnamese were getting killed from malaria than the actual war...so the Chinese government, who were supporting the North Vietnamese, sanctioned the project to find natural products [to fight malaria]. There are trees that grow in that part of the world - [which contain the active ingredient needed] - and for farmers it is basically, waste. They clear it, [the trees] so they are able to extract the active ingredient. The challenge is to extract this active ingredient at a very economical price to make new vaccine. Peter and Andreas have figured out how to do that." Simply, these two men discovered how to inexpensively make the malaria drug from the trees in Vietnam and have broken ground there to do just that. Amazing seems too little a word for what these two men have accomplished. But they do need funding and I am praying that comes their way.

As I write this I wish I could have included the entire afternoon's conversation with my meeting with Fasha Mahjoor, Kari Kelly, and Alex Gharagozlow. These extraordinary people, with Fasha at the helm, are changing the world. What makes me proud is this whole endeavor is grounded in the city of Torrance. Wow. •





"We are going retro mod - way back to the 60s where design was about curvy forms, vibrant colors and eccentric patterns," Nayak says. "Be prepared to leave your design fears at the door and go full throttle with the bright and loud elements found in the mod movement."

### ORGANIC ELEMENTS



### COPPER

"Each year we see a particular metal rise to the top of every designer's list; and this year, it's all about copper," Nayak says.

Copper is a captivating metallic that adds a modern edge to even the simplest scheme. Small pieces make a big statement, so subtly pepper in copper pieces to your decor, like light fixtures, planters or table settings. Display copper cookware in your kitchen - it's a great way to add a touch of glamour without being gaudy. •
