# Council Hosts Public Hearing, Approves Budget as Recommended by City Manager

After the second public hearing and budget workshop regarding the City of Torrance's proposed two-year operating budget for fiscal years 2015-2017, the Torrance City Council approved the budget recommended by the city manager during Tuesday night's regular council meeting.

The first meeting hosted May 12, did not require formal action by the council but city staff was directed to address certain issues and to provide additional information for members of the council.

"We have included that in the budget tonight," Torrance Finance Director Eric Tsao said. "In addition, since then the governor has come out and talked about his May revision. The direct impact on Torrance we believe is very minimal; he talked about state mandates that were delayed or deferred so he is adding another million dollars to pay those cities up to the year 2004. We are dusting off our state records to see if their [state] records coincide with ours and that would be one-time monies for the city."

During that first budget workshop the council asked staff to provide additional information regarding a Military Veterans Commission, farmers market banners, 4th of July fireworks, the Parks & Recreation Enterprise Fund, the Torrance Cultural Arts Center Foundation, the Torrance Rose Float Association as well as City Council travel, all which have been affected due to budget limitations for several years.

"It's a good thing that we are adding things back in; it's not one-hundred percent and not what everyone wishes but there are a lot of good things so I think that moves us in the right direction," Mayor Patrick Furey said.

The council unanimously agreed to establish a Community Services Commission, initially

called Military Veterans Commission, for the next six months at a cost listed in the staff report to range between \$5,000-\$30,000 but that is expected to be on the lower end, given that approval is for six months.

"For the public to understand what that was, rather than just a pure veterans commission, I ask that we broaden it to make it a community service commission that would encompass homelessness, veterans, special needs children and intellectually challenged adults," Mayor Furey said. "I think they all go under a great umbrella and I think we can find seven members of our community that could assist those people."

Other notable adjustments made by the council to the budget at Tuesday night's meeting

were the allocation of a set aside fund for the Torrance Rose Float for the next two fiscal years. Prior to economic recession that forced the city to severely limit budget expenses, the city was able to provide the Torrance Rose Float Association a line-budget item to ensure registration into the yearly Tournament of Roses Parade. Since that item has been removed, the Torrance Rose Float Association has reached out to several sources for donations every year.

"We have a committee of wonderful people that go out and fundraise and possibly there might be a corporate sponsor somewhere along the line," Councilwoman Heidi Ann Ashcroft said. "So if we front the money, that can be

# **School Board Approves Science Lab Floor Plans for District**

In a unanimous vote, the Torrance School Board gave the nod-of-approval to the layout plans presented for the science labs to be built for the district's elementary schools during the May 18 board meeting.

The board's approval of the science lab layout will be the foundation for each of Torrance Unified School District's elementary schools, [Adams, Anza, Arlington, Arnold, Carr, Edison, Fern, Hickory, Lincoln, Riviera, Seaside, Torrance, Towers, Victor, Walteria, Wood and Yukon Elementary Schools] all of which will receive a brand new science lab.

"Just to take you back a moment, this is part of our bond campaign and bond

election that is to provide a science lab for each of our elementary schools," Torrance Superintendent Dr. George Mannon said.

The layout of the soon-to-come science labs will accommodate seating 32-34

"The reason there is no gas, which we do have at the middle schools and high schools, and that is based on the next generation science standards, which indicate that the state not recommend gas for the elementary schools," Dr. Mannon said.

The labs are designed to measure slightly more than 1,200 square feet. While from the exterior the proposed science labs resemble those of the district's middle and high school

## Sunshine Superman Is a Powerful Testament to the Human Spirit

Mankind may institute the laws of the land, but gravity is the law of the universe, and those are the only rules Carl Boenish abides by. The father of the BASE jumping movement, Boenish's story and the extreme sport culture at large is examined in the euphoric documentary Sunshine Superman.

This film is so much more than watching people jump off mountains and buildings; director Marah Strauch finds a goldmine when talking to Carl's family and friends as we discover just who this fearless man was. It will no doubt

bounds. Perhaps that's why it was seemingly so effortless for him to dangle 3,000 feet off of El Capitan mountain in Yosemite National Park on a bicycle seat while BASE jumpers lunged off cliffs to ensure the best aerial footage for his ever-growing video library.

The genesis of BASE jumping, which is actually an acronym for Building, Antenna, Span, and Earth, started with Carl in the 1970s. In order to call yourself a BASE jumper, one must have jumped off of each of the fixed objects. His obsession with the sport took him all over the world, and he was finally able to

leave you with chills, and maybe a few tears.

Growing up in Hawthorne, CA (shout-out to my hometown), Carl worked as an electrical engineer, amateur filmmaker, and skydiving enthusiast. The film takes us through his early years, his law-breaking shenanigans and meeting the love of his life, Jean, whom he later married. Everyone who knew him all said the same thing, Carl had "Peter Pan" syndrome and he was just a big child at heart who never really grew up.

The little things excited him, and his energy was contagious. His enthusiasm for life, exploration, and nature's miracles knew no share his experience with someone special when he married Jean.

Well before the days of the Go-Pro camera, Carl and Jean strapped large cameras on their heads and documented all of their conquests. This footage proves to be some of the film's most rewarding moments; the candidness of their relationship personifies not just a love story between a man and a woman, but also between man and nature.

Sunshine Superman is so uniquely powerful because its story is told through both Boen-

## **Torrance Memorial Medical Center Offers 3D Mammography**


The Vasek and Anna Maria Polak Breast Diagnostic Center at Torrance Memorial Medical Center is the first medical center in the South Bay to offer Digital Breast Tomosynthesis (DBT), or 3D mammography technology, for detecting early stage breast cancers in women with radiographically dense breast tissue. The technology is available to patients of its Torrance and Manhattan Beach offices and will be offered at its Rolling Hills office this summer.

A 3D mammography exam is very similar to a traditional mammogram. There is no additional compression required, and it only takes a few seconds longer for each view. Very low X-ray energy is used during the exam—just about the same amount as a traditional mammogram. There is no additional cost to the patient for a 3D mammogram vs. a traditional mammogram. •



## Spinach Turkey Sliders with Lemon Yogurt Sauce



Serves 10 | Prep time: 25 minutes | Total time: 45 minutes

### **Ingredients**

- 1 can Pillsbury(TM) Grands!(TM) Jr. Golden Layers Butter Tastin'(TM) refrigerated biscuits (10 biscuits)
- 4 tablespoons Crisco(R) Pure Olive Oil
- 2 teaspoons Watkins(TM) Sesame Seeds
- 1 box (9 ounces) Green Giant(TM) Steamers(TM) frozen chopped spinach
- 1 1/4 pounds ground turkey
- 2 containers (5.3 ounces each) 100-calorie fat-free lemon Greek yogurt, stirred
- 1/4 teaspoon Watkins(TM) Garlic Powder

#### **Preparation**

- 1. Heat oven to 400 F. Separate dough into 10 biscuits and place 2 inches apart on ungreased cookie sheet. Brush tops of biscuits with one teaspoon of the oil. Sprinkle with sesame seeds and press in lightly. Bake eight to 11 minutes or until golden brown.
- 2. Meanwhile, microwave frozen spinach as directed on box for 3 to 4 minutes to thaw. Drain well and squeeze dry with paper towels. In large bowl, gently mix spinach, ground turkey, 2 tablespoons of the yogurt, the garlic powder, 1 1/4 teaspoons salt and 1/4 teaspoon pepper just until combined. Shape mixture into 10 (3-inch) patties.
- **3.** In 10-inch nonstick skillet, heat two tablespoons of the oil over medium-high heat. Add 5 patties and cook 4 to 6 minutes, turning once, until meat thermometer inserted in center of patties reads 165 F. Drain on paper towel-lined plate. Repeat with remaining oil and patties.
- **4.** In small bowl, mix remaining yogurt, 1/4 teaspoon salt and 1/4 teaspoon pepper until blended. Split biscuits and spread 1 tablespoon yogurt sauce over cut side of each bottom biscuit. Fill biscuits with patties. Serve with remaining yogurt sauce.

With a twogame sweep of the West High Warriors last Tuesday and Wednesday, Torrance showed just how good they can be.

Game 1 between the Warriors and the Tartars with second place on the line was last Tuesday afternoon at Kendall Field in Torrance. The Tartars came ready to play and by the second inning found themselves leading by a score of 4-1. It was then up to starting pitcher Paul Moon to do his part. Moon did just that and more. Over seven innings pitched, Moon allowed only one run in the top half of the second inning while giving up only five hits and striking out three. Behind the seniors' strong performance, the Tartars were able to easily roll to a 4-1 victory in the opening game.

After a brief period of sleep that was certainly easier to attain for Torrance than the Warriors, the two teams were back at it, this time at West High. This time, the Warriors were first to strike. An RBI double from Jackson Cooper followed by an RBI single from Cody Wissler put West up 2-0 early. The third inning changed the game. JD Kruger and Konnor Smith came through with key RBI's to get their team back in the game. "We've been working all season on our twostrike approach," Smith explained of his at bat. "I was down in the count and I battled my way back." Not only did Smith, but so did the Tartars. Alex Gallegos put a cap on the afternoon when he smoked a two-run double to left-center to put the Tartars up for good, 5-2. "I knew (Josh) Hight was going to come at me with curveballs," Gallegos said. "I took a big hack and got that double." A cache of pitchers including Gallegos, Dante Mendoza, and Jacob Vanderlinden were able to hold West in check long enough for the Tartars to come through with the eventual 6-4 victory and two-game sweep of their bitter Pioneer League and city rivals.

The sweep came at precisely the right time for Torrance. Not only did they close out the

season with six straight wins to finish alone in second place in the Pioneer League, but they also knocked the No. 1 ranked West High Warriors (18-10, 6-4) down into a tie for third place. "Hopefully it's one of those things in baseball where you go through some adversity and respond," West coach Juan Cueva explained. The adversity has led West to four straight losses to end their regular season. The Warriors will have to try to find away to get things turned around in a hurry in the playoffs. Torrance (11-19, 7-3), on the other hand, is as hot as they've been all season long. "We've had a lot of struggles," coach Turner explained of his team. "They didn't turn on each other as a team, they improved and it got us into the playoffs." Not only will Torrance be in the playoffs to defend their title, but they will be doing it with a much improved seeding.

The North High Saxons and South High Spartans got together for a two-game set last Tuesday and Wednesday to end their season. The two teams split the two games with South winning the first at home and North taking the second on their home field.

North vs. South

In Game 1, it was all South from the getgo. Two runs in the first inning followed by three in the third got the Spartans out to an early 5-0 lead. They eventually won the game by a 6-1 final. Matt Mavrosakis went 3-for-4 with two hits and two runs scored and five different Spartans drove in runs to help South to their victory. Drake Pingel pitched seven innings of one run ball, allowing only four hits while striking out eight. The next game between the two was much different and much closer. North helped their own cause by scoring first in the first inning. In the third, the Saxons opened things up with three runs to take a 4-1 lead. Junior Owen Canady had two RBI's on the day and pitcher Jonathan Narimatsu held South in check by allowing only two runs and six hits in 5 1/3 innings. Narimatsu struck out three.

The Saxons (12-12, 6-4) wound up ending their season winning three of their final four games and finished in a tie for third place with the slumping West High Warriors. While South has been strong all season long, the loss to North was only a minor setback. The Spartans (20-8, 9-1) finish their season as winners of six of their last seven games and eight of their last 10. All Torrance teams look to be poised and ready for the playoffs. The Spartans, however, seem to be the most motivated to get revenge for last year's blowout loss to Torrance in the CIF final. •

# Dodgers Should Trade Puig Now

After last Saturday night's slate of action, the Los Angeles Dodgers had a 23-13 record, good for both first place in the National League West and the second best record in the entire league behind only the St. Louis Cardinals. In addition to being among the best teams in the league, the Dodgers have also been one of the most injured teams in the entire league. Closer Kenley Jansen has just recently resurfaced from missing the entire start of the season while Carl Crawford and pitchers Hyun Jin-Ryu, Brandon McCarthy and Joel Peralta have all missed time. Most importantly, though, there is Yasiel Puig. Puig has been missing from the lineup for a few weeks now with a hamstring injury. In his absence, the team has kept winning. The Dodgers ability to weather the storm and remain successful without their best everyday player suggests that they should look to trade him now while his stock is still high.

Trading Yasiel Puig is a suggestion that will certainly not be popular with most Dodger fans. When the 24 year-old outfielder came straight from Cienfuegos, Cuba, and to the major leagues in 2013, he was an immediate hit. Puig-mania swept through Dodger nation while the "Wild Horse", as Dodgers announcer Vin Scully calls him, burst onto the scene batting .319 with 19 home runs and 42 RBIs in just 104 games played in what was his first major league season. Puig finished in the top-15 of the MVP race that year, only to follow it up with an All-Star game appearance the next. Clearly, Puig-mania was taking over. No. 66 jerseys were flying off the shelves, Dodgers merchandise was being sold at an all time high, and Chavez Ravine was packed with fans attempting to get a glimpse of the right fielder, night in and night out.

All of these reasons and more are exactly why the Dodgers need to look into trading Puig. Obviously, the young sparkplug of a player is extremely marketable. Not only does the media gravitate toward his every move, but his presence alone has the ability to energize a fanbase, thus making him even more marketable to other teams. Well, why trade him in the first place? If there is one position on the Dodgers roster where the team is deep, it's in the outfield. As currently constituted, however, it would be very difficult to see this team approach the months of September and October against other contenders like St. Louis and Washington with a starting pitching rotation like the one they currently rely on.

Dodger fans are spoiled. Teams all across the league are in need of outfield help while in Los Angeles, there are at least six players who could get the job done and get it done successfully. Puig's injury has actually proven that fact. Since his departure from the lineup, other role players have stepped up and done a phenomenal job. Alex Guerrero, for instance, has stepped up nicely to play in the Dodgers outfield in the absence of both Puig and Crawford. He is batting .357 with six home runs and 16 RBIs in that time frame. Scott Van Slyke is another player who has just been waiting to get his chance, batting .333 in Puig's absence. Lastly, this right fielder would be hard pressed to be called a role player lest he be the league's highest paid role player. Andre Ethier, yes, the six year, \$96 million Andre Ethier, has finally gotten his chance to play amid Puig's absence and is not taking it for granted. In 32 games this season, Ethier is batting .330 with five home runs and 14 RBI's in what has been a resurgent year for the 33-year-old. Ethier has not only turned himself back into what should be an everyday player for the Dodgers in Puig's absence, but he's hitting again. Hitting like he did when he made back-to-back All-Star game appearances in 2010-11.

As the late, great Branch Rickey stated, it's better to "trade a player a year too early rather than a year too late." While Puig burst onto the scene with major talent and the capacity to bolster the middle of a lineup, his ability has been faltering slightly ever since. After batting .319 in his first season, Puig's average fell to .296 last season. In addition to his inability to hit the curveball, the cutoff man or in the clutch, his careless and reckless behavior suggests that this won't be the only stint of his career on the disabled list. Furthermore, the Dodgers need players who can perform under the bright lights and under pressure. Clayton Kershaw seems to have trouble doing that, but so too, does Puig. In last season's playoffs when the Dodgers needed him the most, Puig hit .250 while striking out eight times. In the 11 games that he has been healthy so far this season, Puig's batting average has dipped yet again to .279 with only four extra-base hits and four RBI's on the year.

When all is said and done, the Dodgers must strike while the iron is still hot. Yasiel Puig's iron is still sizzling in the eyes of other teams. He's marketable, he'll bring fans to the stadium, he's got a cannon of an arm on defense and despite his seemingly declining offensive numbers, he shows as a clean-up hitter. The Dodgers don't need a clean-up hitter. With already the best offense in the entire league (without Puig), what the Dodgers need is pitching. Without pitching, there is no World


#### Level 2 - Water Use Requirements And Regulations

- Outdoor watering limited to 2 days/week; 10 minutes per area or irrigation station

- No watering 48 hours after rain event
- Certain restrictions on filling or refilling pools, spas and ponds
- Provides for administrative rules to implement the ordinance

#### **Permanent Requirements In Effect At All Times**

- No excessive runoff from outdoor watering
- No washing of exterior surfaces
- No washing of vehicles with "open hose"
- All water features must have re-circulating system
- Restaurants to use water-conserving spray valves
- Restaurants to serve water only on request
- Lodging businesses must provide option not to launder linens daily

# Take Me Out To The Ballgame

Most everyone recognizes the sound of a baseball bat connecting hard against a ball just thrown from the mound. For me, the music of a bat smashing a baseball conjures up summer, peanuts, cracker jacks, hot dogs, and fun. It used to be said that baseball was the All-American game, and that may still be true, but the fact remains except for knowing how many innings a normal game contains, how many outs to a side, and the different positions, I know little more about America's pastime. This normally wouldn't be any problem whatsoever, but I've been invited by my family to attend a Dodger game tomorrow night and I want to be ready.

I remember the last time I went to Chavez Ravine. It was a lot of fun and I knew what was going on - most of the time. But somehow I just don't 'get' the people who sit patiently with a scorecard keeping track of the players' hits, misses, et al. But because I want to know more about the ins and out of the game this time, I decided to ask my neighbor, probably the biggest fan the Dodgers have ever had, or will ever have, lifelong Torrance resident Carolyn Weyant, what I should be looking for when I attend the Dodger game, besides what to eat.

Carolyn was kind enough to come over my house, and allowing me to pepper her with questions. First of all she told me, "I have never kept score because you cannot watch the game while you are keeping score. I will not miss a strike, a ball, a hit, a play, or an out because I have to keep score [because it] takes my eyes off the field - even during Little Yikes! I knew my neighbor was a great fan, but I had no idea she was a super duper fan.

Now the important questions. I asked Carolyn if she followed certain players and which Dodgers were her favorites throughout the years? She made a face, and then said, "Vin

Scully, Don Drysdale, Sandy Koufax, Davey Lopes, and Rafael Furcal. I follow them all, daily." Guess that answers that. Then I asked her if it's true she purchased two 1962 seats from the stadium when they were remodeling. "I purchased two Dodger blue seats; numbers 14 for Mike Scioscia, and of course, number 15 for Davey Lopes. I bring them into the living room during baseball season and watch the

and don't want to embarrass myself. Carolyn began, "You need to watch Dee Gordon on the Marlins who we traded last year. He wasn't our All-Star last year. We traded him to the Marlins and Dee Gordon has the highest batting average in the whole league! He will steal bases in a blink – and we got rid of him! He wasn't the best batting average last season but he was excellent – he was a Dodger All-Star last year. On the other side we need to watch and enjoy Adrian Gonzales - our first baseman – he is in the top three batting averages this year. He is beyond fantastic. Watch Andre Ethier - depending upon who's catching, Justin Turner – 3rd base and if Uribe is out...Dan Haren, the other Dodger traded to them this year along with Dee Gordon!" At this point, I was thinking I needed to jot down names of players to give her a report when I got home after the game to prove I paid attention to her tips. I know for sure she will be watching the game.

Carolyn told me that with the Dodgers' injuries this year everyone has stepped up to the plate - and as I must know -- we are in first place. Well, I didn't know that but Carolyn set me straight.

Do I take a glove to the ballpark? "Definitely, always. I take it wherever I sit. I have seen people get carried out because a foul ball hit them. [I have taken my glove to every game] except one and I missed a foul ball because I didn't have my glove that night. I was sick the whole weekend and didn't eat or sleep. I am still not over it, as you can tell. And don't forget the transistor radio to hear Vin Scully."

"People say baseball is boring – baseball is boring only to people who have dull minds and don't get it. It's never over till it's over. Ask Kirk Gibson. He tells how he saw cars leaving the parking lot [in the 1988 World Series] when he was up to bat. Then after he hit the ball, he could see all the brake lights come on of the cars leaving the stadium stopping abruptly when they heard cheering on their radios - and they weren't there," said Carolyn.

What do I look for on the field? "People don't realize each player has a game plan from the pitcher to each batter - what and where he is going to throw - and they have a purpose to what they are going to throw. When we are up to bat, we have a game plan to the pitches they are getting. Most people don't get it. And it still is our national pastime for a reason. These players are so smart and I have learned this with Sports Net LA. All the interviews they do and the information we get is mindboggling from these kids that are so professional..." added Carolyn.

Then I asked Carolyn the 64 thousand dollar question. Could I borrow one of her gloves? Surprisingly, she said yes. WhooHoo! And one last important question that I absolutely had to ask was, what I should eat? She smiled and said, "Okay, here's the deal, I have never

eaten anything else at Dodger Stadium but a World Famous Dodger Dog." Okiedokie. Got my orders and I am ready for the game tomorrow night! I could hardly wait.

Driving to the stadium Tuesday night from Torrance meant I was in some traffic, but I made it into the park in time after going through the entrance surprised it was bobblehead night! Wow, Clayton Kershaw all boxed up for me to take home! Everyone stopped walking during the National Anthem and then I settled into my seat armed with my Dodger dog, the glove I borrowed from Carolyn, my camera, and binoculars. Let the game begin! From the start it was exciting! The crowds, the lights, the peanut man, and the pristine ball field with the Dodgers playing against the Marlins all combined with the activity around me and made for an exciting scene. It was one of those games that was so much fun, because there were home runs, action, fastballs thrown (95 mile pitches), and exciting scoring. In the end, the Dodgers beat the Marlins 11 - 1. ish's old 16mm archive footage of his jumps, as well as Strauch's vision for state-of-the-art aerial photography. The naturalness of weaving footage from past to present is effective in giving the story its euphoric vibe. Not that it needs any special effects, but I can't even imagine what this film would look like in 3D.

It hits you about a quarter through the film that Carl is noticeably absent during interviews. Since this a historical documentary, there are no real spoilers here. In fact, the image above is the Norwegian "Troll Wall" mountain, the location where Carl and Jean jumped off of to claim the Guinness World Record in 1984 for highest BASE jump, two days before his ultimate death.

As charming as Carl was, his naiveté to human limits was his critical downfall. Claiming the angel wings on his back (AKA his parachute) would always guide him to safety, Carl jumped from a cliff that was just days before deemed "suicidal." Tests proved that no one could safely jump from that area of the mountain, but Carl liked a challenge, and ultimately that cliff claimed his life. This moment in the film is sobering, and will no doubt leave you with chills.

Jean knows her reaction to his death is weird, and the way she deals with the loss seems odd. But to Jean, a stoic woman who suppresses her feelings as opposed to wearing them on her sleeve, this is only natural. She goes to the spot where Carl took his last jump just a short time before. She jumps, and lands, only to be greeted by a throng of onlookers inspired by her bravery. "It's what he would have wanted," she says.

Sunshine Superman is more than just a documentary about the BASE jumping movement or Carl Boenish; it's a testament to the human spirit and nature's infinite beauty. Marah Strauch captures here not only arresting visuals, she effortlessly sums up emotions, and extremely inspiring ones at that. Sunshine Superman opens in LA at The Landmark with a national rollout May 29th. •



paid back and we are that much further ahead. I don't want to see someone lose their job in the city of Torrance in order to fund a rose float, either."

The budget, which includes a break down of the city's major revenue and where it is derived from, indicates that every year the city receives 70 percent of its revenue from sales taxes, property taxes and utility taxes. Sales tax is projected to be the biggest contributor at \$48.7 million [26.3 percent], property tax is a close second at \$47 million [25.4 percent] while the utility tax is expected to generate 34.3 million [18.5 percent]. Next year the city is projecting \$185 million in revenue with all three combined.

"Only Councilman [Gene] Barnett and myself were here when the budget cuts were made over the years," Mayor Furey said. "Fourth of July Fireworks have been brought up ad nauseam, over and over again. Everyone loves the fourth of July fireworks and everyone keeps saying lets bring it back but nobody has the funding for it."

Despite the few additions being made to the budget, including the appropriation of \$59,980 for the Torrance Cultural Arts Center, items like the 4th of July Fireworks show were left out of the budget. While budget funds gradually risen in recent years, there is still a shortfall.

"The Cultural Arts Foundation has a hard time raising funds and they have a small budget; the Art Museum is the same thing," Mayor Furey said. "What we have to find here is legacy funding; some way that the money comes in all of the time so for all of the things that we all love."

"Those things aside we have a very tight budget," Mayor Furey said. "We have a couple issues that are in there; almost a million dollars lacking for paramedic services. We have a lack of funding that we will be receiving on a regular basis until ExxonMobil starts using its utilities users tax. The good news is that we are putting some things back in." •

labs, there are significant differences such as the height of the counters, which typically are 29-32 inches for adults. The counters in the new science labs will be significantly shorter so that elementary school kids feel comfortable while using the facilities. Another significant change is that the new elementary school science labs will not be equipped with fuel vents, which are only installed if hazardous chemicals are to be used by the students.

"Because of the curriculum that they [district] researched and what would be taught at elementary school level, they didn't see a need to provide gas lines," Angel Hosband with HMC Architects said. "Because there are no gas lines there will be no fume hoods since there are no chemicals that will be used that could be hazardous to students."

The monies designated to pay for every school's lab falls under Torrance Unified School District General Obligation Bond Measure T. Voters authorized the TUSD bond issue, [21,424 yes votes against 10,689 no votes] Measure T, during the Nov. 4, 2014 election ballot.

Measure T gave TUSD the authority to assign \$144.3 million in bonds in order to allow the district to "upgrade classrooms, improve technology and security, provide emergency equipment, repair roofs and plumbing, install low-water-usage irrigation systems and renovate

or build facilities as needed" stated the ballot language. Among those facilities are the science labs.

"This is the first time we have provided a science lab for an elementary school and it was not much different except for the no gas lines and fume hoods," Hosband said. "The lay out is pretty much the same."

Every school will have the same layout for the science labs. There is still no estimated completion date for each science lab since every elementary school site will be addressed individually. Each site will be updated with its own science lab, based on its individual needs and within its own timeline.

"This is the first science lab of this kind that we have seen here in California," Hosband said. "Now we are going to need to get approval [from state] for each of the sites; we will do everything in phases."

While the board approved the layout of the building itself, it is now necessary for the state to approve the plans for each individual school site. Once the state approves each site, the district can move forward with the construction phase.

"This is something actually brand new, quite frankly. No one has been producing primary science labs," Dr. Mannon said. "We are going to be the first." •



#### LANDSCAPING WITH HARDSCAPES

Landscape professionals use retaining wall systems for a variety of landscaping solutions. Segmental retaining walls are commonly used to transition elevations, shore up slopes along foundations and define spaces such as creating planters, tree rings and other features.

"Hardscape products like retaining walls and pavers are important tools for both landscapers and do-it-yourselfers in creating low-maintenance landscapes," says Scott Arnold, manager of Villa Landscapes in St. Paul, Minnesota. "Permeable pavers are a best practice for storm water management and quality issues because they prevent runoff and let rain water infiltrate in place naturally," says



Burt Plett, product manager of Willow Creek Paving Stones. "Permeable pavers reduce the need for irrigation in drought-prone areas, unlike poured concrete or asphalt." It's best to consult a landscape professional who is experienced in installing permeable paving systems so that they work properly and consistently, Plett says.

## LOW-MAINTENANCE LANDSCAPING PRACTICES

Landscaping practices can make it easier to control weeds and manage lawn care as well. The use of rock mulch and natural rock in gardens and beds, as walkways and as stepping stones offers an attractive solution to weed control and also lessens the need for irrigation. At least three inches of rock mulch or four inches of natural mulch will prevent weeds. A landscape fabric under stepping stones and rock mulch offers even more insurance against weeds.

A simple way to cut down on trimming is to add a course of pavers along the bottom

of a retaining wall, tree ring or planter so the mower can get close to the wall, says Arnold.
