# Torrance Library's New Delivery Van Makes Life Easier for Staff

"Find Yourself at the Torrance Library" is the message on every side of the Torrance Library's new and improved delivery van. The images of a kid opening a book and octopus crawling out of the pages decorates one side of the van while a woman playing the violin fills the other side.

"This project started as we were looking for ways to celebrate our library's centennial back in 2013," Principal Librarian of Operations Dana Vinke Librarian said. "One of the things that I had suggested was what if we did a vehicle wrap to promote the library through the delivery van."

As the idea of wrapping the library's delivery van in order to draw attention to the library was further considered, staff realized that the delivery van being used at the time needed to be replaced. Vinke, who described the old van as not being too ergonomic, required staff to crawl to get in and out of the van in order to load and unload.

"I looked at several different options when we were in the process of shopping. We knew what we wanted but to access things was really a challenge," Vinke said. "I wanted something that people could get in and out of and not hurt themselves."

After several repairs being made to the old delivery van, it was determined that the vehicle would not be around much longer. Opting against wrapping the old delivery van the search for a newer vehicle was underway, so Vinke approached the city's fleet services

department. Fleet services indicated that the library had some funds available that could be used to obtain a new vehicle.

"The city generally has what is known as a vehicle fund where every year they put a little bit of money away with the idea that eventually one would have to replace that particular vehicle," Vinke said. "At fleet services I saw the van we have now."

At the time the van was in possession of the police department as a mobile crime unit but it no longer suited the department's needs. So the library was able to swap their vehicle fund with police department for the van. Once the swap was made, the interior of the van was outfitted to allow for delivery of books and other materials between the main library and its branches, including adjustable shelves.

"The old one [delivery van] was small and we had to crawl through it, this one at least you could walk into and stand in," General Library Clerk Dennis Matsumoto, who drives the delivery van Monday through Friday said. "I go to all the branches and come back here to reload. It carries more and it gives you fairly good mileage."

#### Fire Department Terms for Responses When Away From Duty Stations

The city council approved a resolution that identifies the terms and conditions for the city's fire department personnel when called away from official duty stations and assigned to an emergency incident.

"What this item before you tonight is, is in light in of a change to the California Fire Assistance Agreement which eliminates what is known as the portal-to-portal reimbursement for fire department personnel unless a Memorandum of Understanding or a governing body resolution is in place that confirms that our personnel will be compensated on a portal-to-portal basis

for all assigned emergency incidents in the state of California," Torrance Fire Chief William Racowschi said. "It is just verifying and confirming that it is what we do."

At the request of California Governor's Office of Emergency Services [Cal OES], Cal Fire, federal fire agencies, through the California Fire and Rescue Mutual Aid System, the City of Torrance Fire Department can respond to emergency situations in different parts of "California in the event of a local, State, or federal emergency," indicates the staff report.





#### Cyber-Seniors Proves That You Can Teach an Old Dog New Tricks

The thought of teaching technologically challenged senior citizens, many of whom are in their late 80s, how to navigate a computer, let alone the internet, sounds more like a punishment than a reward. Why anyone at that age would willingly subject themselves to such an ominous learning curve makes no sense to most elderly people, but to a special email after typing "www.email.com" into the search browser.

To engage this group into sticking with the program, a video competition is created to see who can get the most views on YouTube. With the help of their teenage mentors, the seniors set out to make a video based on what is important to them. 93-year-old Marion channels her inner Snoop Dogg and

group of seniors, the motivation comes from members and loved ones. Director Saffron Cassaday documents the heartwarming journey of these hilarious senior citizens learning all about the Internet in the film Cyber-Seniors.

Growing up in an era when letters were written by hand, the very thought of sending an email is mind-boggling; What used to take days to receive can now be read in a matter of seconds. Two teenage sisters, Macaulee (16) and Kascha Cassaday (18) developed the Cyber Seniors program from a high school class project. After seeing firsthand how their grandparents were affected by Internet independence, the sisters were inspired to help other elders reconnect with loved ones in their lives.


In the Cyber Seniors program, teenage students sign up to guide the elderly in navigating the web. The comedic moments are organic; 88-year-old Shura is awestruck that she can "chat" with fellow Cyber Senior Ellard, 89, on Facebook. 76-year-old Annette is only concerned with dating websites and sets up a profile right away. Other seniors get confused when they can't access their

Shura loves to cook, and decides to demonstrate how she makes lunch, which consists of ironing her grilled cheese sandwiches (which actually works)! Despite its amateur, low budget "look," Cyber-Seniors should be taken seriously as a documentary. It is not all jokes either; there are unexpected emotional moments that affect director Saffron Cassaday, unintentionally pointing out the importance of family and desire for connection. You will fall in love with the men and women and can't help but laugh alongside them as they enter the vast world of technology for the first time. Running at a brisk 74 minutes, Cyber-Seniors is a heartwarming story that proves old dogs can learn new tricks, and then brag about it on Facebook.

#### **Ingredients**


- 5 pounds 1/4 thick sliced beef-top sirloin/hanger/skirt steak

# Clippers Are Still the Clippers

Los Angeles has always seemed to be a Lakers town. One of the greatest franchises in NBA history, the Lakers have always had the glitz, glamour, and high-profile fans that a franchise like the Clippers typically has not. One of those fans is former Laker great Magic Johnson. Magic said it best when speaking of the Clippers recent epic meltdown in the conference semifinals versus the Houston Rockets: "I thought the Spurs taught the Clippers how to win after a tough 7 game series," he said. "I was wrong. The Clippers are still the Clippers." A team that in its history has never been to the Western Conference Finals or beyond, the Clippers were so close and were even picked by many to win the title this season. Yet, another meltdown has not only ended their season prematurely, but has also inserted a number of question marks into the team's extremely grim-looking future as well.

Answering the question of what happened to Clippers isn't an easy thing to do. When dealing with a loss, everyone needs someone or something to blame. For the Clippers, however, the blame is multi-layered. Go back, if you will, to when Donald Sterling was ousted from the team. Sterling has nothing to do with how the Clippers lost this year, but in his place, newly appointed Clippers owner Steve Ballmer does. Ballmer, a former Microsoft CEO, doesn't know much about basketball, so when Doc Rivers wanted both head coaching and GM duties, he simply gave him both responsibilities. That was the Clippers first problem. Rivers is a really good coach. If you give him good players, he knows how to motivate his team to get the job done. He has never, however, been a great GM and outside of the Clippers best three players, the roster, that Rivers helped put together, is clearly not a championship type roster.

Chris Paul, Blake Griffin and DeAndre Jordan are all great players and are all deserving of highly lucrative contracts. Unfortunately,

those three players simply can't get the job done all by themselves. That's precisely what Doc asked them to do. After a long and tiring seven game series against last year's world champs, the San Antonio Spurs, it became clear that the core of Doc's team quite simply tired out. You can actually even locate a specific point in time when they did. Game 6 against the Rockets, up by 19 points in the third-quarter, the Clippers simply needed to hold the ball and watch time run off of the clock. They couldn't do it. Paul, Griffin, Jordan and the rest of the team were just too tired. James Harden and his Houston Rockets squad turned on the jets and never looked back. The Rockets wound up winning Game 6 by a final score of 119-107. Game 7 wasn't any better. A game where the Clippers lost by a total of 13 points (113-100) saw the tired team trail by as many as 20 in the fourth quarter to become only the ninth team in NBA history to blow a 3-1 advantage in an NBA playoff series.

"I want to fix it," Rivers told USA TODAY Sports after his team's Game 7 and seriesending loss. "I want to win. That's why I came here." The Clippers have won, they just haven't won enough and this season may have been the team's last and greatest chance at it. Jordan is an unrestricted free agent this July. Rumors of a feud between the Houston-born Jordan and point guard Paul, combined with the center's ability to receive max money from a team like the Dallas Mavericks, can put a serious dent in any future playoff aspirations for the Clippers if Jordan decides to take his talents elsewhere. It will also put a dent in Doc's dream of creating a more balanced roster. The Clippers already have no bench. That much we know has lost them a series. If Paul pushes Jordan out of town though, good luck finding any other max-players or role-players who will choose to play for the Clippers instead of a team like say, the Lakers who are suddenly

# Warriors Recapture Fire

After a disastrous end to the regular season in which West High lost its final four games after being swept by both South and Torrance High, it seems as if the Warriors have suddenly found new life within themselves. Head coach Juan Cueva saw his Warriors baseball team drop from first place into a tie for third place in the standings, but not once did they waver. With a 10-4 wild-card victory over Santa Fe and a 4-3 victory over Ramona in the CIF Southern Section Division 4 first-round, the Warriors seem to be back on track and playing like the team that started the season off on a tear.

Nathan Santiago was the hero of the day for West High in their wild-card matchup against Santa Fe. With two hits and four RBIs, Santiago led his team's offense to an outburst of 10 runs en route to their six-run victory. Matt Mavrosakis made sure that the team would no longer be in need of the ace's services. Mavrosakis went 3 for 3 on the day with a home run that led to five RBIs for the catcher. "This is the first time we've hit this well," Mavrosakis explained. "I'm very happy with that. We came out swinging and ready to go." Not only were the Spartans ready to go, but they led 9-0 after just two innings of play. After the fourth, it was clear to coach Sain that he should remove his starters to keep them fresh. The Spartans (21-8, 9-1), who finished with 12 hits on the day, will move on to face the winner of the Troy vs. Montebello game in the second round.

#### **Torrance High**

The Torrance Tartars' epic comeback attempt to avenge their CIF title of a year ago has at last come to an end. After winning their last six games of the regular season to streak into second place in the Pioneer League, head coach Ollie Turner and his team fell flat in the opening round of the CIF Southern Section Division 4 playoffs against St. Bonaventure. The Tartars came away with only two hits on the day as the game began as a pitcher's duel. By the fourth inning, however, St. Bonaventure started scoring. With one run in the fourth, one in the fifth and two in the sixth, Torrance found themselves down by a score of 4-0 and never could recoup from there. The Tartars season ends with an 11-20 record, but the way that coach Turner and his young team fought down the stretch should certainly have no problem being carried over into next season. •

# Resilience for the Ages

Resilience is the ability to bounce back or to recover strength. When we are hit hard by

a challenge in our lives, how do we react? During WWII, Japanese Americans served their country in the armed forces with pride and integrity. "Go For Broke" was their rallying cry, and last week, I had the opportunity to again hear the stories of four amazing and

The event was sponsored by Green Hills Memorial Park

and Green Ink Marketing, and by the Go For Broke National Education Center. (See Torrance Tribune October 9, 2014.)

Students representing Torrance High School, North High School, West High School and South High School, escorted the honored guests into the room. After the pledge, led by George Nakano, and the invocation led by Milton Herring, David Ono's incredibly moving and informative documentary, Japanese American Heroes - WWII, was shown. Although I had seen bits of this documentary, this was the first time I saw it in its entirety and encourage everyone to go on-line and watch this moving, and brilliant film. It explains the story of Japanese Americans before, during, and after WWII.

Steve Sato, who is featured in the documentary, was introduced by President and CEO of the Torrance Area Chamber of Commerce, Donna Duperron and told the story of the resilience and perseverance of his 24-year-old mother, who lost her husband 70 years ago when he was killed fighting in Italy. Steve then spoke of his mother's grief

Japan to be raised by his grandmother. Ken true within a military unit, but also true in business. The first point is these men shared stayed in Japan 4 1/2 years and returned to a 'common cause.' The second factor was, the United States when he was 15, fluent 'camaraderie.' Adding to these fundamentals,

Don spoke of 'shared cultural values, duty/ obligation to others and intestinal fortitude,' and 'don't bring shame upon your family.' All these cultural values can be used in business. At this point, I was reminded of the Torrance business that exemplifies this sort of cohesiveness. Phenomenex truly runs and lives by these principles. (See Torrance Tribune, April 9, 2015).

Don then introduced the honored guests who took seats on the stage for questions and answers. Honored guests were: Isamu (Ralph) Kaneshiro, MIS (Military Intelligence Service) who was stationed in the Philippines and helped interrogate POWs; Masao Takahashi, who served with Company C in the 100th Battalion in France and Italy; James Makoto Ogawa, who served in Company C, in the 442 Regimental Combat Team in Italy and France; and Ken Akune, who served in the MIS and in Burma and China (attached to the State Department) during the war and ended up in the occupation of Japan.

Ken Akune, born on July 3, 1923, began his story, "I was incarcerated in Colorado in 1942 and what really bothered me most was I had classmates outside the camp who were joining the military. And here we were, I am of the age for draft but they put us in a classification 4-C - enemy agent, undesirable service. On Dec. 12, in 1942, my brother came by and said they were recruiting a team - we didn't know what it was and he was going to see if we could join. I said if loyal to a country but it takes more than that. You've got to be willing to serve the country so without hesitation my brother and I went, we passed and we went into this military language school for 6 months," said Ken. He also said that he had to serve during the

entire war plus 6 months, and that is exactly what he did.

Masao Takahashi, born on August 9, 1924, said, "My brother volunteered from camp but my dad didn't want both of us to volunteer.

Legendary Luncheon Series, a special event honoring guests who served in the Japanese American units of WWII. Attendees, included when she sat him down and said, "Maybe we should die too." But that was a turning point and she became a person of great strength and determination because that brave young mother turned her despair and grief into hope when Steve said his mom told him, "We need to live a long life. We need to live dad's share of life too because he was taken away so prematurely. And we need to honor dad's memory..."

Steve Sato's mother lived a life filled with hope, which epitomizes resiliency, and she later even served in local government in Lihu'e, Kauai. Steve then introduced Don Nose, President of the Go For Broke Education Center, who introduced special guests Honda, Coca Cola, and Exxon Mobil. Don Nose said the Go For Broke organization stands for, "Take the wisdoms of an historic generation, but specifically using the Japanese American WWII Veterans, to enlighten and encourage the youth of today to inspire to greater heights. And clearly resilience is one of the foundational concepts."

Don Nose spoke of several factors, which enabled Japanese American units of WWII to be so incredibly successful - so successful they are the most decorated units in the military. Once again resilience was a major factor in their success along with the cohesiveness of the men. They shared a number of key factors, which are not only

California on October 25, 1923, enlisted right after the war broke out. "I was packing celery in Salinas when the war broke out. A friend of mine wrote a letter to me and told me to come home he wanted to talk to me. I borrowed my boss's car and went to

let me work in the kitchen so they brought me to do KP. I said I didn't want to do KP, and said, teach me how to cook. So then I went to cook school. Later in 1943, when we went to Camp Shelby in Mississippi." Then he joined the 100th and fought in France,

of us so we were put into the orphanage and I stayed in San Francisco for 14 years. In Manzanar we were classified 4-C. They didn't even look at the Constitution or anything – that's what upsets me the most." Masao said he was sent overseas. First, he landed in Scotland, crossed the English Channel into France, and from France he was shipped over to Italy until the war ended.

James Makoto Ogawa, born in Riverside,


Sacramento. And he says, 'Let's join the army,' so I said, what the heck we - join[ed] the ROTC in high school - so we did. We went to San Francisco [to] enlist in the service. After that, we were shipped to Little Rock, Arkansas. We finished up basic training and they took our arms away because we were Japanese. In Fort Leonard Wood they wanted us to do yard work. I said, gee, I didn't come to the army to do yard work. So I told them

where it was so cold, he got trench foot. He was sent north...and later in November he was sent home to Chicago where he lived for nine years. While vacationing in California, he decided to relocate, and worked first as a sheet metal worker, and then became a very astute salesman in the Golden State.

Ralph Kaneshiro, who was born in Maui, Hawaii on August 8, 1925, said, "My MIS Language Education was at Schofield Barracks on Oahu. We were devastated because we couldn't go to the mainland. We stayed in Oahu and got our education there. We were supposed to be a special group; we had half a day of basic training and half a day at language school. In the beginning we all baulked that we wanted to go to the mainland, but we were grounded after that until we decided to study. We relearned Japanese. When I was younger I went to Japanese school and eventually we went overseas. But before we got into the war zone, the war ended. Prior to those couple weeks, we were assigned to Naval Instruction. The Navy wanted us to interrogate prisoners after they sunk all the ships but by the time we got there, the war ended and all the prisoners were sent to the mainland and the rural Philippines. After we landed on this island, about a week later, they told us to pack up - we were to go somewhere else. We ended up in Manila in a camp. It was ATIS (Allied Translator Interpreter Section)." Ralph then continued to tell of his time in the MIS and said he interrogated prisoners of war. Ralph served in Japan after the war from November 1945 to December 1946 as part of the occupation forces. He helped the Japanese recover after the war and said it was because the MIS were there that Japan got back on their feet so quickly.

As the afternoon came to an end, these brave veterans took time to sit, meet, and greet anyone who wished to shake their hands. George Nakano commented, "It's wonderful because for as long as I've been living here – this is the first time this has been done. Every time I see David Ono's documentary, it brings tears to my eyes." George was not alone. I remembered these remarkable men from the Go For Broke Gala last fall and each time I hear their stories, I learn more. This generation truly is special. Thank you, gentleman not only for your service, but for your example of character and resilience for the ages. •





Every day, the library's delivery van is on city streets for an average of five hours and 20 miles each day, for an estimated 5,200 miles a year. During its daily deliveries Matsumoto and the delivery van pass many of the city's busy intersections, schools and shopping centers.

The old delivery van was plain white and simply displayed the City of Torrance logo. However, with the new professional, informative, and visually appealing vehicle wrap the library is able to promote itself while simply conducting its daily operations. Aside from the images on the new van drawing attention to the library, the new delivery van has the City of Torrance logo and the web address www.libraryvan.org, which helps visitors learn more about the variety of services made available through the city's library.

"People always ask me why we have someone playing the violin on the side of the van," Vinke said. "Well we have musical scores, CDs and a lot of music-based programing so we wanted to be able to instill in the van that the library is more than a quiet place."

The library worked with Dogs of Design Studios, the same company that designed the City's Centennial Webpage, to create a conceptual design for a vehicle wrap. They were also an integral component of the design is a webpage [www.libraryvan.org], which will redirect people to the Library's homepage.

The second phase started when the design was determined but the staff needed the vehicle wrap process to begin. After approaching several vendors via a Request For Quotation [RFQ] for a provider it at the lowest cost, the library found Decals By Design.

"Decals By Design took the van over a weekend and delivered," Vinke said. "It had taken so long that when it was finally done, people were blown away. It stands out in a positive way and now that it is done, staff is starting to think of things that we can do as

far as outreach."

One idea is to visit the farmers market so that people can have a bit more exposure to the library. The wrap on the new delivery van is expected to last up to five years and at that point the library can decide to reprint, rewrap or create a different concept.

"I do have to thank everyone involved such as Max Parker at Dogs Of Design Studios, Decals by Design and the staff here were integral in conducting the research to do this," Vinke said. "Now everywhere we go this is very positive promotion and advertising for us and that is what I wanted it to do.

"One of the things that libraries are really interested in is to reach people who for whatever reason do not use the library anymore. I know that for better or worse, people are stuck in traffic and people who are stuck in traffic could be listening to one of our audio books, or CDs, or taking home movies," Vinke said. "It is the perfect way to remind them that we are still there for everyone in the community to utilize."

For Matsumoto, who will drive the van everyday like he has for years now, the new delivery van not only looks great but it allows him to better carry out hiss daily duties.

"The height is much greater and you can stand in it. It is just a few inches wider and a few inches longer but we do have a lot more cargo room," Matsumoto said. "Some of this stuff was ready made and other things were custom made. We changed to these blue crates, which carry more; before that we used to have canvass bags. It was quite a problem to load."

"Hopefully it is a positive experience for people to say, 'I should stop at the library today," Vinke said. "We are very fortunate this particular model became available for us and we thank the police department for letting us swap. Without that we would have been hard pressed to find a similar van." •

The staff report also indicates that when an agency seeks reimbursement for personnel for more than the hours that were actually worked during a specific incident will be required to file and MOU or GBR with Cal OES that must specify how it is that personnel is to be compensated. The City of Torrance compensates its personnel on a portal-to-portal basis.

#### **City Approves License Agreement** For Groundwater Monitoring Well

Based on the recommendation of the Community Development Director, the city council approved a license agreement with Madrona Car Wash, Inc. located at 3405 Sepulveda Blvd. for one groundwater-monitoring well.

The approval will not require funding from the city. The Los Angeles Regional Water Quality Control Board [LARWQCB] instructed Madrona Car Wash, Inc. to install a monitoring well in order to monitor for the possibility of hydrocarbon migration contamination, which may have migrated from the site.

Madrona Car Wash, Inc. requested to install one groundwater-monitoring well that is to be located in the public right-of-way. Since LARWQCB directed that the "potential plume migration northeast of the site must be monitored," the well will be installed along the east side of Madrona Avenue, 200 feet north of Sepulveda Boulevard.

The agreement exempts the city from all and any financial or legal "encumbrances associated with the construction, operation, and relocation" of actions required based on the results of test data that was obtained from the well. •

Ray has tested positive for FIV (feline AIDS). In cats, FIV is not such a big deal; given proper care and attention, an FIV+ cat will live the same lifespan as an FIV negative cat. The disease is extremely hard to transmit from cat to cat, requiring direct blood contact (typically from a deep puncture wound). It is not transmissible to humans. Please give this love bug a chance.

#### **Protect Your Pets from Flea Infestations**

April showers bring May flowers, but May showers bring fleas! The combination of humidity and warm temperatures allows fleas to breed quickly and thrive. Fleas are more than a nuisance. Many cats and dogs are allergic to the flea bites and will have severe dermatitis. Fleas can also transmit disease.

In cats, fleas can transmit Mycoplasma Haemofelis (formerly called Hemobartonella and Feline Infectious Anemia). This is a potentially serious disease for all cats but especially in cats already infected with Feline Leukemia Virus. The red blood cells become altered and the cat's immune system destroys the cells leading to anemia. Fleas can also transmit the bacteria responsible for Cat Scratch Disease (Bartonella). Dogs and people can become very ill from this disease. The clinical signs range from weakness and lameness to fevers and meningitis, as well as affecting internal organs.

Fleas transmit Murine Typhus to people. This disease is seen frequently in Southern California. Murine Typhus is a rickettsial disease caused by a type of bacteria called Rickettsia Typhi that is transmitted via fleabites. Fleas carry the bacteria in their feces, and often defecate while biting and feeding on blood. When a person is bitten by a flea and then scratches the bite, the bacteria from the feces can enter the wound and enter the blood stream. People become infected from fleas brought into the home by their pets, or by rats, mice and opossums carrying fleas around the home. Transference of the bacteria

through the eyes, nose, or mouth can also infect people, or inhaling crushed or dried feces of an infected flea.

So how do we prevent these fleas in the first place? The first thing is to use flea prevention year round whether you see them or not. Trying to put out a fire is harder than preventing one. It helps to understand the flea lifecycle and how the modern medicines work.

Fleas are like most insects. They have four life stages: An egg stage, larval or maggot stage, pupa or cocoon stage, and the adult. Only the adult stage lives on the pet and it spends its entire life of about 10 days to three weeks on the animal. During that time the female flea will lay about 50 eggs per day. That's 500 eggs from one flea. The eggs fall off the pet and hatch into the maggot stage. This stage can be as short as nine days. After molting, the maggots form a cocoon.

Once the flea reaches the cocoon stage it's almost impossible to kill. In fact, a flea in its cocoon can remain alive for over a vear and withstand heat, cold and drought. The covering of the cocoon is sticky and picks up all kinds of dust and dirt making them difficult


to see. The adult flea hatches from the cocoon when it senses movement, warmth and carbon dioxide. With 70-degree temperatures and 70 percent humidity, a flea can go from an egg to an adult in about 14 days. During the cold weather, the flea eggs and cocoons can take longer to go through their life cycle or may not hatch but they don't die. They can just sit and wait for the perfect weather and the perfect host to walk by.

Treat your pet year round with a professional medicine prescribed by your veterinarian. He or she will be able to recommend the best type of flea control for your pet's age, breed and health status. Avoid flea shampoo or sprays. These are marginally effective, can irritate skin and are potentially more toxic than newer products. Stay safe and see your veterinarian for more information about fleas.
