Transit Department to Purchase Bus Operator Simulator

A recommendation made by Transit Director Kim Turner to approve a federally required agreement between the City of Redondo Beach and the City of Torrance for the use of pass through Federal Transit Administration grant funds was given the go-ahead by the city council.

The unanimous vote by the Mayor and City Council also approved the purchase of a bus operator simulator at a cost of \$333,334, in addition to appropriating the funds necessary to pay for the project.

In addition to the FTA grant fund local matching monies will be used from the 2016-2017 Fiscal Year Municipal Operator Service Improvement Plan [MOSIP] without the need of any general fund resources.

"In January 2009, the City of Torrance and the City of Redondo Beach collaborated in an effort to seek federal funding for our respective transit center projects," states the staff report signed by Transit Director Kim Turner. "Redondo Beach's project was already in construction, while Torrance's project was in its initial research and development phase." Redondo Beach and Torrance received \$800,000 of earmarked money from former Congresswoman Jane Harman, which was a single grant that was to be split between the two localities based on project readiness. At the time, the City of Redondo Beach had it project in development so the FTA assigned it the lead agency and grant recipient. As a result, \$533,333 went to Redondo Beach and the remaining \$266,667 being assigned to Torrance. "Transit will use the funds to purchase a Bus Driving Simulator which will be used to train new Bus Operators and provide a refresher course for current Bus Operators on defensive driving skills," indicates the staff report. Simulators are priced between \$100,000-\$300,000 depending on the size of the platform,

all necessary programming software and hardware configurations.

"Staff will procure a simulator that best meets our training needs while staying within project budget," states the staff report. "Staff is attempting to align the procurement for the simulator with the grand opening of the Torrance Park and Ride Regional Terminal upon its completion, where the simulator will be installed and utilized."

City to Convert 3,075 Additional Acre Feet of Unused Groundwater **Pumping Rights to Storage**

The mayor and city council unanimously approved an additional expenditure commitment authorizing the use of \$281,000 from the Water Enterprise operating budget in order to convert 3,075 acre feet of fiscal 2015-16 unused groundwater pumping rights into storage. Also approved was a payment of \$870,225 to the Water Replenishment District of Southern California [WRD] for the payment of the groundwater replenishment assessment for the conversion to storage.

"What this item does is it allows us to take water that we don't use in the current year because of our limited pumping capacity and convert it to storage at the current price," said Public Works Director Robert J. Beste. "Between last year's allocation and this we are able to store a little more than 4,000 acre feet of water. In turn when we pump that water out, it will save the city about \$2 million."

The City of Torrance overlies the West Coast Ground Water Basin, which produces portable groundwater. The city has 5,639 acre feet [AF=326,000 gallons] of annual groundwater pumping rights; these rights were granted to

In 'Swiss Army Man' the First Fart Will Make You Laugh, the Last Will Make You Cry

Meet the Father of Lasik Surgery Who Loves L.A.

The scientist behind the discovery that led to eye-correcting Lasik surgery isn't just really smart, he's generous, too. If you don't know about Mani Bhaumik, it's probably because you don't work in a scientific field or keep books about theoretical physics

on your nightstand.

Dr. Bhaumik just donated \$11 million to the physics and astronomy department at UCLA to attract talented faculty and researchers. Bhaumik came to UCLA in 1959 — "with \$3 in my pocket," according to him, on a postdoctoral fellowship in physics. The people of his village in India raised the money for the airfare to Westwood.

"I thought I'd died and gone to heaven," he recalled, stepping on the campus. "Everyone was treated equally, not like back

at home where the poor were treated like dirt." The best-selling author of "Code Name God"

wants to advance knowledge of the basic laws of nature by establishing a world-leading center at the Los Angeles campus. His passion is for theoretical physics research and intellectual inquiry. Simply put, he is a cosmic detective looking for underlying explanations about the basic physical world.

"It's very difficult to raise funds for this area, because people don't understand what theoretical physicists do," he says. Physics is the study of energy, matter and how they relate to one another. Dr. Bhaumik and his colleagues make sense of the laws that govern the world. Think of them as cosmic sleuths, like TV's Columbo, in lab coats.

Conducting work in theoretical physics takes a Ph.D, however, understanding it does not. Dr. Bhaumik is a huge believer in making science more understandable for the general public and young minds. He co-created an animated television show called "Cosmic Quantum Ray" about an intergalactic team of heroes, including a brainiac kid from Earth, who save the universe from destructive forces using their scientific smarts.

His gift will establish the Bhaumik Institute at UCLA to teach the community about scientific advances made by UCLA physicists, in addition to welcoming scholars and holding seminars and conferences for academics. Faculty, postdoctoral researchers and graduate students at the Bhaumik Institute will address "unanswered questions in all areas of theoretical physics," according to UCLA.

of a research group led by a physics professor. His philanthropic passions are UCLA and making its physics and astronomy department a world leader in research, and preparing generations of theoretical physicists to follow in his footsteps.

> "Every moment of the day, we are touched by science and technology. I believe that we physicists can do a better job of showing how technology spawned by physics has affected all our lives," he said. Bhaumik was born in

a village in West Bengal, India, and as a child slept on rags in a mud hut he shared with his parents and six siblings. He walked four miles to school in bare feet because he didn't own a pair of shoes. "My

family didn't always know where our next meal would come from," yet he decided to pursue a good education.

He overcame his family's poverty conditions using intellect and a fierce sense of intellectual curiosity, an essential quality in a scientists. He earned a master's degree at the University of Calcutta and became the first doctoral graduate from the Indian Institute of Technology Kharagpur.

Bhaumik arrived at UCLA in 1959 on a postdoctoral fellowship in physics, in the early years of laser technology. He began his career in applied physics two years later at Xerox Electro-Optical Systems as a laser scientist, then became director of the laser technology laboratory at Northrop's corporate research laboratory. There, in the early 1970s, they harnessed a laser technology that is used for the vision-correction surgery known as lasik.

It was a form of ultraviolet laser for cutting biological tissue cleanly without damaging surrounding tissue. The surgery eliminates the need for eyeglasses or contacts for many people who undergo the procedure.

Bhaumik is a fellow of the American Physical Society and of the Institute of Electrical and Electronics Engineers and, in 2011, the Indian government awarded him the prestigious Padma Shri for distinguished service in science and engineering.

With previous donations to UCLA, he established the Mani L. Bhaumik Presidential Chair in Theoretical Physics and supported the work of a physics research group.

"I consider UCLA my home, and I want more people to learn about science," which is why he wrote the best-seller "Code Name God" and a followup book, "The Cosmic Detective." He hopes that his books, TV show and his philanthropy give the public a reason

LeBron Brings Title Back to Cleveland

The Cleveland Cavaliers became the first team in NBA history to overcome a 3-1 deficit in an NBA Finals series to become the 2015-16 NBA champions. LeBron James carried his team to Game 7 of the Finals that took place last Sunday afternoon, but the game itself was more about his teammates that stepped up and the players on the Warriors that had horrible games. When the game's final buzzer sounded, the score on the scoreboard read 93-89 in favor of the that may have saved the game. "I'm coming home with what I said I was going to do," James explained. "I can't wait to get off that plane, hold that trophy up and see all our fans at the terminal."

As great as James was with his averages and back-to-back 41-point games to even get the Cavs to a Game 7 in the first place, it was really his teammates that took the game over and gave James a ride on their backs in the final game of the series. Kevin Love resurfaced from the depths of the bench

Cavaliers. With the victory, James and the Cavs wrote their names down in the history books in many ways - one of which was by bringing a championship title to the city of Cleveland for the first time since 1964.

After a brief layover in Las Vegas on their way home, James and the Cavaliers arrived back in Cleveland on Monday morning. As he stepped off of the plane, James hoisted the Larry O'Brien trophy above his head, much to the delight of the 10,000-plus fans that surrounded. It was a moment that both James and the fan of Cleveland have all waited a lifetime to see. Finally, a championship brought back home to Cleveland. This is something that neither the Indians, nor the Browns, nor any other Cavalier team of the past has ever been able to do.

James was selected as this year's Finals MVP, and he was certainly deserving of the award and the main reason why his team reached the seventh and ultimate game of the series. Over the seven game series, James led both his team and the Warriors in every statistical category available. That's right, points, rebounds, blocked shots, steals and assists; if you can think of another category, he probably led in that, too. "Best player on the planet," his teammate Kyrie Irving said of him shortly after their Game 7 victory. James averaged 29.7 points, 11.3 rebounds, and 8.9 assists in the series. Almost a triple-double per game average. He was dominant. His field goal percentage was 53.3 and he became the third player ever to record a triple-double in Game 7 of the finals, joining Jerry West in '69 and James Worthy in '88. James finished the night with 27 points, 11 rebounds, 11 assists and three blocked shots, one of Andre Iguodala and the depth chart to add 30 minutes of gritty play. His 14 rebounds gave the Cavs a number of second chance opportunities and points that kept the Warriors from running away with the game early on. Likewise, J.R. Smith came through with two clutch three-point shots in the second half and not enough can be said about starting point guard, Kyrie Irving. His three-point shot right in the face of Stephen Curry with 53 seconds left in the game turned out to win the game the championship for the Cavs. Irving finished the night with 26 points and six rebounds. "All I was thinking at the end of the game was Mamba Mentality," Irving said, crediting Kobe Bryant and his killer instinct for the ambition to take such a shot. "Now we have our own parade. We'll celebrate it the way it's supposed to be celebrated in Cleveland."

As well as all the Cavs played, it was the main players on the Warriors - especially Curry - that let the game slip away. Harrison Barnes had 10 points, but was an ugly 3-10 from the field and was destroyed on defense for the entire game. Festus Ezeli found himself in the game as a starter, but should never have suited up for the Warriors in the first place. He was exploited and taken advantage of every second he was on the court, specifically by James midway through the fourth quarter when Ezeli inexplicably found himself in the game once again. Anderson Varejao tried to flop his way to a win, but three fouls and one point later found out that it wasn't working. Klay Thompson had an awful game, shooting 6 of 17 from the field and 2 of 10 from three-point range. Then there's Curry. Completely dominated by James since Game 5, Curry, the same

Up and Adam Saxons Baseball Sneaks Into Playoffs

The North High Saxons are the next team up on the list of recapping the 2015-16 baseball season. The Saxons had an up and down season this past year, but at the end of the day, they wound up experiencing just as good of a year as either of the two teams that finished in front of them in the standings. While the West High Warriors and the Torrance Tartars finished in first and second place, above the third place Saxons, neither team managed to make it out of the first round of the playoffs this postseason. For North High, the circumstances were the same. The team managed to sneak its way into third place at the end of this year's Pioneer League standings, just ahead of the South High Spartans, but like the two teams better than them in the standings, were ousted after the first game of the CIF Southern Section Division 4 playoffs.

It was difficult to decide what type of team the Saxons were going to be when the baseball season started this year. Two losses to Palos Verdes and San Pedro began the year, but two victories over Animo and Westchester quickly followed. It wasn't until the middle of March that the Saxons hit their lowest point of the season. Another loss to Palos Verdes led to seven more losses just like it. Before the Saxons knew it, they were towards the bottom of the Pioneer League standings and fighting to remember what it was like to win a baseball game.

League play finally began in the middle of April and a matchup with the Centennial Apaches was just the thing the Saxons and head coach Mike Neily needed. An 8-1 victory followed by a 25-2 victory quickly took North High from out of the dumps and gave the team some confidence again. The Saxons then stole a game from Torrance, wound up sweeping Leuzinger in a two-game set, and took one of two from South High in the last series of the regular season. All in all, it was an average year for North, but there was still one game that managed to remain on the schedule.


In what was the third straight game in four days between the two teams who ended the regular season with a matchup against one another, the Saxons (10-16, 7-4) and the Spartans (16-12-1, 6-5) were locked in the Pioneer League standings. The two teams were slated to meet up one last time to determine which would take third place and ultimately get a wild-card bid into this year's playoffs. Fortunately for North, it was the Saxons who got off to a fast start in the game. Vincent Rojas led the offense, driving in two RBIs, while Kyle Hatai put together two hits to get North off to an early 3-0 lead. The Spartans battled back with three runs of their own in the top of the fourth, but North came right back and put another three on the scoreboard in the bottom of the inning. Behind Michael Blomquist's two RBI game, the Spartans would rally again in the sixth inning, adding two more runs to their total, but ultimately, it wasn't enough. The Saxons came through with a fortunate 6-5 victory and a trip to this year's playoffs. "We had a great week," coach Neily explained of his team. "The players are suddenly coming together and playing exciting ball."

North hoped that the team chemistry and excitement would last for a deep, playoff run. Their first round opponent, the Alhambra Moors, had other ideas, though. Alhambra's starting pitcher, Gilbert Romero, was able to keep the North High offense quiet all afternoon. In his seven innings of pitching, he gave up nine hits to the Saxons offense, but they were only able to manage one run that came in the bottom of the seventh and final inning. Josh Carillo and Alexander Khatib both came off the bench and hit back-to-back singles in the inning before Ryan Tobias knocked Carillo home for the team's only run of the game. North's starting pitcher, on the other hand, struggled a bit, especially in the third inning. Jared Darocha walked two of Alhambra's batters when later, two defensive throwing errors would lead to those two batters crossing the plate.

"We killed ourselves in that one inning," Neily explained. "That hurt us, but the kids are resilient. It's a shame we aren't moving on." Alhambra would get one more on a sacrifice fly to take a 3-0 lead, but the damage was already done. The Saxons ultimately took the 3-1 loss and like West and Torrance, were eliminated in the first round of this year's playoffs.

The Saxons will lose some key players on their team from this past season to college like Jacob Northup, Ryan Tobias, and Dylan Hatai, but there is an overwhelming sense of optimism revolving around the team's young core. "I think the program is turning the corner," coach Neily said of his kids. "I think we have some young ballplayers that can turn into good varsity players."

We'll have to wait and see if the coach is right. The 2016-17 season will bring with it new opportunities and a chance for the younger kids on the Saxons to take what the team did this year and create an even better baseball team next season. •

Many years ago, I visited the National Archives Museum in Washington D.C. and saw the original Declaration of Independence with my husband, Dave, and our son, Christopher. I can still remember standing in front of that impressive document, moved by the words, passion, and history that forged a nation. The original Declaration of Independence is housed in the Rotunda for the Charters of Freedom in Washington D.C. Although it is 240 years old, I am told, with all due respect to Nicolas Cage and the film National Treasure, there is nothing on the back of the document but, "Original Declaration of Independence dated 4th of July 1776." But then again, I have never actually seen the back of the document.

This afternoon, I read the Declaration of Independence, including The Constitution and the Bill of Rights, mindful of the founding father's words. Powerful, brave, incredibly wise words. These are the words that founded a country. Our Declaration of Independence begins, "When, in the course of human events, it becomes necessary for one people to dissolve the political bonds which have connected them with another, and to assume among the powers of the earth, the separate and equal station to which that laws of nature and of nature's God entitle them, a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation. We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable rights, that among these are life, liberty and the pursuit of happiness..." How can that not bring a lump in the throat?

Studying the Declaration of Independence, Constitution, and the Bill of Rights in school was one thing, but re-reading the documents after living as an adult, and observing the world in all its complexities is definitely another thing. Our Declaration of Independence remains one of the most important documents of the age.

I am reminded with the 4th of July approaching, how very special I feel being a citizen of the United States. Celebrations all over the country hail our independence, variety, and spirit. When I was little, our whole family gathered at my Uncle Henry and Aunt Ginny, and Uncle Frank and Aunt JoAnn's property. They lived on a large piece of land with one house in the front for one family, and one in the back for the other family. My cousins (their children) had the run of the land, and on the 4th of July the property transformed into a huge park-like setting complete with a pool – one of those above-ground Doughboy's, a large barbecue area, lots of picnic tables and a badminton area where lots of games were won and lost. We would pick avocados off the trees and run around playing games. It was an idyllic Southern California 4th of July. My cousin Frankie, being very musical, would lead us all in patriotic songs, acting as the choral leader of children, aunts and uncles. The food was American fare, complete with potato salad, watermelon, corn on the cob, pie, homemade Southern California, most every family I knew had their own fireworks display. My daddy and uncles would set ours off for us, and thinking back, I am sure today's fire code would shut us all down! At the end of the 'show' we kids would twirl our sparklers in the air, writing our names in the air with the lit wands.

My guess is that old-fashioned 4th of July celebrations are still alive and well and most

Thinking back, there were around 57 of us, and that was just aunts, uncles, cousins and a few neighborhood kids that would come over for the fireworks. My good friend, James Ide remembered, "[I remember] my dad taking me and my brothers to find a fireworks stand, - legal or not. We always wanted the GIANT box, but we inevitably ended up with the sensible sized one. So I learned to love sparklers, Piccolo Petes, and especially black sulfur snakes. I remember spending most of the night trying to calm down the family dog...I do get verklempt when I hear Kate Smith sing 'God Bless America'." Jeanette Gross told me she is heading to her mom's house to watch the fireworks shot off the pier at the shore. Gail Shota said, "We usually BBQ typical all-American food - hot dogs, burgers, potato salad, corn cobs, watermelon, chips/dips, and apple pie. Depending upon who's home we are at, if sparklers are allowed we let the kids do that. It is one my favorite holidays. We all celebrate having freedom nationwide no matter what each ethnic background is. We are blessed to be able to live in this country."

I remember spending the day at Wilson Park by the gazebo watching hometown entertainment, ending with a fabulous fireworks display at night. The fireworks exploded right over our heads, as synchronized patriotic music played along with each boom. This year, the city of Torrance once again plans a fireworks display that will be 'launched' from the parking lot behind the Katy Geissert Civic Center Library at 9 p.m. Although the parking lot will be closed to the public, you may watch the display at the nearby Toyota Sports Complex at 599 Maple Avenue, which will open at 7 p.m. Free tickets are required for viewing at the Sports Complex. For more information access TorranceCA.gov/fireworks. And, possibly for the last time, the Briles family will delight residents with a fireworks display off Torrance Beach at 9:30 p.m. Although Jackie Briles died at age 95 on March 30, the family will host the fireworks off Torrance Beach on the barge in honor of Jackie, one more time.

Our Declaration of Independence, Constitution, and Bill of Rights are the building blocks on which the United States was founded. As we celebrate the 240th birthday of our beloved country, may we never take the ideals and principles which our Founding Fathers wrote, or our country, for granted. Happy 4th of July!

showed they were more than capable of showing the world the best of humanity. My hope is that what happened in Orlando and our response to it compels others to find ways to work together to overcome hate, intolerance and injustice. Incredibly, we've already begun to hear from those who say that what has happened here and how our community has responded has sparked a change in their hearts.

My hope is that we will be remembered, not as the city where a horrible shooting took place, but as the city that showed others that love can conquer hate. In June of last year the council approved the conversion of up to 3,300 AF of unused groundwater pumping rights at a total cost of \$884,000. [TMW] was able to "bank approximately 1,098 AF into CU storage."

"Agencies that elect to store unpumped rights pay the WRD's prevailing replenishment assessment at the time of conversion, and this amounted to an expenditure commitment of approximately \$294,300 for last year's CU storage, which leaves an authorized expenditure of balance of approximately \$590,000," states the staff report.

Beste confirmed that the current price for pumping is about \$283, which when combined with power and other associated costs to pumping water reaches up to \$500 when compare to an acre of imported water. In fiscal 2015-16, TMW will be able to bank 3,075 AF of unused pumping rights into CU storage.

"Storing water has both financial and reliability benefits," states the staff report signed by Beste. "It is highly beneficial to subscribe the maximum allowable amount of unused pumping rights to storage as expediently as possible to minimize any loss of pumping rights."

"Once unused pumping rights are converted to storage they are 'banked' in the applicant's storage account and can be extracted at a later date when needed."

Agencies can store up to 200 percent of its APA and for Torrance that translates to 11,278 AF. For TMW to store its maximum eligible amount of unused carryover pumping rights, it will require an additional \$281,00 in above the original authorization of \$884,400 as approved last year. •







Grilled Flank Steak with Grapes and Stilton



Makes 6 servings

Ingredients

- 1 flank steak (2 pounds)
- kosher salt
- freshly ground black pepper
- 1 1/2 tablespoons red wine vinegar
- 1 tablespoon chopped shallot
- 1/4 teaspoon Dijon mustard
- 1/4 cup extra-virgin olive oil
- 2 bunches (8 cups) watercress, trimmed

- 1/2 cup crumbled Stilton or other blue cheese
- 2 cups red California grapes, halved

Preparation

- **1.** Heat grill to high and oil grates.
- 2. Sprinkle steak with salt and pepper.
- **3.** In small blender or food processor, combine vinegar, shallot, mustard and olive oil to make dressing. Season with salt and pepper, and puree until smooth.
- **4.** Grill steak until it reaches 130 F for medium-rare, about 6-7 minutes per side. Transfer to cutting board and let rest 5 minutes.
- 5. In large bowl, combine watercress, salt, pepper and enough dressing to coat. Thinly slice steak across the grain and transfer to platter. Top with watercress, Stilton and grapes, and serve with additional dressing.
