## Ads Stay Aloft: In-The-Air **Beach Advertising to Continue**

The Torrance City Council decided (6-1) to allow airplane advertising banner towing company Aviad to continue operating out of Zamperini Field. The June 17th meeting pitted those concerned with maintaining a business-friendly atmosphere in the city against opponents more concerned with noise issues. Facilities Operations Manager Shant Megerdichian explained that based on prior direction from the Council part of the extension of this contract is that Aviad would be up for review each year in October at the Airport Commission, with serious issues coming up before the Council. "October was chosen because it is right after the peak banner towing season of July, August and September and this would allow the Airport Commission to have a review right after those peak months on Aviad's performance," said Megerdichian.

While the Council has received numerous e-mails on the issue, only one Torrance resident spoke during the meeting, Richard Root. Root was opposed to continuing to allow Avaid to tow banners out of the city's airport, saying that banner flights have a longer durations than other flights and are unlikely to abide by the Federal Aviation Administration's suggestions for noise abatement. "It's hundreds of hours of flight," said Root. "That's a lot of noise in the community."

However, Council member Bill Sutherland was concerned about dwindling business opportunities at Zamperini Field. "I do realize that airplanes make noise. Motorcycles make noise, cars make noise. Maybe we're all used to noise, but we just lost a business at Torrance Airport due to noise," said Sutherland. "At some point we're going to keep on losing businesses if we keep on saying, 'I can't allow a plane to fly over the beach.' I don't want to drive out businesses." Ultimately, the Council

approved the item, with only Councilmember Kurt Weideman opposed.

Also during the meeting, Mayor Frank Scotto asked the Council for agreement to have city staff approach car sharing company Car2go with concerns from Torrance residents. Scotto specifically asked them to address the locations where cars are being parked as well as length of time is take them to move cars out of the city. Currently, the police department is following up on complaints by marking cars and towing any that haven't been moved in 72 hours, but Scotto would like to see the city work with the company to keep the cars out from in front of private residences. "We can suggest a number of places that would be . . .

a better place to park instead of in front of people's homes," said Scotto.

While the city of Torrance has been in negotiations to allow the car sharing service to operate in the city for years, they failed to come to an agreement. Car2go wanted exemptions from parking regulations that the Council weren't willing to concede to the company. Instead, Redondo Beach approved a trial agreement with the company which included operations in Torrance outside of areas with restricted parking. In order to do that the company is paying a business license fee, but other than that Scotto was clear to reiterate that the city hasn't made any deals with the company. "The city of Torrance

## **TUSD Creates Funding Design** for Local Accountability Plan

After numerous meetings with parents and school staff members, the Torrance Unified School District presented its latest draft of their Local Control Accountability Plan (LCAP) to the Torrance School Board during the Board's June 16 meeting. The LCAP is a mandated part of the budget process that was approved along with the Local Control Funding Formula (LCFF). Instead of accounting for a wide variety of categorical funding that could only be used for certain programs, LCFF collapses that funding into three types of grants with the LCAP guiding how these three grants are spent. The first of these is the base grant: all districts receive a base grant, which is given to all districts based on the number of students the district

serves and has fewer restrictions attached to how the funding is utilized.

Beyond the base grant, districts can receive a supplemental grant to be used to support additional support for impoverished youth, foster youth and English learning students. Each student that falls into one of these three categories (no students are double counted) add to the increased funding the district receives from the state. District staff estimates that the district will receive just over \$5 million in supplemental grant funding. Lastly, if a district is made up of 55 percent or more of students that fall into these categories, then that district will be entitled to a concentration grant. TUSD is expecting a base and supplemental grant, but

not a concentration grant, with its population of targeted students resting at about 33 percent.

The LCAP explains how the district will use these grants to meet the goals like improving implementation of the Common Core State Standards or increasing parent involvement over the next three years. Chief Academic Officer Time Stowe said that while it is a three-year plan, it will be revisited on an annual basis to make sure it is still serving the goals it claims to be addressing. "We're going to analyzing this and evaluating this on a constant basis," said Stowe. "Next year it'll still be a three-year plan we'll just take off the goals we had for this year and add goals for the following years."

Creating the district LCAP is an involved process. The first mandated step of the process is having district staff hold meetings with parents, teachers and administrators. In addition, TUSD staff expanded their outreach to meetings with the Board created Parent Advisory Committee and the district's various District English Language Multicultural Advisory Committees (DELMAC). The questions and comments from these meetings

are required to receive a written response from Superintendent George Mannon. Stowe said the top concerns of these stakeholders was providing intervention support and behavioral counseling for students, professional development for teachers, and making efficient use of resources and technology. "We've received a lot of input from the parent advisory committee," said Stowe. "As we met with each group we talked about the need to maximize student achievement... all of the groups that we met with had a good focus on that and gave good ideas."

After compiling this guidance into a document, this June 16 meeting marks the next step in the path to adopting the LCAP. During this meeting the Board held a public hearing to seek input from the community – although no one took the opportunity to speak up. Following this meeting, the LCAP will be brought to the Board as a final product on June 30 concurrent with budget. Once the Board approves it, the LCAP will be posted on TUSD.org and submitted to the state for approval. Torrance also has one non-mandated

## Correcting a Misleading Number

I wanted to point out a misleading number in the June 5th edition of the Tribune. RE: Election results it states the number of votes cast was 52,478. That would be a 65.6% turnout. That is technically true.

That would be a wonderful turnout. I think you added the votes cast for Council together. People could vote for 0-4 candidates so it is misleading. Using the Mayor race as an example where people could only vote for 1, the count is 19,505 or 23.5%, which is more realistic. This is the number of voters as opposed to the votes cast in a 16 candidate race.

The voter count is imperfect until the total

votes are counted and certified in early July. I suspect the 23.5% is very close to what the turnout was. Still, less that 25% of the eligible voters bothered to vote. That is a sad statement.

Samuel Adams, American statesman and Founding Father, said, "Let each citizen remember at the moment he is offering his vote that he is not making a present or a compliment to please an individual--or at least that he ought not so to do; but that he is executing one of the most solemn trusts in human society for which he is accountable to God and his country."





## Family Business in Empanada Heaven

In most instances, a successful longstanding business will also offer an interesting backstory especially if the road to starting out was completely unexpected. Such was the case of Roberto Mortara, who has owned the Continental Gourmet Market in Hawthorne since 1980. A native Italian whose family moved to Argentina when he was a child to escape the ravages of World War II, Roberto eventually moved to the United States to make a better life for himself-first in New York in the early '60s before ultimately settling in Los Angeles because he didn't like The Big Apple. He chose engineering as his career path and his resume included a stint working on the Concorde SST, the supersonic jet of which only 20 were made. Another gig involved designing a wheelchair and Roberto ended up having an argument about how the rotation should go. "After that, he decided he was never going to work for anyone again," said Sergio Mortara, Roberto's son.

So did Roberto go on to start his own engineering firm? Not quite. Instead, he bought a pizzeria in Los Angeles on Hobart and 3rd because "the price seemed right." Realizing he had zero experience in the restaurant business and no crew to boot, he flew back to Argentina and spent a month soaking up every bit of information and advice he could muster from six successful pizzeria owners. The trip proved fruitful. Flash forward five years and Roberto had launched another seven locations. He then opened La Traviata in Hermosa Beach and during this period heard about an opportunity to purchase a rundown little grocery store on Prairie in nearby Hawthorne. Thirty-four years later, Continental Gourmet Market is a community

landmark and a destination for shoppers looking is wonderful and has some voice, but it's not for hard-to-find products from Latin American countries such as Argentina, Peru and Guatemala.

Now in his eighties, Roberto only works at the store part-time--though he is still very involved with the business. The day-to-day operations

of the place now fall under the steady hand of Sergio, who has run Continental Gourmet Market with his wife Sandy since 2004 and taken it to the next level. An eight-year community resident married with two young children, Sergio Mortara was elected to the Hawthorne School Board in 2013. "My son [now three years old and he also has a nine-month-old daughter] will be going to school across the street from us, so I wanted to get a head start," Sergio explained of his desire to serve. "PTA

Sergio said. "But that's actually a good thing."

Though it wasn't that way in the early years, Roberto eventually transformed Continental Gourmet Market into a destination for specialty and nostalgic products from Central and South America. The deli counter features hard-to-find, labor-intensive delicacies such as Matambra (an Argentinean meatloaf). The butcher section has just about every specialty cut from Argentina you can imagine—from vacio (flap meat) to tiras de asado (three-bone short ribs),

as well as the popular chorizo and morcilla (blood sausage). "We're very selective with our meats and only carry choice or prime," Sergio noted. Pricing is also unusually reasonable considering the quality. For instance, a recent display showed some tempting T-bone steak at just \$6.29 a pound.

The market also carries an interesting selection of Argentinean and Chilean wines, cheeses, fresh-baked breads, cookies and pastries, plus Peruvian ice cream, among other selections. Of course, one can also shop for "regular" household sundries and groceries as well as fresh produce. As small as the place is, it's surprisingly well-stocked.

But the item that has truly put the market on the map is its signature empanada. A stuffed pastry that is a staple in Argentina, empanadas are made by folding dough around a filling that usually consists of some type of meat, cheese or vegetable. Baked daily on the premises, Continental's empanadas have earned acclaim across the region with customers as far away as New Jersey—not to mention the Marine son of a Herald Publications sales representative who takes home a box to his Camp Pendleton buddies every Monday. The empanadas even drew the attention of Food Network star Alton Brown, who stopped by in late 2012 to sample the goods for his show. "The empanadas took off in 2010/11 after we decided to focus on them," Sergio said. "A lot of items we have you can find at other Latin specialty markets, but not empanadas."

While staying mostly true to his dad's original recipes, Sergio does like to make tweaks to the specific blend of flour and spices and

In the wake of their first-ever championship in school history, there has been much to reflect on for head coach Ollie Turner, pitcher Kyle Smith and the rest of the Torrance Tartars baseball team. Ascending to the top of a consistently tough Pioneer League in the city of Torrance is never an easy thing to do. This year alone, the two teams who played in the CIF championship game finished first and second, respectively, in the Pioneer League (South High and Torrance High). The strength of schedule and intense competition that is prevalent year in and year out makes winning a championship that much harder. This year, though, the Torrance Tartars did just that giving light to the great players and great team that took the field for Torrance High every week this year.

The Torrance Tartars baseball team has been to the CIF Finals before. Once in 2009 and again in 2010, losing both times in heartbreaking games. Fast-forward to 2014 and coach Turner knew that he wasn't going to relive the pain of losing in the championship game again. One big reason for his team's success was Kyle Smith. In High School baseball, a pitcher is only allowed to throw a maximum of 10 innings in one week in an effort to try to preserve their arms. Smith had already thrown previously in the week when the Tartars beat the Laguna Beach Breakers by a final score of 4-3. Smith only pitched two innings of work in that game, allowing just two hits and striking out four, giving him enough innings to go the distance in the championship game.

Smith didn't only go the distance. He struck out 12 batters and allowed only two hits in an amazing performance that got his team the CIF Southern Section Division IV championship and brought him Player of the Year honors. "It just feels great to do it for our team and for all of the Torrance teams in the past," Smith said. "It feels great to bring it home." Smith brought it home by going a remarkable 13-1 this year on the mound for the Tartars with an ERA of 0.46. Insane numbers for a kid who is going on to have a

remarkable baseball career in college and what certainly looks to be beyond in the pros as well. In 89 innings this year, Smith had 115 strikeouts while only walking 16. Torrance pitching coach, Terry DeWan, had nothing but praise for his 5-foot-10 senior pitcher. "We've had a lot of great pitchers here, and Kyle has had the ability to focus like no one. When he was on, he was immensely focused and got even better when runners were in scoring position." Smith's focus got even better in the playoffs. His postseason numbers can be a testament to that. Smith threw 24 shutout innings of playoff ball while recording four victories in four games for his team.

Where would any great player be without a great coach? Torrance's Ollie Turner knows baseball, there is no doubting that. After 10 years as the head coach of the Tartars baseball team and an ability to not only get the best out of his players but to also make it to the tournament for the championship, Turner finally broke through. Turner didn't just win, but he destroyed his league and inter-city rival, the South High Spartans, by a final score of 11-0 to capture the school's first baseball title ever. "It's so hard to get here, it's such a struggle," Turner said. "I'm enjoying it on so many different levels." For such a hard task to accomplish, Turner has certainly made it look easy in the past. The only difference is that this time, he didn't just get there, he took the championship home with him.

Perhaps the greatest part of the Turner's run as a head coach this year was his ability to get the most out of each and every one of his players to the point where everyone had a hand in capturing the final victory of the season. From pitchers like Smith, or offensive specialists like Manny Olloque, to even Billy Bryant, who capitalized on his speed and keen base running abilities, every player on the team had a part in bringing home the championship. "It's just cool how everyone contributed," Turner continued. "Everyone did their part and that's what you need to win a championship."

Throughout my years of living in Torrance, I have heard a particular name pop up quite frequently with regard to everything from the arts and history to philanthropy. That name is Jerry Ronan. The other day I made an appointment to visit with Jerry in his lovely home in the heart of Torrance. It was evening and the cool chill off the ocean hadn't quite made it to the center of the city as I walked up the path to Jerry's Spanish style home. The red front door opened and Jerry welcomed me into his home with a smile. Stepping down into the large living room a sculpture of Don Quixote caught my eye and I couldn't wait to speak with Jerry.

Eighty-eight years ago, Gerald Thomas Ronan was born in Fort Pierre, South Dakota. He was the sixth of nine children born to Thomas Stephen Ronan and Maggie Ronan. "There were [only] seven hundred people [in the town] when I was born, so I know about small towns," said Jerry. Jerry told me he had many brothers and sisters and they all respected each other's things, never felt cramped, and never borrowed from each other. His mother, a "Martha Stewart before her time" had charge of them all quite nicely. He told me they never really quarreled.

After turning eighteen in 1944, Jerry was drafted right after high school into the Navy during WWII. "In May I took my physical, was sworn into the Navy - got home from the physical on prom day - of course I was standing 7-feet tall. I was in the Navy two years. I was a yeoman - Ships Company. They sent me to Yeomen's school - they call them feather merchants. Their insignia is the crossed feathers - the clerks, the office people. I had taken shorthand in high school thinking I could get a job with that – and typing," said Jerry. The navy sent him to school in San Diego right after boot camp at Farragut Naval Training Station, in Bayview, Idaho. "I fell in love with California. Again, a serviceman - you would just go on the road and raise your thumb and you got a ride. You didn't use public transportation. People picked you up. It was incredible. It was another time in history. You could stand in a line to get on a train, or whatever, and you'd be there maybe for hours and you'd leave your bag and go to the restroom and people would look out for it and it would be there when you came back," explained Jerry. "Or there would be a service wife with a baby and sailors would be picking it up and passing it around 'cuz they had one at home and it was just - everybody was in this thing together - and everybody connected with each other," added Jerry. Jerry shared his memories of another time in California when it was quieter and simpler. He said the rationing and hardships during the war turned into opportunities for bonding with others 'in the same boat.' One time his sister went to the movies during the war years carrying her

admission, which happened to be a tire. Jerry served in the Navy until August 1946 and then worked for a year at the First National Bank in Pierre, South Dakota. Later, he decided to go to school on the GI Bill at Creighton University College of Arts & Sciences, graduating with a BS in History in 1951. Jerry continued working for the bank but later decided

he wanted to see Europe, so he left and headed on his adventure onboard the Queen Mary.

"I got a job in Europe with the American Engineers negotiating real estate leases and I stayed two and a half years. Salzburg, Austria was pretty much my [base]. I love that city, it's like home. I lived at the Bristol Hotel for part of the time and then I moved into the Nonnberg Convent which was built about the year 700 [AD]. There was an American woman who lived there that I knew and she was leaving and I wanted to live up there. Now they [the nuns] were very leery about living with an American man, but I convinced them. It's convent where Maria Trapp did her novitiate. In her book she says there are 145 steps up to the convent and I counted 143 – we disagreed - two steps," laughed Jerry.

Moving back to Pierre after two and a half years in Europe seemed natural for Jerry because he was, coincidentally, coming home and standing up as best man at his friend, Dick's wedding. Jerry taught High School English and history in Lemmon, South Dakota, but soon left for California. "You know the tough thing in life is transitions. I have never been involved in anything that I wasn't happy doing. And then you have to give it up and move to the next thing – leaving friends and routine and experiences and you don't know what's on the other side. . . . I loved the Navy, I loved college. . . . My folks had moved to California so. . . . " said Jerry.

In 1955 Jerry found himself interviewing with the Torrance Unified School District for a job at Torrance High School teaching history and English. He interviewed on a Friday and started teaching on Monday. Jerry found a place to rent near the school and began teaching with a salary of \$3850 per year. And that was the beginning of a thirty-seven year career teaching at Torrance High School when the big eateries were Ding How, Buffy's and George's Meatin' Place (apparently George's used to be a butcher shop). There were piano bars around Torrance and the South Bay and Jerry told me that Jack Jones and Andre Previn used to play at the local spots. Amazing! "Torrance was a little town," added Jerry.

Jerry Ronan told me he didn't retire in 1992 after teaching and I believe him. "I have

never owned a car. That is probably my most distinguishing feature. [It] is way down low on my priorities. There is no way you could go to college and afford a car – I couldn't. And I wanted to go to Europe. And when I was out of Europe – I was saving money – then I wanted to buy a house," confessed Jerry.

Actually, this shocked me and I proceeded to ask Jerry how he goes to the grocery store without a car. Let's just say this man is in great shape. He uses shuttles when he travels to the airport and public transit for museum visits downtown. He rode a bicycle until he was hit by a car.

Jerry is very active. He was president of the Torrance Cultural Arts Foundation, on the board of the Torrance Historical Society Museum, on the school committee at Nativity Catholic School, and a volunteer with the L.A. Philharmonic Volunteers, who are involved with AMSOV (American Major Symphony Orchestra Volunteers). In 1994, Los Angeles hosted the AMSOV conference and Jerry created an early morning walking tour of Downtown Los Angeles which developed into a walk he calls "Six in the City." He uses it as an auction item for fundraising and also takes friends from out of town on the tour. It is a big hit and covers highlights of L.A. including the Cathedral, Central Market, Pershing Square, the Music Center, Public Library, the Bradbury Building, Angels Flight and many more. Jerry rides Torrance Transit so frequently he 'starred' in the City of Torrance video showing off the new busses. Jerry was picked up at his home by Torrance Transit! Now, that is service.

Jerry Ronan volunteers and gives back to the community of Torrance and the South Bay every day. He taught thousands of students at Torrance High about the history of our world.

"To me it's a small town and I try to support things. I am very interested in TAM (Torrance Art Museum) and Gia [Inferrera] and TTC (Torrance Theatre Company) do an incredible job. She just

attracts talent," said Jerry. Additionally, Jerry paints, does needlepoint, cooks, and bakes bread. He told me his favorite thing to bake is bread. "The one I make all the time is whole wheat and flax seed meal. Throw in a half cup of flax seed meal in and it's very healthy. Get the meal and dump it in with your flours. I made one with two cups of milk, honey, and molasses, half a stick of butter, half teaspoon of salt and the flax seed. I have been using a white whole wheat. It is ground like white flour. Then I make a Vienna bread that I like," said Jerry.

Jerry proceeded to share a couple more recipes with me and I promised to share my 7-grain bread recipe with him. I was just about to leave after Jerry showed me his needlepoint

and painting when he opened up a hutch in his bright breakfast room and handed me a Meissen demitasse cup and saucer. Not to look at, but to keep. I was overwhelmed and deeply touched by the generosity of this kind, sweet, Renaissance man. Jerry Ronan continues to give of himself in Torrance and everywhere he travels. Torrance is the kind of city it is because of citizens like Jerry Ronan. •

he can't share particulars when it comes to the ingredients or, as they say, he "might just have to kill you." For the spicy beef empanada (the other varieties at the Hawthorne market are beef, chicken and spinach and each is "stamped" with an ID), he is especially driven to perfectionism. "I want it to be when you bite into it, you say, 'Ah, okay," and you don't realize it's spicy, but then it kicks in." A few bites of the spicy beef proved his point—it did kick in, prompting several swigs from the water bottle. But it was worth it. This and the other varieties are outstanding empanadas and as good as you'll find, with perfectly baked crusts and all-natural fillings bursting with complex flavors. At just \$1.49 each and \$14.99

for a dozen, they are also a bargain.

You can find other empanada options (including ham and cheese and pomodoro) plus a full menu of sandwiches, pizzas, pastas, salads and more at Continental Gourmet Market's second location opened in Lomita two years ago that provides a sit-down restaurant experience. You may also notice some subtle differences in the empanadas between the two locations. While the Hawthorne market uses a four-burner oven for its baking, Lomita utilizes a pizza oven. Sergio was pleased to report that the Lomita spot has succeeded nicely despite initial reservations from Roberto. "He didn't think I could pull it off-the place is hidden, but I wanted to see if our product could become a

destination and it has," Sergio said.

Empanadas are not the only items that consume Sergio. "I tried 12 different flours to bake the perfect cookie," he said. He may have succeeded, though he will never rest on his laurels. "We use only natural ingredients—butter, sugar, salt and flour." Cookies such as pepas (which also feature a quince filling) crumble delicately and melt in your month. The Peruvian alfajores with dulce de leche and coconut provide an understated elegance in every bite. These are some serious cookies, folks.

Now that he serves on the School Board, Sergio has noticed more teachers coming into the market as well as neighbors who didn't even realize the place existed before. "It has helped," he said of his position. "But when I look at my dad and all the hard work he put into it, more than 30 years later all of it paid off. People may see me around town and say, 'That's the empanada guy,' but it's not me—it's him [Roberto]..."

additional step. While not required by the state, TUSD is asking each school site to create it's own LCAP-style plan for their individual school. These site-specific LCAPs will replace the district's current method of creating a Single Plan for Student Achievement at each school. Stowe said they will "mirror district goals and objectives" and used to ensure groups like school site councils get a say in student outcomes and funding. "[It] will drive the funding that they get and how the use the funding," said Stowe. "We want to mirror at the site level what we've done at the district level. We feel that the process

has been very powerful. We've been able to seek community input and input from all the different stakeholders in the community and their ideas have been incorporating into the goals that we've developed and put into place."

While the LCAP and the district budget are closely tied together, Mannon wanted to be clear that the goal of the LCAP isn't to be a repositiory of numbers, but something parents and district staff alike can use to see what the district's goals are and how they know if they've achieved them. "The Governor's vision in this is to tell a story," said Mannon. "His vision is not to have a document that is anything close

to a budget document. This is to be a story of what you're doing with students in your district." While the Board wasn't completely satisfied with the document - Board member Michael Wermers asked to see a version with increased gifted education funding - Board member Don Lee expressed that the process local control to the district's accountability plan. "This is what we've talked about wanting to have," said Lee. "We own all the outcomes now." •

has not entered into any agreement with Car2go. No fee is being paid to the city of Torrance other than a business license fee under the category of equipment rental," said Scotto.

The Council also approved an extension to another contract, its agreement with Allied Waste, which transfers the city's waste to landfills outside the area. Sanitation Services Manager Matthew Knapp said that in addition to extending the contract, the city also negotiated for lower rates which the staff report calls "an unprecedented cost saving benefit to the city" and based on the current tonnage of waste processed through Allied Waste would save Torrance \$123,660 per year. The waste transfer company also agreed to forgo a consumer price index (CPI) adjustment planned for July 2014, delaying a CPI adjustment until July 2015. "We were doing this looking for a reduction and in this case we were able to get one," said Knapp.

City staff compared Allied Waste's offer to a quote from their competitors Waste Management who were nearly \$350,000 more expensive. The new contract will be a three-year term with two optional one-year extensions. Weideman was pleased that the Knapp and his staff found creative ways to reduce costs for the city. "I really think this is really excellent work on your part and your staff's part," said Weideman.

Lastly, Melissa Wright and June Lee invited the community to greet Mike Viti as he stops at Seaside Heroes Park as part of his 7,100 kilometer hike from DuPont, Washington to Baltimore Maryland in memory of the American service members who have given their lives as part of the struggle against terrorism. The distance of his hike, 7,100 kilometers, corresponds to the number of military personnel that have been killed in the recent conflicts in Iraq and Afghanistan and he will be dedicating one kilometer each to an individual service member, whose name he will add to a flag to be presented at the Army/Navy football game on December 13, 2014. "The goal of this project is to honor the legacy of our nation's heroes and rally support for their families who are and will be saddened by their sacrifice," said Lee. Currently, Lee and Wright are expecting to great Viti the morning of Sunday, June 29th. However, because Viti is traveling on foot, this is just an estimate, and Lee and Wright encouraged community members interested in wishing him well to stay up to date via his website and Facebook.


