Only Safe and Sane Fireworks Allowed on the Fourth of July Celebration

The Lawndale community has allowed "safe and sane" fireworks for more than 10 years and each year the warnings continue to be circulated about the penalties when illegal fireworks are brought into the city for the Independence Day holiday. This year, when Friday, July 4th dawns, the Los Angeles County Sheriff's Department deputies, the Los Angeles County Fire Department, and the city officials are working together to keep the residents, and, of course, any of their holiday visitors safe from illegal fireworks. There have been booths all over the city, staffed by approved nonprofit organizations chosen in a lottery, where the legal, safe and sane fireworks have been selling.

Any witnessing of the illegal fireworks should be immediately reported to the Fireworks Hotline at (888) 654-FIRE (3473). The Sheriff's deputies will have added patrols in the city of Lawndale and the fire departments all over Los Angeles County will have full crews on duty through the holiday weekend. Any purchased safe and sane fireworks have been approved by the State Fire Marshal and are marked as such with registered mark from the state. Any and all other fireworks are illegal and use of these is a violation punishable by a minimum fine of \$500.

The use of the illegal fireworks is a misdemeanor and the fines could increase to \$1,000. However, the penalty could also include up to one year in the county jail, or both.

The possession of and the use of illegal fireworks involving a pound or more of them is classified as a felony is punishable by

incarceration in the state prison system up to one year and/or a fine up to \$5,000. Even the safe and sane fireworks have cautionary warnings about their use. These fireworks are for outdoor use only. The lighting of fireworks should only be done one at a time. All fireworks should be lit away from buildings, vehicles, and barbecues. Be extremely careful in the drought conditions we are experiencing to not light fireworks on dry grass or any grass. Have a bucket or water ready for any emergencies and for dousing misfired fireworks. A separate bucket filled with water should be used as a receptacle for used/spent fireworks. Never attempt to relight or fix any malfunctioning fireworks. Never dismantle, take apart, or alter any fireworks.

Never under any circumstances should fireworks be handled by children. All fireworks should be lit and handled by adults only at all times. No fireworks should ever be pointed at or thrown toward another person. Many injuries are sustained by the mishandling of fireworks, even the safe and sane allowed ones. Burns from fireworks can be extreme and difficult to treat. Fireworks can cause injuries such as loss of fingers, hands, arms, toes, and feet, and can also affect eyes and faces. Any injuries caused by a person mishandling fireworks are punishable by fines and jail. In addition, any damage caused by a person handling fireworks becomes the financial responsibility of the perpetrator. Fines and jail are the punishments risked if fireworks cause a fire.

Do not possess or attempt to ignite fireworks that explode, rise in the air, moves about the ground or are labeled as Sky Rockets, Bottle Rockets, Roman, Sky Rocket Mortars, Fire See Fireworks, page 10

California Legislature **Kicking into High Gear**

The Torrance community is catching its breath after a busy and exciting election season; however, the California legislature is kicking into high gear. Politicians continue to make painstaking decisions on another minimum wage increase and mandated paid sick leave for part-time employees.

California is well over halfway through the 2013-2014 legislative cycle. The end of May marked a key deadline in the legislature as all non-tax related bills were required to pass out of their House of Origin or face termination. The legislature is under the gun as they begin a summer recess period commencing July 4 and ending on August 3. Following the recess, California legislators will have only four short weeks to make final decisions on the myriad bills still in limbo. If a bill's fate is not determined by the August 31 deadline to pass all bills for this legislative cycle, then it will no longer be under consideration.

With the recess looming, our legislators were hard at work in their respective policy committees as the June 27th deadline for all policy committees to meet and report bills approached. Many eyes were watching the legislation authored by State Senator Mark Leno, of the 11th State Senate district, attempting to raise the California minimum wage for the second straight year. Just last year, the legislature voted to increase California's minimum wage to \$9.00/hr beginning July 1, 2014, and to \$10.00/hr on January 1, 2016. Sen. Leno's bill, SB 935: Minimum wage: annual adjustment, sought to expedite and increase the current law to reach \$11.00/hr on January 1, 2015 and eventually \$13.00/hr on January 1, 2017. The bill would also require the wage to continue to increase according to the Consumer Price Index. Although the

Another closely watched bill, AB 1522: Employment: paid sick days, authored by Assemblymember Gonzalez of the 80th State Assembly district, is seeking to mandate employers to provide paid sick leave for part-time California workers. The bill, which was passed out of the Assembly this past May, is still alive in the State Senate as the legislation recently passed out of the Senate Judiciary committee: however, it did not pass unscathed. The bill originally required employers to provide paid sick leave to parttime employees who work a minimum of seven calendar days in a year; however, the bill was amended in the Senate to require employees to work a minimum of 30 days in a calendar year to receive the paid sick leave benefits. Following the amendment, the bill was re-referred to the Senate Appropriations committee where it will continue to be reviewed and subsequently voted on by

With another busy election season only a few months away and the August 31 legislation deadline rapidly approaching, the Torrance community will be keeping a close eye on the policy decisions of our lawmakers. In order to help guide the community through this multifaceted and often confusing legislative process, the Tribune is excited to announce our new Governmental Affairs column. 



For the Fourth of July I wanted to give you an All-American recipe. When I started thinking about what is really American food it wasn't as easy as I thought it would be.


There are very few real American food items. Because we all really came from other countries, the American kitchen is a blend of the world.

About 20 pieces of thick bacon cut in half 20 6-inch bamboo sticks




Directions

A Draft Rolled In

For the first time in more than two years, the Los Angeles Lakers and their fans finally had something to be happy about. Last Thursday night in the NBA draft, the Lakers, with the seventh overall pick, were able to select one of the best prospects coming out of College: Julius Randle. Randle, previously of the Kentucky Wildcats, has

championship experience, albeit on the college level, when he and the John Calipari-coached Wildcats won the NCAA's National Championship this past season. Certainly, Randle isn't the answer to a Lakers team that had its worst year in franchise history last season, but it certainly is a start. With only four players currently under contract on the Lakers roster, Randle will be a welcome addition and be a small factor in enticing the most popular players of this year's free-agency to take their talents to Los Angeles.

Randle isn't the kind of player who is going to set the league on fire like LeBron James or Kobe Bryant did. He doesn't have the skill-set of the draft's two headliners, Andrew Wiggins and Jabari Parker, either. Randle, however, is a bigbodied bruiser that will give the Lakers quality minutes in the paint and quite possibly be the foundation for a Lakers team that is in desperate need of rebuilding. The thing that will make Parker a good fit is not only his passion for the game, but his passion for the Los Angeles Lakers. "It was a humbling experience," Randle said of stepping on the court for his pre-draft workouts with the Lakers. "[I'm] the biggest Lakers fan," he continued. "Probably more of a Kobe fan."

Good news for Randle. The 19 year old, 6'9" 250 pounder who averages 20 points and 10 rebounds at Kentucky will finally get the chance to play alongside what is presumably a healthy Kobe Bryant. Bryant reciprocated the excitement over twitter. "Welcome home @J30Randle from one legendary institution to one epic franchise #LakersDraft." The first step in improving the ballclub is attaining pieces that the sometimes stubborn Bryant would like

Kupchak and the rest of the Lakers brass are apparently waiting to see if they can lure any big name free agents to the franchise given the opportunity to give their own input on the coaching vacancy. Front-runners for the job include Byron Scott, Mike Dunleavy and Lionel Hollins. Coming off of the worst season in franchise history, Kupchak, Kobe and the Lakers might have to do a little bit more convincing. "It depends," Kupchak said. "Sometimes you have to go to their city and you can't point to the trophies. Sometimes they come here. Sometimes you have to go to an office in Beverly Hills and meet there." Certainly, the Lakers' main targets this year will be both the aforementioned James and Anthony. It is rather unlikely that the team secures both and if they don't, they will set their sites on re-signing Pau Gasol and make even take a run at Kyle Lowry of the Toronto Raptors.

Boehner's Lawsuit Against Obama Just Another Waste of Tax Money

An American Yo-Yo Story

Did you ever have a favorite toy that was fun to play with and easily fit into your pocket? One toy that fits the bill is the yoyo. I thought the yo-yo was an American toy with a long American tradition but I found out the simple yo-yo has a rich, ancient history and noble life which continues to connect players around the globe.

I asked South Bay resident Christopher Adame if he ever played with a yo-yo and he told me, "I had one that lit up when you threw it!" Vickie Vega, on the other hand said, "I had two brothers and they were learning to use it and kept knocking me on the head and it wasn't for me. I preferred my Barbie dolls!" Mine was a clear, plastic, Duncan Imperial Yo-Yo. I played with that yo-yo until the string was frayed and dirty and the 'shoulders' of the yo-yo were scraped from my attempts to 'walk the dog' and perform other tricks.

The yo-yo has a very long history. The yo-yo most probably dates back to ancient China but according to Valerie Oliver, Vice President of Spintastic Skill Toys, Inc., the first documented mention of a yo-yo was 500 BC in Greece. The humble yo-yo strung its way all over the world, finally landing in the United States thanks to Pedro Flores from the Philippines, who was responsible for mass-producing the toy. The word yo-yo is Tagalog for 'come-come' or 'to return.' Donald Duncan purchased Flores' company, rights, and trademark in 1932 for a quarter of a million dollars, which was a lot of money during the depression. Duncan, a brilliant businessman, is responsible for marketing

and popularizing the toy in the United States. Last week, I met with 16-year-old Alex Hattori, a young yo-yo champion who will be a senior in the fall at South Torrance High School. Alex was born at Torrance Memorial Hospital in 1997. He won the 2011 Most Inspirational Player Award and in 2011 came in second in both the National and World Yo-Yo Contest 3A Championship. "I've been playing with a yo-yo for about four years," said Alex. He told me his older sister [Tiffany] bought him his first yo-yo, the Legacy. The first trick Alex learned was 'the sleeper.' "It is just making the yo-yo spin," said Alex. He told me he practices "everywhere I go." That was evident as he unzipped his 'yo-yo case' to reveal several yo-yos of different colors and types. This young man was serious. He has designed two yo-yos: the C-Force (or Centrifugal Force) in 2012, and the Collider, in 2013. "I donated my [winning] yo-yos to the National Yo-Yo Museum in Chico, California," added Alex.

Next, I asked Alex to teach me 'the sleeper,' and he did. It has been a long time since I played with a yo-yo. I finally performed the trick over the grass at the park, but it wasn't the most stellar attempt. Alex told me he doesn't do the 'sleeper' or 'walk the dog' trick on concrete because it scrapes the yo-yo

and throws off its delicate balance. Now I understand why my clear Duncan yo-yo didn't perform up to championship standards - I had damaged it! Alex proceeded to show me his favorite trick - the sideways double trapeze. He said the reason yo-yos are so expensive (\$50 - \$500) now is because they are made from precision aluminum and every piece needs to be identical so it balances perfectly. Alex gave me one of his cool trading cards that list his yo-yo accomplishments and stats. "It has opened a lot of doors for me. I have met celebrities and I have been on TV. I've been on a Nickelodeon game show called Figure it Out, on a Fox news show that focuses on teens with passion called Live Life and Win, the ABC 7 news, and on the Queen Latifah show," added Alex. You can contact Alex at yoyoshowsforall@gmail. com and see him perform at Rock Around the Block on July 17, 2014 from 5 p.m. -8p.m. in downtown Torrance.

The following weekend I was very fortunate to make contact with Dale Oliver, President of Spintastics Skill Toys, Inc. and Science of Spin LLC, who also happens to be the developer of the Science of Spin. Dale is the 1992 World Yo-Yo Champion, and one of only four initial National Yo-Yo Grand Masters. He is Founder and Former President of the American Yo-Yo Association, the 2006 recipient of the Lifetime Achievement Award, World Yo-Yo Contest, and inducted into the Hall of Fame in 2005. Oliver's accomplishments in the sport of yo-yoing are impressive and it was an honor speaking with him.


"Now there is so much online, we find kids all over the world don't have to be involved in a yo-yo community. They can just use the internet. We find kids popping up in major competitions that we've never seen before

who are excellent players. It takes probably 8,000 - 10,000 hours to become a world class competitor," said Dale.

This year, the National Yo-Yo Competition will be held in Prague. Dale told me, "The last one was in Orlando and the one in 2015 will be in Tokyo. I started the World Competition in 1992 and ran it through 1998. Now there is an International Yo-Yo Federation that is a consortium of 3-4 people. One of the members ran the Czech competition and one was very instrumental in Tokyo. In 2016 it will come back to the United States." The nationals are held yearly the first Saturday in October in Chico, California.

I asked Dale when he started playing with a yo-yo and he told me, "1949. I was 9 years old. My father bought me a yo-yo and taught me about 4 or 5 tricks because he entered in a yo-yo contest when he was young. He was a player." I asked Dale where he grew up and he said, "Kansas City, Missouri. I was a Duncan man and started working for Duncan full time in 1957. I did that for a number of years and finally decided to start my own company in 1989, Oliver's Toys. I started traveling when I was 17 and traveled all over the United States and ended up in Washington State." In 1996 Dale was working his successful school program, Science of Spin, which demonstrates physics, form, and motion through the yo-yo, and people began calling, asking if they could buy the yo-yo he had designed. He had never intended to sell it in stores, but could see this could lead somewhere. Dale decided to make yoyos available and called his friend, Valerie,

another yo-yo expert and the two started a business selling yo-yos, which became Spintastic Skill Toys. The company moved to the Fort Worth, Texas and in 2001, Valerie and Dale married. Check out their website, www.spintastics.com.

"Through many years of doing this and teaching kids and hearing so many anecdotal stories about ADD/ADHD kids, the yo-yo teaches focus, discipline, and practice. I have heard so many stories from parents that their kids - how much improvement - that their schoolwork got better, their self-esteem and growth. It is a cross over in the brain 'cuz they have to use both hands on a lot of those tricks," said Dale.

I asked Dale if he likes what he does and he said, "Oh, sure. That was the whole idea. I really like working with kids, I enjoy playing with yo-yos. My advice would be - don't go to a big box store to buy a yo-yo. The company that sells the most yoyos is Duncan

and the most popular is the Imperial - it sells for \$2.50/\$3. There isn't a yo-yo player anywhere who would even pick one up. I mean, the yo-yo has to be able to unscrew, that is number one. You can't play with a yo-yo for 15 minutes without getting the string caught up in it and if you can unscrew it, the knots come out easily."

There are 2 basic kinds of yo-yos: fixed Axle yo-yos and ball bearing yo-yos. Fixed axle yo-yos means the whole yo-yo spins

as a unit – so the axle that goes through is affixed to the sides to the yo-yo. Dale told me, "Old wooden Duncan yo-yos used to be turned on a lathe out of a single piece of wood. Most of the yo-yos you find today have plastic sides with a steel pin and they are not supposed to come apart. Almost all decent yo-yos unscrew and the fixed axles are really considered beginners yo-yos because they don't have ball bearings. On a fixed axle - if you double loop the string around the middle it will go down and it will come back half way without you doing anything. If you do that with a ball bearing yo-yo, it will go down and stay down and you won't be able to get it back up because the string around the bearing stays still and the plastic sides spin. But it has to be spinning fast enough for you to jerk it to come up. With a bearing yo-yo you have to be able to throw it hard enough to make it function correctly. Ball bearing yo-yos are what everybody uses except for rank beginners." Guess that includes me!

"I have taught literally over a million kids to yo-yo in my life so I have pretty much seen it all. It was designated 'toy of the century' in the 90s and we know that as a toy, it is dated at least 500 years before Christ but it didn't achieve the level of popularity until Duncan started promoting it in the late 30s," said Dale. Since then, it has matured from a fad toy into a sport and now there are people who yo-yo all over the world.

This 4th of July I am going to bring out my yo-yo and see how many of my friends can keep it going longer than I can without

a miss - which won't be too long. Grab a toy you love and share it with someone else. Happy 4th of July everyone! •

for their sacrifices. "I don't think that story is told enough . . . just because that soldier is gone doesn't mean there isn't anything you can do for him," said Viti. "What we can do as Americans . . . is we can always reach out to [Gold Star families] and let them know their son's legacy, their husband's legacy is alive."

Another goal of the project is to create memorials in the hometowns of service members killed in action, like Torrance's own Seaside Heroes Park, which in a Facebook post he said was "an amazing monument. . . that stands to honor three local Heroes who sacrificed their lives in preservation of everything that makes being an American so fulfilling our Country so beautiful." On June 29 Viti made a stop at the park to meet with the families of the two of three heroes to whom the park is dedicated. The families of Joseph Anzack Jr. and Matthew C. Ferrara added their sons' names to the remembrance flags Viti hikes with and shared a little about their sons' lives and what it means to them to be a Gold Star family. Joseph Anzack Sr. said a major part of it is reaching out to those who served and thanking them. "Being part of a Gold Star family is a big thing," said Anazack Sr. "To have your head up high, to walk through it and to honor our loved ones as best we can. And also to say thank you to

the people who have served and been though the stuff I have never been through and I'm fortunate to have never been through."

Veterans and supporters of all types attended the gathering at Seaside Heroes Park to thank the Anzacks and Ferraras for their sacrifices as well as to honor service members that have touched their own lives. While the gathering was a special moment, Viti was truly surprised the night before, when he

was about to add a name to his flag. He was staying with the Ferraras and found out the next name he was to write on his flag was that of Lt. Matthew Ferrara.

"There's no way I would've been able to time this. Today is the sixty-fourth day and I'm on the Fs. Sure enough in their backyard, where Matthew grew up, I wrote Lt. Matthew Ferrara," said Viti. "It's one of those moments where it's not about you. This project is not about me, I'm a vehicle. I just ask everyone to raise awareness and to connect with people."

While Viti is leaving Torrance behind, he's still got months of hiking ahead of him. He's documenting the journey at his website http://www.mikeshikingforheroes.com, as well as Facebook https://www.facebook.com/ Mikeshikingforheroes. His website also allows you to donated to help Viti on the road and to fund future memorials. •


