Local South High Heroes Recognized During City Council Meeting

For Sebastian Gutierrez, Sean Hamilton and Ryan McLernon, saving people from drowning wasn't about heroics--it was about doing the right thing.

On Memorial Day Weekend, the three South High students were enjoying their three-day weekend in Kernville when the fun took turned into a life or death situation. The teens noticed a group of five people who were river rafting had been thrown off their raft and were now struggling to stay above water. "Now that I look back at it, it was dangerous...but if I had to, I would do it again and still think it wasn't that big of a deal," Gutierrez said. "I think it was completely worth it." "People should really pay attention to the local advisories because they were saying that the water was the highest that it has been in 20 years," McLernon said. "People just need to really pay attention to what the professionals say, especially if they give you a tip as to what to do if you fall in the water."

During the City Council meeting, Mayor Patrick J. Furey and his colleagues recognized the South High sophomores with a certificate and City pin, and thanked them for their selfless act. "You guys are a reflection of the youth in our community, members of the Torrance family and students of South High School," said Furey.

City Moving Forward With Project to Replace Downtown Street Light System

The Torrance teens immediately called 911, but were told that emergency services would take a while to arrive. It was then that the trio decided that the people in the river didn't have the luxury of waiting.

School Board Approves New Courses For Torrance Adult School's Fall Term

Members of the Torrance School Board this week approved a list of new courses for the Torrance Adult School (TAS) for the 2017 fall term. The school board must approve TAS courses, but those come at no cost to the Torrance Unified School District.

"Staff members continually revise the curriculum and develop new courses to meet the needs and interests of the community," states the staff report. "Prior to seeking Board of Education approval for addition of new courses to the curriculum, administrators have established course content and recruited instructors."

Two of the approved courses are part of the Adult Secondary Education Programs and include the High School Equivalency English Language Arts Preparation Course and a College Math Preparation Course. Both courses are electives worth five credits and are tailored to help students better prepare to pursue and complete higher education goals.

The High School Equivalency English Language Arts Preparation Course emphasizes "the development of critical thinking, comprehensive reading skills, test taking strategies, and the development of written full-length essay responses," states the staff report. Through course completion students will be able to develop and enhance their reading competency, while developing more advanced critical thinking skills as well **See School Board, page 3**

Construction Training Program Launched to Meet LAX Demand

The building industry and Los Angeles International Airport need construction workers to complete the airport's \$14 billion facelift. The partners have launched a free training program that offers South Bay residents a gateway to a career in the building industry and a little piece of history. The Apprenticeship Readiness Program is open to residents of Inglewood, Hawthorne and Lennox who are at least 17 1/2 years old and have a strong interest in the construction industry. A California identification card and a Social Security card are required to join the program.

The eight-week training program, provided through HireLAX, offers job-seekers an introduction to construction careers, union rules, safety, basic on-the-job math skills, and first aid training. The classes at Los Angeles Southwest College will offer handson training with construction materials and tools, and assistance with creating a resume and preparing for job interviews to land a construction job.

The classes begin September 11 at the college, 1600 W. Imperial Avenue in Los Angeles. The instruction will take place from 7 a.m. to 1 p.m. Mondays through Fridays. Participants must attend a mandatory orientation meeting at 8:30 a.m. on Saturday, August 19. Register online at https://hirelaxorientation2017-08-19.eventbrite.com. Eligibility is limited to residents of the South communities of Inglewood, Hawthorne, Lennox, Gardena, Westchester and Harbor City.

"The HireLAX Apprenticeship Readiness program is a first of its kind collaboration, providing the local community with specialized training, and connecting participants with the contractors who will hire them to be part of the construction teams modernizing LAX," said Samson Mengistu, Chief Operating Officer for Los Angeles World Airports. The project's partners include Los Angeles Trade Technical College and Los Angeles/ Orange Counties Building and Construction Trades Council.

Participants in the program will receive "everything they need" to begin a union construction job, according to the organizers. Jobs will be waiting for those participants who complete the courses in November. Los Angeles County is facing a severe labor shortage in construction, and the upgrades at LAX are expected to strain local construction manpower even further.

"With the HireLAX program, we provide a new way for the local community to take a key role in the re-imagining of LAX, by linking workers to immediate and long-term skilled jobs, and making available the training they need to be successful," the airport's COO said.

The ongoing LAX modernization project encompasses terminals, runways and parking facilities and includes a proposed people mover that will connect off-site parking near the 405 freeway with the nation's secondbusiest airport. Projected to last through 2023, the program is considered the largest public works project in the history of Los Angeles. It began in 2009 with the expectation it would create 121,000 construction jobs annually over the project's 14-year span, according to the Los Angeles World Airports website.

The Southern California construction business is booming with major improvements at Los Angeles International Airport expected to take years to complete and the Los Angeles Rams football stadium project in Inglewood breaking ground after a rain delay. Now, See Construction Training, page 4



as test-taking strategies. Students will also develop and practice argumentative writing that will allow them to pass the High School Equivalency subset exams in reading, social studies, science, and English Language Arts.

TAS's College Math Preparation Course helps students develop fundamental math knowledge, build basic math skills, and learn and master elementary and intermediate algebra. Students are also taught reasoning skills, test-taking strategies and problemsolving skills and applications. The course was developed to prepare students for the transition from fundamental-level mathematics to college-level math. Furthermore, upon course completion, students will have math knowledge equal to college elementary algebra courses. They will be ready for college-level Intermediate Algebra and be prepared for the Accuplacer math test.

As part of the TAS's English as a Second Language Program, the School Board approved the non-credit course Pronunciation for the Workplace. This class was made for students already working, seeking to enter the workforce or those already enrolled or ready to register in CTE courses. Through this course, students will also be expected to walk away with an understanding of what is expected of employers and employees in the American workforce. "The course will assist participants in exploring current trends and issues in the U.S. workplace and expose the students to potential work scenarios and appropriate responses," states the staff report. Lastly, the School Board approved Dried Flower Arranging (In a Small Basket), a non-credit, community education program. they dry. While the arrangements made in this class will be in small, palm-size baskets, students will be capable of transferring their skills to create larger-scale arrangements.

School Board Approves **Instructional Service Agreements** for Pre-Engineering Programs

Members of the School Board also approved a recommendation by the Director of Curriculum and Senior Director of Secondary Schools to approve an Instructional Service Agreement (ISA) with El Camino College during the 2017-2018 school year.

As part of the District's Project Lead the Way (PLTW) curriculum, Board members have previously approved the High School Course Outlines for "Principles of Engineering," "Introduction to Engineering Design" and "Aerospace Engineering." Through the Instructional Service Agreement (ISA) approved during Monday night's meeting, students enrolled in the Principles of Engineering, Instruction to Engineering Design and Aerospace Engineering courses will be eligible to receive college credit via examination at El Camino College.

PLTW works with K-12 students and teachers throughout the United States to create an engaging classroom environment not seen through any other program. Among the programs offered by PLTW are its K-12 Computer Science Pathway, the K-12 Engineering Pathway and K-12 Biomedical Science Pathway. Students from North, Torrance or South high schools will be eligible for testing at El Camino through the approved ISA. All costs associated with expanding and sustaining PLTW will be covered through the SB-70 Grant from the State of California, AMETLL Consortium/California Career Pathways Trust Grant and the El Camino College Foundation. •



South High School Football Looks to Take Playoff Leap

The South High Spartans football team has struggled to rediscover its glory days in recent years, but hopes that the 2017 season brings with it a bit more success. Head coach Matt Mishler will be back at the helm for the Spartans in what will be his second season in charge of the team. Mishler should be able to get a better grasp of a team that will be returning many key starters from one year ago. It has now been three seasons since South High tasted the playoffs and seven years since the Spartans were at the goal line of a CIF championship victory. Mishler and the rest of the South High football team will look to put those streaks to rest when they lace up the cleats and put on the pads for this year's regular season that will be underway in just three short weeks.

To say that the Spartans football team went through various periods of struggle last season is perhaps putting it a bit too lightly. A team that finished the season with a 4-6 record overall and a 2-3 record inside of divisional play got things started off slowly from the get-go. A 28-3 loss to the Lawndale Cardinals on opening day may have been a bit of foreshadowing for South High fans who hoped their team would take the next step toward success. Unfortunately for those fans, that 25-point loss to the Cardinals turned out to be just the beginning of what was a rollercoaster season that featured various amounts of frustration.

If Spartans fans thought that a 25-point loss was bad, they must have really cringed when what happened next took place. South hit the road for a trip to Santa Monica to play the Vikings and managed to only score three points in what was eventually a 53-3 beat-down. The Spartans scored their field goal in the second quarter, but were already down by 19 points after the first quarter and by 29 points at the half. Things didn't get much better for Mishler and his team after that either. South continued on a three-game losing streak that also saw the team take a 52-7 loss at El Segundo and a 56-7 loss at home against the eventual Pioneer League champions, the Leuzinger Olympians. Needless to say, defense has been something that Mishler has been stressing all offseason long.

Last season wasn't only filled with disappointment, though. The Spartans did enjoy various key victories like a 24-20 victory over their inner-city rivals from Torrance High and a 37-20 victory over their league rivals from Centennial. The teams victories may have been few and far between, but those two wins alone managed to get South out of the gutter of the Pioneer League standings and into fourth place, where they eventually finished, ahead of both Torrance and Leuzinger.

This year's Spartans team will be looking to get the job done after saying goodbye to some key players from last year. Most notably, senior starting quarterback Anthony Bjazevich has graduated and opened up a spot at what might be the most important position on the South High roster. Two-sport star Javin Fish will presumably take over that position for the Spartans once the season gets underway. At 6-foot-5 and 215 pounds, Fish would certainly prove to be a difficult catch for opposing defenses.

South will also be forced to say goodbye to key players like wide receiver Carl Richardson and running back Jeremiah Narvaiz, to name a few, but will enjoy the benefit of a deep and young roster to fill those holes left by graduating seniors. Another multiple-sport athlete in Kohl Kutsch will take the field and look to make a difference in his senior season after dominating on the volleyball court. A backfield filled with the likes of seniors Anthony Rugnetta and Julian Chavez should also give the Spartans a formidable running game.

Mishler and South High will get this year's regular season started with a game against Fountain Valley on Thursday, August 31. The team will also have to revisit a brutal stretch of games from a year ago that somewhat demoralized the team. This year's Spartans will be looking to rebound, however, when they invite Santa Monica and El Segundo to their home turf before traveling to Leuzinger to take on the Olympians in the first Pioneer League game of the season.

A new season brings with it new opportunity and Mishler and the rest of his Spartans are ready to snatch that opportunity from their opponents' hands this season and make a run at the CIF playoffs. Another year of experience in the books for Mishler and his young team should mean much more success than one season ago. Follow South High all season long to see if the team can make a run at what would be its first postseason appearance in what has been a very long three years running now.




about the team this year and, not surprisingly, everyone had an opinion.

America. With more major building projects in the pipeline in the Los Angeles area, his group is worried that high school and middle school students aren't aware of the career opportunities in carpentry, plumbing, electrical, concrete and other skilled labor for home and commercial construction jobs. The Apprentice Readiness Program at Southwest College is designed to help entry-level workers overcome barriers to employment, including lack of transportation or past troubles with the law. Other barriers to full-time employment will be addressed, such as lack of a high school diploma or GED, childcare, homelessness, and an inability to afford tools. The HireLAX Apprenticeship Readiness program will prepare a diverse group of local community members for placement into union apprenticeships, according to its organizers. Once hired, the recruits will continue to receive training both on-the-job and in the classroom, while earning prevailing wages and receiving health and retirement benefits. Blueberry Hand Pies



Ingredients

- 2 9-inch, store-bought, ready-to-bake pie crusts
- 1 pint fresh blueberries
- 1 tablespoon all-purpose, unbleached flour
- 3 tablespoons granulated sugar
- 1/4 teaspoon pure vanilla extract
- 1 large egg yolk, lightly beaten with 1 teaspoon of water
- 1/4 cup confectioner's sugar 1 tablespoon reduced-fat milk



Preparation

- 1. In a medium bowl, toss blueberries with flour. Add sugar and vanilla extract. Toss to combine. Set aside.
- 2. Allow store-bought crust to come to room temperature. Preheat oven to 375 degrees. Line a baking sheet with parchment paper and set aside.
- 3. Flour a work surface and roll out the warmed pie crust to 1/4-inch thickness. Cut into eight rectangles about 3-by-4 inches in size. Scoop a scant 1/4 cup of the blueberries into the center of four dough rectangles. Place the remaining dough rectangles over the top of each blueberry filling. Use a fork to seal the edges of each pie and transfer pies to the prepared baking sheet.
- 4. Pierce the tops of the pies with a paring knife a few times and brush with egg wash. Bake for 30 minutes or until dough is golden brown. Allow pies to cool completely before icing. Use a fork to stir together the confectioner's sugar and 1 tablespoon of milk. Drizzle over cooled hand pies. Serve with a glass of cold milk. •

Law Enforcement, Criminals Must **Be Accountable For Their Actions**

A video of two U.S. Customs and Border Protection Officers encouraging a drug smuggler to drink out of a bottle filled with liquid methamphetamine has caused the smuggler's family to file a lawsuit against the agency. Before getting into the core of this piece, it must be stated that in this case I in no way supported any type of lawsuit against the agency--nor am I in favor of the \$1 million settlement that the family received. In a video from 2013, Cruz Marcelino Velazquez Acevedo is recorded in the process of committing a crime as he crosses the border into the United States. Due to his initial decision, the 16-year-old died. Hence, there is no agency to blame for Velazquez Acevedo's death other than that of the individual. Was death the appropriate consequence to a horrible decision being made by a teenager? Absolutely not. Velazquez Acevedo made two horrible choices that day: smuggling drugs across our borders and drinking liquid meth in hopes of not being detained by customs. Having said that, the two agents who encouraged and allowed for the smuggler to drink this poison should face consequences. As a country that prides itself in law and order, and that has a fundamental belief in due process, this death at the San Diego/ Tijuana border is untimely, unfortunate and should have been prevented. In the video released by CBP, officers Valerie Baird and Adrian Perallon are seen engaging with the teenager. Velasquez Acevedo, who was carrying a backpack, had two bottles of tea-looking liquid that soon after tested positive for methamphetamine. After a brief dialogue between the agents and Velazquez Acevedo, the agents begin making gestures for the teen to drink from the bottle. After a few sips Velasquez Acevedo is directed to second inspection where he is asked to take (and does) two drinks from one bottle. Two hours later he was dead.

Did Baird and Perallon really force him to drink? Not at all. These officers did not hold a gun to Velazquez Acevedo's head, nor did they funnel the drugs down his throat. However, they behaved in a manner that lacks not only human decency and common sense, but they displayed an absolute lack of professionalism. CBP released a statement through its Office of Professional Responsibility and declared that no additional action was needed, so the officers involved would not be disciplined. Again, I'm not defending the smuggler or the family's absurd lawsuit. It is not CBP policy to force smuggling suspects to consume the substance/s they are alleged to be trafficking, nor does CBP force accused smugglers caught with white powder to snort the substance. Thus, the agency should not have to pay for the actions of two reckless officers. There is an operating procedure in place for a reason. We have due process--but because these two officers failed to uphold those standards, their actions contributed to the death of a teenager. Not one penny should have been paid out to the family, but CBP Officers Baird and Perallon should have been reprimanded. These officers upheld their commitment to vigilance and service to country, but they failed at integrity. •





DIY Pressure Washing: How to get Great Results

(BPT) - Clean siding and trim can do as much for a home's curb appeal as fresh flowers, neatly trimmed hedges and a repainted front door. You could scrub for hours trying to remove dirt, mold and mildew, or you could do the job more quickly and easily with a pressure washer.

However, if you decide to pressure wash your home's siding, trim, fence or other surfaces on your own, it's important to choose the right equipment for the project, and to know the basics of good pressure washing.

Pressure washers use powerful pumps to boost water pressure and force water through a special nozzle. The intense spray powers away dirt, grime and debris, and depending on the type and size pressure washer you choose, they can be great for both major and minor home cleaning projects. While professionals often use gas-fueled versions for home renovation projects, electric versions like those from Karcher are affordable, convenient, and easy to use and maintain for most around-the-home applications such as siding, driveways, fences, patio furniture and vehicles.

Pressure washers use less water and complete cleaning jobs more quickly than simply scrubbing by hand. Generally, the higher the PSI (pounds of pressure per square inch) the greater a pressure washer's cleaning power. However, PSI is not the only consideration



when choosing a pressure washer.

You should also look for ease of setup and use, and availability of accessories like extensions and wands for the different projects you might want to complete with your pressure washer.

It's also important to understand the type of detergent the washer will use in addition to water. Some cleaners might be too harsh for certain applications. Never use bleach with a pressure washer, as this can permanently

damage the pump.

Pressure washers are powerful pieces of equipment, and you should always follow basic safety practices, such as using eye and face protection, and the manufacturer's instructions for use. Be aware that using too high a pressure setting or holding the nozzle too close to surfaces could cause damage. Further, there are some things you should never do with a pressure washer, including:

• Never point the jet at people, animals,

windows or the pressure washer itself.

• Never stand on a ladder when using a pressure washer. The kick from the wand could cause you to lose your balance. Instead, use an extension wand or second-story nozzle to clean overhead areas.

• First, place drop cloths over nearby shrubs and greenery to protect them from the spray and detergent.

• With the washer set at low pressure, apply detergent, moving from top to bottom.

• Use clean water and a higher pressure setting to rinse off detergent, again moving from top to bottom.

• Use a sweeping motion to clean, and keep the nozzle at least 6 inches from the siding.

• Whether it's a cement retaining wall, a brick path or a patio of stone pavers, first rinse the surface to be cleaned using fresh water.

• If you're using detergent, apply it at a low pressure and work in smaller sections of about 25 square feet.

• Using a rotating turbo nozzle and a sweeping motion, clean by holding the nozzle 3 to 6 inches from the surface.
