City of Torrance Approves Agreement for New Bus Line Shelter Installation

A unanimous yes vote by Torrance Mayor Patrick J. Furey and the city council approved an agreement to provide the City of Torrance with \$880,000 to be used to install new bus shelters along the busiest bus routes in the city.

The agreement between the City of Torrance and Los Angeles County Metropolitan Transportation Authority [LACMTA] will provide the \$880,000 in funds to the city for the installation of 29 new bus shelters along Torrance Transit's Line 3 rapid service.

"These shelters will have distinctive branding that will identify them as being part of the overall regional rapid bus program and will include new amenities such as benches, trash receptacles, LED solar lighting and a passenger information board that will display real-time bus information," James Lee with the city's transit department said during the staff report. "Staff believes this will help to greatly enhance the service we offer on our lines in rapid and will most likely attract new ridership to the system."

The project, which will be fully funded by LACMTA, will remove 10 current shelters along Torrance Transit's Line Route 3 Rapid Route and replace them with new facilities.

"T'm really happy to have this item in front of use and that staff has brought this to us," Councilman Tim Goodrich said. "Often times I'll be driving down the road and I'll see some of our residents sitting on our benches and there is absolutely no shade out there; and in the middle of the summer it can get pretty warm put there, especially if you're a senior citizen and happen to be stuck out there."

Torrance Transit's Line 3 operates east to west, extending from the South Bay Galleria in Redondo Beach, making its way through the City of Torrance, to the Long Beach Transit Mall. Within the city's bus lines, Line 3 is one of the most used during peak hours.

"Torrance Transit has the ability to design, fabricate and install these new shelters per our branding style," states the staff report.

Each of the shelters is budgeted at \$30,000 but it is not expected that the entirety of that money will be needed. Anything left over will be considered for roll over for maintenance of the shelters from usual wear and tear or any form of vandalism. Staff also plans to use the city's current vendor in order to provide maintenance for the new shelters.

"I want to thank you for the supplemental material that was provided to advise exactly where all the shelters will be put up. I think that was very instrumental," Mayor Furey said. "I think it is very good that we are providing a much more comfortable situation for our ridership."

Council Approves Memorandum Of Understanding For Prop 84 Integrated Regional Water Management Grant

The mayor and city council approved a recommendation by the Public Works Director to approve an MOU with the Los Angeles County Flood Control District in the amount of \$16,165.75. The agreement will prepare a Proposition 84 integrated regional water management grant program application that covers the city's North Torrance Well Field Project.

Torrance is looking for ways to use groundwater rather than continuing to depend on the Metropolitan Water District and the State Water Project. The staff report indicates that the cost to treat groundwater is half the expense of using MWD.


"The City has acquired a property behind Yukon Elementary School for the development of the North Torrance Well Field Project," states the staff report signed by Public Works Director Robert J. Beste. "The city has obtained utility easements and access to the project site from Torrance Unified School District in Phase I of the project."

Utility pipes have been installed during the easement stage in 2014 and an access road built. Phase II of the project will include the installation of utilities in the right-of-way on Yukon Avenue, from McMaster Park to 182nd Street and will connect with the developments of Phase I. Phase III consists of developing a groundwater well, a new 2 million gallon storage tank, booster station, along with treatment systems.

"This project would allow for the removal of the 900,000 gallon tank and pumping station at McMaster Park," states the staff report. "The City has drilled a pilot Well #10 at the North Torrance Well Field site and now has water quality and production capacity information."

The state is expediting the Prop 84 grant program to help localities with the development a local, potable water supply in order to address the drought. The grant funds from Prop 84 are distributed via the Integrated Regional Water Management [IRWM] groups responsible for the preparation of IRWM plans. The IRWM group lists projects by priority and the North Torrance Well Field Project, Phase III, is labeled by the South Bay IRWM group as a priority project. •

VA Long-Term Care Benefits: Not Easy to Get, But Worth It

A survey conducted by the National Association of Area Agencies on Aging, National Council on Aging and UnitedHealthcare reveals a frightening statistic in the United States of Aging survey. 97% of professionals supporting people 60 and older believe that seniors will not be able to afford their health care costs as they age. Only 3% are very confident older Americans will be able to manage health care costs. Not a pretty picture.

The high and ever-increasing cost of long-term care is the leading reason that professionals do not believe that seniors will be able to afford their health care. The median price of a private room in a nursing home now costs about \$91,000 - an increase of 4% from last year. The survey on aging, reported on in an article in Forbes, offers a glimmer of hope with a look at a little-known program from the VA: "The VA Program That Pays For Long-Term Care for Vets."

About half of us will someday use nursing home care, and many others will need longterm care in assisted living facilities or at home. But here's a little good news: there's a little-known Veterans Administration (VA) program that pays for some long-term care costs for vets and their families. It's called the Aid and Attendance Benefit. This benefit has been around for over 60 years and covers some expenses for in-home care, nursing homes and assisted living facilities. This benefit is available to honorably-discharged wartime veterans over age 65 and their widowed spouses who are eligible for a VA pension and require the "aid and attendance" of another person or are housebound. The VA calls this "additional pension benefits for care assistance in the home or in an assisted living community."

Aid and Attendance pays up to: \$1,788 per month to a single veteran, \$1,149 to a

surviving spouse, \$2,120 to a married veteran and \$2,837 to a veteran couple. The benefit is tax-free. To qualify, the applicant must either require assistance with Activities of Daily Living (ADLs) like dressing, bathing, and eating; be bedridden; be a nursing home patient due to mental or physical incapacity; or have eyesight limited to a corrected 5/200 visual acuity or less in both eyes or concentric contraction of the visual field to five degrees or less.

Of course there's a catch: applying for and receiving the money is a real pain in the bottom. The VA estimates it can take on average about five months for an Aid and Attendance claim to be processed after a veteran applies to a VA regional office. Even so, some applicants have been crushed with red tape and much longer waits.

The article tells the story of Frank Fassnacht, an 84-year-old former Disney projectionist now living in a Motion Picture & Television Fund home. He applied for the benefit three years ago, and still no luck. Because of the VA's high turnover rate, it's hard to find a consistent person to help you.

One other thing to note: a veteran may be turned down for the Aid and Attendance benefit if his or her assets are too great. The VA doesn't have a strict rule on how much assets one can have, but it's typically no more than \$80,000 (not including your home), depending on age.

The article advises you to seek the assistance of an elder law attorney to apply. The rules and paperwork can be super difficult, so a qualified attorney can really be a help. He or she can also assist you in preserving assets. Also, you should be ready to document your long-term care expenses and provide all the application materials.

Shakespeare Comes To Torrance

What comes to mind when you think of Shakespeare? The very first Shakespeare play I ever read and studied was the The Merchant of Venice and it had a huge impact on me from the moment I finished the first act. The fascinating story with the beautiful poetic, iambic pentameter had me hooked and pulled me in and made me a fan for life.

Sometimes, William Shakespeare's work may seem daunting, but in reality, I feel it is a slice of life of the late 1500s and now. There are those who are skeptical as to whether Shakespeare actually wrote all the plays attributed to him, but that is a debate I will leave to the scholars. One summer night in 1998, I went with a group of friends to my very first Shakespeare By the Sea production, Comedy of Errors, under the direction of Lisa Coffi, in San Pedro at Point Fermin Park. The evening was magical and on the small stage, with very minimal sets and costumes, and ocean breezes wafting up from the cliff, Shakespeare's play came alive. I loved it and was hooked on viewing the performance as I imagine it would have been performed during the Elizabethan era.

Last Saturday night, As You Like It by William Shakespeare was performed near the gazebo at Wilson Park in Torrance. Shakespeare by the Sea had traveled to Torrance and as I entered the park, I found myself walking beside Chris Noble, who told me he has been coming to Shakespeare in the Park for seven or eight years. "We go to Point Fermin too," said Chris. And when I asked him what his favorite Shakespearian play was he immediately responded, "Hamlet. Very dramatic and very tragic - [Shakespeare is] about humanity, everything – the way the world works."

I then hurried backstage to check up on the actors who were running lines, dressing, putting on their make-up, and preparing for the evening's performance. What I found refreshing was that this group of thespians was not only open to my queries and photographs right before the performance, but they were genuinely gracious and seemed truly excited about the evening. Some of the actors I met were: Bryson Allman, Olivia Schlueter-Corey, Mitchell McCollum, Alastair James Murden, Maggie Contreras, and Cylan Brown.

Looking up the hill from the gazebo and stage, a large crowd had settled in for the evening, well stocked with food, beverage, blankets, and chairs. Frances Harder and her husband Helmut, who met in Germany and have been married 40 years, live in Torrance and have been coming a long time to the plays here in Torrance, and also in San Pedro. "We love it, it's great," said Frances. Further up the hill, sitting on low lawn chairs, I spoke with Paula Burke and Peter Mand who are veteran viewers as well. Paula told me, "Peter has taken a class in Shakespeare so this is one of the plays he studied, so we wanted to see it performed." "It is very interesting," said Peter.

Ten minutes before curtain, I ran into Martha and John Bauman who were excited for the show to begin. John told me, "This is only my third time." Beaming and ready for the show to start also was, Linda Reynolds who said, "Last year was my first year [coming to the plays] and this is my second year - and last year was absolutely wonderful and I enjoyed last year so I am back again this year. My daughter saw this play last weekend at the Marine Mammal [Care Center at Fort MacArthur] and said it was absolutely wonderful and so we are here to see it." Another Torrance raised audience member Cecilia Hernandez told me she and her husband of 33 years, Alex, are repeat attendees, and her favorite Shakespeare play is The Taming of the Shrew.

Way up near the top of the hill, overlooking the stage and park, sat four young adults snuggled together, waiting for the show to begin. Gregorio Rodriguez, Sarah Ocon, Alma Cruz, and Majeli Cervantes were excited

because this was the first time they had ever attended Shakespeare in the Park. I can't say they were in the 'cheap seats' simply because there are no cheap seats. All the seats (which you bring yourself) are free. I can hear the ringing of the rhyme, "Shakespeare by the Sea, where admission is always free."

Yes, you heard me right and if you happen to be living in a cave somewhere in the Southern California area, and haven't heard about this absolutely wonderful program, check it out. Two plays are presented each summer for ten weeks – four weeks in San Pedro at Point Fermin Park, and then six weeks in venues throughout three counties (Los Angeles, Orange, and Ventura).

in San Pedro, and an educational outreach program, "Shaking it up with Shakespeare," tours schools all over the area.

This entire production is due to the efforts of Producing Artistic Director Lisa Coffi. I was able to speak with Lisa and found out that Shakespeare by the Sea was an effort by her to offer Shakespeare in the park during the summer months in the South Bay beginning in 1998. Lisa and her husband, Curt relocated to the South Bay from the Sacramento area and she immediately dove into finishing her master's degree in theatre. But where was summer theatre? After all, theatre was alive and well in other areas of California, so why not here? Lisa decided to

change that. After touring around one day, with her husband Curt, Lisa stumbled upon Point Fermin and knew it was the perfect place for her vision. Thus began an adventure of huge proportions.

Striving to offer Shakespeare wasn't as easy as one might imagine. But Lisa's mind was made up to put on Shakespeare and she diligently worked with the city to attain her goal. She opened her first play on a shoestring budget, with very limited sets, and borrowed costumes that first year. She began the program with a 'learn by doing' approach with free admission - which has remained in place for 18 years. That in itself is remarkable. Lisa's undergraduate degree is in art and her graduate degree in theatre, allowed her to put 'theory and practice' to the test. "It's fun, it's crazy. There is a lot of work," said Lisa. She admits that when she is overwhelmed and overworked – a random e-mail from an audience member, telling her how they enjoyed a particular show and what it meant to them, reminds her that all the hard work is worth it. After the first 3 years of summer shows, Lisa hired a Development Director, Suzanne Dean, and between the two

Kevin Bacon's Comedic Chops Make the Midnight Flick Cop Car a Quiet Hit

Kicking off this year's Next Fest (the LAset sister film festival to Sundance), Cop Car is being touted as a must-see for "midnight movie" cinephiles. A corrupt cop, two rebellious kids, and a stolen police vehicle make up this dark little comedy that proves to be one of summer's top coming-of-age thrillers. The film premiered in Los Angeles on Sunday,

confusion, he is not happy. After some illegal activity leads him away from the car in the first place, he is left immobile and alone in the vast countryside, and determined to get his car back (as the trunk is learned to be holding precious cargo) quickly and in one piece - a fate he doesn't hold for the rest of the parties involved.

Cop Car is a reflection of a successfully made, true independent film. With its limited


August 2nd at the Hollywood Forever Cemetery (a fitting location for added creepiness), and the tense cinematic sequences that Cop Car organically conjures up were felt long after the film's brisk 86-minute run time.

Kevin Bacon, who stars in the set-up opposite the film's two young leads, shows off his devilish comedic chops as mustachioed and corrupt county sheriff Kretzer. Bacon doesn't appear in the film's initial scenes, a job left to newcomers James Freedson-Jackson and Hays Wellford, who play young runaways and best friends Travis and Harrison. The boys, moseying through the picturesque Colorado plains while one-upping each other in an innocent-enough swear-off as they look for more adventure, find just that in an abandoned cop car in the middle of nowhere. With an empty beer bottle on the roof and the keys in between the seats, the boys take off on a joyride that every young kid dreams of.

Donuts, burnouts, and speeding make for a very entertaining montage sequence, but it's not until the owner of the car comes back to claim it (shown in a brief flashback to the moment said driver leaves the car), and realizes it's missing, when the tension (and comedy) hits. The car belongs to Sheriff Kretzer, and, past his comedic budget, seen in its rural-set locations and singleday narrative, director Jon Watts manages to produce something small and wonderful. It's no wonder why Watts was chosen to direct the forthcoming Spiderman reboot. This smallscale production produces high stakes horror, and while Watts sets us up with the perfect scenario and tone reminiscent of the Coen Brothers' No Country For Old Men, it is the actors that truly drive the story home. Kevin Bacon is selfish, evil, and lacks empathy, yet I still found myself rooting for him. Perhaps that's just the power of Kevin Bacon, but I'd like to think it comes from the undeniable magic that happens when a talented actor is matched with an as equally talented and creative director like the promising Watts.

For some, however, this tightly wrapped story may leave some important questions unanswered after the film cuts to black. Why were the kids running away in the first place? What ultimately happened to Sheriff Kretzer? Did the boys make it out ok? I don't believe these facts are detriment to the film's success; in fact, it makes for a perfect setup for "Cop Car 2." Now that's one sequel I'd like to see. Cop Car is now playing at the ArcLight Hollywood. •

Saxons Plan to Shine

High School football is just around the corner and with the opening game just weeks away, teams from around the city of Torrance are gearing up to make a run at this year's Pioneer League title. Last week we took a look at last year's division winners, the West High Warriors. This week, we'll take a look at last year's second place finishers, the North High Saxons, to see how they'll stack up in the run for the division crown. Don't let the standings from a year ago fool you. The Saxons are poised and ready to break out as not only one of the best teams in the city, but also as one of the best teams in the entire area.

When mentioning North High, it would be a disservice to not also mention the name Mique Juarez. If you haven't heard of him before, he is the standout, do-it-all player on the Saxons who will most likely help the team become one of the most successful teams in California this year. Juarez is a five-star USC commit who is listed as a linebacker on defense and a quarterback on offense, but really plays all over the field. Last year for the Saxons, Juarez had 107 tackles, 8.5 sacks, six forced fumbles and three interceptions. On offense, he totaled 2,200 all-purpose yards and 22 touchdowns playing mostly quarterback and wide-receiver. You can expect very similar numbers this year out of Juarez who will once again be playing all over the field for North High and head coach Todd Croce.

There is obviously no questioning the talent of Juarez, but one player can't do it all

by himself. If the Saxons are looking to be successful not only in the Pioneer League but also in CIF this year, then other players must make significant impacts as well. Though the Saxons lost starting quarterback of a year ago, Chris Kuaea, to college, you can expect to see Juarez stepping in behind center and senior running back Nathan Brown lining up in the backfield to lighten Juarez's load. One thing that is scary about the Saxons this year is their amount of returning starters. The team's starting defensive and offensive lines are both full of seniors that played in Croce's system last year who are back and looking to improve on their second place finish from just one year ago.

Speaking of last year, despite their inability to finish in first, it was a pretty successful year for coach Croce and company. A 7-3 overall record and a 4-1 league play record saw the Saxons finish just behind the Warriors and above the Torrance Tartars in the Pioneer League standings. Things looked good for North from the outset. A 13-10 win over Redondo Union began the Saxons season on the right foot as they rallied from their opening day victory to form a three-game winning streak. It wasn't until week 4 that North got themselves into some trouble. Coming off of a 48-0 shellacking over Beverly Hills, the Saxons suffered their first loss of the season to Nordhoff of Ojai. North would only lose one more game for the rest of the regular season, but was given credit for a loss because of a forfeit due to a fight against Inglewood.



What You Think You Know About Social Security May Be Totally Wrong

(BPT) - Americans may have faith in the Social Security system, but many still don't really understand how it works. That's a key take-away from a recent survey of Americans' knowledge of Social Security retirement benefits. While 63 percent of respondents said they do believe Social Security benefits will be available to them when they retire, many were confused about who qualifies for benefits, how much they'll be eligible to receive, and when they can start drawing benefits without penalty.

The survey, by Massachusetts Mutual Life Insurance Company (MassMutual), included a true/false quiz about Social Security facts. Just 28 percent of those surveyed scored a passing grade, and only one person out of the 1,500 polled was able to answer all survey questions correctly. The survey results illustrated a significant lack of knowledge about Social Security, including:

- Although 75 percent of those surveyed thought being an American citizen is a requirement to receive Social Security retirement benefits, this is not the case. Noncitizens lawfully living in the U.S., and who have permission to work here, can obtain a Social Security number, pay into the Social Security system and draw benefits.
- More than seven in 10 respondents mistakenly thought that 65 is the age when everyone can begin drawing full retirement benefits. Actually, your full retirement age depends on what year you were born.
 - Fifty-five percent of those surveyed



incorrectly believed they could continue working during retirement while collecting full Social Security benefits, regardless of their age. If you work during retirement, but have not yet reached your full retirement age, your Social Security benefits may be reduced if you earn too much. Once you reach full retirement age, those withheld benefits will be repaid over your lifetime.

"Perhaps the greatest Social Security deficit in this country is the lack of education around the retirement benefits of the program," says Michael R. Fanning, executive vice president, U.S. Insurance Group, MassMutual. "With millions of Americans nearing retirement each year, many may be at risk of underutilizing a critical component of their retirement income stream."

Still, some good news emerged from the survey. Americans seem aware that Social Security should be only one component of their overall retirement savings plan. Just 39 percent said they expected to rely more on

Social Security than their personal savings or income during retirement, and just 15 percent expected to rely solely on Social Security.

You can test your Social Security knowledge by taking the MassMutual quiz.

Here are some Social Security facts to help improve your knowledge:

- No single filing strategy works for everyone filing for Social Security benefits; there are just too many variables. For example, a married couple may have hundreds of options for filing for Social Security retirement benefits.
 - Americans are living longer. It's no

longer sufficient to plan for just 10 years of retirement. You may well need savings and income to carry you for three decades or longer.

• While Social Security can be an important component of your retirement plan, you need to have other income as well. Under- or over-valuing your Social Security retirement benefits could keep you from getting a true picture of your retirement savings plans. 
