“Their mission is to identify youth issues and concerns and make recommendations and suggestions to the City Council, City commissions, committees and staff on related matters,” Torrance Mayor Patrick J. Furey said. “In addition, they will officially represent the City in youth affairs and provide support to The ATTIC, the Torrance Teen Center.”

Torrance Youth Council (TYC) members will be tasked with working on several projects, such as the Youth Forum, Christmas and Spring Boutiques, the ATTIC Pancake Breakfast, Prom Fashion Show, and Service Fair, among other events. TYC members will also engage in a series of community events, in a volunteer capacity, and a member of the Youth Council

will be required to sit in on a City Council meeting and different commission meetings.

Iffy Weather Expected for Monday’s Solar Eclipse

South Bay residents should get the first peek of a solar eclipse that hasn’t been seen in North America in nearly a century, though they may need to head inland to catch it. The National Weather Service has forecast partly sunny skies and patchy fog along the coast for The Great American Eclipse of 2017, which starts at 9 a.m. Monday and will last about three hours. Solar eclipses aren’t rare. However, this celestial event is different.

Solar eclipses happen every 12 to 18 months, but Monday will mark the first time since 1979 that an eclipse will be visible across the entire country. It is a

total eclipse, but only along a 70-mile band running from Oregon to South Carolina, according to published reports. Here in the South Bay, the eclipse will be noticeable at 9:05 a.m. and be fullest at 10:21 a.m. when the moon passes between the earth and sun. At its peak, the eclipse will block 70 percent of the sun and create a halo effect across the region. The visible band of sunlight is considered dangerous to look at without protective eyewear. Special solar-viewing glasses are recommended and available at retail stores. Sunglasses do not provide enough eye protection from the eclipse’s damaging rays.

How to Control the Problem of Small Dog Syndrome

Mark Twain famously said, "It's not the size of the dog in the fight, it's the size of the fight in the dog." If you own a small dog, you may have observed this phenomenon. Why do small dogs seem to want to pick fights with much larger dogs? Why do they act like a Great Dane packed into a five-pound body? Why are they so yappy and bossy? There is even a name for this behavior and it's called Small Dog Syndrome or SDS. There are theories on why SDS occurs, but many behaviorists and trainers believe it's the fault of their owners. After researching SDS for this article and being an owner of a small dog, I can say I may be guilty of doing some of these things.

The main reason for SDS appears to be allowing a smaller dog to behave in ways we would not tolerate from a large dog. The "traits" that we give little dogs may actually be learned behavior and not in their genes. The dominant behavior of little dogs is seen as cute rather than threatening and they often are allowed to run up to people or bark at them, for instance. Little dogs may pull on the leash when walking because they are too small to really knock you down. But allowing these behaviors may embolden them and reinforce their dominant behaviors.

Behaviorists advise using positive reinforcement training with treats and praise. Getting down to the little dog's level when giving instruction may be helpful. Teaching tricks such as paw shakes for treats can be a fun way to reinforce discipline. Ask your veterinarian to refer you to a trainer or behaviorist to help with difficult cases.

Avoiding SDS in your little dog may also save his life.

When little dogs encounter larger dogs on a walk, SDS can lead to a lopsided and brief battle that usually does not favor the little dog. Serious injury, or in some cases death, can happen in a blink of an eye.

One way to avoid conflicts is by staying alert and keeping your dog under a short leash and voice control at all times. You can take the additional step of not allowing your dog to look or sniff at another dog.

Teaching a dog early on that he can't visit with every other dog he meets is one good way owners can prevent leash aggression. Teach the dog not to pull on the leash, and to sit and wait for permission before greeting another dog. Basic obedience training can help prevent fights.

Along with leashing and good training, owners can avoid conflicts by keeping their pets from roaming, neutering young dogs before six months of age, and socializing their dogs during the critical puppyhood stage between six to eight weeks of age.

Even if you follow all the rules, many fights occur with little warning. Watch for these behavioral cues to see if a fight is imminent:

- A hard, unwavering, targeted stare
- Dominance posturing, such as mounting
- Stiff body movements
- Extreme body language: the tail held stiffly up or down, lips pulled tight against the teeth

Dogfights can occur between any dogs, not just little dogs with SDS. We are a very dog-friendly city and we like to take our dogs with us to enjoy the great Southern California weather. We all love our dogs big or small. Let's keep them as safe and healthy as we can.

As many as 300 million people across North America are getting ready for the eclipse, which will last for two hours and 39 minutes in Southern California. The last time a total eclipse was visible coast to coast was in June 1918, according to information posted at timeanddate.com. Monday's eclipse is worth catching because another one won't happen for another seven years: April 8, 2024. For the majority of people living in the United States and North America, seeing the full eclipse will require a road trip to a state that falls within a 71-mile band.

Parts of 14 U.S. states will go completely dark on Monday, and the blackout will start on the West Coast in Oregon and move eastward. The blackout of the sun will make landfall in Lincoln City, Oregon and then move eastward through the western states of Idaho and Wyoming. It will pass through the Midwest by way of Nebraska, Kansas, Missouri and Illinois before moving across the South toward South Carolina—the final viewing place for the total eclipse. When the sky goes dark, stars will make a rare daytime appearance, promises the website. Planets also become visible and other features of the sun come into view during a total eclipse.

Looking at any sized eclipse is considered dangerous and should only be done using eclipse glasses or using a pinhole view that can be made at home. Instructions on how to build an eclipse viewer made from card or paper are available at www.timeanddate.com/eclipse/make-pinhole-projector.html. Staring at the sun without eye protection or a pinhole viewer can cause blindness, and consumers are being warned to avoid buying eclipse glasses that don't meet specific safety specifications. Amazon last weekend announced it was recalling solar-protection eyewear that the online retailer sold ahead

of Monday's event because of concerns they're fakes.

Glasses considered safe for directly viewing the sun must meet the International Organization for Standardization's standard, according to American Astronomical Society. The proper eyewear will carry a label that the produce is ISO 12312-2 compliant. However, fakes started turning up on Amazon and the Web and there are concerns that people who bought the protective glasses could be put at risk. The society recommends checking eyewear for the ISO logo and certification and buying from vendors whose products have been laboratory-checked and approved for safety. Eclipse glasses should not allow any light other than the sun's brightness or an intense halogen lightbulb, the society says.

The brands that have been verified as meeting the optic-safety standard for an eclipse are:

American Paper Optics (Eclipser); APM Telescopes (Sunfilter Glasses); Baader Planetarium (AstroSolar Silver/Gold Film); Celestron (EclipSmart Glasses & Viewers); DayStar (Solar Glasses); Explore Scientific (Solar Eclipse Sun Catcher Glasses); Lunt Solar Systems (SUNsafe SUNglasses).

Meade Instruments (EclipseView Glasses & Viewers); Rainbow Symphony (Eclipse Shades); Seymour Solar (Helios Glasses); Thousand Oaks Optical (Silver-Black Polymer & SolarLite); and TSE 17 (Solar Filter Foil).

NASA officials also are concerned about the public viewing the eclipse with inadequate eye protection. Eclipse glasses that are scratched or damaged should be avoided, and people who normally wear eyeglasses should wear them under a pair of solar-filtering glasses, NASA says. More information about Monday's solar event, how to prepare for it and safety recommendations for supervising children are listed at eclipse2017.nasa.gov. •

South Bay Workforce Investment Board Receives Grant to Serve Homeless Veterans

The South Bay Workforce Investment Board (SBWIB) was awarded a \$97,000 grant from U.S. Vets in Inglewood to provide employment services to homeless veterans throughout the South Bay region. The funding comes from the Homeless Veteran Reintegration Program (HVRP) through the Department of Labor's Veterans' Employment and Training Service. The funding obtained will also provide assistance to veterans who were formerly incarcerated or will soon be released and are now seeking employment.

The grant will provide job training, counseling, placement and related employment services to expedite the reintegration of homeless and formerly incarcerated veterans into the labor force. Veterans with families and those who are at risk of homelessness also qualify for services.

The SBWIB will focus on employing many veterans within the construction industry due to the current high demand for job seekers in the South Bay area with numerous major projects taking place; including the Los Angeles Football Stadium and Entertainment District at Hollywood Park. The Inglewood football stadium is projected to provide more than 3,500 on-site jobs during construction and more than 10,000 support jobs by the time it is completed.

For those job seekers that may not fit within the construction sector the SBWIB will place them into another priority industry. SBWIB's Executive Director, Jan Vogel stated, “Our partnership with U.S. Vets is very important to us and we are honored to be able to receive this funding and help homeless veterans gain meaningful employment.” – Source: SBWIB •

Saxons Football Set to Rely on Experience This Year

It wasn't much of a stretch to think that the North High Saxons football team and their head coach Todd Croce had what it took last season to capture a divisional title. A little bit of bad luck, combined with a difficult Pioneer League schedule, however, crumbled those plans as the Saxons finished in third place behind both Leuzinger and their rivals from West High, respectively. This year, the Saxons are back and looking poised to take their division by storm. North High will benefit from an experienced group of starters who will be returning to the team this season in order to dominate their rivals from both the city of Torrance and from around a highly competitive Pioneer League.

The Saxons football team got off to a mediocre start last season by winning just two of the first four games of the regular season. Despite a bit of bad luck in an opening day loss to the Banning Pilots by just six points, North was able to respond in a big way. Consecutive victories versus Aliso Niguel and Bishop Montgomery got the Saxons back on track, but it wasn't long before the team would fall back down to earth with a loss to Culver City to even their record out at 4-4 just before the beginning of league play.

Quarterback Glenn Searcy led the way for North High last year in his senior season, but was also backed with great talent in wide receiver JJ Belmontes and running backs Malik Welch and Saeed Galloway, to name a few players from the talented team. The talent put on display by those four players was enough to get past a few impressive teams within the Pioneer League--but an unlucky four-point loss to the Warriors and a 68-28 blowout on the road at the hands of the eventual league champions, the Leuzinger Olympians, dropped the Saxons down to third place in the end of the year standings with a 6-5 overall record and a 3-2 mark in league play.

Despite their third place standing, North was able to put together various victories throughout the year, including wins in rivalry games against both Torrance High and South High in the final two games of the regular season. Those back-to-back victories were enough to get the Saxons an at-large bid into the CIF playoffs, where they took on the St. Margaret's Tartans. Searcy was responsible for the team's first touchdown, which came early

in the game. Welch galloped a TD of his own into the end zone late and accounted for 171 all-purpose yards, but a lackluster defensive effort led to a 55-14 loss, eliminating North from the playoffs in just the first round of play.

The Saxons' biggest obstacle in repeating the success that they enjoyed last season will be in overcoming the loss of their quarterback, Searcy, and their star running back, Welch, who has now gone on to play ball for the University of Nevada Wolf Pack. All in all, North will lose 12 seniors from the 56-man roster heading into this season. Galloway and Belmontes will be back, however, and will bring a ton of talent with them returning to the roster. Now a senior, quarterback Sean Sigala will be looking for his chance to shine as well, and is one of 19 juniors who played for Croce's team last year.

A great combination of youth and talent should be the perfect potion for Croce and North High to take the Pioneer League by storm this season. If they are going to look to do that, however, they will first have to avenge losses to Banning and Culver City. The Saxons will get Banning in the season opener next Friday night and will get Culver City three weeks later. Not only will non-league opponents provide a challenge, but a traditionally difficult Pioneer League filled with inner-city opponents and rivalry games will test the Saxons' strength every step of the way. The team will get another crack at West High in the opening game of league play before it takes on Leuzinger the very next week. That two-game stretch should do its job to tell North and its fans just how good of a season the Saxons will be bound to have this year.

The Pioneer League is always impossible to predict and will boast a schedule for all of its opponents that is daunting, to say the least. For North High and their head coach Todd Croce, though, confidence exudes--not just because of the successful season that the team experienced last year, but also because of the talent returning to the roster this year. If the Saxons ever had a chance to take the league by storm and make a deep run into the CIF playoffs, it would be in this 2017 season. Now, Croce and his influx of talent must simply execute if they'd like to beat out the rivals that will inevitably be breathing down their necks all season long.

Summerfest 2017 is Upon Us in Downtown Torrance!

Summerfest is the brainchild of Chef Michael Shafer, owner of the historic Depot Restaurant in downtown Torrance. When I asked him recently how Summerfest began, he waxed nostalgic and told me, "It got started 10 to 15 years ago--more than that probably--where I just wanted to have a party like the parties we had when I was young at the end of the summer. We would have a big block party. Everybody came out and one of the local bands would play at somebody's house and it became this great end of summer community thing." He remembers it was a *big thing*, and they had a communal barbecue and everyone contributed with one of the fathers acting as grill master, while the mothers sat around and talked. He also told me someone would usually get a blender going for whisky sours...and they also had an end of summer parade. Chef told me about cars in the parade...and he remembers one crazy guy in particular who had a hearse with a fake skeleton in the back as if to say we are *burying the summer*. "Crazy stuff like that and done with such community pride. It was a simpler time. Nobody had cell phones, nobody had Internet. We played outside," added Chef Shafer. At that time, Labor Day officially marked the end of summer, and then all the kids would go back to school. Chef Shafer told me he wanted Summerfest to reflect that feeling.

Listening to Chef Shafer talk about his memories of old-fashioned block parties brought back memories of my own neighborhood block parties. Obviously, it must have

been the same with families and neighborhoods on both coasts, with Chef Shafer in Buffalo, New York, and me in Torrance, California. Although I don't remember any live bands, we did have music--probably from someone's radio. Potluck was the menu of the day and I remember, fondly, it was fun playing in the middle of the street. New friends were made and neighbors enjoyed each other's company.

One big difference between the old-fashioned block parties and the updated Summerfest event (besides now having to get permits to close streets) lies in the philanthropy. As with nearly everything Chef Shafer does, he started Summerfest with the goal of fun, yes, but he also wanted

to raise money for local non-profits. This big-hearted, community-minded, talented chef has orchestrated the Summerfest event benefiting countless organizations through the years.

This year, proceeds from the event will benefit the Torrance Area Chamber of Commerce Junior Leadership Program, which begins this fall. "This program will be a Junior Leadership Torrance program mirrored after the Chamber's Leadership Torrance program. The net proceeds from Summerfest will be designated, through the foundation to the Junior Leadership Program. We are thrilled Chef Shafer has provided this wonderful opportunity to us," said Donna Duperron,

Murder in Charlottesville a Tragic Reminder We Must Always Be Vigilant

It's heartbreaking that Heather Heyer, the victim of Neo-Nazi rage, lost her life in Charlottesville during the weekend because of the savage behavior of an unhinged racist. However, it is infuriating that the President of the United States must have his arm bent in order for him to place blame where it belongs: with violent Neo-Nazi groups. I'll be clear and state that President Trump did not give birth to these extreme racist groups. They have existed in one form or another throughout our nation's history. These groups usually hide and only expose their ignorance when they have a compelling reason to make noise. The problem we have today is that President Donald Trump is their reason to come out in full force. And the President's refusal to directly call out these radical racists for their actions is not only disgusting, but it empowers the very scourge that killed Heyer.

After this weekend's horrible events, let's stop using the label "Alt-Right" and identify these groups for what they are: racist Neo-Nazi groups. The longer decent Americans continue to call racists "Alt-Right" supporters instead of Neo-Nazis, the more these racists are normalized and empowered. Let's stop sugarcoating our own reality. People like Richard Spencer, David Duke and suspected murderer James Alex Fields, Jr. are racist. These three animals want nothing less than a homogenous state--and the murder of Heyer is only a small sample of what they are willing to do. When the President of the United States fails to directly condemn the actions of these

groups, the racists are empowered.

This argument isn't hollow rhetoric either. Neo-Nazi supporters across the country see President Trump as that inspiration to come out of hiding. In a video shot during the Charlottesville "Unite the Right" rally, Duke is recorded saying that he and his like-minded supporters are determined to take the country back: "We are going to fulfill the promises of Donald Trump. That's what we believed in, that's why we voted for Donald Trump. Because he said he's going to take our country back." Duke said these words. So it's not paranoia from the left. It's not an unfounded accusation by fake news. These are the words of a prominent racist leader to describe how they feel about our current President. The only thing more disgusting than Duke's beliefs is Trump's reluctance to condemn people like Duke.

The President condemning these actions and ideologies is not going to eradicate them from our country. However, it does make it clear that such behaviors and actions are unacceptable, which in turn will stop normalizing racism. We, as a society, need to stop calling the Spencers, Dukes and Fields of the world anything less than what they are: racist. There is no "Alt-Right"--because hard-working, kind-hearted, God-fearing conservatives do not support these fringe behaviors. Alt-Right is a term used to lie to ourselves about the reality of this new wave of racism, and it must be stopped. Since the President won't take them to task, then it's up to us. •

My summer reading list included some of the works of the prolific "Gonzo" journalist, the late, great Hunter S. Thompson, who often opined on the political scene. Not a fan of most politicians, he labeled most pols as "swine."

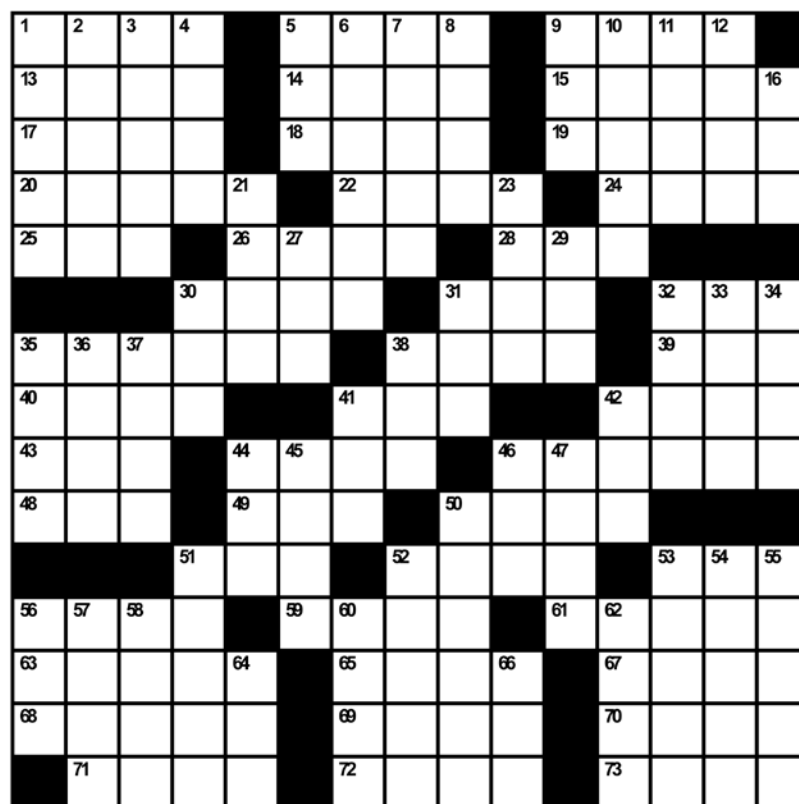

be a representative. "Going into it I didn't know what to expect, but you become really involved with the City and get to be involved with many activities--so I decided to do it again," he said. "I will definitely plan ahead of time, more than I did last year, so we can get more done in an efficient manner."

The 18 students appointed by the Council were selected out of a pool of 32 applicants. The Youth Council Committee, made up of one member of the Parks and Recreation Committee, Commission on Aging, the Library Commission and three Youth Council members, interviewed all applicants between June 8 and 9 to select this year's TYC members. Modifications to the selection process were adopted back in April of 2008 when the City Council approved several Youth Council recommendations, including the adoption of Resolution 2008-52. Through the new resolution applicants would be required to apply for their position during the spring, with appointments being made during the summer so TYC members can begin their terms at the beginning of the school year. Through these changes, TYC members have more time to serve, set and accomplish goals during their terms.

Lum introduced his friend Sydney Matsubara, a South High Junior and first-year TYC member who joins the program with a year of student council experience in her grade level. "I noticed how the older [Torrance Youth] Council members get together and it feels like they're a really close-knit family," Matsubara said. "The way the function is a lot more assertive than anything I have seen, so I am excited."

Lum, whose favorite activity last year was the ASB Bowl competition where all of the high schools leadership classes gather and compete for a trophy that the winner keeps until the following year, looks forward to continue growing as a leader and student. "When you have a conversation with someone, you introduce yourself and shake their hand--but before I joined Youth Council, I was kind of shy," Lum said. "I wanted to get to know people more, but I lacked that confidence. But going through Youth Council, I was able to meet a lot of new people."

Meetings are scheduled to begin this month and will take place every first and third Wednesday of the month in the West Annex Commission Room of the Torrance Civic Center. •
