## Police Department Has New Top Dog

There's a new officer patrolling the streets of Torrance, although unlike most officers he's doing it on four legs. Rex, the Torrance Police Department's newest K-9 officer was introduced to the Torrance City Council during their August 26 meeting.

Rex is filling the paw prints of Torrance's last K-9 officer, Faro, after Faro's retirement from the force. Mayor Pat Furey said Torrance's K-9's have been a valuable part of the city's police department. "A trained K-9's ability to quickly search and accurately detect is far superior to a human and significantly enhances police efficiency," said Furey.

The department was able to afford another K-9 due to donations from Simon Property Group (who operated the Del Amo Fashion Center), Toyota Motor Sales, and Scott Robinson Honda, each of whom Furey thanked for their commitment to the community. Torrance resident Judy Gibson was instrumental to getting these donations, although she modestly said it was "very easy to solicit." She said she was amazed by the police work K-9s do.

"If I were a criminal and I saw Chief Matsuda coming I'd be scared, but I'd be more afraid if I saw the dog," said Gibson. "They are amazing what they can do and we are so lucky in Torrance to have this program."

The Torrance Police Department is also warning citizens about a telephone scam where callers claiming to be the police or fire department ask for contributions from citizens. Matsuda warned Torrance residents that neither department directly seeks funding this way. He and Furey asked residents to contact the Police at (310) 618-5570 with any information connected to the scammers, such as the times of the calls and any phone numbers given or displayed by the caller.

"Neither department calls and directly solicits funds from residents," said Matsuda. "However of note, the [Police and Fire] associations do

sometimes. If you feel the solicitation is a scam, feel free to call our detective division with the information, such as time of day, number that shows up on your machine if there is one."

Torrance resident Georgia Perkins said she had received a scam call claiming she was delinquent for Jury duty. The scammer asked for her e-mail and her credit card information to pay the bogus fine. "The Chief didn't go far enough we he spoke of the scam," said Perkins.

Lastly, the Council approved funding for the construction of 14 electric vehicle charging stations in six different locations in Torrance, including Wilson, Columbia, and McMaster parks, as well as the Walteria and Katy Geissart Libraries. The charging stations are intended to encourage electric vehicle use to cut down on emissions from commuters. The original

plan was approved by the previous Council, although it was missing a fast charging station that senior planner Danny Santana said wasn't feasible with the original budget.

"The last time we were before [the Council, you] expressed an interest in incorporating DC fast charging," said Santana. "The funding we had available at that time did not allow for that."

However, Santana, with the help of a number of other city departments, found a way to bring a fast charging unit to each of the proposed locations in the city. The California Energy Commission awarded the city a grant for over \$400,000 for the fast charging stations, as well as allowed the city to use its previous grant funding to help match the funds, resulting in more funding at less cost to Torrance taxpayers.

## Diagnosing and Treating Allergic Reactions in Pets

My article this month is dedicated to Riley the bulldog. He was a well-known canine celebrity in the city of Long Beach, and will be missed.

Allergic reactions can occur for many reasons and can vary from mild to severe. One of the most common reasons for allergic reactions is a bite or sting from an insect. However, allergic reactions can occur from exposure to almost anything, just as it can in people. Dog breeds with short muzzles, such as pugs, Boston terriers, and bulldogs are at higher risk of developing severe anaphylactic reactions.

**Mild:** Pets that have a mild reaction will have minimal swelling or pain where they were stung. Your pet may or may not require treatment but monitoring for

worsening symptoms is strongly advised. Your pet may not develop allergic symptoms right away so it's a good idea to call your veterinarian and have a plan should things worsen.

**Moderate:** This is the most common reaction in dogs. Pets with moderate allergic reactions often will have urticarial, a moderate vascular reaction of the skin marked by hives or weals and rapid swelling and redness of the lips, around the eyes, and in the neck region. It is usually extremely itchy. Urticaria may progress to anaphylaxis and is considered life threatening.

**Severe:** The most severe reaction is anaphylaxis, a sudden, severe allergic response that produces breathing difficulties.

Employee Engagement is the Secret for Small Businesses

(BPT) - One of the biggest worries for a small business owner is training and investing in quality employees and then losing them to a larger company - potentially a competitor - that might be able to offer larger salaries or better benefits.

It might look like a no-win scenario for a small business to entice quality employees to stay, except for one

factor - engagement. When employees are engaged in the company business, they're less likely to jump ship, they'll be more productive and they'll make the company more money, according to a Hay Group Study.

"Why should anyone care if they have engaged employees?" asks David Fagiano, chief operating officer for Dale Carnegie Training. "Engaged employees create superior results. A Gallup study shows that companies with more engaged employees outperform others by up to 202 percent. That translates to a substantially better bottom line.

How can a small business owner encourage his employees to become more engaged in the company? Consider the following drivers of engagement:

- A sense of value: Employees who feel valued tend to be fully engaged in a company's goals and help achieve big milestones. Supervisors have the ability to create this sense of value, which can lead to confidence, empowerment, enthusiasm and inspiration. Review how your employees are supervised. Are they trusted to do their jobs without heavy review? Do they ask for help only when needed? When requested, do they receive assistance? Finally, do employees feel their supervisors are being honest when presenting information or answering questions? According to the Dale Carnegie Training "How to Drive



Employee Engagement in Small and Mid-sized Businesses" whitepaper, 67 percent of employees deem that having help or support when needed is important, compared to 46 percent who report that compensation increases above the cost of living is important.

- Continued training: Investing in employee training develops a bond between the employee

and the business. Additional training shows the employee there's room to grow in the company, and that the business values his or her expertise. Plus, the company benefits by having employees learning the latest information in the industry.

- Improved communication: There is a difference in opinion on how well employers communicate with employees. According to the whitepaper, employers think they do a better job of it than their workers report. Because of this discrepancy, employers need to make more effort in communicating business information. Consider holding a weekly progress report meeting or developing a newsletter. Involve employees in meetings discussing the future of the company, and give everyone tasks to help achieve the goals that are decided upon. This allows employees to feel they're taking an ownership in the company, which will lead to them becoming more engaged.

Making an employee feel like he or she is important can take the professional relationship far. "Engagement means winning the hearts as well as the minds of employees," Fagiano says. "It's the difference between someone in your company saying, 'I understand where this company is going,' versus, 'I believe in where this company is going.' If you can generate belief at that level, you can drive spectacular results." •

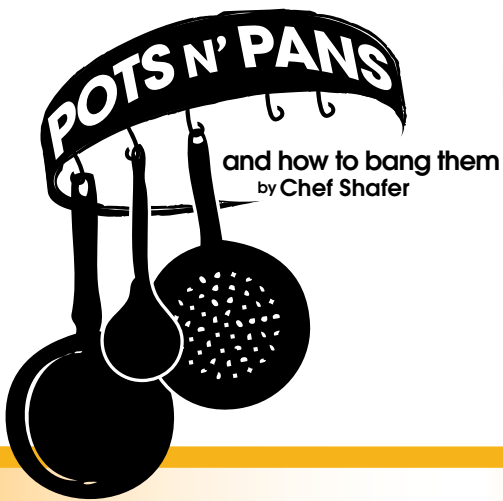

# Baked Brown Sugar and Peach Custard



Ingredients:

- 3 pounds of peaches cut into wedges
- 2 cups heavy cream
- ¼ pound butter
- ½ cup flour
- 1 ½ cups brown sugar
- 1 pinch ground cinnamon
- ½ teaspoon vanilla
- Pinch of salt

Instructions:

- Place the peaches in a casserole dish 9 by 11 or so
- Chop the butter into little pieces and sprinkle over the peaches
- In a mixing bowl mix together the cream sugar flour salt cinnamon and vanilla.
- Pour over the peaches evenly then bake at 350 for 35 to 45 minute or till golden brown and bubbly
- Serve with ice cream.

Naturally, only time will tell what the season has in store, but with a favorable schedule and the undying will of Waybright and his Spartans to retrieve a Pioneer League crown, there is surely nothing that is out of the realm of possibility for the season to come. •

Banning Plastic Bags Won’t Save the World

## Eye See You

“Of all the senses, sight must be the most delightful” -- Helen Keller.

Our eyes are one of the most fascinating organs of our bodies as they allow us to see, and we rarely think about them unless they get sore, tired, or sick. I remember from biology class that the eye is composed of nerves, cornea, retina, and other parts that captures light into the magnificent sphere and sends messages by nerve fibers to the brain allowing us to see and comprehend what we are looking at. Actually, even if I could explain perfectly how the eye works, I still don't understand exactly how we see.

Every year we are told by our eye doctor that we should get an examination for the health and welfare of our eyes. Most of the time I seem to get in for an exam, but it had been three years since I succumbed to the dark rooms and strange machines used by the eye doctor.

Three weeks ago, I made an appointment for an eye exam at my local eye care center in town. It wasn't completely out of responsible eye care that I made the appointment. It was honestly because I was down to my last pair of disposable lenses and needed an exam for a prescription to order more. But I did feel better just making the appointment.

Arriving at the office, I had to wait a bit. Why is it that most doctors' offices usually are running behind? Waiting for the eye exam, I began to check my own eyes by closing one eye and then the other to test how well I could read the brochures on the table in front of me as I sat in the black chair.

Finally, a pleasant assistant, Darielle Crawford, called my name and I followed her into the first cave, I mean room. It was a nice enough room and I sat down in front of a contraption that sort of looked like a microscope. This device was to check my peripheral vision. It was a test. I know it is a test that checks health and not a 'grade' check for subject matter, like at school, but I sat up straight in the chair, held the clicker in my hand and was ready to get 100%. That part of the test went fine and I did well. After the peripheral vision test, there was a color-blind test. I remember taking those tests when I was young and they seemed so easy. I mean, color? Then I was told the importance

of the test. My father in law is color-blind. He wasn't aware of it until he went to take his physical when he wanted to join the Air Force in WWII. They informed him that he was color-blind so he immediately left the office and joined the Marines. Being color-

blind hasn't hindered him in any way. Well, maybe a bit. Once my father-in-law painted the kitchen wood trim in their mountain cabin red, as a surprise for my mother-in-law. She was shocked, returning home, to find out he had painted the trim bright pink. My mother-in-law always picked out the paint after that.

Darielle told me, “Before a patient sees the doctor, I pretty much do the pre-assessment. It assesses your vision before she [the doctor] sees you, so she can see what is going on, which is pretty awesome.” We finished up with the first tests and then Darielle escorted me into the next room, which had more machines. One of the machines took a photograph of my eye. Darielle instructed me how to press my face against the machine, to reveal only my eye into the machine for the photograph. As I looked into the dark space I saw red, green and yellow pop up as I varied the pressure of my face on the machine. Red meant I pressed too hard, yellow meant I was close to green and green meant I had applied the perfect pressure for distance so the photograph could be taken and read clearly. My goal was to press my face against the rim and hold it still when I saw green. It was when the green light was on that a light

flashed and took the photo. I did that for each eye. It was sort of like balancing your face to hit a green light. “We've brought in [this] new technology which is really great, - [it is called] the 'Optos' machine, which takes a photo of the retina of the back of the eye. You can tell anything that is going on with the retina. For instance if someone comes in – and there is a retina tear they wouldn't have known if [we] didn't take the photos. So it really is a lifesaver for people. You can also tell what is going on with the body, which is awesome too,” said Darielle. That machine was amazing and I had no idea the photographs could show so much. In addition, the machine detects problems such as diabetes, cataracts, or elevated pressure in the eye. “You can definitely look at someone's eye and see that something is going on. That's what our Retina Optos machine does,” said Darielle.

I then asked Darielle how she got involved in eye care and she told me she is a recent college graduate and has been working in the eye field for a little over a year. I asked her if she enjoyed her work and she told me, “It is really fun. I love meeting people from all over. I have met people from the U.K., Russia, Guam, and just meeting people in the area. They are so nice. I love working with my

the room where I was waiting I noticed how eye doctor's offices have changed. Nowhere to be found was the big white poster with an 'E' on top and letters and numbers in graduated reduced sizes underneath tacked on the wall. What has replaced the poster is a camera which projects the test letters and numbers on the wall when the doctor flips off the lights.

Dr. P. opened the door, checked my chart, and asked a few questions before dimming the lights and moving the eye equipment in front of my eyes to take a look. She turned on a beam of light toward one eye and then the other, scanning for who knows what. She explained everything she was doing which made me feel relaxed and comfortable. After a few other tests I was told to look through the 'contraption' toward the 'chart' and read.

In the end, I was pleased to find out my eye prescription hadn't changed, which made me happy. I ordered what I needed and preceded to the last room – that made four rooms I visited – to put on my new contact lenses. They fit perfectly and I felt wonderful. New contacts or glasses make everything brighter and clearer.

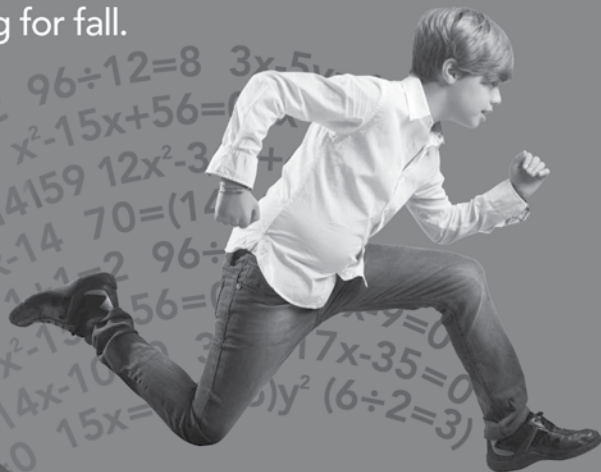

It seems when this enzyme is elevated after an insect sting, prognosis goes down for the dog and more aggressive treatments are needed. Your veterinarian may want to check this enzyme if an insect sting is suspected. In many anaphylactic reactions the gall blad-

be transported to a veterinarian immediately. Severe reaction treatments may include I.V. medication, such as epinephrine and fluids, as well as oxygen and other life supporting procedures.

There is no way to prevent or predict these allergic reactions, so it is important

to have a plan and be prepared. Put your veterinarian's phone number, as well as the after hours emergency clinic that your veterinarian recommends when they are closed, on your cell phone.

airway obstruction, seizures and cardiovascular collapse or death. This reaction is life threatening for your dog. Antibodies that the immune system has made to some portion of the insect venom trigger anaphylaxis and urticaria.

It is important to note that in the most severe reactions I've seen, the owners never suspected a bug sting or any other allergic reaction. They called our hospital because their dog was vomiting, lethargic or had diarrhea.

There is no diagnostic test for anaphylaxis or urticaria. However there is a correlation between a liver enzyme called Alanine Transferase (ALT) and insect envenomation.

der and liver will become edematous and swollen and can trigger a chain reaction of organ failure that may be fatal.

Treatment in mild cases can include oral diphenhydramine (Benadryl); however, call your veterinarian for proper dosing. Treatment for a moderate reaction involves a trip to the hospital for evaluation and will usually include injections of cortisone and other medicine. Treatment for a severe reaction is critical and your pet should be taken to a hospital as soon as possible. Minutes count. Giving oral antihistamines, like Benadryl, in an acute, severe reaction is usually ineffective and can be dangerous. These animals need to

style, from rustic to mid-century modern to sleek contemporary.

### GO BEYOND PLAIN VANILLA

For those who want to add a splash of color, the ceiling holds special allure. Painting the ceiling the same color as the walls (or

one shade lighter) can make a small room feel larger. A bright color, say yellow or pink, could enliven a child’s room, while a sky blue ceiling creates a more soothing ambience. Black ceilings have their own design advantages, dramatically defining a dining area in an open floor plan, for instance, or enhancing the enveloping atmosphere of a home theater.

### LOVE THE LOOK OF METALS

Add some character and shimmer to your ceiling. Consider today’s pressed metal ceiling tiles. They’re far easier to install than their antique ancestors, and the light-bouncing properties of copper, brass and lacquered steel can help raise the ceiling visually in any room.

### HIDE THE POPCORN

Even confident DIY-ers don’t relish the idea of scrapping popcorn ceilings to remove the material and then deal with the messy cleanup. But now there’s an easier and more attractive fix, Vento says.

“We took the plunge and installed an Armstrong Woodhaven plank ceiling, which can be applied directly over the popcorn,” she says. Like wood, Woodhaven planks come in different finishes, and can also be painted.
