Funds To Benefit Female Officers/ Supervisors Locker Room Project

Through two funds transfers from different projects, the Torrance Police Department's Female Officers/Supervisors Locker room project will receive an infusion of \$57,985.25. Approval by members of the city council was unanimous during Tuesday night's council meeting and establishes the project's total expense budget at \$207,985.25.

In the absence of Mayor Patrick J. Furey but with Mayor Pro Tem Geoff Rizzo leading the meeting, the council voted unanimously to approve the recommendation by Torrance Chief of Police Mark A. Matsuda. The specific breakdown of the transfer of funds is to take \$43,760 from the Field Support Office Reconfiguration [FEAP859] and \$14,225.25 from the DNA Testing [FEAP226] project for the completion of the Female Officers/Supervisors Locker room project [FEAP746].

"In 2000, FEAP #226 was established to pay for DNA Testing," states the staff report signed by Chief of Police Matsuda. "This was when DNA evidence testing was somewhat new and we had to pay for analysis on a case-by-case basis to a private laboratory for priority testing. This was before we entered into a contract with Los Angeles County for a Full-Time Criminalist."

During the Aug. 3, 2010 council meeting, the body approved and established FEAP746 to begin the locker room project at a price tag of \$150,000. Three years later, on Nov. 19, 2013, the council approved the establishment of FEAP859 along with \$156,240 in general funds and \$43,760 in Police Impact Fee Funds, totaling \$200,000.

FEAP859 was established to reconfiguring the Field Support Offices, including "the Patrol Report Writing Room, the Patrol Sergeant's Office, the Patrol Equipment Room, the Field Training Officer's (FTO) office and the SWAT Locker Room," states the staff report. "This is still an intended project, but the start date is unknown as other facility improvements have taken priority."

The \$43,760 from the Police Impact Fee Funds are set to expire by August 2016 if not used. Since the field support offices project will not break ground prior to August of next year, it was determined that transferring the funds into a project that can use them was a better alternative.

"The Female Officers/Supervisors Locker Room project is currently underfunded and the Police Impact Fees with the remaining funds from the DNA Testing project will greatly assist in closing the gap," states the staff report. "The cost of DNA Testing is now covered by Los Angeles County. There have been no charges to this FEAP in over 4 years. FEAP #226 has a remaining balance of \$14,225.25 that can be reallocated."

The reallocation of funds from both projects will bump the total budget of the locker room project to \$207,985.25, but remains underfunded.

"Staff will look at other internal remedies to completely fund the projects," states the staff report. "However, the reallocation of the already appropriated funds is a great start."

Agreement Reached For 186th Street Improvements At Columbia Park

A recommendation by the city's public works director to enter a consulting services agreement with CivilSource Inc., based in the City of Irvine, to develop storm drain design services for the 186th Street Improvements at Columbia Park, I 140 was approved by members of the city council.

The agreement will be in effect from Oct. 20, 2015 through Oct. 20, 2017 and caps off the price tag at \$33,155, which will be paid for through IAP I 140 funds. The Torrance City Council has previously approved agreements with CivilSource, Inc. for the performance of engineering design services at the same location.

"The areas along 186th Street along the frontage of Columbia Park and Bailey Drive

(from 184th Street to 186th Street) experience localized flooding during heavy rains," states the staff report signed by Public Works Director Robert J. Beste. "Their scope of work included design services for: sidewalks, ADA [Americans with Disability Act] curb ramps parking spaces, curb and gutter along 186th Street and an investigation of soil conditions in Columbia Park to determine whether localized stormwater could infiltrate in Columbia Park and ultimately reduce or eliminate localized flooding in the area using proposed modifications at Columbia Park to capture and infiltrate stormwater."

Through CivilSource Inc., the construction of additional storm drains in the area can begin for the project to meet its February





Assemblyman David Hadley told me, "It is a great milestone for Torrance and the whole community. It is part of a great complex in I then spoke with Councilwoman Heidi Ann Ashcraft who said, "I am very proud to be on the city council at a time when we can celebrate ten years of having an art museum. I am very happy with the gallery productions we have in here, especially the amount of people who come and visit our museum. I am very interested in seeing we have a lot of coverage and a lot of advertising so everybody in Torrance and the outlaying cities can come and celebrate art."

On the other side of the room I saw Councilman and former Park and Recreation Director for the city of Torrance Gene Barnett, who was instrumental in overseeing the growth

The Estate Tax, Loved and Hated, Celebrates 100 Year Birthday

The estate tax, enacted 100 years ago on September 8, 1915, when revenue was needed to fight a war, is a polarizing tax with enemies and friends on both sides of a big divide. Film Review

Brie Larson, Jacob Tremblay Beautifully Take on the World in the Emotional Film Adaptation, *Room*

Hands down, I have not felt so much emotion from a movie since I was 13-years-old watching Titanic for the very first time. What I experienced while watching Room was a combination of gut-wrenching sorrow, enthusiastic triumph, and sympathetic love all wrapped up in a tightly packaged 118 minutes. Already touting Oscar buzz, and rightfully so, Room is one of those special films that gets everything right- from phenomenal performances to ingenious storytelling and visceral camerawork. Films like this don't come in spades. If there is one movie to see this weekend, heck-this year, make sure it is Room.

Brie Larson delivers one of the strongest performances of her career as Ma, a victim of a kidnapping who has been forced to create a home out of the petty 10"x 10" woodshed where love and how through the power of imagination one can survive anything.

Room tips much of its success to the powerhouse performances of industry veterans Joan Allen and William H. Macy. Their heartwrenching reunion with Ma is near impossible to get through with dry eyes. As I stated earlier, Brie Larson solidifies her reputation in this business as she takes Ma to the darkest of places. We follow her emotional journey so closely that we may begin to lose ourselves in her struggles as a mother, and relate to her even if we don't have children ourselves. And I can't say enough about Hollywood's next rising star, 9-year-old Jacob Tremblay, who brings beauty to the ugliness of his circumstances in Room. His innocence and extraordinary talent make him the perfect "Jack," no one could have played

she is being held captive. The film begins on the morning of her son Jack's (Jacob Tremblay) 5th birthday. Jack doesn't know of life outside of their room, or "Room" as it's so innocently named, and Ma has purposefully kept it that way. She creates a vast and exciting wonderland inside this tiny space; from telling stories to coming up with creative rituals to pass the time and intellectually stimulate him. Jack's sense of wellbeing and happiness are all Ma cares about, however, she knows that the two of them can't stay locked in Room forever. One night Ma hatches a risky plan that could either result in living happily ever after in the real world or risk never seeing each other again.

Imagine never knowing anyone other than your mother. Not knowing what a dog looks like, what rain is, or how the wind feels when it blows on your face. This is the life Jack leads, yet despite the absence of materialistic items, he is happy. He is curious when he sees a mouse, whom he simply names "Mouse," eating crumbs from the floor. The single skylight gives Jack an outlet to dream about space and planets. All of this is made possible by Ma who, herself still a child, refuses to give up on a future for herself or Jack. This special bond between mother and son is a testament to


the part as well. His ability to carry a scene and evoke mature emotions with the purity of his childhood makes him so sympathetic and a magnet for our eves on-screen.

Room is an adaptation of author Emma Donoghue's best-selling literary work of the same name, and those familiar with the novel will certainly not be disappointed in this cinematic interpretation. Keeping true to its integrity, director Lenny Abrahamson (Frank) delicately transforms the 2-dimensional pages of the book into a visually stunning, highly engaging experience.

I left the screening literally speechless: not only do I think *Room* is one of the best films of the year, it sets the bar for other filmmakers attempting innovative storytelling and dynamic character development. Room isn't just a movie, it truly is a full body experience and although it can be uncomfortable at times, it pushes the audience to tap into emotions in a way that has rarely been done before. We embrace everything and are mesmerized by it.

A team has finally scored on the North High Saxons. After allowing absolutely zero points over their past four games, the Saxons finally allowed two touchdowns and a field goal to their rivals from West High. It didn't matter much, as the Saxons and their all-star quarterback Mique Juarez still put up 35 and ran past West High rather easily with a huge second half. "Obviously No. 3 is a heck of a player," West High head coach Greg Holt said of Juarez. "They jumped on his back and he made plays. No doubt he was the best player on the field."

With a little over six minutes remaining in the game, the Warriors found a bit of life on the shoulders of Timmerman again. The running back took the ball in from 21-yards out to pull the Warriors to within 28-17. Eventually, Juarez sealed the deal, though, and put the game away with yet another touchdown run, this time from 8-yards away, to complete the 35-17 win.

Juarez's numbers through the air were less than stellar as he went 10 of 22 for 94 yards, one touchdown and two interceptions. Where the all-star did most of his damage was on the ground compiling 195 yards and four touchdowns on 24 carries. Timmerman,

The Spartans still maintained an 11-8 lead going into the half, but the team seemed not to wake up until the second and third quarters of the game.

A safety and a rushing touchdown accounted for all 11 points in the first half for South High. Only up by three points at the break, however, the Spartans and head coach Joshua Waybright knew that they would need much more. The second half of play provided the team with just that. While holding Centennial scoreless in the third quarter, South got on the board behind their starting quarterback, Gabe Zuniga, who gave his team an 18-8 lead with a 3-yard rushing touchdown. The fourth quarter was all about running back Cameron Dillon. Dillon punched in scores from 3-yards out and 1-yard out, respectively, to put the game in the bag for the Spartans and seal a 32-14 end of game victory.

The Spartans (7-1, 3-0) are currently in a tug-of-war with the North High Saxons (6-1, 2-0) for first place in the Pioneer League standings. Déjà Blue

The Los Angeles Dodgers are incapable of winning in October. No matter how much money the team spends, no matter how many big name pitchers are on the staff, the Dodgers continue to find a way to fall apart in the playoffs. Last Thursday night at Chavez Ravine, it was more of the same to end their playoff lives. A 3-2 loss at the hands of the New York Mets in Game 5 of the MLB Divisional Series put the latest exclamation point on yet another Dodgers meltdown. Dodger supporters will tell you that there is reason to be optimistic about the ball club, but positivity remains lacking in a team that can't score runs and put up wins when it truly matters the most.

Dodger Stadium has never been so quiet before. Well, that is unless you count last year. As A.J. Ellis struck out to bring the Dodgers down to their last out, the silence that blanketed a stadium with the largest attendance in the league this year was a firm reminder that the Dodgers don't have what it takes to compete in playoff baseball. A team that has struggled all year long against above-.500 ball clubs, the Dodgers were simply out-pitched, out-hit, and out-managed by Terry Collins and the New York Mets. For a third consecutive year, in a third consecutive playoff series, the Dodgers disappeared into thin air, almost as if they had never even been apparent in the first place.

In the 27 years since going to the World Series last, the front office has changed, players have changed, ticket prices have changed, but the Dodgers' inability to produce

when it matters most, and ability to let all of their fans down, remains the same. "Been standing here before," Dodgers outfielder Carl Crawford said with a blank look on his face. "Same ending again." \$300 million worth of payroll and literally the most expensive team in the MLB couldn't get the job done and continued the narrative that you simply can't buy championships. All of the expectations put on the Dodgers were beaten by a group of young, hard-throwing Mets players that weren't bought, but came up through their farm system and simply wanted to win more. Instead of thinking they were owed a series win, the Mets went out and took it.

"There are really no words to describe how you feel right now," Dodgers manager Don Mattingly said. "You come to spring training, you work all winter, you scratch, you fight all year long to get into this situation and you have a chance. It comes to a crash." The Dodgers' season may not be the only thing coming to a crash-ending. Expect the Dodgers' roster, starting with Mattingly, to look completely different at the start of next year. Between Andre Ethier catching a foul ball in right field that led to a Mets run, the entire Dodgers team forgetting basic fundamentals and leaving third base wide open to the opposing team and players yelling at Don Mattingly in the dugout on live television, it's evident that it's time to make some changes. More changes, though, doesn't necessarily mean more winning.

With 13 runners in scoring position, the Dodgers managed just two hits. If you've been a fan of the Dodgers, not even in just this



the museum. I think in order to really sustain and grow; you have to look a little bit beyond the local community too. That is true for a lot of the programs the city runs, but I do think that over time with Kristina Newhouse, as the founding curator, and now with Max Presnell, they both have made huge contributions and have set the stage to move forward to make com and offer your time and talent. "... Their time is really very valuable and they have been generous with that, which is great," added Eve.

Another thing the museum did a few years ago showed its character. When the big tsunami hit Japan in 2011, the museum happened to have an exhibition open that consisted of an exchange with a lot of Japanese artists, who

2016 established deadline for completion. In the past the city has entered agreements with CivilSource Inc. but all past agreements have since expired.

"Staff is requesting a sole source agreement with CivilSource, Inc. to perform storm drain design services because they previously obtained all the necessary data and electronic files and base maps for the area," indicates the staff report. "And have already completed storm drain capacity analysis for the area. Staff has reviewed their scope of work and cost and finds them to be very reasonable."

When the design for the project is finalized, staff will seek the inclusion of the design plans in the bid documents for the 186th Street Improvements at Columbia Park.

"This will reduce management and construction costs, as well as ensure that underground work is performed prior to constructing surface improvements on 186th Street and Bailey Drive," concludes the staff report.

Recycled Water Retrofit Refund Check Will Be Allocated To Stormwater Basin Enhancement Project

The city council approved accepting the Recycled Water Retrofit Refund Check from the Metropolitan Water District of Southern California in the amount of \$22,961.25 and

Basin Enhancement Project. The council also approved budget transfers and appropriations at a total of \$278,520 to the Stormwater Basin Enhancement Project.

For the work undertaken to retrofit Entradero Park and baseball fields to use recycled water, the City of Torrance was awarded the refund check. The Stormwater Basin Enhancement Project was developed to address the Santa Monica Bay Beaches Bacteria [SMBBB] and Santa Monica Bay Debris. The monies from the refunds are to partially fund the expense associated with stormwater quality monitoring and a landscape maintenance program.

"The Environmental Protection Agency (EPA) is required to establish limits for pollutants to navigable waters referred to as Total Maximum Daily Loads (TMDLs)," states the staff report.

The Stormwater Basin Enhancement Project includes: Amie Basin, and is to provide passive wetland treatment, native habitat and trash screens on catch basins; Henrietta Basin, to provide passive wetland treatment, additional infiltration and habitat restoration, trash screens and catch basins; as well as Entradero Basin, to provide additional infiltration, habitat restoration, trash screens on catch basins and improved public access without affecting the existing park and baseball activities. •

Police Department To Purchase New Vehicles

A recommendation by General Services Director Sheryl Ballew and Torrance Chief of Police Mark A. Matsuda to purchase 12 new vehicles was approved unanimously by members of the city council.

The first item approved by the city council approved a purchase order of two 2015 Honda Accords and two 2015 Honda Odysseys in the amount of \$110,771.20 from local dealership Scott Robinson of Torrance. The second item approved awarded a purchase order for eight 2016 Ford vehicles in the amount of \$208,198.72, sales tax included. Each new Ford vehicle will replace seven 2002 Impalas, with odometers registering from 68,319 to 98,856 miles. The eight vehicles to be replaced is a 2002 Dodge with 73,387 miles on the odometer.

"The Police Department requires unmarked vehicles for detective and training operations throughout Torrance and the greater Los Angeles area," states the staff report. "The proposed vehicle purchases are replacements for eight existing vehicles which have reached their established service lifecycles."

Bid documents for the Ford vehicles were submitted to 42 dealerships but only one bid was received by the city, from Wondries Fleet Group in Alhambra. The staff report highlights that AutoNation Ford and Martin Chevrolet, both based in Torrance, were contacted by staff to verify receipt of bid documents but both decided not to respond.

With regards to the two Honda Accords and Honda Odysseys, the city only received one bid submittal out of the four dealerships that were delivered bid documents. These four vehicles will replace a 2009 Nissan Altima [76,931 miles], a 2009 Honda Accord [121,292 miles], a 2009 Toyota Sienna [123,939 miles] and a 2010 Honda Odyssey [128,010 miles].

"The Police Department requires unmarked vehicles for undercover operations throughout the city," states the staff report. "The bid from Scott Robinson Honda reflects pricing well below the Manufacturer's Suggested Retail Price, and is also lower than the Kelley Blue Book fair market range for these vehicles." •


Pluto's Big Moon Charon Reveals a Colorful and Violent History

NASA's New Horizons spacecraft has returned the best color and the highest resolution images yet of Pluto's largest moon, Charon-and these pictures show a surprisingly complex and violent history. At half the diameter of Pluto, Charon is the largest satellite relative to its planet in the solar system. Many New Horizons scientists expected Charon to be a monotonous, craterbattered world; instead, they're finding a landscape covered with mountains, canyons, landslides, surface-color variations and more.

"We thought the probability of seeing such interesting features on this satellite of a world at the far edge of our solar system was low," said Ross Beyer, an affiliate of the New Horizons Geology, Geophysics and Imaging (GGI) team from the SETI Institute and NASA Ames Research Center in Mountain View, California, "but I couldn't be more delighted with what we see!"

High-resolution images of the Plutofacing hemisphere of Charon, taken by New Horizons as the spacecraft sped through the Pluto system on July 14, and transmitted to Earth on Sept. 21, reveal details of a belt of fractures and canyons just north of the moon's equator. This great canyon system stretches across the entire face of Charon, more than a thousand miles, and probably around onto Charon's far side. Four times as

long as the Grand Canyon, and twice as deep in places, these faults and canyons indicate a titanic geological upheaval in Charon's past.

"It looks like the entire crust of Charon has been split open," said John Spencer, deputy lead for GGI at the Southwest Research Institute in Boulder, Colorado. "In respect to its size relative to Charon, this feature is much like the vast Valles Marineris canyon system on Mars."

The team has also discovered that the plains south of the canyon, informally referred to as Vulcan Planum, have fewer large craters than the regions to the north, indicating that they are noticeably younger. The smoothness of the plains, as well as their grooves and faint ridges, are clear signs of wide-scale resurfacing.

One possibility for the smooth surface is a kind of cold volcanic activity, called cryovolcanism. "The team is discussing the possibility that an internal water ocean could have frozen long ago, and the resulting volume change could have led to Charon cracking open, allowing water-based lavas to reach the surface at that time," said Paul Schenk, a New Horizons team member from the Lunar and Planetary Institute in Houston.

Even higher-resolution Charon images and composition data are still to come as New Horizons transmits data, stored on its digital recorders, over the next year -- and as that happens, "I predict Charon's story will become even more amazing!" said mission Project Scientist Hal Weaver, of the Johns Hopkins University Applied Physics Laboratory in Laurel, Maryland. The New Horizons spacecraft is currently 3.1 billion miles (5 billion kilometers) from Earth, with all systems healthy and operating normally. •


